## **FOREWARD**

Pursuant to Article 152 (2) of the Constitution and section 5 of the Public Appointments (Parliamentary Approval) Act, No. 33 of 2011, His Excellency the President nominated **Mr. Solomon Kitungu** to the position of Principal Secretary for State Department of Transport. His nomination was conveyed to the Speaker of the National Assembly through a letter Ref. No. OP/CAB.1/40A, dated 15<sup>th</sup> January, 2020. The nominee's Curriculum Vitae and Testimonials were enclosed in the letter.

On Monday, 10<sup>th</sup> February, 2020 and pursuant to Standing Order 42(1), the Speaker of the National Assembly read the message from H.E. the President communicating the name of the nominee for the position of Principal Secretary for State Department of Transport, to the House. Pursuant to section 4 of the Public Appointments (Parliamentary Approval) Act, 2011 and Standing Orders, the name of the nominee was referred to the Departmental Committee on Transport, Public Works and Housing for vetting and reporting to the House within fourteen (14) days.

In compliance with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011, the Clerk of the National Assembly placed an advertisement in the print media on Wednesday, 12<sup>th</sup> February, 2020, (*Annexure 4*) inviting the public to submit memoranda by way of written statements on oath (*affidavit*) on the suitability or otherwise of the nominee in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011. The advertisement indicated that the submissions were to be received by Tuesday, 18<sup>th</sup> February, 2020 at 5.00 pm. By close of the submission deadline, the Committee had not received any submission on the suitability of the nominees or otherwise for appointment as Cabinet Secretaries.

Further, in fulfilment of the provisions of Article 118 of the Constitution, section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011 and Standing Order 45(3), the Clerk of the National Assembly on Friday, 14<sup>th</sup> February, 2020, notified the public in the print media the intention of the Committee to conduct the approval hearing of the nominee on Thursday, 20<sup>th</sup> February, 2020 from 10.00am (*Annexure 4*).

The nominee appeared before the Committee on Thursday, 20<sup>th</sup> February, 2020 for approval hearing in accordance with the provisions of the Constitution, the Public Appointments (Parliamentary Approval) Act, 2011 and the National Assembly Standing Orders on his suitability or otherwise for appointment to the position of Principal Secretary for State Department of Industrialization.

The Committee made the following observations having considered the nominee's curriculum vitae, filled questionnaire pursuant to the Schedule to the Public Appointments (Parliamentary Approval) Act No. 33 of 2011 and the oral submissions during the approval hearing:

## **1.0 PREFACE**

### **1.1 Mandate of the Committee**

The Departmental Committee on Transport, Public Works and Housing is mandated, pursuant to the Standing Order 216 (5), to;

- a. investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
- b. study the programme and policy objectives of Ministries and departments and the effectiveness of the implementation;
- c. study and review all legislation referred to it;
- d. study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
- e. investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
- f. to vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (*Committee on Appointments*);
- g. examine treaties, agreements and conventions;
- h. make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
- i. make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
- j. consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
- k. examine any questions raised by Members on a matter within its mandate.

Further, the Second Schedule to the Standing Orders mandates the Committee to consider matters relating to the following subjects:-

- a) Transport;
- b) Roads;
- c) Public works;
- d) Construction and maintenance of roads, rails and buildings;
- e) Air and seaports; and
- f) Housing.

In executing this mandate, the Committee oversees various State Departments, namely:

- i. The State Department of Transport;
- ii. The State Department of Infrastructure;
- iii. The State Department of Housing and Urban Development;
- iv. The State Department of Public Works; and
- v. The State Department of Shipping and Maritime Affairs.

## **2.0 BACKGROUND**

### **2.1 Establishment of the Committee**

The Departmental Committee on Transport, Public Works and Housing is established under Standing Order 216(1) with the mandate to vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (*Committee on Appointments*).

### **2.2 Notification of nomination**

On 15<sup>th</sup> January 2020, H.E. the President forwarded to the National Assembly, for consideration and approval, the notification of nomination of Mr. **Solomon Kitungu** as Principal Secretary, Transport. This was in accordance with the provisions of Article 155(3)(b) of the Constitution and section 5 of the Public Appointments (Parliamentary Approvals) Act, 2011. (*Annex 1-Notification*)

In accordance with Standing Order 42 (1) and (3) (c), the Speaker, having read the Message from the President, referred the names of the nominee together with his curriculum vitae to the Departmental Committee on Transport, Public Works & Housing to conduct approval hearing. The Speaker further advised the Committee to conduct public participation as provided for under Article 118 of the Constitution as well as the Public Appointment Parliamentary Approval Act (No.33 of 2011) and report to the House within 14 days. (*Annex 2-CV and Testimonials*)

### **2.3 Nomination & Appointment Process**

The candidate was nominated in accordance with the provisions of Article 155(3)(a) of the Constitution which provides that the President shall nominate a person for appointment as Principal Secretary from among persons recommended by the Public Service Commission. (*Annex 3-Recommendation from the PSC*)

The Constitution provides that the recruitment of officers to public office should be conducted in a competitive, transparent and fair process before nomination for appointment by H.E. the President with the approval of the National Assembly.

The National Assembly having received the name of the nominee is obligated to conduct approval hearing and make a determination of the nominee's suitability or otherwise within fourteen days as provided for in section 8 (1) of the Public Appointments (Parliamentary Approval Act) (No.33 of 2011).

#### **2.4 Notification to the public**

Section 6(9) of the Public Appointments (Parliamentary Approval) Act provides that “*any person may, prior to the approval hearing and by a written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated*”.

The Clerk of the National Assembly placed an advertisement in the print media on Friday, 14<sup>th</sup> February, 2020, inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011. The advertisement indicated that the submissions were to be received by Tuesday, 18<sup>th</sup> February, 2020 at 5.00 pm.

Pursuant to the provisions of Article 118 of the Constitution, Section 6(4) of the Public Appointments (Parliamentary Approval) Act and Standing Order 45(3), the general public was on Friday, 14<sup>th</sup> February, 2020 notified in the print media by the Clerk of the National Assembly of the intention of the Committee to conduct the vetting of the nominee on Thursday 20<sup>th</sup> February, 2020. (*Annexure 4 – Print media adverts/ Public notification*)

#### **2.5 Clearance requirements and Matters Touching on Integrity;**

Additionally, on Wednesday 12<sup>th</sup> February, 2020, the Clerk of the National Assembly wrote to the Registrar of Political Parties (RPP), the Directorate of Criminal Investigation (DCI), the Ethics and Anti-Corruption Commission (EACC), the Higher Education Loans Board (HELB) and the Kenya Revenue Authority (KRA) (*Annexure 5*) requesting for reports with respect to the nominees on the following:-

- (a) matters touching on integrity;
- (b) tax compliance;
- (c) political affiliations; and
- (d) Loan repayments.

On matters touching on integrity, pursuant to chapter six of the Constitution, the Committee received a letter from the Ethics and Anti-Corruption Commission (EACC) dated 19<sup>th</sup> February 2020 under Ref. EACC.7/10/5VOL.XII (182) indicating that the Commission had not undertaken any investigations where the nominee had been found culpable. The nominee further submitted to the Committee the EACC declaration form as received by the EACC on 31<sup>st</sup> January, 2020.

On matters of tax compliance, the Committee received a letter from the Kenya Revenue

Authority (KRA) dated 19<sup>th</sup> February 2020 under Ref, KRA/5/1002/26(1085) showing that the nominee was tax-compliant. In addition, the nominee submitted a certificate of compliance from KRA.

As regards political affiliations, the Committee received a letter from the Registrar of Political Parties (RPP) dated 13<sup>th</sup> February, 2020 under Ref No. RPP/ORG/34/Vol III (4) confirming that the nominee is not an official of a registered political party. With respect to criminal records, the Committee received a letter from the Directorate of Criminal Investigation (DCI) dated 13<sup>th</sup> February 2020 under Ref. DCI/CRO/SEC/6/7/2/A/VOL.III/172 confirming that the nominee had applied for a Police Clearance Certificate and had been issued with the same on 31<sup>st</sup> January 2020;

### **Loan repayments**

With regards to higher education loans, the Committee received a letter under ref. HELB/RR/112009/30 dated 17<sup>th</sup> February, 2020 from the Higher Education Loans Board (HELB) indicating that the nominee had cleared his loan on 22<sup>nd</sup> Feb, 2013 and had been issued with a certificate for the same.

### **2.6 Notification to the nominee**

Finally, on Wednesday 12<sup>th</sup> February, 2020, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act, the Clerk in writing invited the nominee for the vetting hearings indicating the time and place for holding the approval hearings (*Annexure 6-Nominee Invite*).

### **2.7 Issues for consideration during the approval hearings**

The Committee observed that the issues for consideration in relation to the nomination and approval exercise are as provided under section 7 of the Public Appointments (Parliamentary Approvals) Act, as follows-

- a) The procedure used to arrive at the nominee;
- b) The constitutional and statutory requirements relating to the office in question; and
- c) The suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made.

#### **(a) Procedure used to arrive at the nominee**

The procedure for appointment of Principal Secretaries is outlined under Article 155(3) (a) of the Constitution which provides that the President shall nominate a person for appointment as Principal Secretary from among persons recommended by the Public Service Commission.

**(b) Constitutional and Statutory requirements**

The Constitution, in addition, sets out certain requirements regarding the appointment of persons to public office which include -

**(i) Two-thirds Gender Principle**

Article 27 (8) of the Constitution provides that the State shall take legislative and other measures to implement the principle that not more than two-thirds of the members of elective or appointive bodies shall be of the same gender.

**(ii) Persons with Disability**

Article 232 (1) (i) of the Constitution provides that the values and principles of public service include affording adequate and equal opportunities for appointment, training and advancement, at all levels of the public service, of—

- (i) men and women;
- (ii) the members of all ethnic groups; and
- (iii) persons with disabilities.

Further, Article 54(2) of the Constitution mandates the State to ensure the progressive realization of the principle that at least five percent of members of the public in appointive bodies are persons with disabilities.

**(iii) Youth**

Article 55 of the Constitution mandates the State to take measures, including affirmative action to ensure that the youth have opportunities to associate, be represented and participate in political, social and economic spheres of life.

Article 260 of the Constitution defines a “youth” as a person who has attained the age of eighteen years but has not attained the age of thirty-five years.

**(iv) Leadership and Integrity**

The Committee, in determining the suitability of the nominees, took into consideration the provisions on leadership and integrity as outlined under Chapter Six of the Constitution. In particular, the Committee took cognizance of the following provisions-

- i. Article 73 (2) of the Constitution which provides that the guiding principles of leadership and integrity include –
  - (a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;

- (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
  - (c) selfless service based solely on the public interest, demonstrated by —
    - (i) Honesty in the execution of public duties; and
    - (ii) The declaration of any personal interest that may conflict with public duties;
  - (d) accountability to the public for decisions and actions; and
  - (e) discipline and commitment in service to the people.
- ii. Article 75(1) of the Constitution that requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties and Article 75(3) of the Constitution that prohibits a State Officer who has been removed from office under that Article from holding any other State Office.
  - iii. Article 77(1) of the Constitution that prohibits a full time State Officer from participating in any other gainful employment.
  - iv. Article 77(2) of the Constitution that prohibits an appointed State officer from holding office in a political party.
  - v. Article 78 of the Constitution that disqualifies persons who are not Kenyan Citizens and persons holding dual citizenship from appointment as State Officers.
- c) Suitability of the nominee for the appointment proposed having regard to whether the nominee’s abilities, experience and qualities meet the needs of the body to which the nomination is being made**

The Committee observed that suitability of the nominee should be evaluated holistically taking into account the nominee’s academic credentials, professional training, experience, background and personal qualities as well as the performance of the nominee during the approval hearing.

**i. Nominee’s Abilities**

The nominee possesses excellent professional and educational qualities with an impressive work background. He has managed some of the most challenging assignments in his career as a public servant. It is on this background that he had served as an Investment Director since 2017 to date at the National Treasury.

## ii. Nominee's Experience and Qualities

The nominee has a wealth of experience in public service having been in the public service since 1988 as an economist and risen through the ranks. The nominee has been an Investment Director at the National Treasury since the year 2017 where he took part in the implementation of an ambitious privatization programme that has seen the completion of the concessioning of the operations of the Kenya Railways, the IPO of KenGen, the IPO of Safaricom Ltd, among others. The nominee has previously served in other different capacities. These include his position as:

- i. Executive Director and CEO, Privatization Commission between 2009 and 2017;
- ii. Principal Economist, the National Treasury between 2000 and 2003;
- iii. Senior Economist, the National Treasury between 1996 and 2000;
- iv. Economist I, the National Treasury between 1991 and 1996; and
- v. Economist II, the National Treasury between 1991 and 1996

It is worth noting that the nominee has participated in many Ministerial and Inter-Ministerial Committees some of which he has chaired and has also represented the National Treasury in many boards of directors of State Corporations including Kenya Commercial Bank, Kenya Electricity Generating Company, the Kenya Power and Lighting Company, Kenya Petroleum Refineries Limited, the National Bank of Kenya, Kenya National Assurance Company Limited, National Shipping Line and many others. The nominee has also played lead roles in many projects and institutional and sectoral reforms and currently he is a member of the Civil Aviation Sector Restructuring Steering Committee and also the Chairperson of a taskforce on Merger of Industrial and Commercial Development Corporation, IDB Capital and Tourism Finance Corporation.

### 2.8 Memoranda from members of the public

Section 6(9) of the Public Appointments (Parliamentary Approvals) Act, provides that *any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold office to which the candidate has been nominated.*

The Clerk of the National Assembly placed an advertisement in the print media on Wednesday 12<sup>th</sup> February, 2020 inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act.

By close of business on Tuesday, 18<sup>th</sup> February, 2020 at 5.00 pm, the Committee had not received any written statements on oath in respect of the nominee.



### **3.0 APPROVAL HEARINGS OF THE PRINCIPAL SECRETARY NOMINEE**

The Committee on Transport, Public Works & Housing conducted an approval hearing on Thursday 20<sup>th</sup> February, 2020 in Committee Room 9, Main Parliament Buildings, in Nairobi. This was as per the schedule that had been advertised by the Clerk of the National Assembly and which was communicated to the members of the public and the nominee.

In conducting the approval hearings, the Departmental Committee on Transport, Public Works and Housing examined the nominee against the following criteria as set out in the Public Appointments (Parliamentary Approval) Act -

- (a) Academic qualifications;
- (b) Employment record;
- (c) Professional affiliations;
- (d) Potential conflict of interest;
- (e) Knowledge of the relevant subject;
- (f) Overall suitability for the position;
- (g) Integrity;
- (h) Vision and leadership; and
- (i) Expectations and key priorities.

### **3.1 Nominee's Background**

Mr. Solomon Kitungu appeared before the Committee on Thursday 20<sup>th</sup> February, 2020 at 10.00 am and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. Mr. Solomon Kitungu is a Kenyan citizen, ID number 0273815, born in 1961 in Mwingi Central, Kitui County.

### **3.2 Educational and Professional Qualifications**

1. He holds a Masters of Economics and Social Studies from Manchester University, UK, 1990.
2. He holds a Bachelors of Economics, Upper Second Honours degree from the University of Nairobi, 1987.
3. He did his A-levels exams at Machakos Boys School and passed with three principals and one subsidiary pass in General Paper.
4. He did his O-level exams at St. Charles Lwanga, Kitui and passed with Division 1, 13 points.

### **3.3 Employment Records, Work and Professional Experience**

5. He has been working at the National Treasury as an Investment Director, Public Investments & Portfolio Management since the year 2017 till his nomination.
6. The nominee has also worked as the Executive Director & CEO, Privatization Commission from April 2009 to September 2017.
7. The nominee has served as a Principal Economist at the National Treasury between 2000 and 2003.
8. In addition, he has worked as a Senior Economist at the National Treasury between 1996 and 2000.
9. The nominee also worked as an Economist I at the National Treasury between 1991 and 1996.
10. Finally, the nominee has also worked as an as an Economist II at the National Treasury between 1988 and 1996.
11. The nominee holds various other Certificates including on Advanced Management Programme, University of Navarra, Spain, 2011; Strategic Leadership Development Programme, Kenya School of Government; Strategic Planning and Decision Making, Setym International, Canada, 2019; Virtuous Leader Executive Seminar, Strathmore Business School, 2010; Fundamentals for Leading and Managing State Owned Enterprises and Government Agencies, South Africa, 2014; Infrastructure Investment and Financial Analysis from the Institute for Public Private Partnerships in Washington DC, 1998; and on Privatization and Private Sector Development from Bradford University in the United Kingdom in 1995.

### **3.4 Honors and Awards**

12. He has never been given any honors or awards.

### **3.5 Integrity**

- a) He has never been dismissed or otherwise removed from office under Article 75 of the Constitution. The nominee has never been adversely associated with practices that depict bias, favoritism or nepotism in the discharge of public duties as evidenced by EACC clearance issued to him on 19<sup>th</sup> February 2020.
- b) He has neither been charged in a court of law in the last three years nor adversely mentioned in any investigatory report of Parliament or any other commission of inquiry, as evidenced by DCI clearance issued to him on 13<sup>th</sup> February 2020.
- c) The nominee has paid taxes due as provided by law, as evidenced by a KRA Compliance Certificate issued to him on 3<sup>rd</sup> February 2020.

### **3.6 Potential Conflict of Interest**

The nominee stated that he had no potential conflict of interest in so far as his nomination was concerned and further indicated that good governance requires disclosure of any conflict of interest situation and recusal from related decision making.

### **3.7 Net worth**

The nominee stated that his net worth is around 100.7 million Kenyan shillings and includes both assets and cash.

### **3.8 General and Sector Specific Issues**

The Committee posed questions to the nominee relating to past experience and knowledge in the sector. The nominee responded as follows:

- a) Mr. Kitungu informed the Committee that he has risen from an Economist II at the National Treasury in 1988 to a Principal Economist between the year 2000 and the year 2003. He was also the CEO of the Privatization Commission from April 2009 to September 2017. Currently, he is the Investment Director, Directorate of Public Investment & Portfolio Management; a position he held since 2017.
- b) As the Investment Director, and previously as the Executive Director of the Privatization Commission, Mr. Kitungu interacted with numerous State Corporations, a task that enhanced his knowledge on matters governance and management.
- c) The nominee has a wealth of experience in public service having been in service since 1991 in investment promotion, banking, privatization and public enterprise reform. As an Investment Director at the National Treasury and CEO of the Privatization Commission, he took part in the implementation of an ambitious privatization programme that has seen the completion of the concessioning of the operations of the Kenya Railways, the IPO of KenGen, the IPO of Safaricom Ltd and Kenya Commercial Bank (KCB), among others.
- d) On the nominee's vision on the aviation sector in general and on Kenya Airways in particular, the nominee acknowledged that as it is at the moment, Kenya Airways cannot survive. He commended the Committee for their inquiry in 2019 and their recommendations to improve and restructure the aviation sector. He explained that in his current assignment at the National Treasury, he was involved in the implementation of the Committee's report and that they have already created an Aviation Holding Company with its own fund. All the funds from the company, its subsidiaries and other sources shall all be directed to the fund. He was hopeful that

with the support from the National Assembly, the restructuring of the aviation industry will succeed as intended by Parliament.

- e) On his stand about corruption, the nominee reported that he has never had a single audit query for the nine years he was working at the Privatization Commission and further declared that he was personally not corrupt.
- f) On his performance as the CEO of the Privatization Commission, during which time no privatization was ever achieved despite the nominee associating himself with their restructuring plans, the nominee explained that everything had a well-defined process and that he played his part well, and that he did not have mandate or power over continuing and connecting processes. Further that there was moratorium against privatization.
- g) The nominee assured the Committee that, given an opportunity to serve, he will definitely make significant contribution in his new capacity. Further, the nominee allayed fears that he was more of a boardroom officer, explaining that whereas the nature of his work rightly appeared to be so, he was also the brains behind so many great policies and good works which in many cases, no direct reference was made to an individual's contribution. He explained that he was well experienced and exposed, and in a sure position to deliver and turn around the transport sector.

#### 4.0 COMMITTEE OBSERVATIONS

The Committee, having considered the nominee's filled questionnaire pursuant to section 6(8) of the Public Appointments (Parliamentary Approval) Act, his curriculum vitae and having heard his oral submission during the approval hearing, made the following observations on his suitability for appointment as the Principal Secretary in the State Department for Transport.

- (i) The candidate was nominated in accordance with Article 155(3) of the Constitution
- (ii) The nominee exhibited vast knowledge and experience having served in various capacities and as a career civil servant since 1991 with experience especially in the investment sector.
- (iii) The nominee possess impressive knowledge of topical issues in the governance, public and management sectors;
- (iv) In accordance with Article 78(1) (2) he is a Kenyan citizen and does not hold dual citizenship and is therefore fit to hold office as a Principal Secretary;
- (v) His academic credentials, and professional training and experience are impressive and in compliance with Section 6(7) of the Public Appointments (Parliamentary Approval) Act;
- (vi) He satisfies the requirements of Chapter 6 of the Constitution on leadership and integrity having been cleared by the DCI, RPP, HELB and the EACC;
- (vii) The nominee has never been charged in a Court of Law having been cleared by the DCI;
- (viii) As stipulated in Article 75(1) of the Constitution, he has no potential conflict of interest;
- (ix) He satisfies the requirements of Article 77(1) of the Constitution in that he does not intend to participate in any other gainful employment;
- (x) He does not hold office in any political party hence satisfies the provisions of Article 77(2) of the Constitution;
- (xi) The nominee has never been dismissed from office under Article 75 of the Constitution for contravention of the provisions of Articles 75(1) (conflict of interest), 77 (restriction of State Officers) and 78(2) (dual citizenship).

**5.0 COMMITTEE'S RECOMMENDATIONS**

Pursuant to Article 155 (3) of the Constitution and Standing Order 216 (5) (f), the Committee recommends that the National Assembly approves the nomination of **Mr. Solomon Kitungu** for appointment by H.E. the President as Principal Secretary, State Department of Transport, Ministry of Transport, Infrastructure, Housing and Urban Development.

- (v) Demonstrable leadership and management capacity including knowledge of financial management and strategic people management; and
- (vi) Meet the requirements of Chapter Six of the Constitution on leadership and integrity.

In addition, the advert outlined the following core competencies and skills matching the position of Principal Secretary:

- (i) Ability to portray and uphold a positive national image;
- (ii) Exhibit visionary and strategic thinking;
- (iii) Capacity to work in a multi-cultural and multi-ethnic environment with respect to diversity;
- (iv) Excellent organizational, interpersonal and communication skills; and
- (v) Capacity and resilience to work under pressure to meet strict deadlines.

In-keeping with best practice, the advert contained terms of service, application procedure, the need for submission of curriculum vitae and testimonials among other supporting documents including evidence of citizenship.

Clearance from the following Agencies was underscored:

- Kenya Revenue Authority;
- Higher Education Loans Board;
- Ethics and Anti-Corruption Commission; and
- Directorate of Criminal Investigation.

At closure of the advert on 1<sup>st</sup> September, 2017, a total of Two Thousand One Hundred and Ninety (2,190) applications were received. Subsequently, the applications were rigorously processed and assessed. Shortlisting premised on criteria derived from the advert was undertaken on 15<sup>th</sup> November, 2017. Arising from the pre-selection exercise, a shortlist of One Hundred and Eighty Four (184) applicants comprising of Forty (40) serving Principal Secretaries and One Hundred and Forty Four (144) other applicants was agreed upon.



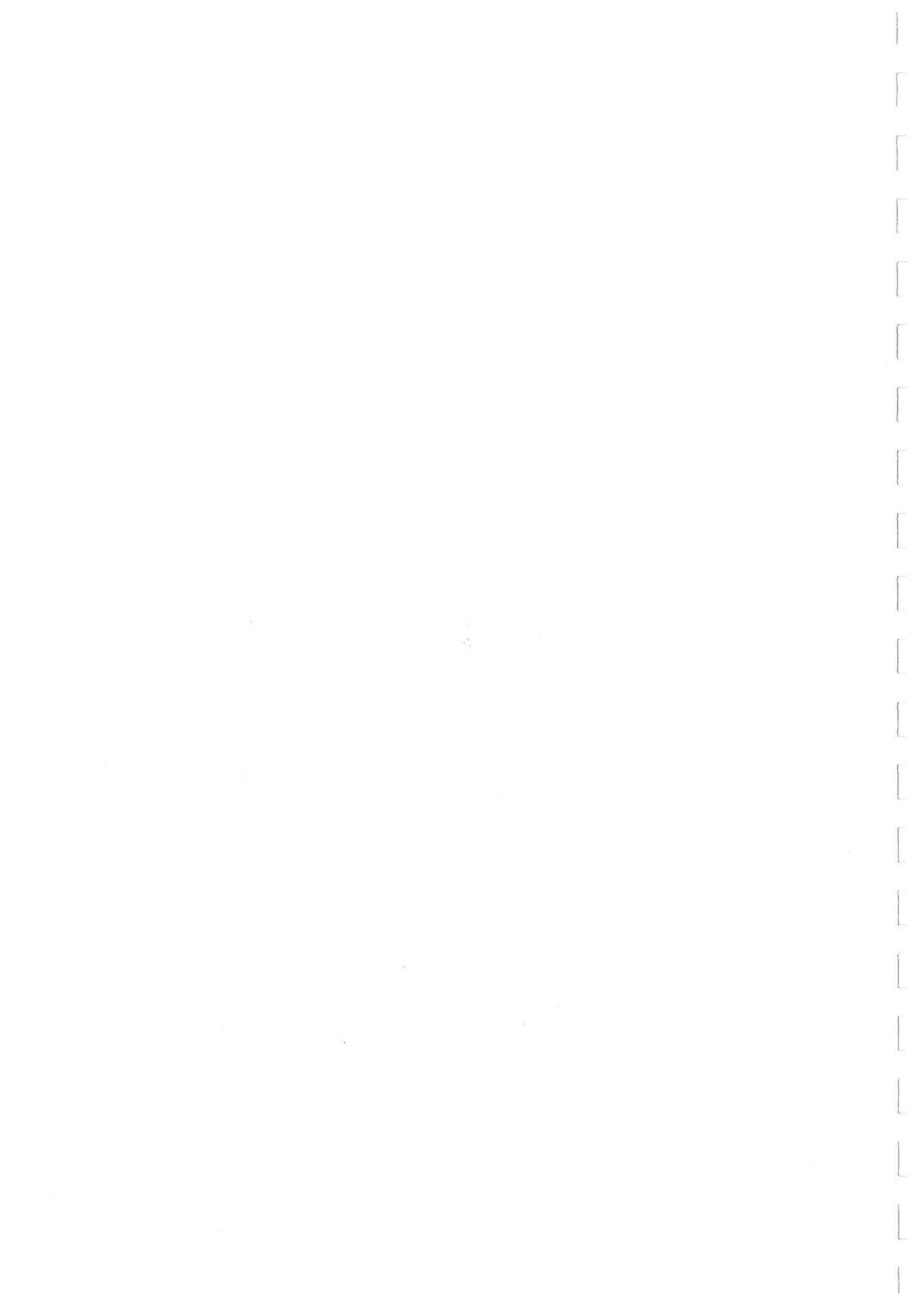

Livestock production is the backbone of Isiolo county economy. It provides food security, income, social backing and wealth to the livestock keepers. The production is mainly under extensive system (pastoralism), and on natural pastures and fodder. # Zimbabwe orders 21 Ugandans deported

Court rules that scores trying to enter South Africa illegally be forced back home

A Zimbabwean court has ordered the deportation of 21 Ugandans for entering the southern African country illegally.

The immigrants, who included a five-year-old who was in the company of her mother, were arrested on February 8 while travelling to Bulawayo, Zimbabwe's second largest city.

**A similar offence**  
Prosecutors said the immigrants evaded immigration officials when they entered Zimbabwe through the Victoria Falls border post from Zambia. Bulawayo magistrate Tinash Chishaya sentenced 20 of them to serve three months in prison before suspending the sentence for five years on condition that they do not commit a similar offence within the same period.

In brief

ARRIVALS AND DEPARTURES

Zimbabwe is a country with a long history of cross-border mobility that has also witnessed a significant brain drain, thanks to Robert Mugabe's tyranny. The country has also witnessed increased internal and border migration resulting in an upsurge in irregular migration and human smuggling, requiring a comprehensive migration policy to deal with.

The magistrate also ordered the deportation of the Ugandan nationals. Zimbabwe regularly depots illegal immigrants from countries such as Ethiopia, Eritrea, Burundi, the Democratic Republic of Congo and Malawi, who take advantage of the country's porous borders to sneak into South Africa.

The country is also home to 10,000 refugees, mainly from Mozambique and the Great

Lakes region where they escape conflicts, but a significant number are economic immigrants who use Zimbabwe for transit.

The immigrants either use illegal entry points along the country's vast borders, or bribe immigration officials and police officers as they travel across to neighbouring South Africa.

Zimbabweans also cross the border into South Africa in their numbers every day, escaping the harsh economic environment and political persecution.

Were defrauded

The Zimbabwe Lawyers for Human Rights (ZLHR) had pleaded with court not to hand the Ugandans custodial sentences. ZLHR's representative of the Ugandans Jabulani Mhlanga and Ngobani Sithole, said the accused had adhered to the legal requirements, but were defrauded by a person who was trying to get them to South Africa through Zimbabwe.

Mr Sithole said that the Ugandans were first offenders, and they had used up almost all the resources in their possession, having been on the road for the past 10 days.

Bouteflika kin jail term upheld

An Algerian military court on Monday confirmed a 15-year jail term for the brother of former President Abdelaziz Bouteflika and two former intelligence chiefs convicted of conspiracy against the state, a lawyer said. "Said Bouteflika, Gen (Athmane) Tartag and Gen (Mohamed Lamine) Mediene received 15 years in jail. The initial verdict was confirmed," lawyer Boudjemaa Guechir told AFP. (AFP)

AU to unveil cross-border rail

The African Union (AU) will implement two cross-border high-speed trains, the first infrastructure project of its kind, AU Commissioner for Infrastructure and Energy Abou-Zedl Amani, said. "One flagship project of Agenda 2063 is a high-speed train connecting African capitals," he said, adding that the Bujumbura-Dar es Salaam line is one of the projects. (Xinhua)

The Chairman called the meeting to order at 10.00am followed by a word of prayer. Members confirmed the agenda of the meeting as approval hearing for the nominee to be appointed to the position of the Principal Secretary, State Department for Transport, Mr. Solomon Kitungu

#### **MIN No. TPWH 024/2020: CONFIRMATION OF THE MINUTES OF THE PREVIOUS SITTING**

Confirmation of the minutes of the previous sittings were deferred to the next meeting.

#### **MIN NO. TPWH 025/2020: APPROVAL HEARING FOR THE NOMINEE TO BE APPOINTED TO THE POSITION OF THE PRINCIPAL SECRETARY, STATE DEPARTMENT FOR TRANSPORT, MR. SOLOMON KITUNGU**

The nominee introduced himself as Mr. Solomon Albert Musyoki Kivanguli (AMK) Kitungu, and submitted his original documents before the Committee. He was born in 1961 in Mwingi Central, Kitui County. He holds a Masters in Arts from Manchester University (1990) and a Bachelor of Arts degree from the University of Nairobi (1987). He holds numerous certificates from other institutions nationally and globally.

The nominee has risen from an Economist II at the National Treasury in 1988 to a Principal Economist between the year 2000 and the year 2003. He was also the CEO of the Privatization Commission from April 2009 to September 2017. Currently, he is the Investment Director, Directorate of Public Investment & Portfolio Management; a position he held since 2017.

The nominee has also served as Alternate Director for the Permanent Secretary Ministry of Finance (and now Principal Secretary National Treasury) in several boards over the years including Kenya Commercial Bank, Kenya Electricity Generating Company, the Kenya Power and Lighting Company, Kenya Petroleum Refineries Limited, the National Bank of Kenya, Kenya National Assurance Company Limited, National Shipping Line and many others.

He is a member of the Institute of Economic Affairs and a member of the Mwingi Horticultural Farmers' Co-operative Society. The nominee declared that his wealth was worth Kshs. 100.7 million and it included both assets and cash.

The nominee explained that he took part in different charity work and participated in many community projects. This include donating land worth Kshs. 500,000 for construction of a community dispensary at Kalisasi Market in Mwingi Sub-County.

By virtue of his position at the National Treasury, the nominee interacted with a lot of parastatals, including those in infrastructure sector. He has also done a lot of policy work and other works include making many presentations and preparing papers such as Cabinet Memoranda.

### ***Questions Raised***

Members were concerned that despite the nominee being the CEO of the Privatization Commission, no privatization was ever achieved during his reign. Further, Members were concerned that a number of parastatals performed dismally despite the nominee associating himself with their restructuring plans. In response, the nominee explained that everything had a well-defined process and that he played his part accordingly, and that he did not have mandate or power over continuing and connecting processes.

Members were also concerned about the nominee's ability to make any meaningful change if he were to be confirmed to the position, considering that he was 58 years of age and may retire in less than two years' time. The nominee assured the Committee that, given an opportunity to serve, he will definitely make significant contribution in his new capacity.

On his stand about corruption, the nominee reported that he has never had a single audit query for the nine years he was working at the Privatization Commission and further declared that he was personally not corrupt.

On the nominee's vision on the aviation sector in general and on the Kenya Airways in particular, the nominee acknowledged that as it is at the moment, Kenya Airways cannot survive. He commended the Committee for their inquiry in 2019 and their recommendations to improve and restructure the aviation sector. He explained that in his current assignment at the National Treasury, he was involved in the implementation of the Committee's report and that they had created an Aviation Holding Company with its own fund. All the funds from the company, its subsidiaries and other sources would be directed to the fund. He was hopeful that with the support from the National Assembly, the restructuring of the aviation industry would succeed as intended by Parliament.


In conclusion, the nominee allayed fears that he was more of a boardroom officer, explaining that whereas the nature of his work rightly appeared to be so, he was also the brains behind so many great policies and good works which in many cases, no direct reference was made to an individual's contribution. He explained that he was well experienced and exposed, and in a sure position to deliver and turn around the transport sector.

On behalf of the Committee, the Chairperson thanked the nominee for his presentation, and wished him well.

The Committee resolved to retreat on Monday, 24<sup>th</sup> February 2020 to prepare its report.

**MIN NO. TPWH 029/2020: CONSIDERATION OF THE REPORT ON THE APPROVAL HEARING FOR THE NOMINEE TO BE APPOINTED TO THE POSITION OF THE PRINCIPAL SECRETARY, STATE DEPARTMENT FOR TRANSPORT, MR. SOLOMON KITUNGU**

The Committee went through the draft report on the vetting of the nominee to be appointed to the position of the principal secretary, State Department for Transport, Mr. Solomon Kitungu. The Committee noted that by Tuesday, 18<sup>th</sup> February, 2020, no affidavit or memoranda was received contesting the suitability of the nominee.

The Committee further noted that the National Assembly was in receipt of the report from the Public Service Commission conveying the name of the nominee to the President in line with Article 155(3) (a) of the Constitution.

The Committee noted that it was in receipt of all the clearance letters from the HELB, DCI, KRA, RPP and the EACC.

The Committee went through the guiding principles of suitability in line with the constitution and satisfied itself that the nominee's nomination was in order.

The Committee further went through the academic and professional qualifications of the nominee.

**ADOPTION OF THE REPORT ON THE APPROVAL HEARING FOR THE NOMINEE TO BE APPOINTED TO THE POSITION OF THE PRINCIPAL SECRETARY, STATE DEPARTMENT FOR TRANSPORT, MR. SOLOMON KITUNGU**

The Committee adopted the Report on the Approval Hearing for the nominee to be appointed to the position of the Principal Secretary, State Department for Transport, Mr. Solomon Kitungu; the Proposer being Hon. Johnson Many Naicca and the Secunder Hon. Shadrack John Mose.

**MIN NO. TPWH 031/2020:**

**CONSIDERATION OF THE DRAFT REPORT ON THE BUDGET POLICY STATEMENT FOR THE FINANCIAL YEAR 2020/2021**

The Committee went through the Draft Report on the Budget Policy Statement for the Financial Year 2020/2021 and adopted the following recommendations according to Departments:

***Under Infrastructure***

Annuity Programme seem to be expensive in the long run. The Committee recommended that the National Treasury amends the annuity legal instruments through the finance bill 2020/21 to allow the annuity funds to finance Development of roads and used as counterpart funding in the budget estimates in order to construct roads outside the PPP programme.

The Committee further recommended that the National Treasury should take into account the expected proceeds from the roads bond in formulating the Budget Estimates for the FY 2020/21.

Ngong-Kiserian-Isinya Road is better, but Imaroro to Kajiado the quality of the road is extremely wanting. The Hon. Member for Kajiado, Hn. Tobiko, proposes that the Committee makes an inspection tour of the road to see for itself. The Committee to plan on the activity soon.

#### ***Under Transport***

The committee recommends amendments to Railway Development Levy Fund to finance the operations of the Standard Gauge Railway (SGR) since land compensation is completed and phase 2 B (Naivasha – Kisumu) is yet to take off

#### ***Under Housing***

the Committee recommends that the National Treasury provides the Kshs. 45 billion shortfall in the Affordable Housing programme in phases starting with the fourth quarter 2019/20 and the balance in the FY 2020/21.

The Committee further noted that the Cabinet Secretary for Transport and the Cabinet Secretary for the National Treasury have been invited for a meeting on 27<sup>th</sup> February 2020 to discuss funding for the Affordable Housing.

#### ***Under Public Works***

- i. The committee recommends that resources to enablers of the big four projects be made available only when sites are ready from the side of the driver to avoid locking resources from other priority areas.
- ii. The committee recommends that the National Treasury avails the Kshs. 5.7 billion to the State Department in the FY 2020/21 to enable the State Department complete the stalled projects hand over to the clients.

#### ***Under Shipping and Maritime Affairs***

Operationalization of the KNSL is still at formative stage. The Ministry should fast track operationalization of the Kenya National Shipping Line. As it stood, even the funding for the new Bandari Maritime Academy was still a challenge. KPA was funding its budget, but because of legal constraints, the Authority may not be able to continue funding the Academy.



**MIN No. TPWH 032/2020:**

**PENDING BUSINESS**

The Committee noted that the following was pending business before the Committee:

1. Two Pending Bills, one on County Walkways (Senate Bill) where a report was already tabled and the Committee recommended for rejection and one on Business Laws (Amendment) Bill 2019 which was to be considered in the afternoon sitting on 24<sup>th</sup> February 2020 and on Tuesday, 25<sup>th</sup> February 2020.
2. One Petition by Hon David Ochieng. The petitioner did not appear two times. Committee to consider the draft report on Tuesday, 3<sup>rd</sup> March 2020.
3. A Petition to the Committee and copied to Hon. Abdulswamad Shariff Nassir. Committee to write to the petitioner to inform the petitioner to do the petition proper, considering that it was not conveyed through the floor of the House.
4. Bilateral Air S. Agreements between Kenya and South Africa and between Kenya and Botswana. Secretariat to schedule them any day possible.
5. Three Questions, being Question 001/2020, 004/2020 and 012/2020.

**MIN No. TPWH 033/2020:**

**ANY OTHER BUSINESS**

1. Members want to know the extent of the Committee's mandate on NTSA. The meeting noted that on administrative issues, NTSA was under Internal Security in line with the Executive Order of 2019. But in terms of legislation, the Committee will be responsible in line with the current Act.
2. Members proposed that the local visits and inspection tours to continue throughout the country as a way of enhancing oversight over the departments under the Committee's purview.
3. Visit to Isiolo International Airport proposed, especially in light of reports in the media on 24<sup>th</sup> February 2020 that there was a big crack on the airport's runway.
4. A follow up on Suneka Airstrip be made to ensure that the issues touching on the airstrip are resolved at the earliest time possible.
5. Safety issues on the roads should be taken seriously and the relevant agencies should be taken to account. Roads marking, signage, pot holes are some of the issues of concern raised. These agencies concerned include the NTSA, KeNHA, KERRA and KURA.

6. On public works, Members felt that there were a lot of inefficiencies in the department. Pending Bills was, for instance, an issue that the Department has struggled to address. Public Works to be invited soon to report to the Committee on all issues affecting the sector.
7. List of Members' travel record to be prepared and updated to guide the Committee when determining who to travel.
8. Observed during the visit to Mombasa in 2019, the KMA building construction had issues including on variation. The matter to be discussed later.
9. Tolling road has no legal framework and the Committee needs to consider the same.
10. KCAA report on the way forward on air accidents to be sought.
11. National Land Commission should be invited to explain on the compensation money from the Ministry of Transport, intended to compensate people whose properties re affected by planned and ongoing projects.
12. RDLF issue to be addressed.
13. It was proposed that an inquiry into other sources of funding roads be conducted.
