# **BACKGROUND**

- 1. Parliament enacted the Vetting of Judges and Magistrates Act, 2011 which commenced on 22<sup>nd</sup> March, 2011. The Act was later amended and commenced on 19<sup>th</sup> May, 2011.
- 2. The Judges and Magistrates Vetting Board is established in Section 6 of the Vetting of Judges and Magistrates Act, 2011.
- 3. Section 7 of the Vetting of Judges and Magistrates Act, 2011, Act states that:-

The Board shall consist of nine members comprising a chairperson, a deputy chairperson and seven other members of whom-

- (a) Six shall be citizens of Kenya appointed in accordance with Section 9(1) to (12) and of whom, three shall be lawyers; and
- (b) Three shall be non-citizens of Kenya appointed in accordance with Section 9(13).
- 4. The President in consultation with the Prime Minister pursuant to section 9(2) of the Vetting of Judges and Magistrates Act, 2011 as amended by the Vetting of Judges and Magistrates (Amendment) Act 2011 declared the vacancies in the office of Chairman and Members of the Judges and Magistrates Vetting Board and invited qualified applicants through Gazette Notice No. 5367.
- 5. On 17<sup>th</sup> November ,2011, H.E the President, through a letter by the Permanent Secretary, Secretary to the Cabinet and Head of Public Service forwarded the names of the following persons to be considered for appointment to the respective positions pursuant to section 9(13) of the Vetting of Judges and Magistrates Act, 2011 as amended by the Vetting of Judges and Magistrates (Amendment) Act 2011:
  - i). Justice F.M.Chomba from Zambia-Member
  - ii). Justice Albei Sachs from South Africa
- 6. On 22<sup>nd</sup> November, 2011, the Honorable Speaker in a Communication to the House referred the names of the two non-citizens of Kenya nominees to the Departmental Committee on Justice and Legal Affairs for vetting and directed the Committee to submit its recommendations on the nominees to the House.

# CONSIDERATION OF THE NOMINEES BY THE COMMITTEE

- 7. At a meeting held on 14<sup>th</sup> December, 2011, the Committee examined the Curriculum Vitae's of the two Candidates and were satisfied that the two non-citizens possessed the requisite experience, record and competency(copies of the C.V's attached)
- 8. Section 8 of the Judges and Magistrates Act, 2011 sets out the qualifications for appointment to the Judges and Magistrates Vetting Board. The qualifications are:-
  - 8. (I) A person shall be qualified for appointment as a member if such person-
    - (a) holds a degree from a university recognized in Kenya;
    - (b) has at least fifteen years' distinguished post- qualification experience in their field of study: and
    - (c) satisfies the requirements of Chapter Six of the Constitution.
    - (2) A person shall not be qualified for appointment as the chairperson or deputy chairperson unless such person has at least twenty years' or an aggregate of twenty years' experience as a judge of a superior court, a distinguished legal academic, a judicial officer or other relevant legal practice in the public or the private sector in Kenya.

# RECOMMENDATIONS OF THE COMMITTEE

The Committee did not interview the two non-citizen of Kenya nominees nominated under Section 7 (b) of the Vetting of Judges and Magistrates Act, 2011. However, the Committee considered their curriculum vitae and recommends:-

- i). **THAT**, this House approves the appointment of Justice F.M.Chomba (Zambia)
- ii). THAT, this House approves the appointment of Justice Albie Sachs (South Africa)

## CURRICULUM VITAE OF JUSTICE F.M. CHOMBA.

DATE OF BIRTH: February 2, 1936

NATIONALITY : Zambian by birth

1960 todate. Eight children born of the marriage.

#### **EDUCATION AND PROFESSIONAL STATUS:**

1951 - 1954 Kafue Training Institute - Std 6 Upper

1954 – 1958 Munali Secondary School – Cambridge School Certificate, First Division.

1959 First Year 6<sup>th</sup> Form, but had to leave owing to inability to pay School fees.

1962 – 1965 Law studies leading to qualification as Barrister-at-Law, called to the Bar as a Member of the Honourable Society of the Inner Temple, London in December, 1965.

December 1967 — called to the Zambian Bar as an Advocate and Solicitor of the High Court and Supreme Court of Zambia.

1979 – Admitted as State Counsel of the Supreme Court of Zambia.

#### **EMPLOYMENT RECORD:**

1959 – 1965: Clerical Officer in the Northern Rhodesia Civil Service.

1965 – 1970: Magistrate Class II rising through the ranks to positions of Resident Magistrate, Senior Resident Magistrate, exercising administrative and judicial responsibilities as head of station at Chingola, Kitwe and Livingstone respectively.

Feb. 1970: Dec. 1973: Puisne Judge of the High Court at Ndola and later as Judge-in-Charge from 1971 to Dec. 1973.

1974: March 1977: Established the Commission For Investigations upon being appointed as Investigator-General (Ombudsman) in Jan. 1974 and led that institution until mid-March 1977.

March. 1977: June 1978: Supreme Court Judge, Zambia.

June 1978: Nominated to Parliament and appointed Minister of Legal Affairs and Attorney-General; incidental to that status, became Chief Legal Advisor to the Government.

October 1978: Elected to Parliament representing Mpika East Constituency (now Luangwa Constituency); reappointed Minister of Legal Affairs and Attorney-General.

December 1980 - April 1986: Minister of Home Affairs, a portfolio carrying responsibilities for the Zambia Police, Immigration, Citizenship, Prisons National Registration, etc.

Oct. 1983: Re-elected M.P. for Mpika East and reappointed Minister of Home Affairs.

May 1986 - 1987: Supreme Court Judge. During that period acted briefly as Chief Justice of Zambia for administrative convenience only.

1987 – Oct. 1991: Minister of Legal Affairs and Attorney-General.

1991: Appointed a Judge of the Preferential Trade Area of the Eastern and Southern African states (PTA)

October 1999 – October, 2005: Executive Director of the Zambia Institute of Advanced Legal Education on contract. This is the institution where university law graduates receive professional training leading to call as Barristers-at-Law.

#### **EXPATRIATE APPOINTMENTS:**

1992 – November 1993: Visiting Judge of the Supreme Court of Namibia.

November, 1993 - October 1994:

Justice of Appeal, Gambia Court of Appeal.

November 1994 – June 1999: President of the Gambia Court of Appeal.

Sept. 2000 – July 2010: Visiting Judge of Supreme Court of Namibia. Finally retired as a Judge in July 2010.

#### OTHER PUBLIC ENGAGEMENTS:

In December 1999 I was invited by the Zimbabwe Judicial College to give, and did give, a lecture to Zimbabwean Magistrates on the topic "The Role of a Magistrate in Changing Zimbabwe."

December 2002 – December 2010: Chairman, Judicial Complaints Authority – we set up the Authority from scratch and left it as a well established watchdog over judicial officers in the judiciary.

In or about 2002, upon invitation by the Government of Swaziland, I went to Mbabane and inquired into the dispute between the Judiciary of that country and the Government. I thereafter submitted my report to the Government.

May 2003 – appointed by Media Institute of Southern Africa (MISA) HQ in Windhoek as a one-man Commissioner to inquire and report on the leadership wrangles in the Zambia Independent Media Association, the Zambian Chapter of MISA. The report was submitted in due course

Aug. 2005 – Aug. 2010: Judge of the Tribunal for the SADC region headquartered in Windhoek, Namibia.

#### PRIVATE LAW PRACTICE

1992 – 1993: Practised law briefly in a firm styled Mutinondo Chambers at Chester House, Cairo Road, Lusaka. However, I closed down the firm upon being appointed to the Judiciary of The Gambia.

2004 – todate: Certificated Arbitrator and a Member of the Zambia Arbitrators Association.
