### **PREFACE**

### PROPOSED AMENDMENTS TO THE WITNESS PROTECTION BILL, 2006 (BILL NO.15)

#### Preamble: Proposed Amendment

That the words "*commissions of inquiry"* be inserted after the word 'cases'.

Rationale: To make it consistent with the Memorandum.

#### Clause 3: Proposed Amendment

That Clause 3 (1) (a) be amended by inserting the following new sub-section-

## 3 (1) (a) (iii) Any legally constituted proceedings including quasijudicial bodies".

**Rationale:** The protection of witnesses by the Attorney – General should not be discriminatory. The classification of the witnesses is narrow, restrictive and defeats the very purpose of the Bill.

#### Clause 5: Proposed Amendment

That Clause 5 (1) be amended by inserting the following words "or a legal representative of **the witness**" immediately after the words 'law enforcement agency'.

**Rationale:** To make it possible for a witness to apply to be included in the programme.

## Clause 6: Proposed Amendment

That Section 6(1) (g) be deleted

**Rationale:** The Attorney General has absolute power to determine the participants of the programme irrespective of their past conduct.

# Clause 7: Proposed Amendment

That Section 7 (2) (c) be amended by inserting the words "**and/or all other identification documents**" immediately after the word passports.

**Rationale:** Identification should not be restricted to passports only.

## **Clause 9: Proposed Amendment**

Insert the words "*Notwithstanding the provisions of section (5) (1)*" at the beginning of the sentence.

**Rationale:** To make it consistent with clause 5.

## **Clause 12: Proposed Amendment**

Insert the words "*within twenty one days of such cessation*" after the word shall.

**Rationale:** This information should be disseminated within reasonable time for effective decision making.

## **Clause 35: Proposed Amendment**

That the word "*Attorney General"* be inserted in place of the word "*Minister".* 

**Rationale:** The Attorney General is in charge of the Programme not the Minister.
