The Departmental Committee on Justice and Legal Affairs derives its mandate from provisions of standing order 216 (5) which outline functions of the Committee as being:

a)To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;

b) To study the Programme and policy objectives of ministries and departments and the effectiveness of their implementation;

c) To study and review all the legislation referred to it;

d) To study, assess and analyze the relative success of the ministries and departments measured by the results obtained as compared with their stated objectives;

e) To investigate and inquire into all matters relating to the assigned ministries and departments as may be deemed necessary, and as may be referred to it by the House or a Cabinet Secretary;

f) To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No.204 (Committee on appointments); and

g) To make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.

In accordance with Second Schedule of the Standing Orders, the Committee is mandated to consider:-

- ·a) Constitutional Affairs
- b) The administration of Law and Justice
- c) The Judiciary
- d) Public prosecutions
- e) Elections
- f) Ethics, Integrity and anti-corruption and
- g) Human rights

### 1.3 Committee Meetings

The Committee held a number of sittings during which the Marriage Bill, 2013 was considered in accordance with the standing orders of the National Assembly. The Committee also received Memoranda from various stakeholders.

The Marriage Bill, 2013 was read a first time on 16th July 2013 and stood committed to the Committee. The National Assembly adjourned and went on recess soon thereafter and thus the Committee did not proceed and report as expected. This Report contains deliberations of the Committee on the Bill and has proposed some amendments.

Finally it is now my pleasant duty and privilege, on behalf of the Departmental Committee on Justice and Legal Affairs, to introduce this report to the House, so that it may enrich debate on the Bill.

# PROPOSED AMENDMENTS TO THE MARRIAGE BILL, 2013

# PART 1 - PRELIMINARY

### SECTION 2

**THAT** the Bill be amended in subsection (2) by deleting the word "Director" and inserting the word "Registrar".

# PART II- GENERAL PROVISIONS

### SECTION 8

**THAT** the Bill be amended in subsections (4) (5) and (6) by deleting the words "Director" and inserting the words "Registrar".

# SECTION 11

THAT the Bill be amended by deleting the word 'disorder or mental disability' appearing in subsection (2) (c) and replace with 'mental condition'

#### SECTION 12

THAT the Bill be amended by deleting subsection (d) and (f)

### SECTION 14

THAT the Bill be amended by deleting the word the words 'one year' and inserting the words 'six months' appearing in subsection (1)

# SECTION 17

THAT the Bill is amended by inserting a new section 17A to read as follows: "Under Part III, a marriage officer means a licensed Church Minister appointed by the Director under Section 51".

"18. A marriage under this Part may be celebrated in a public place of worship or any other place as may be permitted by the Church".

(2) A notice of objection shall include the name of the person giving the notice of the objection and that person's relationship with either of the intended parties and shall state the reasons for objection to the intended marriage.

(3) A person who has given notice of objection may withdraw the objection in writing at any time.

### SECTION 22

THAT the Bill be amended by inserting a new section 22 to read as follows:

22(1) The Church Minister shall hear an objection forthwith under Clause 21 and if he or she considers the objection requires further hearing, he shall adjourn the marriage ceremony until such time as the objections will be determined in accordance with the church regulations.

(2) The Church Minister shall determine an objection within a reasonable period but in any case not more than seven days after the hearing under subsection (1).

(3) ) The Church Minister who takes the parties through the determination of the objection shall prepare and submit a report of the process of determination of the objection in the prescribed form to the parties and the Director within seven days.

(4) Any party dissatisfied with the decision of the Church Minister may appeal to the court within fourteen days of the decision by the Church Minister".
