- f) To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under standing order 204 (Committee on appointments); and
- g) To make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.

In accordance with Second Schedule of the Standing Orders, the Committee is mandated to consider:-

- a) Constitutional Affairs
- b) The administration of law and justice
- c) The Judiciary
- d) Public prosecutions

- e) Elections
- f) Ethics ,Integrity and anti-corruption and
- g) Human rights.

- b) The Judiciary
- c) Ethics and Anti-Corruption Commission
- d) Independent Electoral and Boundaries Commission
- e) Commission on Administrative Justice
- f) Directorate of Public Prosecutions
- g) Kenya National Commission on Human Rights (KNCHR)
- h) Office of the Registrar of Political Parties.

## **2.0 BACKGROUND**

1. The National Cohesion and Integration Act No.12 of 2008 is an Act of Parliament meant to encourage national cohesion and integration by outlawing discrimination on ethnic grounds and to provide for the establishment, powers and functions of the National Cohesion and Integration Commission and for connected purposes.
2. The National Cohesion and Integration Commission is established pursuant to the provisions of section 15 (1) of the Act which states as follows:-

***(1) There is established a Commission to be known as the National Cohesion and Integration Commission.***
3. The membership of the Commission is stipulated in the provisions of section 17 of the Act.

Section 17 of the Act states as follows:-

***(1) The Commission shall consist of—***

- a) a Chairperson appointed by the President from amongst the commissioners appointed under paragraph (b);***
- b) eight commissioners nominated by the National Assembly in accordance with the First Schedule and appointed by the President;***
- c) the Chairperson of the Kenya National Commission on Human Rights;***
- d) the Chairperson of the National Commission on Gender and Development; and***
- e) the Chairperson of the Public Complaints Standing Committee (Ombudsman).***

*(3) The commissioners shall, at their first meeting, elect a vice-chairperson from amongst the commissioners appointed under subsection (2)(b).*

*(4) In appointing members to the Commission, the principle of gender equity shall apply.*

### **3.0 RECRUITMENT PROCESS BY THE COMMITTEE**

- i. Pursuant to the provisions of Section 17 and paragraph 1 of the First schedule of the National Cohesion and Integration Act, the National Assembly advertised in the daily newspapers on the 20th June 2014 inviting qualified persons for nomination as Commissioners.
- ii. At the expiry of twenty days of the advertisement (10<sup>th</sup> July, 2014) a total of two hundred and fifty (250) applications had been received by the Office of the Clerk of the National Assembly.
- iii. The Office of the Clerk of the National Assembly forwarded the names of the two hundred and fifty applicants (250) applicants to the Departmental Committee on Justice and Legal Affairs for interviews and Consideration.
- iv. The Departmental Committee on Justice and Affairs through the Office of the Clerk of the National Assembly wrote to the Minister of Interior and National Security inviting him to participate in the process.
- v. The Ministry of Interior and Co-ordination of National Government sent Dr.F.O Owino, Director of National Cohesion to represent the Ministry and participate in the exercise throughout the recruitment process.
- vi. The Departmental Committee on Justice and Legal Affairs considered the applications for the positions of commissioners to the National Cohesion and integration Commission pursuant to the provisions of Chapter six of the Constitution on leadership and Integrity and paragraph 3 of the First Schedule to the National Cohesion and Integration Act.

**Article 73 of the Constitution on leadership and Integrity provides as follows:**

- 1) Authority assigned to a State officer:
  - a) Is a Public trust exercised in a manner that:-

- i. is consistent with the purposes and objects of this Constitution;
  - ii. demonstrates respect for the people;
  - iii. brings honour to the nation and dignity to the office;
  - iv. promotes public confidence in the integrity of the office; and
- b) Vests in the State officer the responsibility to serve the people rather than the power to rule them.
- 2) The guiding principles of leadership and integrity include:-
- a. Selection on the basis of personal integrity, competence and suitability in free in free and fair elections;
  - b. Objectivity and impartiality in decision making and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices.
  - c. Selfless services based solely on the public interest, demonstrated by-
    - i. honesty in the execution of public duties
    - ii. the declaration of any personal interest that may conflict with public duties.
    - iii. accountability to the public for decisions and actions; and
    - iv. discipline and commitment of service to the people.

**Paragraph 3 of the First Schedule to the Act provides as follows:**

*The relevant Parliamentary Committee in consultation with the Minister shall, within seven days of the expiry of the period prescribed under paragraph 2—*

- a) consider all the applications received under paragraph 2; and*
- b) recommend to the National Assembly suitably qualified persons for nomination as commissioners.*

The Committee scrutinised the applications and shortlisted those who met the minimum qualifications as per the provisions of section 18 (1) & (2) of the Act which states as follows:-

***A person shall be qualified for appointment as a commissioner if such person—***  
***(a) is a citizen of Kenya;***

- (b) is a person of high moral character and proven integrity; and*
- (c) has knowledge and experience in matters relating to race, ethnic and human relations, public affairs, and human rights.*

*(1) No person shall be qualified for appointment as a commissioner if such person—*

- (a) is a member of the National Assembly;*
- (b) is a member of a local authority;*
- (c) is a member of the executive body of, or is actively involved in the affairs of, a political party;*
- (d) has promoted sectoral, ethnic, racial or religious animosity or openly advocated for partisan ethnic positions or interests.*

### **3.1 CONSIDERATION OF APPLICATIONS BY THE COMMITTEE**

- i. On July 14<sup>th</sup>, 2014 the Committee held a sitting to consider all the applications received for positions of Commissioners in the National Cohesion and Integration Committee.
- ii. A total of two hundred sixty (250) applications were received.
- iii. The Committee scrutinized all the applications including Curriculum Vitae's of the applicants taking into consideration academic qualifications, gender, regional balance and relevant experience.

**The Committee developed a criteria to be applied when conducting the interviews where it was recommended that each candidate would be awarded a total of fifty points (50) depending on academic qualifications and knowledge of matters relevant to the Act which matters were categorized under the following topics:-**

- a) Academic and Professional Qualifications.
- b) Knowledge of National Cohesion & Integration Act
- c) Knowledge of working with marginalized and disadvantaged, diverse groups
- d) Knowledge in Public Affairs and Human Rights
- e) Personal presentation

f) Suitability of the applicant

On Wednesday 16<sup>th</sup> July, 2014, the Committee shortlisted thirty two (32) applicants to be invited for interviews. The Committee resolved to conduct the applicants through publication in the print media and telephone calls.

17. In conducting the interviews, the Committee was guided by the provisions of Section 18(1) & (2) of the National Cohesion and Integration Act herein earlier cited in this report.
