KNOW ALL MEN BY THESE PRESENTS that in consideration of the sum of Shillings One thousand two hundred by way of Stand Premium paid on or before the execution hereof the GOVERNOR AND COMMANDER-IN-CHIEF OF THE COLONY AND PROTECTORATE OF KENYA under and by virtue of the powers vested in him by the Native Lands Trust Ordinance (Chapter 100) hereby GRAMTS unto HIRJI KALIDAS MAGANLAL HIRJI and JAYANTILAL HIRJI of Maraboi Trading Centre in the said Colony (hereirafter called "the Grantees") ALL that piece of land situate in Maraboi Trading Centre in the Kericho District of the said Colony containing by measurement nought decimal one one nine four of an acre or thereabouts that is to say Land Reference Number 8934/10 which said piece of land with the dimensions abuttals and boundaries thereof is delineated on the plan annexed hereto and more particularly on Land Survey Plan Number 66672 deposited in the Survey Records Office at Nairobi TO HOLD for the term of thirty-three years from the first day of January One thousand nine hundred and fifty-seven SUBJECT to (a) the payment in advance on the first day of January in each year of the annual rent of Shillings Two hundred and forty (b) the provisions of the said Native Lands Trust Ordinance (Chapter 100) (c) the Town Planning Ordinance (Chapter 154) and (d) the following Special Conditions (namely):-

SPECIAL CONDITIONS

1. The Grantees shall erect complete for occupation within twenty-four months of the commencement of the term buildings of approved design on proper foundations constructed of stone burnt-brick or concrete with roofing of tiles or other permanent materials approved by the Provincial Commissioner and shall maintain the same (including the external paintwork) in good and substantial tenantable repair and condition.




