## **Committee Mandate**

---

The Departmental Committee on Lands was constituted on 16<sup>th</sup> May 2013, pursuant to the provisions of Standing Order no. 216 (1) and (5) of the National Assembly. The functions of the Committee as outlined in the **Standing Order. 216 (5)** are as to:-

1. *Investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations, and estimates of the assigned ministries and departments;*
2. *Study the Programme and policy objectives of Ministries and Departments and effectiveness of the implementation;*
3. *Study and review all legislation referred to it;*
4. *Study, assess and analyze the relative success of the Ministries and Departments as measured by the results obtained as compared with their stated objectives;*
5. *Investigate and inquire into all matters relating to the assigned Ministries and Departments as they may deem necessary, and as they may be referred to them by the House;*
6. *Vet and report on all appointments where the Constitution or any Law requires the National Assembly to approve, except those under Standing Order 204(Committee on Appointments); and*
7. **Make reports and recommendations to the House as often as possible, including recommendations on proposed legislation.**

The Committee oversees the operations of the Ministry of Lands, Housing and Urban Development on the following matters: Land Policy and Physical Planning, Land Transactions, Survey and Mapping, Land Adjudication, Settlement, Land registration, Land Valuation, Administration of community and Public Land, and Land Information and Management System.

# 1. Introduction

---

1. On 23rd October 2013, the Hon. Joseph Ngugi Nyumu, MP presented a public petition by the Members of Ex-Muthanga Farm Farmers Company Limited informing the House that the Ex- Muthanga Farm Farmers purchased the Muthanga farm (Makuyu/Kimbiti/Block1/1-51, 61 and 62) formerly identifiable as L.R. No. 9447/2 from the Department of Settlement in the Ministry of Lands and that the said properties are situated in Muthike Township, along Thika-Makutano-Nyeri road approximately 40 Kilometers to the North-East of Thika town within Kambiti trading Centre, in Makuyu Sub-District, Muranga County.
2. The petitioners prayed that the Departmental Committee on Lands investigates the matter and intervenes with a view to assisting the farmers access the land or if the squatters are to remain, ways of compensation for the owners be sought.
3. The Committee held 4 Sittings to deliberate on the matter and visited the farm on 3<sup>rd</sup> February, 2014 so as to interact with the petitioners and the squatters and also to obtain facts on the ground. The Committee also had an opportunity to discuss salient issues touching on the said farm with the Member in one of the Sittings.

# 2. Findings

---

4. The Hon Joseph Nyumu appeared before the Committee to highlight salient issues pertaining to the Petition he had made to Parliament on behalf of Ex-Muthanga Farm Company Limited who were evicted from their farm. Hon Nyumu had sought the following from the Committee: That the Committee would investigate the matter; that the National Assembly would intervene and assist the farmers get access to their land and that the National Assembly explores ways of seeking compensation for the owners of the land.
5. Hon Nyumu informed the Committee that the farmers bought Muthanga Farm (Makuyu Kambiti/Block 1/1-51, 61 and 62) formerly identified as LR No. 9447/2 from the Department of Settlement in the Ministry of Lands. He further informed the Committee that persons from a neighboring community moved into the land and settled in it leading to the formation by the Government of a Presidential Probe Committee on Large Scale Farms in Makuyu- Murang'a. The Committee looked into the matter of Muthanga Farm among others in the region. Investigations carried out by the Probe Committee established that the farm belonged to Muthanga Farmers. Thereafter in 1988, the Members were issued with title deeds. In 2002, the Court gave orders for the residents/squatters to be evicted.
6. The Committee was also informed that in the year 2012, the Government made an attempt to purchase the land from the farmers but the latter declined as the amount offered of Kshs.100, 000 per acre was negligible. He appealed to the Committee to follow up the matter with the Cabinet Secretary for Lands, Housing and Urban

Development and have the matter resolved. Hon Nyumu further tabled a list of allottees for Muthanga Farm as established by the Probe Committee.

7. Gatundu Front Farmers Company was incorporated in 1964 comprising of 31 shareholders, however only 3 members were registered with the Registrar of Companies who were: Messrs. Livingstone Wainaina Wambaya, James Njau Gakuo and Joseph Mwaniki Kihuria: The Company was struck off the Register of Companies for failing to make returns to the Registrar General's Office. However by the time the Company was de-registered the following were directors: Messrs Livingstone Nditire, Samson Chege, Joseph Kaguo (Company Secretary), Michael Muoni, and Samwel Wandu.
8. Muthanga Farm Company Limited was incorporated on 3rd April 1976 with the objectives of representing the interests of the members of the defunct company including its liabilities hence all members of Gatundu Front Farmers Company became members of Muthanga Farm Company Limited.
9. The Gazette Notice No. 3212 registration No.6006 dated 19th October 1972 declared that land L.R. NO. 9447/2 which belonged to Gatundu Front Farmers Company Ltd had reverted to the Government since the said Company had been struck off the register of Companies.
10. The directors and shareholders of the defunct company formed a new company called Muthanga Farm Company Limited and applied for allocation of land L.R. No. 9447/2 which had earlier reverted to the government. The government considered the application and allocated the lands to the Company vide Letter of allotment Ref. 71662/100 dated 26<sup>th</sup> April 1983. It is noted that Gatundu Front Farmers Company had a mortgage loan of Kshs. 72,000.00 from the Settlement Fund Trustees who were in possession of the title deed.

### **Presidential Probe Committee**

---

#### **The Committee was informed that:-**

11. Following complaints in 1987 the Government of Kenya formed a Presidential Probe Committee to establish the rightful owners of the said land, which the Committee on identified as Muthanga Farmers. Consequently the said land was sub-divided into smaller parcels for farmers and registered as free-hold interests under the Registered Land Act (Cap 300) (Repealed) and the farmers issued with title deeds through the Murang'a Land Registry in 1988.
12. The permission to subdivide L.R. No. 9447/2 was granted on 19th September, 1986.

### **3. Concerns by the petitioners**

---

**The Committee was informed that:-**

13. Mr. Michael Mwohi, a shareholder of Muthanga Farm informed the Committee that the squatters were hostile and that they attacked the owners of the farm any time the latter tried to access the land for cultivation and various development initiatives.
14. The Committee was also informed that in October 2011 some owners of Muthanga farm had offered to sell their land to the Ministry of Lands at a cost of Kshs. 450,000.00 per acre and in May 2012 the government agreed to purchase the said land at its valuation cost of Kshs. 100,000.00 per acre.

### **4. Squatters and their history in the farm**

---

**The Committee was informed that:-**

15. The farm was formerly called Mathengeta before it was transferred to Masyana Farm where the squatter's great grand parents lived. They lived cultivating and grazing their cattle in the farm and in the year 1936 a white settler, Machael Cantonias, arrived and occupied the farm. At the time the colony sub-divided the farm Mathengeta into two parcels, namely, Masyana and Riato farms. In 1940 the settler started planting coffee in the farm and in 1952 the he had forced their ancestors to live in a camp, in order to use them as workers in the farm. In 1964 he became sick and left the farm for treatment and did not return. Their parents therefore continued to cultivate and occupy the land.
16. In 1975 a man from Gatundu called Mr. Ndutire arrived in the farm claiming to be the owner of the farm and by 1983 he stated that he had been allocated the land by the Commissioner of Lands. By 1985 he (Ndutire) hired a surveyor to subdivide the land, but the residents resisted and reported the matter to then D.C. - Machakos, who consequently wrote a letter to the D.C. - Muranga requesting that the survey exercise be stopped and the sub-division of the farm stopped. However, in the same year (1985) the D.C. Mr. Mutemi called a meeting with both parties (Muthanga Farm Residents and Gatundu Men) in that meeting the D.C. (David Mutemi) stated that if the Gatundu men wanted the residents of Muthanga Farm to leave the farm they should pay all the properties belonging to the residents such as buildings/houses, trees, terraces etc. Thereafter, harassment of residents through arrests began arising from complaints from Muthanga farmers.
17. On 10<sup>th</sup> February 1990, the President visited Makuyu Division, in order to issue the area with title deeds. However there were five (5) farms which the President did not issue the title deed due to complaint and one of them was Muthanga farm, because there were indigenous residents who were living there. On 11th February 1990 there were claims that some people had bought the land and possessed title deed. The Squatters on 12<sup>th</sup> February 1990 visited the area Chief, District Officer as well as the District Commissioner, who were not helpful, thereby forcing them to seek audience with the Provincial Commissioner on 13th February 1990.

18. During the meeting with the Provincial Commissioner, the D.C. revealed that he had issued the title deed to Muthanga Farmers and the P.C. ordered the titles be released to his office.

### **Insecurity in the farm and Police bribery in Makuyu**

#### **The Committee was informed that:-**

19. In 1990 some of the Gatundu residents burnt Mr. Bonface Gichaka Kori's houses/homestead and it was alleged that the same people bribed the police in Makuyu Police Station after which victims of the arson attacks later charged in a Court in Thika.
20. In 1992 three squatters were arrested and later accused of having settled in the farm illegally. Two of the accused died in remand. During the same year, one of the alleged owners hired men to raid cattle, while they were grazing in the farm. When the residents came to rescue the cattle they seized one man and took him to the chief's camp. The Chief later came in a Land Rover, arresting nine (9) squatters out of 146 who went to report the matter to the Chief's camp. After they were taken to the police station, the case was filed in court at Thika. In this case one squatter died a few days after he was released from remand.

### **Arbitration process**

#### **The Committee was further informed that**

21. On 4<sup>th</sup> December 2001, the DC Maragwa convened a meeting of both parties, where Muthanga Farm owners were asked to produce an agreement that shows that they had bought the farm from the settler along with the transfer document, which they failed to produce;
22. Later during the meeting the DC asked that both sides to appoint five (5) people to meet in the DO's office in Makuyu, but the Muthanga Farmers never showed up whereas the five people representing the squatters went to the DO's office thrice and stopped since the other party was not keen in attending the meetings.

### **Eviction Notices**

#### **The Committee was further informed that**

23. On 4th March 2003, sub-chief, chief, DO, OCS and OCPD convened a general meeting to issue eviction orders from the High Court and squatters were issued with a NOTICE to vacate within 21 days from the day of the meeting. However on 24th March 2003, squatters went to court and the order was set aside to be heard on 31st March by both sides (1159 of 2000).
24. Mrs. Monica Kasyoka a squatter living in the farm explained that she came to the farm as a young girl before independence and had lived there since then and some people from

Gatundu started making claims in the 1980's that they own the land. She further asserted that the area is peaceful and the squatters are not hostile

## 5. Committees Observations

---

### The Committee observed that:-

25. Between 19th October 1972 and 20th April 1983 the said land had reverted to the government because the company which owned the land had failed to remit its returns to the Registrar General's office; the criteria used to re-allocate the land to a different company is not clear as it does not indicate if the government recovered what it was owed by the former company and if the new company paid for the land. Further it was not clear why the government arbitrarily allocated the land without considering re-settling the workers who had stayed in the farm for the period in question.
26. After Independence the land reverted to government and search documents indicated that the land was un-occupied. The scenario may have led to merchants speculation and eventual purchase of the land without due diligence being done by the Ministry of Lands, as it would have confirmed that there were people occupying the farm before any allocations were done.
27. The government was sold the land when as early as the time the colonialist left there were inhabitants in the parcel of land. Furthermore, the Committee noted tribal undertones in the evidence received from the squatters and the allottees as they constantly referred to one another as *Kambas and Gatundu men*, a factor which it views with a lot of concern, necessitating speedy action on the Muthanga Farm.
28. In October 2011 some owners of Muthanga farm had offered to sell their land to the Ministry of Lands at a cost of Kshs. 450,000.00 per acre and in May 2012 the government agreed to purchase the said land at its valuation cost of Kshs. 100,000.00 per acre.
29. There are allegations of the Provincial administration officers being bribed to frustrate squatters in the area.
30. There are no public institutions and social amenities planned for in the farm.

## **6. Committees Recommendations**

---

As to the prayers sought by the Petitioners the Committee recommends that:-

1. The Government through the Ministry of Lands, Housing and Urban Development should consider purchasing the said land L.R 9447/2 from the owners and re-allocate the same to the residents (Squatters) and that Title Deed be issued within Six (6) Months.
2. A comprehensive profiling of the squatters in the farm be conducted by the Ministry of Interior and Coordination of National Government together with the Ministry of Lands, Housing and Urban Development to ascertain the number of genuine squatters.
3. A comprehensive planning and subsequent subdivision survey be conducted by the Ministry of Lands, Housing and Urban Development in the farm to provide for social amenities / public institutions.
4. The Government through the Ministry of the Interior and Coordination of National Government together with the Ministry of Lands, Housing and Urban Development should ensure that the status quo is maintained in the farm in order to avoid any form of insecurity.
5. The Director of Criminal Investigation Department should carry out investigation on the allegations of bribery and victimization, with a view to prosecuting all persons found culpable.

- ii) THAT, the said properties are situated in Muthike Township, along Thika-Makutano- Nyeri road approximately 40 kilometres to the North-East of Thika town within Kambiti Trading Centre, in Makuyu sub-district, Murang'a County;
- iii) THAT, following formal complaints, the Government formed a Land Commission in 1987 to establish who the rightful owners to the land were; and the Muthanga farmers were identified as the rightful owners;
- iv) THAT, the land was subsequently subdivided into smaller parcels for the farmers which were all registered as free-hold interests under the Registered Land Act (Cap 300) (repealed) and the farmers were issued with title deeds through the Murang'a land registry in 1988;
- v) THAT, the farmers have since been evicted from the land following a judgment by the High Court on November 19, 2002.

THEREFORE, your humble petitioners PRAY that:-

- i) The relevant departmental Committee of the National Assembly investigate into this matter;



MAKUYU LAND BUYING COMPANIES, CO-OPERATIVE  
AND SELF HELP GROUPS

Further to our report presented to you last year on this subject, we wish to present to you a list of all the recipients of titles in Makuyu and those other areas that our committee managed to cater for. As indicated in our earlier report, we dealt with a few farms which were beyond our jurisdiction. These include Mavoloni Farmers Company (which extended to Machakos), Kiambu Mwitumberia Farmers Company which had another land in Nakuru besides what they had in Makuyu), Kihiumwiri Farmers Company (Owed land in both Makuyu and Laikipia).


Our involvement in the farms outside Makuyu division was based on the single principle that since the owners of these farms were based in Makuyu, their problems could not be completely solved unless we also solved their problems outside Makuyu. This is the only way we saw that could eliminate the members' complaints. This was also aimed at assisting those complaints to wind up once their problems in other districts were solved. We are glad to say that this move was well received by members of these companies as their titles were prepared and issued in Makuyu. This also saved them the agony of travelling all the way to Nakuru, Nyahururu as Machakos for their title deeds. It is now hoped that at the end of this exercise, we shall hand over all the documents to the respective land registries i.e. Machakos, Nyandarua, and Nakuru.

This list is an extract from the green cards which have been prepared and authenticated by the Land Registrars as the appropriate record of the title holders. This committee will only be answerable for the names which appear in this list. If there will be any additions or subtractions after this committee wind up, this committee wishes to be absolved from it. We have also attempted to declare all the public plots per farm. In the process of planning, we tried to cater for all planning standards. Hence we provided for public utilities which we have since surrendered to the government as per the provisions of statutes. We have instances where a few councillors have claimed that the plots belong to the Murang'a County Council. We, as a committee, did not have anything to offer the local authorities. It is only hoped that if anybody wishes to claim any public utilities, they should channel their claims through



As for the case of Methi & Swani Farmers co-operative society, their loan of Kshs. 25 million still remains unpaid. Although we subdivided the land among 3147 members, none of them has got any title and the loan has to be cleared. We have prepared the titles but they cannot be issued out as no acceptable proposals have yet been advanced to the financiers who are the co-operative Bank of Kenya. We propose to hand over these titles to the District Commissioners office for custody until the matter is resolved by the parties concerned.

Once again we wish thank His Excellency the President through you, for having appointed us to this committee.

We as Muthanga farm written this memorandum to you telling you our problem of this farm.

Sir this was former called Mathengeta before it was transferred to Masyana Farm where our grand-grand parents lived. They lived cultivating and grazing their cattle in the farm. In the year 1936 is when the settler came and occupy the farm. This was time the colony sub-divided the farm Mathengeta and formed Masyana farm and Riato. In the year 1940 is when the settle started planting coffee in the farm. By the year 1952 the white settler forced our parent to live in a camp, in order to use them as workers in the farm. In the year 1964 the white man called Constantine Machael Cantonias became sick and left the farm for treatment and didn't come back. In the year 1966 when the refused to come back our parents continued to cultivate and occupying the land.

In the year 1975 a man from Gatundu called Ndutire came complaining to be the owner of the farm. By the year 1983 he claimed he was given land by the commissioner of land. By 1985 he (Ndutire) hired the survey to come and sub-divide the land, but the residents resisted and reported the matter to the D.C of Machakos, later the D.C of Machakos wrote a letter to the D.C of Muranga in order to stop the survey not to go further to sub-divide the land.

In the same year 1985 D.C Mutemi called meeting of both party (Muthanga Farm Resident and Gatundu Men). In that meeting D.Cs David Mutemi said if the Gatundu men wanted the resident of Muthanga Farm to leave the farm they should pay all the properties of residents. E.g (a) Houses, Trees, Terraces etc. from there on forth they started arresting residents one by one.

On 10<sup>th</sup> Feb.1990, the former president visited Makuyu Division, In order to issue the area with title deed. But there were five (5) farms of which the president didn't issue the title deed due to complain. One of them was muthanga farm. Because there were indigenous resident who were living there.

On 11<sup>th</sup> Feb. 1990 we heard the complainant who said they have bought the land, they had the title deed, of which we don't know who gave them the title deed. Oloo, commissioner of land, said, He didn't issue the title deed of the farm. On 12<sup>th</sup> Feb. 1990, we went to chief, D.O DC, and we didn't meet them. We decided to go to P.C office on 13<sup>th</sup> Feb. 1990. On this day we reported the matter to the P.C's office. The P.C called D.C to his office immediately when the D.C reported, P.C asked him who gave the title deed to these people (Gatundu men) of Muthaga farm. D.C said he is the one who issued them the title deed. P.C ordered the D.C to refund the title deed immediately to the office. In the year 1990 some of the Gatundu men burned one of our resident house Mr. Bonface Gichaka Kori. Some of our Resident resists the action, but Gatundu men reported the matter to the police Makuyu station. After the matter was

reported some of our squatters were caught and arrested at Makuyu police station where they were accused as criminals and later taken to court in thika. In the year 1992, other three squatters were arrested, later accused of being settled in the farm illegally where two of the accused died in the remand. In the same year 1992, one of Gatundu man hired men to raid the cattle, while they were grazing in the farm. But, when the resident came to rescue the cattle they seized the man and took him to chiefs camp. The chief went to D.Os office where he came in a land rover, arresting nine (9) squatters out of 146 who went to report the matter to the chiefs camp. After they were taken to police station, the case was filled in court at Thika. In this case one squatter died a few days after they were released from the remand.

On 4<sup>th</sup> December 2001, D.C Maragwa called a meeting of both party, Muthanga Farm resident asked the Gatundu men to produce an agreement that shows they bought the farm from the settler. Also we asked them to produce the transfer form. From there D.C said both side to appoint 5 (Five) people to meet at Dos office Makuyu Gatundu men and Muthanga Farm resident. Five people of Muthanga farm went three times to D.Os office and they didn't come.

Lastly, on 4<sup>th</sup> March 2003, Sub-chief, chief, D.O, O.C.S and O.C.P.D called us a general meeting to give a letter of eviction order from high court giving us a **NOTICE** to vacate within 21 days from the day of meeting.

On 24<sup>th</sup> March 2003, we squatters went to court and the order was set aside to be heard on 31<sup>st</sup> March by both sides. (1159 of 2000) Our advocate served letters of order in the same day (24<sup>th</sup> March 2003) to the advocate of the Gatundu men.

On 27<sup>th</sup> March 2003, 3.00 am they evicted the farm setting houses in blaze where our belongings were burned, damaged, and demolished.

More than 1500 victims were affected by this eviction the night of 27<sup>th</sup> -28<sup>th</sup>  
March 2003.

# Squatters face eviction Scientific talks date

By NATION Correspondent  
The Murang'a District Commissioner, Mr David Mutemi, on Thursday ordered 288 squatters occupying Muthanga Farm in Makuyu Division to vacate it immediately.

Mr Mutemi told the squatters that the farm was sold to the Gatundu Front Farmers Company in 1964 by the Government Land Trustee.

The farm was sub-divided and title deeds issued to the owners by the President on January 10, this year.

Mr Mutemi told the squatters that they would not be compensated for the mud houses and

grass thatched stores built on the farm.

The DC, who toured the farm for about one hour to talk with the squatters, said he had seen no development that would warrant its owners to compensate the squatters.

A spokesman for the squatters said they had formed a self-help group which had raised money to buy land elsewhere.

He said the group had given Sh837,900 to Kakuzi Ltd which had bought a 228-acre piece of land for the squatters.

However, the spokesman said the squatters would not vacate the farm until they were compensated for developing the land.

He said there were 700 mud houses and 700 grass thatched stores. The squatters, he said, were demanding Sh56,000 for the mud houses and Sh30,000 for the stores and an unspecified amount for mango and orange trees planted on the farm.

The squatters also demanded to be paid for terraces they built to curb soil erosion.

One of the squatters claimed that, according to Akamba traditions, Muthanga Farm was their ng'ũũ (ancestral land).

He blamed unnamed senior Government officers who, he alleged, sold the farm to tycoons


