I, the **undersigned**, on behalf of residents of Golini, Kwale County;

DRAW the attention of the House to the following: -

- 1. THAT**, residents of the then Golini Location in present day Matuga Constituency have been living on their land for many years and utilizing it to sustain their economic needs;
- 2. THAT**, between 1969 and 1971, land in the said Location was adjudicated for purposes of registration, except parcel with LR. No. 5003 which was registered as community land and occupied by residents as a community;
- 3. THAT**, in 1994, Golini Settlement Scheme was established on LR. No. 5003 with the intention to benefit the local community that owned the land under communal land tenure system;
- 4. THAT**, following complaints raised by locals regarding the process, the District Plot Allocation Committee formed a taskforce in 2003 to look into the matter and recommend appropriate remedies;
- 5. THAT**, a Ministerial Directive made on 2nd March 2007 directed re-survey of the land in question, which process resulted in sub-division of two hundred and sixty-eight (268) plots based on the recommendations of the Golini Settlement Scheme Taskforce Report;



6. **THAT**, after the re-survey, Kwale County Lands Board and the National Land Commission sanctioned verification of the process with a view to hear and sort out any unresolved issues and recommend how to amend and/or operationalize the Taskforce Report;
7. **THAT**, since the 2007 re-survey, residents of Golini have never been issued with fresh allotment letters yet the initial map has not yet been abolished, leading to erroneous allocation of the land;
8. **THAT**, in 2017, the National Land Commission delivered its findings and recommendations at a public *baraza* in the presence of affected beneficiaries, noting that the said land was ancestral as evidenced by homesteads, graveyards and mature trees;
9. **THAT**, residents have sought assistance from all relevant state institutions but no satisfactory response has been given;
10. **THAT**, the matters raised in this Petition are not pending before any court of law, constitutional or legal body;

THEREFORE, your humble Petitioners pray for the intervention of this House through the Departmental Committee on Lands, to compel the concerned department to consider issuing them allotment letters in respect of the re-survey map of the year 2007 and restrain the beneficiaries of the allotment in the first survey from selling their respective plots before full issuance of allotment letters as per the re-survey of the year 2007 is concluded.

And your **PETITIONERS** will ever pray.

GOLINI SETTLEMENT SCHEME - KWALE COUNTY

Golini Settlement Scheme was established in 1994 on LR.No.5003 with an area of 377.02 ha. About 395 plots were realized, the scheme was registered and titles deeds issued.

Complaints from locals alleging marginalization during plot allocation necessitated formation of a Task Force Committee by the District Plot Allocation Committee in 2003, which produced the Golini Task Force Report.

Conflicting legal status after the second re-survey arose as the first allocation was not nullified and the scheme had already been registered.

The scheme was abolished through a ministerial directive of 2nd March, 2007, and re-survey done as per ground occupancy, realizing 268 plots as was recommended by this Task Force Report.

It is on the strength of this re-survey that the Kwale County Land Management Board sought to hear any unresolved/pertinent issues and gave recommendations on how to amend and or operationalize the Task Force proposals.

This verification exercise was sanctioned by both the National Land Commission and County Government of Kwale, the latter also providing kind facilitation for the work, for which NLC is most grateful. The Report of the verification is attached.

On Monday 23rd January, 2017 the National Land Commission delivered its findings and recommendations at a public baraza at Golini village in the presence of the affected allottees, the County Commissioner's representatives and NLC representatives. It was noted that:-

- 1) This area is an ancestral village that was formally allocated to East African Estates during the colonial times of early 1900.
- 2) The people were not informed of this decision and continued to reside on their land completely unconcerned of their plight.
- 3) It would have been reasonable to declare this as an adjudication process given the evidence of ancestry on the ground: all families were properly located on their original homesteads, old mature coconut and cashew nut trees present, old grave yards etc.
- 4) At the time of declaring the Golini Settlement Schemes in Kenya were allocated on the basis of equal acreage which was not the case for Golini which had varying sizes of land allocated to individuals and families.
- 5) There was a purported Golini Settlement Scheme tension but even this was found to be within the same area, with similar characteristics.
- 6) The area at the edge of the Golini cliff that has a scenic view of Mombasa town was seemingly left out of the scheme but later allocated to officers who later transferred to rich people.
- 7) Even within the traditional village areas, there are disputes over boundaries and inheritance of the allocated land.
- 8) Quite a number of allottees are alien to the Golini and Kwale areas implying that the scheme was not demarcated on the ground.
- 9) There is a remarkable and alarming difference between the list of original allottees, numbering 395 and the verified list of people occupying their ancestral land. The latter list had only 268 names. These two are found from page 10 to 42 of the Report.

Our verdict is that Golini Settlement Scheme was improperly demarcated and registered, a clear case of corruption and historical land injustice.

In view of the above and pursuant to Article 67 (2) (e) of the Constitution operationalized via Section 14 of the Land Act and Section 38 of the Land

Laws (Amendment) Act of 2016, the National Land Commission now declares:-

- a) That the first survey map used to allocate the land is abolished because it led to erroneous allocations.
- b) The letters of offer that followed were hence null and void.
- c) The second survey map that was done with the consent and involvement of the Golini people be upheld and used as the basis of allocation of the subject land.
- d) Fresh letters of offers be issued in conformity with this map, subject to resolving boundary and inheritance matters therein.
- e) A proper PDP be prepared to reflect the existing land use and public utilities.
- f) New titles reflecting the actual scenario on the ground be issued and registered thereafter.

The entire correction process should not exceed two months from the date of these recommendations.

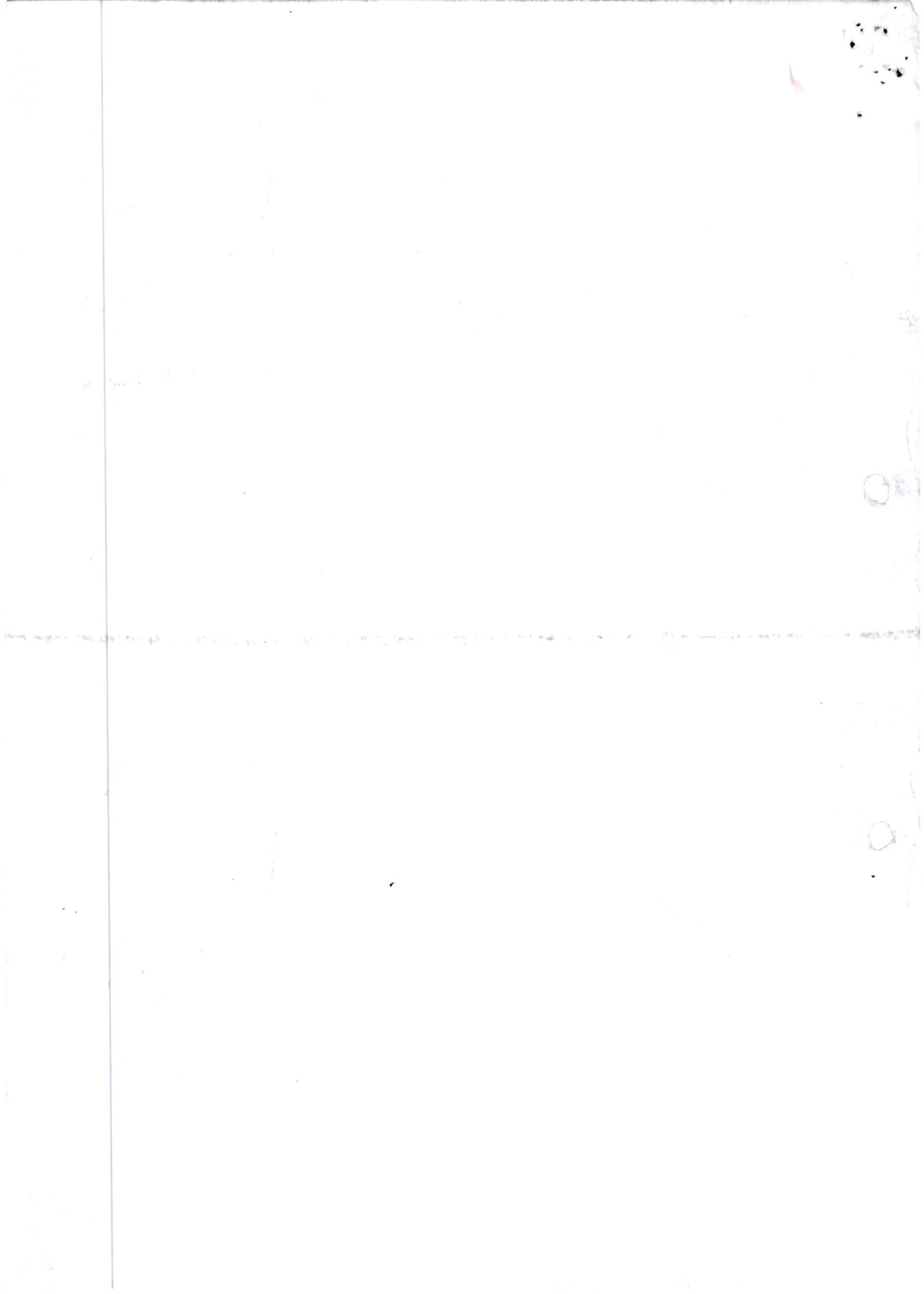

I developed this land fully for future benefits of my family, built two houses surrounded by cash trees such as coconut trees, cashewnut trees, Mango trees, orange trees among others. I lived therein with my family ever since.
2. My 20 acres are within area of land formerly known as private land, when Kenya attained independence the area became State land, thereafter Golini Settlement Scheme in 1986, whereby area residents were to be allocated their respective land with their family. When processed my land was demarcated into 4 pieces of 5 acres each and plots No. 19, 20, 45 and 50 created. Surprisingly I was allocated 5 acres only (plot No. 20), other 15 acres allocated to people not residing in the area while my ten children were landless.
3. Your Excellency since 1986 I personally approached several District Commissioners and Land Adjudication officers of Kwale for their help to re-allocate the 15 acres (plots No. 19, 45 and 50) to my three adult sons but no help, other District Commissioners even ordered me out of their offices. Eventually Provincial Commissioner, Coast advised me to resort to Court of Laws. In 1989 I appealed to Hon. Darius Mbela for his help but referred me back to District Commissioner, Kwale. In February this year I again appealed to Hon. Noah Katana Ngala hoping he would use his ministerial power to help but no result todate.

4. Your Excellency I served our beloved government faithfully for 35 years, I retired 18 years ago, am now 68 years old and unable to find another land elsewhere. I put my investment and strength to develop this land, if I lose it, I will suffer a great loss. It appeared as if my tireless efforts to demand my land back seemed to have annoyed various government officials also resulted enmity and misunderstandings. Sometimes my wife and I have been maltreated then found ourselves locked-up in police cells purposely formed with false malicious allegation just to frustrate us.

5. I dare not interfere with His Excellency's rules and powers but I would sincerely pray that the District Commissioner Kwale be directed to nullify allocation of plots No. 19, 45 and 50 to other people then be registered in the following names of my sons who were not considered, namely:-



- (i) I have been occupying a parcel of land about 20 acres at Golini, Kwale District, since 1959. I have built two houses and have lived therein with my family ever since. I developed the land fully - planted coconut trees, cahewnut trees, mango trees, orange trees and etc.etc.
- (ii) About 1986/87 the area was converted to settlement Scheme whereby the area residents were to be allocated their respective areas with their families. In the process my 20 acres land was sub-divided into four pieces and plots Nos. 19, 20, 45 and 50 were created. Surprisingly, I was allocated 5 acres only (Plot No. 20), the rest of my land was allocated to different people not residing in the area who immediately attempted to sell or have sold to other parties.
- (iii) Your Honour, I have ten (10) Children, three of whom are adults - namely
 - (1) John Dzinendo Lugo - recently resigned from Police Force.
 - (2) Geoffrey Siwa Lugo - with Police Force (GSU)
 - (3) John Mahendo Lugo - working with a private firm.


They are landless and were not considered for plots. They also have children to take care of. Presently, I am living with my children and grand children in one house because my plot is insufficient to build more houses.

Afterwards it turned to be Crown Land thereafter - "Golini Settlement Scheme".
- (vi) Your Honour, I earnestly hope that justice will be done and fair action be taked accordingly.



1. I established shamba in 1959 on a plain bushy piece of land in Golini area. I planted cash crops also did some subsistence farming in approximately 20Acres. To list but a few plants included: coconut trees, cashew nut trees, mango trees, orange trees etc. for my well being and future ^{benefit} ~~benefit~~ of my family.
2. On or about 1986 Golini area was converted or re-named "Golini Settlement Scheme" and residents notified that every family would be allocated 5Acres only despite the fact that most of the families lived in the areas since their fore-fathers and had big shambas with various cash crops. This move disappointed Golini residents followed by series of meetings with District Land Officers and Local Chief whereby, ~~whereby~~ residents were assured that every one would be allocated land where one had developed and lived with his / her family. This assurance was never fulfilled forever.
3. Likewise I was dissatisfied too with the method used in allocating plots within the converted settlement scheme and surprisingly my well developed shamba was divided into four pieces and plots No.19, 20, 45 and 50 created. I was allocated 5Acres only (Plot No.20) and the rest of my shamba was allocated to

people who were not residents of Golini, who in turn immediately sold the plots. None of my ten children was considered for any plot not even within the 20 Acres I had already developed.

4. Although thereafter I constantly approached former District Lands Officers and District Administrative Officer, appealed in writing to previous Lands Ministers (Late Hon. Darius Mbela and Hon. Noah Katana Ngala) and further seeking an audience with retired president Daniel Arap Moi, during 'KANU' Government so that allocation of plot No. 19, 45 and 50 could be nullified and be re-allocated to my elder sons namely: John Dzinendo Lugo (ex- police officer), Geoffrey Siwa Lugo (Police Officer- GSU) and John Mahendo Lugo (Accounts Clerk) but unfortunately my appeal was turned down.
5. Now that, Sir, you are the ^{present} ~~president~~ Hon. Lands Minister under the constitution and coalition Government of Kenya, respectfully beg to ask your good office if there would be way possibility of nullifying plots No.19, 45 and 50 within Golini settlement scheme so that I get back that piece of my shamba I had developed but benefited others other than my family and I hope you will use powers ^{bestowed} ~~bestowed~~ upon you and authorize the nullification. May God bless you, give you wisdom and helpful leadership.



I respectfully beg to submit this memorandum to you and hope you will pardon me for taking your very precious time to read through this long memo.

1. Within Golini area there had been a parcel of land privately owned by East African Estate Company, during colonial regime, where local residents were strictly prohibited to utilize it. later late Hon. Ronald Ngala and late Councilor John Mahendo Zani led by Mr. Ghalia (advocate) filed a case in the High Court, Mombasa for the aforesaid company to be evicted from the tract of that land. The company lost in the case and residents were allowed to build and cultivate the land .
2. Consequently, in 1959, I established a shamba and planted cash crops as well as doing some subsistence farming in an approximately 20 acres; piece of land . To list but a few the plants included coconut trees, cashewnut trees, orange trees, mango trees e.t.c. I also built two houses on this shamba (one permanent ,one semi - permanent) for my well - being and for future benefit of my family.
3. That parcel of land automatically became state property when Kenya got its independence in 1963 , thereafter converted to ~~or~~ ^{or} re-named Golini settlement scheme on or about 1986. This move disappointed local residents which followed by series of meetings with Land officers, Administrative Officers and local Chief where residents were assured that everybody will be allocated land where one had developed or shared with his family. Unfortunately that assurance did not stay to be fulfilled , whosoever.
4. However when the settlement scheme system was introduced my well developed shamba was divided into four pieces and plots No. 19, 20, 45 and 50 created. The method used in allocating the plots within the converted scheme dissatisfied me moreover I was surprised when I was allocated only 5 acres (plot No. 20) and the rest of my shamba (plot No. 19, 45 and 50) allocated to people other than the residents of Golini , who immediately sold them . My ten children were not considered for any plot , not even within the 20 acres I had already developed.

- Although I constantly approached and appealed to the former Land officers and Administrative officers from Kwale District also appealed to the previous Land Ministers (Darius Mbela and Noah K. Ngala) and further seeking audience with the retired President Daniel Torotich. Moi, during 'KANU' government so that plot No. 19, 45 and 50 could be nullified and re-allocated to my elder sons namely: John Dzinendo Lugo (ex-police officer), Geoffrey Siwa Lugo (police officer to date) and John Mahendo Lugo (accounts clerk) but both turned down my complaints.
6. Nevertheless when you visited Kwale District a few months ago residents of Golini and Kwale District as a whole anxiously welcome your announcement that , "Golini settlement scheme was nullified and all fake Title Deeds will be cancelled , " and people will get back their land unless one has sold his shamba or part of it to someone else. We are awaiting anticipatively for the announcement to be effected officially and may Almighty God bless you, give you wisdom and helpful leadership. "AMEN"
