CHAIRPERSON'S FOREWORD

This report contains the proceedings of the Departmental Committee on Justice and Legal Affairs during the approval hearing of Hon. Shadrack John Mose, nominee for appointment as the Solicitor-General as forwarded by H.E. the President and communicated to the House by the Speaker on Tuesday, 14th February 2023.

In the exercise of his powers conferred by Section 9 (1) of the Attorney-General Act, 2012 as read together with Sections 3 and 5 of the Public Appointments (Parliamentary Approval) Act 2011, H.E. the President notified the National Assembly of the nomination of Hon. Shadrack John Mose as Solicitor-General, vide a letter dated 25th January, 2023. The Rt. Hon Speaker vide a communication made on Tuesday, 14th February, 2023 conveyed to the House the Message from H.E. the President and subsequently referred the name of the nominee, his *Curriculum Vitae*, and the Report of the Public Service Commission on the nominee's recruitment to the Departmental Committee on Justice and Legal Affairs for approval hearing. While referring the matter to the Committee, the Speaker directed that the Committee undertakes the vetting exercise within twenty-eight (28) days pursuant to Section 8 of the Public Appointments (Parliamentary Approval) Act, 2011. The Rt. Hon. Speaker further directed the Clerk of the National Assembly to notify the nominee and the general public of the time and place of holding the approval hearing, by placing advertisements in two newspapers of nationwide circulation and the Parliamentary Website.

In compliance with Article 118 (b) of the Constitution and Section 6 (4) of the Public Appointments (Parliamentary Approval) Act, 2011, the Clerk of the National Assembly placed an advertisement in the print media on Thursday, 16th February, 2023 informing the public of the nomination, date, time and place of the approval hearing. He invited the public to submit memoranda by way of written statements on oath (*affidavit*) on the suitability of the nominee in conformity with section 6 (9) of the Public Appointments (Parliamentary Approval) Act, 2011. The memoranda were to be received on or before Wednesday, 22nd February 2023 at 5.00 p.m. (East African Time). By the close of the submission deadline, the Committee had not received any memorandum against the nominee's suitability.

The Clerk of the National Assembly also wrote to the Kenya Revenue Authority (KRA), Ethics and Anti-Corruption Commission (EACC), Directorate of Criminal Investigations (DCI), Higher Education Loans Board (HELB) and Office of the Registrar of Political Parties (ORPP) seeking references and background checks relating to the suitability of the nominee.

The nominee appeared before the Committee on Thursday, 23rd February, 2023 for the approval hearing. The Committee examined his suitability based on the criteria set out in section 7 of the Public Appointments (Parliamentary Approval) Act, 2011. In addition, the Committee examined his academic credentials, relevant experience, knowledge of sector issues and on leadership and integrity. The Committee paid due regard to the procedure used to arrive at the nominee, the constitutional or statutory requirements relating to the office in question and the suitability of the

nominee for the appointment proposed having regard to whether the nominees' abilities, experience and qualities meet the needs of the State Department.

Committee Recommendation

The Committee, having held the approval hearing of the nominee regarding his suitability, observed that due process was followed on the recruitment process as provided for under Section 9 of the Attorney-General Act, 2012 and Sections 3 and 5 of the Public Appointments (Parliamentary Approval) Act, 2011. The Committee, therefore, recommends that the National Assembly **APPROVES** the nomination of Hon. Shadrack John Mose for appointment as Solicitor-General.

Acknowledgements

The Committee registers its appreciation to the Office of the Speaker, Office of the Clerk of the National Assembly, Office of the Director of Departmental Committees and the Committee Secretariat for the logistical support extended during the approval hearing process.

In addition, the Committee thanks the nominee for his cooperation during the Parliamentary approval hearing process. Finally, the Committee appreciates KRA, EACC, DCI, HELB and ORPP for providing references and background checks relating to the suitability of the nominee.

I acknowledge and appreciate Members of the Committee for their patience, sacrifice and commitment which enabled the Committee to complete the task within the required timelines.

1 PREFACE

1.1 Establishment and Mandate of the Committee

1. The Departmental Committee on Justice and Legal Affairs is one of twenty departmental committees of the National Assembly established under **Standing Order 216** whose mandate pursuant to the **Standing Order 216 (5)** is as follows:

- i. To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;*
- ii. To study the programme and policy objectives of ministries and departments and the effectiveness of the implementation;*
- iii. To, on a quarterly basis, monitor and report on the implementation of the national budget in respect of its mandate;*
- iv. To study and review all legislation referred to it;*
- v. To study, assess and analyse the relative success of the ministries and departments as measured by the results obtained as compared with their stated objectives;*
- vi. To investigate and inquire into all matters relating to the assigned ministries and departments as they may deem necessary, and as may be referred to them by the House;*
- vii. To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments);*
- viii. To examine treaties, agreements and conventions;*
- ix. To make reports and recommendations to the House as often as possible, including recommendations of proposed legislation;*
- x. To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and*
- xi. To examine any questions raised by Members on a matter within its mandate.*

1.2 Mandate of the Committee

2. In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider¹:-
 - a) The Judiciary;
 - b) Tribunals;
 - c) Access to Justice;
 - d) Public prosecutions;
 - e) Ethics, Integrity and Anti-corruption;

 - g) Community service orders and witness protection;
 - h) Constitutional Affairs;
 - i) Sovereign immunity;
 - j) Elections including referenda;
 - k) Human rights;
 - l) Political parties;
 - m) The State Law Office' including insolvency, law reform, public trusteeship, marriages and legal education.
3. In executing its mandate, the Committee oversees the following Ministries/Departments:
 - a) State Department of Correctional Services
 - b) State Law Office and Department of Justice
 - c) The Judiciary
 - d) Judicial Service Commission
 - e) Office of the Director of Public Prosecutions
 - f) Ethics and Anti-Corruption Commission
 - g) Independent Electoral and Boundaries Commission
 - h) Commission on Administrative Justice

2 BACKGROUND INFORMATION

2.1 Legal Framework

6. Article 9 of the Office of Attorney-General Act, 2012 provides for the procedure and qualifications for the appointment of a Solicitor-General as well as the roles of the Office. It expressly provides that:

9. (1) *There shall be a Solicitor-General who shall be appointed by the President with the approval of the National Assembly.*
- (2) *The President shall nominate a person for appointment as a Solicitor-General from among persons recommended by the Public Service Commission.*
- (3) *A person shall be qualified for appointment to the office of Solicitor-General if the person—*
 - (a) *is qualified to hold the office of judge of a superior court under the Constitution; and*
 - (b) *meets the requirements of Chapter Six of the Constitution.*
- (4) *The Solicitor-General shall assist the Attorney-General in the performance of the duties of the Attorney-General.*
- (5) *The Solicitor-General shall carry out any function, discharge any duty and exercise any power as may be directed by the Attorney-General and shall—*
 - (a) *organise, co-ordinate and manage the administrative and the legal functions of the Office;*
 - (b) *assist the Attorney-General in the performance of his duties as the principal legal advisor to the Government;*
 - (c) *conduct, or assign and supervise all court cases, including appeals or petitions on behalf of the Attorney-General; and*
 - (d) *subject to Article 234 of the Constitution, be responsible for the discipline of State Counsel and other members of staff of the Office.*
- (6) *In the performance of the functions and the exercise of the powers of the Solicitor-General, the Solicitor-General shall be responsible for —*

- a) *organizing and coordinating the administrative and legal functions of the Office;*
- b) *formulating and ensuring implementation of development strategies for Government Legal Services;*
- c) *undertaking duties of alternate Chairperson of the Disciplinary Tribunal;*
- d) *performing duties of alternate Chairperson of the College of Arms;*
- e) *performing duties as a member of the Council of Legal Education;*
- f) *coordinating the attachment of candidates for pupillage in the Office; and*
- g) *performing such other duties as may be conferred by law or otherwise assigned to the Solicitor-General by the Attorney-General.*

7. In light of this, H.E. the President nominated Hon. Shadrack John Mose for appointment as Solicitor-General.

8. The Departmental Committee on Justice and Legal Affairs was assigned the role of conducting the approval hearing of the aforesaid nominee.

9. The Committee was guided by the following provisions of the Constitution and statutes in executing its assignment:

- i. Article 10 of the Constitution on the national values and principles of governance;
- ii. Chapter 6 of the Constitution on leadership and integrity;
- iii. Article 77 of the Constitution on restriction on activities of State Officers;
- iv. Article 78 of the Constitution on dual citizenship;
- v. Article 118 of the Constitution on public participation;
- vi. Article 124(4) of the Constitution on consideration of persons for appointment to public office;
- vii. Article 166 of the Constitution on qualifications for appointment as a judge of a superior court;
- viii. Article 232 of the Constitution on values and principles of public service;
- ix. The Public Appointments (Parliamentary Approval) Act (No. 33 of 2011);
- x. The Leadership and Integrity Act (Cap. 182);

- xi. The Office of Attorney-General Act (No.49 of 2012); and
- xii. The Public Officer Ethics Act (Cap. 183).

2.2 Notification of Nomination

10. Pursuant to Section 9 of the Office of Attorney-General Act (No.49 of 2012), the Public Service Commission invited applications from suitably qualified persons for the position of Solicitor-General. The advertisement was published in the print media, and on the Public Service Commission's Website on 1st November 2022 with a closing date of 14th November 2022. A total of eighteen (18) applications were made, of which eight (8) candidates were shortlisted and interviews were conducted on the 13th and 14th of December, 2023.

11. Consequently, a list of the successful applicants was transmitted to H.E. the President by the Public Service Commission and on 25th January, 2023 H.E. the President nominated Hon. Shadrack John Mose for appointment as Solicitor-General.

12. The Public Service Commission vide its Report RefNo. PSC.SEC.93/71 Vol.VI (32) dated 16th December, 2023 noted that it adhered to all provisions of the Constitution in the process of advertising, shortlisting and interviewing the candidates including, merit, gender, ethnic and regional balance.

2.3 Message from H.E. the President

13. H.E. the President on 25th January, 2023 communicated the name of the nominee for appointment to the position of Solicitor-General to the Speaker of the National Assembly for approval by the House pursuant to Section 9 of the Attorney-General Act, 2012.

14. The Rt. Hon. Speaker in his Communication issued on Tuesday 14th February 2023 and pursuant to Standing Order No. 42 referred the name of the nominee to the Departmental Committee on Justice and Legal Affairs to conduct approval hearings and report within twenty-eight (28) days.

2.4 Notification to the House and Referral to the Departmental Committee on Justice and Legal Affairs

15. Pursuant to the provisions of Standing Order 42(1), the Speaker, vide Communication No. 004 of 2023 dated **Tuesday, 14th February 2023**, informed the House of the Message from H.E. the President regarding the nomination of the Solicitor-General for approval by the National Assembly.
16. Pursuant to section 8(1) of the Public Appointment (Parliamentary Approval) Act, 2011 and Standing Order 45(1), the name and curriculum vitae of the nominee were referred to the Departmental Committee on Justice and Legal Affairs for approval hearing and reporting to the House on or before Thursday 9th March, 2023.
17. While referring the matter to the Committee, the Speaker directed that the Committee undertakes the approval process within twenty-eight (28) days pursuant to Section 8 of the Public Appointments Parliamentary Approval Act, 2011. The Speaker further directed the Clerk of the National Assembly to notify the nominee and the general public of the time and place of holding the approval hearing.

2.5 Notification to the Public

18. Article 118 of the Constitution provides that Parliament shall facilitate public participation and involvement in the legislative business and other business of Parliament and its Committees.
19. Section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011 provides that the clerk shall notify the public of the time and place for holding an approval hearing at least seven days before the hearing.
20. Further, Section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011 provides that *“any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated”*.

21. Pursuant to Article 118 of the Constitution as read together with Section 6(4) of the Act, the Clerk of the National Assembly placed an advertisement in the print media on **Thursday, 16th February, 2023** inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominee in conformity with Section 6(9) of the Act. The advertisement indicated that the submissions were to be received by **Wednesday, 22nd February, 2023 at 5.00 pm (East African Time)**. At the close of the submission deadline, the Committee had not received any memorandum for or against the suitability of the nominee.
22. Further, pursuant to Article 118 of the Constitution, Section 6(4) of the Public Appointment (Parliamentary Approval) Act, 2011 and provisions of Standing Order 45(3), the Clerk of the National Assembly notified the general public that the approval hearing of the nominee would be conducted on **Thursday, 23rd February, 2023**.

2.6 Notification to the Nominee

23. The Clerk of the National Assembly vide the advertisement placed in the print media and letter Ref. NA/DDC/JLAC/VETT/2023/005 dated 20th February, 2023 invited the nominee for the approval hearing in accordance with Section 6(3) of the Public Appointments (Parliamentary Approval) Act, 2011.

2.7 Clearance and Compliance Requirements

24. On 15th February, 2023, the Clerk of the National Assembly vide letter Ref No. NA/DDC/JLAC/VETT/2023/006 wrote to the Directorate of Criminal Investigations (DCI) requesting a report concerning the nominee's criminal records.
25. On 20th February, 2023, the Clerk of the National Assembly vide letters of Ref No. NA/DDC/JLAC/VETT/2023/007, NA/DDC/JLAC/VETT/2023/008, NA/DDC/JLAC/VETT/2023/009, NA/DDC/JLAC/VETT/2023/010 wrote to HELB, EACC, ORPP and KRA requesting for reports with respect to the nominee on the following matters:
- a) Higher education loan repayments;
 - b) Ethics and integrity;
 - c) Political party affiliations; and

d) Tax compliance.

26. The following institutions wrote back to the National Assembly clearing the nominee: KRA vide letter Ref No. KRA/5/1002/5 (8557) dated 22nd February, 2023; DCI vide letter Ref No. DCI/SEC/6/7/2/A/VOL. XII/49 dated 22nd February, 2023; ORPP vide letter Ref No. RPP/ORG/34 VOL. VI (53) dated 21st February, 2023; EACC vide letter Ref No. EACC/7/10/5 VOL XXII (67_ dated 22nd February, 2023 and HELB vide letter Ref No. HELB/RR/112009/22/211 dated 28th February, 2023.

2.8 Issues for Consideration during the Approval Hearings

27. Section 6(7) and (8) of the Public Appointment (Parliamentary Approval) Act, 2011 provides that:

(7) An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

(8) The criteria specified in the Schedule shall be used by a Committee during an approval hearing for the purposes of vetting a candidate.

28. In addition, Section 7 of the Act stipulates the issues for consideration as:

a) The procedure used to arrive at the nominee;

*b) Any constitutional or statutory requirements relating to the office in question;
and*

c) The suitability of the nominee for the appointments proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made.

29. While conducting the approval hearing, the Committee was guided by the provisions of Section 6(7) and (8) and Section 7 of the Public Appointments (Parliamentary Approval) Act, 2011.

a) Procedure for Nomination

30. Section 9(1) and (2) of the Office of the Attorney-General Act, 2012 confers upon the President the power to nominate a person for appointment from a list of persons recommended by the Public Service Commission.
31. Section 5(1) of the Public Appointment (Parliamentary Approval) Act, 2011 further requires that the appointing authority, upon nominating a person for appointment, notifies the relevant House of Parliament.
32. In light of this, pursuant to Sections 9(1) and (2) of the Office of the Attorney-General Act, 2012 as read together with Section 5(1) of the Public Appointments (Parliamentary Approval) Act, 2011, the President notified the National Assembly of the nomination of Hon. Shadrack John Mose for appointment to the Office of Solicitor-General.

b) Constitutional and Statutory Requirements

33. The Committee was guided by the following provisions of law which act as a guide on the requirements for appointment to the State Office:

i. National Values and Principles of Governance

34. Article 10 of the Constitution provides for the national values and principles of governance which State Officers must abide by in discharging their mandate. They include: patriotism; national unity; sharing and devolution of power; the rule of law; democracy and participation of the people; human dignity; equity; social justice; inclusiveness; equality; human rights; non-discrimination and protection of the marginalized; good governance; integrity; transparency and accountability; and sustainable development.

ii. Conduct of State Officers

35. Article 77 of the Constitution outlines that a full-time State officer must not participate in any other gainful employment and that any appointed State officer must not hold office in a political party.

36. Moreover, the Constitution under Article 78 further stipulates that a State officer must not hold dual citizenship but instead shall be a citizen of Kenya only.
37. Article 232 provides for the values and principles of public service as: high standards of professional ethics; efficient, effective and economic use of resources; responsive, prompt, effective, impartial and equitable provision of services; involvement of the people in the process of policy-making; accountability for administrative acts; transparency and provision to the public of timely, accurate information; fair competition and merit as the basis of appointments and promotions; representation of Kenya's diverse communities; and affording adequate and equal opportunities for appointment, training and advancement, at all levels of the public service of men and women, members of all ethnic groups and persons with disabilities.
38. The Public Officer Ethics Act, Cap 183 outlines the obligations of a public officer as: professionalism; carrying out duties in accordance with the law; prohibition from unjust enrichment; avoiding conflict of interest; not using the office as an avenue for soliciting or collecting harambees; not acting for foreigners; care of property; political neutrality, not practising nepotism or favouritism; giving impartial advice; conducting private affairs in a way that maintains public confidence; bar from sexual harassment; submission of a declaration of income, assets and liabilities once every two years.

iii. Qualifications for Appointment as Solicitor-General

39. Section 9(3)(a) of the Office of the Attorney-General Act, 2012 provides that a person shall be qualified for appointment to the office of the Solicitor-General if the person is qualified to hold the office of a judge of a superior court under the Constitution.
40. In light of this, the Committee was guided by Article 166 of the Constitution which stipulates as follows:

Appointment of Chief Justice, Deputy Chief Justice and other judges.

166. (1) The President shall appoint—

- (a) *the Chief Justice and the Deputy Chief Justice, in accordance with the recommendation of the Judicial Service Commission, and subject to the approval of the National Assembly; and*
- (b) *all other judges, in accordance with the recommendation of the Judicial Service Commission.*
- (2) *Each judge of a superior court shall be appointed from among persons who—*
- (a) *hold a law degree from a recognized university or are advocates of the High Court of Kenya, or possess an equivalent qualification in a common law jurisdiction;*
- (b) *possess the experience required under clause (3) to (6) as applicable, irrespective of whether that experience was gained in Kenya or in another Commonwealth common-law jurisdiction; and*
- (c) *have a high moral character, integrity and impartiality.*
- (3) *The Chief Justice and other judges of the Supreme Court shall be appointed from among persons who have—*
- (a) *at least fifteen years' experience as a superior court judge; or*
- (b) *at least fifteen years' experience as a distinguished academic, judicial officer, legal practitioner or such experience in other relevant legal field; or*
- (c) *held the qualifications specified in paragraph (a) and (b) for a period amounting, in the aggregate, to fifteen years;*
- (4) *Each judge of the Court of Appeal shall be appointed from among persons who have—*
- (a) *at least ten years' experience as a superior court judge; or*
- (b) *at least ten years' experience as a distinguished academic or legal practitioner or such experience in other relevant legal field; or*
- (c) *held the qualifications mentioned in paragraphs (a) and (b) for a period amounting, in the aggregate, to ten years.*
- (5) *Each judge of the High Court shall be appointed from among persons who have—*

(a) at least ten years' experience as a superior court judge or professionally qualified magistrate; or

(b) at least ten years' experience as a distinguished academic or legal practitioner or such experience in other relevant legal field; or

(c) held the qualifications specified in paragraphs (a) and (b) for a period amounting, in the aggregate, to ten years.

iv. Leadership and Integrity

41. The Committee, in determining the suitability of the nominee, was also guided by Section 9(3)(b) of the Office of the Attorney-General Act, 2012 as read with the provisions on leadership and integrity as stipulated under Chapter Six of the Constitution and the Leadership and Integrity Act, 2012. In particular, Article 73(2) of the Constitution provides that the guiding principles of leadership and integrity include:

- a) selection based on personal integrity, competence and suitability, or election in free and fair elections;
- b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices;
- c) selfless service based solely on the public interest, demonstrated by —
 - i. honesty in the execution of public duties; and
 - ii. the declaration of any personal interest that may conflict with public duties;
- d) accountability to the public for decisions and actions; and
- e) discipline and commitment in service to the people.

42. Article 75 of the Constitution requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties. This Article further prohibits a State Officer who has been removed from office under it from holding any other State Office.

43. Article 77(1) of the Constitution prohibits a full-time State Officer from participating in any other gainful employment.

44. Article 77(2) of the Constitution prohibits an appointed State officer from holding office in a political party. Article 78 of the Constitution disqualifies persons who are not Kenyan Citizens from appointment as State Officers. Further, a State Officer is barred from holding dual citizenship.

45. In addition, the Committee considered Section 10 of the Leadership and Integrity Act, 2012 in particular which provides that –

A State officer shall, to the best of their ability—

(a) carry out the duties of the office efficiently and honestly;

(b) carry out the duties in a transparent and accountable manner;

(c) keep accurate records and documents relating to the functions of the office; and

(d) report truthfully on all matters of the organization which they represent.

c) Suitability of the nominee for the proposed appointment having regard to whether the nominee’s abilities, experience and qualities meet the needs of the body to which the nomination is made

46. The suitability of the nominee was assessed after scrutiny of his background, academic credentials and professional qualifications, work and professional experience, personal integrity as well as his performance during the approval hearing conducted on Thursday, 23rd February, 2023.

3 APPROVAL HEARING

47. The Committee conducted an approval hearing for the nominee on **Thursday 23rd February, 2023** and was guided by, among others, the Office of Attorney-General Act, 2012, the Public Appointments (Parliamentary Approval) Act, 2011 and the National Assembly Standing Orders.

3.1 Approval Hearing of Mr. Shadrack John Mose – Nominee for Solicitor-General

48. Hon. Shadrack John Mose appeared before the Committee and was orally interviewed by the Committee to examine his suitability or otherwise. The Committee noted the following:

Personal Background

49. The nominee is a male Kenyan citizen of Identification Card Number 8532233 and does not hold any other citizenship. He was born on 12th June, 1967 in Nyamira County.

Academic and Professional Qualifications

50. The nominee holds a Bachelor's Degree in Law (LL.B) from The University of Nairobi and a Post Graduate Diploma from the Kenya School of Law. He is a notary public, commissioner for oaths, certified public secretary and has over thirty years of experience as a legal practitioner.

Work and Professional Experience

51. The nominee has worked all his career life in the following capacities:

- a) as a Member of the Parliament for Kitutu Masaba Constituency from 2017 to 2022;
- b) as Managing Partner of Mose, Mose & Milimo Advocates from 2007 to 2017;
- c) as Managing Partner of Mose & Mose Advocates from 1996 to 2007;
- d) as Associate Advocate at Esmail & Esmail Advocates from August 1994 to December 1995;
- e) as Associate Advocate at Khamati Minishi & Co. Advocates from August 1992 to June 1994.

Professional Associations

52. The nominee submitted that he is a member of the Law Society of Kenya and the Institute of Certified Secretaries of Kenya.

Public Office, Political Activities and Affiliations

53. The nominee submitted that he has never been an official of any political party but had been a member of the United Democratic Alliance.

Potential Conflict of Interest

54. The nominee stated that he is the managing partner in the firm of Mose, Mose & Mose Advocates but if approved, he would tender his resignation as a partner in the firm.

Sources of Income and Networth

55. The nominee estimated his net worth to be Kshs. 250 Million with the sources of income being rental income, parcels of land and shares in the lawfirm. Concerning his current sources of income, the nominee submitted that his current annual income included salary from the Parliamentary Service Commission and a share of profits from Mose, Mose & Mose Advocates of Kshs. 13.5 Million and Kshs. 5.7 Million respectively.

Pro-bono/Charity Work

56. The nominee is involved in charity work through the support of street children in Keroka Town with basic needs. He also submitted that he had previously been engaged in pro-bono legal work in Kiambu Civil Case CMCC No. 213 of 2017 and Kibera Criminal Case No. 2564 of 2021 in which he represented parties in the cases.

Integrity

57. The nominee demonstrated integrity in public service. He has neither been charged in a court of law nor mentioned in any investigatory reports of Parliament or any Commission of Inquiry

in the last three (3) years. He has also never been dismissed or otherwise removed from office for contravention of the provisions of Article 75 of the Constitution.

3.2 General and Sector-Specific Questions to Hon. Shadrack John Mose

58. The Committee posed several questions to the nominee on his knowledge of the Office of Solicitor-General. The nominee responded as follows: -

On Government losing high profile cases

59. The nominee stated that as an assistant to the Attorney-General, he would advocate for the State Law Office to be well equipped through additional funding from Parliament to ensure technical training and capacity-building for the State Counsels to motivate them to work well and effectively deal with complex cases. He emphasized there was a need for continuous and rigorous training of State Counsels both locally and internationally.

60. Noting that the terms of service for State Counsel at the Office are way below most of the other officers in the justice sector, he added that improving their terms of service would help the office retain its best talent.

On the massive failure of Advocates' Training Programme (ATP) students occasioned by the disharmony between the Kenya School of Law (KSL) and the Council of Legal Education (CLE)

61. The nominee informed the Committee that there were two task forces set up by the former Attorney-General in 2016 seeking to harmonize the working of the two institutions and that he would assist the Attorney-General in the implementation of the recommendations of the task force, particularly, decentralization of the Kenya School of Law.

On the stringent qualifications of LL.B holders to join the Advocates' Training Programme in KSL

62. The nominee informed the Committee that there were two pending Bills seeking to address this issue and asked that Parliament consider them. He further proposed that a mechanism be introduced whereby aspiring Advocates, upon enrolling to undertake undergraduate studies in

law are given a clear picture of what to expect throughout the entire journey up until they are admitted as advocates.

On un-honoured judgements against the Government

63. The nominee reiterated that court decrees should be honoured. He underscored the need to come up with innovative ways of addressing the issue such as employing post-judgement negotiations since some of the payments had increased significantly due to interest on the awarded damages.

On fair recruitment of pupils to the State Law Office

64. The nominee intimated that it was his earnest desire to allow young lawyers to advance their careers. He also stated that, as an ardent defender of the Constitution, he would uphold, respect and defend the Constitution by adhering to Article 232 on the values and principles of public service to afford all aspiring candidates an equal opportunity for appointment as pupils. He added that he would ensure that pupils are recruited on a merit basis and in a manner that takes into account ethnic and regional balance.

On his mission and vision for the Office of Solicitor-General

65. The nominee affirmed that he was aware that the role of the Solicitor-General is to deputize Attorney-General and assist him in discharging his mandate as the principal legal advisor to the government. He further stated that another role was to conduct and supervise cases on behalf of the government.

66. He informed the Committee that his vision for the State Law Office is that it emulates a premier legal firm that can respond promptly to issues. He stated that, if approved, he would ask the government to allocate more funds to the Office to allow it to effectively discharge its mandate.

67. Furthermore, the nominee reiterated that he would improve the terms and conditions of service for State Counsels and hold them to account to ensure that the government zealously defends all its matters in court.

68. He also stated that it was his vision to increase the presence of the State Law Office in all regions by increasing the number of offices across the country as well as through the digitization of services to emulate the Business Registration Service (BRS).

On whether there exists a vacancy in the Office of the Solicitor-General

69. The nominee confirmed to the Committee that there was an advertisement by the Public Service Commission inviting applications for the position and that, in his view, that amounted to there being a vacancy in the office.

On the term of office of the Office of Solicitor-General

70. The nominee noted that the term of office was five years as stipulated in the advertisement.

On the relevance of the Office of Solicitor-General in light of the 2010 Constitution

71. The nominee stated that Section 9 of the Office of Attorney-General Act, 2012 as read with Article 156 of the Constitution of Kenya spells out the roles and functions of the office.

On how to handle a difference of opinion between the Office of Solicitor-General and Attorney-General

72. The nominee stated that as an assistant to the Attorney-General, there is a clear demarcation of roles between the two offices. He further emphasized that he would foster good relations to allow him to work well with the Attorney-General.

On impartiality having been a UDA candidate in the 2022 General Election

73. The nominee noted that he is an Advocate with over thirty years of experience and that he cherishes fidelity to the rule of law and thus, would serve all Kenyans irrespective of their political affiliations. He added that in his long legal career there have never been complaints regarding his professionalism and that it would be his greatest pride to serve all Kenyans with distinction.

On the curtailment of career progression for officers in the State Law Office

Report of the Departmental Committee on Justice and Legal Affairs on the Approval Hearing of the Nominee for Appointment as Solicitor-General

74. The nominee stated that the position of Solicitor-General had been advertised and was open to all including those working at the State Law Office. He added that the recruitment process was competitive.

On the misuse of the State Law Office to sanitize illegal payment of pending bills

75. The nominee noted that, if approved, he would espouse the greatest level of integrity as an accounting officer and that if any State Counsel is found to have engaged in unprofessional conduct, he would ensure that the Counsel is dealt with accordingly.

On why he deems himself fit for the position

76. The nominee informed the Committee that he had a vast experience in different areas and had acquired in-depth knowledge in the legal field having practised law for over thirty years.

On reclaiming the glamour of the Office of Attorney-General

77. The nominee stated that the office is as good as the office bearer and that through continuous capacity building and training, the office would be equipped with a rich human resource which is vital to restoring the honour of the office.

4 COMMITTEE OBSERVATIONS AND FINDINGS

78. Pursuant to Section 6(7) and (8) and Section 7 of the Public Appointments (Parliamentary Approval) Act, 2011, the Committee made the following observations with regard to the following issues for consideration:

4.1 Procedure for Nomination

79. Pursuant to Section 9 (2) of the Office of the Attorney-General Act, 2012, the Committee observed that the procedure used to arrive at the nominee was lawful and in compliance with the values and principles of public service under Article 232(1)(g) and (h) of the Constitution.

80. Further, the Committee found that the nominee was recommended to the President for appointment as required by the law.

4.2 Constitutional and Statutory Requirements

81. The Committee found as follows:

- a) That the nominee is a Kenyan citizen and is not a citizen of any other country and therefore meets the requirement of Article 78(1) of the Constitution;
- b) That the nominee, being an Advocate of the High Court with over thirty years of experience, meets the requirements of Section 9 of the Office of the Attorney-General Act, 2012 as read with Article 166 of the Constitution;
- c) That the nominee demonstrated an aspiration for integrity in public service and thus meets the requirements of Chapter Six of the Constitution on leadership and integrity;
- d) The nominee, having being cleared by KRA, HELB, EACC, DCI, ORPP, with regard to tax compliance, higher education loan repayments, ethics and integrity, criminal records and political party affiliations has met the statutory requirements for appointment to the Office.

4.3 Suitability of the nominee for the proposed appointment having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is made

82. The suitability of the nominee was assessed after scrutiny of his background, academic credentials and professional qualifications, work and professional experience, personal integrity as well as his performance during the approval hearing conducted on Thursday, 23rd February, 2023 and the Committee observed that:

- a) The nominee exhibited a clear understanding of the role of the Solicitor-General within the Office of the Attorney-General which includes:
 - i. organising, co-ordinating and managing the administrative and the legal functions of the Office;
 - ii. assisting the Attorney-General in the provisions of legal to the Government;
 - iii. conducting, or assigning and supervising all court cases on behalf of the Attorney-General;
 - iv. being responsible for the discipline of State Counsel and other members of staff of the Office;
 - v. formulating and ensuring implementation of development strategies for Government Legal Services;
 - vi. undertaking duties as an alternate chairperson of the Disciplinary Tribunal established under the Advocates Act;
 - vii. performing duties of alternate Chairperson of the College of Arms;
 - viii. performing duties as a member of the Council of Legal Education; and
 - ix. coordinating the attachment of candidates for pupillage in the Office.
- b) The nominee possesses relevant experience for the position of Solicitor-General of the Republic of Kenya. The nominee has practised law for over thirty years during which he has mentored pupils under the Advocates Training Programme and maintained a perfect disciplinary record. He has also been a legislator for five years and served as a member of the House Business Committee and the Departmental Committee on

Transport, Public Works and Housing. A background in law and experience in public service are critical tools for any person discharging the role of Solicitor-General.

- c) The nominee exhibited a comprehensive grasp of the challenges currently affecting the State Law Office, including retention of staff, congestion, overall motivation, remuneration, capacitation and lack of decentralization. He identified adequate budgetary support as one of the key solutions that may restore the office to its high standing within the justice sector.


5 COMMITTEE RECOMMENDATIONS

83. Having considered the suitability, capacity and integrity of the nominee, and pursuant to Section 9 of the Office of Attorney-General Act, 2012 and Section 8(2) of the Public Appointments (Parliamentary Approval) Act, 2011, the Committee recommends that the National Assembly **APPROVES** the appointment of **Hon. Shadrack John Mose** to the position of Solicitor-General of the Republic of Kenya.

The suitability of the nominee was assessed after scrutiny of his background, academic credentials and professional qualifications, work and professional experience, personal integrity as well as his performance during the approval hearing conducted on Thursday, 23rd February, 2023 and the Committee observed that:

- (1) The nominee exhibited a clear understanding of the role of the Solicitor-General within the Office of the Attorney-General which includes:
 - (a) organising, co-ordinating and managing the administrative and the legal functions of the Office;
 - (b) assisting the Attorney-General in the provisions of legal to the Government;
 - (c) conducting, or assigning and supervising all court cases on behalf of the Attorney-General;

- (d) being responsible for the discipline of State Counsel and other members of staff of the Office;
 - (e) formulating and ensuring implementation of development strategies for Government Legal Services;
 - (f) undertaking duties as an alternate chairperson of the Disciplinary Tribunal established under the Advocates Act;
 - (g) performing duties of alternate Chairperson of the College of Arms;
 - (h) performing duties as a member of the Council of Legal Education; and
 - (i) coordinating the attachment of candidates for pupillage in the Office.
- (2) The nominee possesses relevant experience for the position of Solicitor-General of the Republic of Kenya. The nominee has practised law for over thirty years during which he has mentored pupils under the Advocates Training Programme and maintained a perfect disciplinary record. He has also been a legislator for five years and served as a member of the House Business Committee and the Departmental Committee on Transport, Public Works and Housing. A background in law and experience in public service are critical tools for any person discharging the role of Solicitor-General.
- (3) The nominee exhibited a comprehensive grasp of the challenges currently affecting the State Law Office, including retention of staff, congestion, overall motivation, remuneration, capacitation and lack of decentralization. He identified adequate budgetary support as one of the key solutions that may restore the office to its high standing within the justice sector.

The Committee deferred the adoption of the report until the Report of the Selection Panel of the Public Service Commission was availed.

The Chairperson Informed Members that the main agenda was to conduct approval hearing for the person nominated for the position of the Solicitor-General of the Republic of Kenya. He further informed the meeting that there were no memoranda received contesting the suitability of the nominees.

The agenda was adopted having been proposed by Hon. Mohamed Aden Daudi M.P, and seconded by Hon. Gichohi Kaguchia John Philip, M.P.

MIN. NO/DC/JLAC/2023/093 CONFIRMATION OF THE MINUTES OF THE PREVIOUS SITTING

The agenda was deferred.

MIN.NO/DC/JLAC/2023/094 APPROVAL HEARING FOR THE PERSON NOMINATED FOR THE POSITION OF THE SOLICITOR-GENERAL OF THE REPUBLIC OF KENYA

The Hon. Shadrack John Mose, the nominee for the position of the Solicitor-General of the Republic of Kenya appeared before the Committee and submitted as follows;

- a. **On personal background**, the nominee stated that he was a male adult, a Kenyan citizen born in Nyamira County and residing in Nairobi County.
- b. **On Education qualifications**, the nominee stated that he was an advocate of the High Court of Kenya and holds a Post-Graduate Diploma in Law from Kenya School of Law; and a Bachelor of Laws Degree (LLB)(Hons) from the University of Nairobi
- c. **On Experience and employment record**, the nominee stated that he has over 29 years' experience in legal practice and served as the Member of the National Assembly for Kitutu Masaba Constituency: 2017-2022: Managing Partner Mose, Mose & Millimo Advocates: 2007-2017: Managing Partner Mose and Mose Advocates: 1996-2007: Associate Advocate, Esmail & Esmail Advocates: August 1994 - December 1995: Associate Advocate, Khamati Minishi & Co.: August 1992 – June 1994.
- d. **On professional and relevant skills**, he indicated that he has developed and maintained a strong working relationship with colleagues, judges and corporate clients in variety of sectors ranging from banking, manufacturing and state corporations. He stated that his reputation as a diligent and thorough advocate is one of the strengths, he would bring to the State Law Office as this would aid in management of the Office. He also stated that his adverse record has afforded him a well-rounded skill set, including first-rate leadership skills, organizational skills, financial management skills and strategic people management skills that will position him to excel as Solicitor-General
- e. **On relevant experience and exposure**, he informed the meeting that he has vast experiences and exposure in various areas of practice including complex commercial litigation encompassing tax law, banking law, insurance law, constitutional law, conveyancing, criminal law, employment law and public international law among other. He stated that his dedication to justice and commitment to provide quality representation would use to reform the State Law Office if appointed as he has actively participated in pro bono briefs over the years.
- f. **On why the government loses landmark cases**, the nominee stipulated that the government wins or loses cases depending on the merits of the case. The nominee stated the need to equip the State Law office with resources so as to retain State Counsels by securing financing through budget allocation. The nominee also stated the need for intergovernmental state agencies to consult with the State Law Office when making critical decisions to avoid breach of contract which in return leads to the government paying a lot of fees.
- g. **On lack of Office Space in the State Law Office**, the nominee stated the need to automate the State Law Office. Most services offered by the Office are document-heavy hence occupy much space that would have been occupied by staff. The nominee also stated the need to digitalize customer service so as people do not have to physically visit the Office.
- h. **On how the nominee would address the massive failure at the Kenya School of law and high examination fees by the Council of Legal Education**, the nominee stated the need to decentralize the Kenya School of Law in order to harmonize the

content and structure of the curriculum. This would also reduce the congestion at the institution. The bar exam is administered by Council of Legal Education. The Council does not offer legal training.

- i. **On why the government does not obey Court decrees**, the nominee stated that Court decrees are to be honoured. He also stated the need to establish and embrace post judgement negotiations.
- j. **On the issue of understaffing at the State Law Office**, the nominee pointed out the need to decentralize the State Law Office. He stated that currently the State Law Office is only represented in thirteen regions in the Country and there is need to increase the presence of the office in number in the thirteen regions and also in line with devolution so as to have the office in all the forty-seven counties.
- k. **On the roles of the Solicitor-General**, the nominee pointed out the roles of the Solicitor-General are articulated in Section 9 of the Office of the Attorney-General Act, 2012 and Article 234 of the Constitution of Kenya 2010 to include: assist the Attorney-General in the performance of the duties of the Attorney-General; carry out any function, discharge any duty and exercise any power as may be directed by the Attorney-General; organize, co-ordinate and manage the administrative and the legal functions of the Office; assist the Attorney-General in the performance of his duties as the principal legal advisor to the Government; conduct, or assign and supervise all court cases, including appeals or petitions on behalf of the Attorney-General; and responsible for the discipline of State Counsel and other members of staff of the Office.
- l. **On whether there is a vacancy for the position of Solicitor-General**, he stated there was a vacancy in the State Law Office for the Position of Solicitor-General. The vacancy was advertised in newspapers of general circulation and the nominee applied as he met the qualifications stipulated in The Office of the Attorney-General Act. He stated that he underwent an interview by the Public Service Commission and was nominated by the President of the Republic of Kenya in accordance with Section 9(2) of the Office of the Attorney-General Act, 2012.
- m. **On what is the term of service for the position of Solicitor-General**, the nominee stated the term of service to be five (5) years.
- n. **On whether there is a likelihood of different opinions between the Attorney-General and the Solicitor-General**, the nominee stated that the two positions play different roles as stipulated in the Constitution of Kenya 2010 and the Office of the Attorney-General Act 2012 hence he does not foresee an incidence of conflict arising. He further stated that they must work in consultation for the betterment of the State Law Office.
- o. **On whether the nominee had been nominated by a partisan political party**, the nominee pointed out that he has over twenty-nine years' experience in legal practice hence professional independency and fidelity are virtues he stands by to ensure delivery of justice.

p. On why the nominee feels he is the best candidate for appointment for the position of the Solicitor-General of the Republic of Kenya, the nominee stated that he is an Advocate of the High Court of Kenya with over twenty-nine years' experience and has practiced from informative stages of the legal profession. He also stated that from his experience as a legislator he has gained vast experience in public policy and legislative processes
