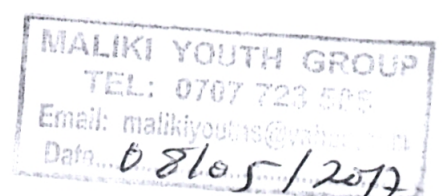

- 1.2 THAT the constitution I voted for is not cast in stone and amendments can be effected
2. THAT the presidential five year term limit be immediately amended to a ten year one term limit in order to channel the campaign money to other government projects.

10. THAT none of these issues raised in this petition is pending in any court of law, constitutional or other legal body.

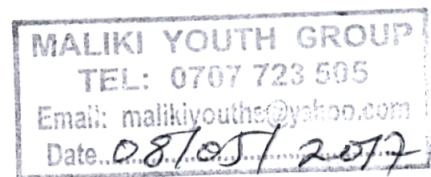
WHEREFORE, your humble petitioner prays that the senate:
