

REPORT OF THE DEPARTMENTAL COMMITTEE ON HEALTH ON THE
PETITION TO PARLIAMENT IN REGARD TO THE PHARMACY AND
POISONS (AMENDMENT) BILL OF 2014

Introduction

- 1) The Petition by Mr. Barnabas Bargoria was presented to the House on 1st July, 2014 on behalf of the Petitioner by the Hon. Hellen Chepkwony, Member of Parliament for Kericho County. Subsequently, the Report was committed to the Departmental Committee on Health pursuant to Standing Order No. 227.

Contents of the Petition

In the Petition, the Petitioner raised the following issues:-

- 2) **THAT** one of the key functions of the Chief Pharmacist of the Pharmacy and Poisons Board is to regulate the quality of drugs and ensure that imported drugs conform to the prescribed standards of quality, safety and efficacy for human consumptions;
- 3) **THAT** the laxity and gross conduct by the Chief Pharmacists threatens the lives of many Kenyans who unsuspectingly purchase and consume drugs that do not conform to the prescribed standards of quality, safety and efficacy;
- 4) **THAT** on 28th May, 2009, the Petitioner, a diabetic patient purchased insulin drugs namely Humulin 70/30 from Eldochem Ltd. in Eldoret town and that the drug had been imported by Statim Pharmaceuticals Limited;
- 5) **THAT** after using the drug, the Petitioner suffered near fatal injury and had to obtain emergency treatment at the Moi Teaching & Referral Hospital;
- 6) **THAT** the drug was subsequently tested by the National Quality Control Laboratory and was found to be harmful since it did not conform to the prescribed quality, safety and efficacy standards;

court of law. The Committee therefore sought to establish the facts of the Petition and Civil Case No. 309 of 2010. Below is a summary of its findings: -

- 13) With regard to Criminal Case No. 4663 of 2009 – Republic Vs. Nawaz Gulam and William Chumba, the Committee heard that the case was dismissed on 24th August, 2014, not as a result of the Chief Pharmacist's failure to avail key witnesses or exhibits to the Court, rather, that the case collapsed as a result of some of the witnesses, the Petitioner himself, included, failing to appear before the Court to give evidence.

The Board informed the Committee that it availed a witness, one Mr. James Kingo'ri. Mr. Barnabas Bargarora himself failed to present himself to court and also give evidence despite being the complainant.

The Director, National Control and Quality Laboratory Board, also listed as one of the witnesses, failed to present exhibits in the form of certificate of analysis of the said sub-standard drugs. The case was thus dismissed on 24th August, 2010.

- 14) Following the dismissal of Criminal Case No. 4663 of 2009, the Petitioner filed a Civil Case No. 309 of 2010 on 16th June, 2011 against Eldochem Limited (First Defendant), Statim Pharmaceuticals Limited (Second Defendant) and the Pharmacy and Poisons Board (Third Defendant).

In the Suit, he claims the following against the Pharmacy and Poisons Board;

THAT

- a) The Board licensed and authorised Statim Pharmaceuticals Ltd. to source and supply pharmaceutically unfit *Humulin 70/30* for application by persons in Kenya including the plaintiff.
- b) The Board being the authority established by law to regulate and control importation, circulation and manufacture of drugs and storage thereof,



3. The delegation to the 45th Lung Conference will travel to Barcelona Spain on 25th October, 2014 as scheduled.



ON IMPORTATION OF SUB-STANDARD
DRUGS**

The Legal Counsel informed the Committee that on scrutiny of documents submitted by the Pharmacy and Poisons Board and the Petitioner, it is evident that the subject matter of the Petition is indeed sub-judice. He further reported that the case was due for hearing on 23rd September 2014 and that he was awaiting the outcome of the proceedings for further scrutiny.

The Committee resolved to finalize its report on the matter for submission to the House.

**MIN. NO. DCH 389/2014: CONSIDERATION OF THE TRADITIONAL
HEALTH PRACTITIONERS BILL, 2014**

MIN. NO. DCH 387/2014: DELIBERATION ON EBOLA CRISIS

The Committee deliberated at length on the Ebola crisis and made the following observations:- THAT

- i. Kenya should lobby the World Health Organisation and the international community for a proposal to have JKIA designated Africa's Certified Quarantine Centre for Ebola. The direct benefit of doing so will boost Kenya's economy and also safeguard the country against Ebola threat by ensuring that Kenya remains Ebola-free because of the enhanced surveillance system;
- ii. The Committee observed that Kenya ought to take the Ebola threat more seriously and that the Committee should visit various border/entry points eg JKIA, Namanga, Busia, Malaba etc to inspect Kenya's preparedness in screening and tackling the diseases in any eventuality;
- iii. The Committee resolved to request for utilization of funds allocated to manage Ebola;
- iv. Hon. Daniel Maanzo informed the Committee that a Kenyan national from Makueni County working in Seychelles died while undergoing treatment in Seychelles and the authorities quickly poured acid on his corpse because of the fear that he may have died of Ebola. The deceased had just returned from a holiday in Kenya. Efforts to repatriate the body for burial in Kenya have not borne fruit because the Seychelles authorities have ruled it dangerous for transportation. Hon Maanzo and Hon Musimba asked for the Committee's support should their efforts to have the body transported to Kenya for burial fail to bear fruit. They were assured of the support.

Way Forward

1. The Committee resolved to write to the CS Health requesting for the information below:-
 - i. The Committee also resolved to request the Cabinet Secretary, Ministry of Health to submit to the Committee weekly review status of preparedness and challenges encountered in the fight against the Ebola threat in Kenya.
 - ii. Breakdown of utilization of funds allocated to ensure the country is safeguarded against Ebola;
2. On the issue of repatriating the body of the Kenyan patient stuck in Seychelles, the Committee advised the two Hon Members (Hon Maanzo and Hon Musimba) to liaise with the Ministry of Health and W.H.O. Country Office with the aim of establishing the actual cause of death to facilitate release of the body to the relatives.

MIN.NO.DCH 333/2014: ADOPTION OF REPORT ON PETITION BY THE KENYA MEDICAL LABORATORY TECNHNOLOGISTS AND TECHNICIANS BOARD IN REGARD TO THE PHARMACY AND POISONS (AMENDMENTS) BILL, 2014.

Report on the Petition by the Kenya Medical Laboratory Technologists and Technicians Board in regard to the Pharmacy and Poisons (Amendments) Bill, 2014 was unanimously adopted having been proposed by Hon Dr. James Murgor MP and seconded by Hon Zipporah Kering MP.

It was further reported that Hon Dr. Robert Pukose, MP, will sponsor the Pharmacy Practice Bill as a Committee Bill.

The Senior Researcher took the Committee through analysis of the In-vitro Fertilization Bill (copy attached).

Hon Millie Odhiambo's Presentation

Hon Millie Odhiambo, sponsor of the Bill was present during the deliberations and informed the Committee as follows:

- i. That the Bill was introduced in the 10th Parliament but was not passed before the House was dissolved. The Bill intends to create a legal and regulatory framework for the practice of In-vitro fertilization.
- ii. Currently, Kenya lacks legal framework on In-vitro fertilization thereby creating legal hurdles for women/couples intending to undertake the procedure. It is also a very expensive procedure.
- iii. That Budget & Appropriations Committee approved the Bill for publishing as a money bill albeit with recommendations that the sponsor considers working with the Kenya Medical Practitioners and Dentists Board or Kenyatta University, a public institution to host the IVF public clinic and secretariat as opposed to creating a new authority that will occasion additional spending from the exchequer. The Member indicated that she is willing to work with an already existing public institution to host IVF secretariat.

Plenary on the Bill

The Committee made the following observations and comments on the Bill:

1. That In-vitro fertilization is a small aspect of maternal health and does not necessarily need its own regulatory body. The Committee was opposed to the creation of a new authority to oversee operations of IVF if passed into law. The sponsor was implored upon to consider working with already existing public institutions to host IVF activities.
2. That the issues of In-vitro fertilization are well captured in the Clause 69 of the proposed Health Bill. This will however not adequately address the larger issues of maternal and child health. The Committee therefore proposes to introduce a Maternal and Child Health Bill to address maternal of reproductive health amongst other issues affecting mothers and children.

WAYFORWARD.

Hon Millie Odhiambo agreed to consult further (including looking at provisions of the Health Bill) during recess and report back to the Committee on her decision on whether to proceed with the Bill or not.



- ii. However, in May 2009, he purchased insulin drug namely *humulin* 70/30 from Eldochem Limited in Eldoret town. Statim Pharmaceuticals Limited imported the drug.
- iii. After using the drug, the petitioner suffered a near fatal injury and had to obtain emergency treatment at the Moi Teaching and Referral Hospital and that the drug was subsequently tested by the National Quality Control Laboratory and was found to be harmful since it did not confirm to the prescribed quality, safety and efficacy standards and that the laxity and gross failure by the Chief Pharmacist threatens the lives of many Kenyans who unsuspectingly purchase and consume drugs.

Way Forward

During the meeting, it came to the attention of the Committee that the subject matter of the Petition could be a matter before the Judiciary (Court) and as such it was resolved that until the matter is determined as not *sub-judice*, further consideration of the matter would be suspended.

Parliamentary Legal Counsel was tasked to analyze the documents presented to the Committee and report back to the Committee. Further, the Petitioner and the Board were asked to submit more detailed information on the court case.





PHARMACIST/SECRETARY TO THE PHARMACY AND POISONS BOARD

I, the undersigned, on behalf of Barnabas Bargarioria, a citizen of Kenya and resident of Eldoret,

DRAW the attention of the House to the following;

THAT aware that one of the key functions of the Chief Pharmacist of the Pharmacy and Poisons Board is to regulate the quality and ensure that drugs imported conform to the prescribed standards of quality, safety and efficacy for human consumption;

THAT laxity and gross failure by the Chief Pharmacist threatens lives of many Kenyans who unsuspectingly purchase and consume drugs that do not conform to the prescribed standards of quality, safety and efficacy;

NOTING THAT on 28th May 2009, the petitioner, diabetic patient, purchased insulin drugs namely *Humulin 70/30* from Eldochem Limited in Eldoret town and that the drug had been imported by Statim Pharmaceuticals Limited;

THAT after using the drug, the petitioner suffered near fatal injury and had to obtain emergency treatment at the Moi Teaching and Referral Hospital;

THAT the drug was subsequently tested by the National Quality Control Laboratory and was found to be harmful since it did not conform to the prescribed quality, safety and efficacy standards;

THAT this contravenes Article 43(1) (a) of the Constitution which provides that every person is entitled to the highest attainable standard of health, including right to health care services;

THAT the Chief Pharmacist lodged a case against employees of the dispensing chemist at the Resident Magistrate's Court in Eldoret as *Case No. 4663 of 2009: Republic vs. Nawaz Gulam and William Chumba*;

SUBMISSION ON WHETHER THE MEMORANDUM OF PETITION BY BARNABAS BARGORIA IS SUB JUDICE

1. The Petitioner filed the Memorandum of Petition seeking:
 - a. The National Assembly makes urgent recommendations to the Cabinet Secretary of Health to take urgent appropriate deterrent action against the Chief Pharmacist and officers involved in the circumstances complained of herein;
 - b. The National Assembly makes urgent recommendations to the Cabinet Secretary to the Ministry of Health to ensure sufficient controls are in place to guard against manufacture or importation of non-qualifying drugs.
2. The Petitioner's complaint in the Memorandum of Petition is against the conduct of the Chief Pharmacist who is also the Secretary of the Pharmacist and Poisons Board for :
 - a. Failing to secure and avail witnesses in *Eldoret Resident Magistrate's Court Criminal case No. 4663 of 2009 Republic vs. Nawaz Gulam and William Chumba* leading to discharge of the case, thereby occasioning injustice to the civic right of the Petitioner particularly and deterrence to any persons dispensing non qualifying drugs;
 - b. For killing the case, for reasons and grounds that were never explained to the Petitioner;
 - c. Failing to incorporate for prosecution the importers of the offending drug Statim Pharmaceuticals Limited and generally protecting parties that offend provisions of the Pharmacy and Poisons Act;
 - d. Having been advised by Eldochem Limited from where the offending drug was sourced from, they deliberately fail to charge the said known supplier with the offence, hence unduly and by collusion shielding the supplier from prosecution;
 - e. Exposing Kenyans including the Petitioner to peril by permitting, by acts of omission, importation of substandard drugs;
 - f. Abusing office.

3. The matter in the Memorandum of Petition does not touch on the civil culpability of the importer or civil culpability of the Poisons Board. The Petitioner filed Nairobi High Court Civil Case No. 309 of 2010 Barnabas Bargarora vs. EldoChem Limited, Statim Pharmaceuticals Limited and Pharmacy and Poisons Board, seeking redress for civil torts against him, the issues in the matter are not the issues in the Petition.
4. Indeed the Director of Public Prosecutions conducted investigations and found that there was evidence to prosecute and that is why Eldoret Resident Magistrate's Court Criminal case No. 4663 of 2009 Republic vs. Nawaz Gulam and William Chumba was opened and prosecution commenced.
5. The issue is therefore why the Chief Pharmacist and officers failed to take steps to ensure prosecution of the case. The Proceedings evidence that the case was dismissed because of failure of the Chief Pharmacist to produce the exhibits from Nairobi, which were the test results.
6. The individuals in the Criminal case are not parties to the civil case.
7. The Petitioner having the civic right to complain to the Police for atrocities of a criminal nature, is indeed, and legitimately so, aggrieved when the prosecution that was commenced was stifled deliberately by the Chief Pharmacist and his officers.
8. The other issue is the prayer that the National Assembly makes urgent recommendations to the Cabinet Secretary to the Ministry of Health to ensure sufficient controls are in place to guard against manufacture or importation of non-qualifying drugs. This is because persons with diabetes continually need the insulin and if not checked, then prejudice shall be suffered on mass scale.
9. Clearly therefore the issue in the Memorandum of Petition is not the issue in the Civil case. The Sub judice issue does not therefore arise at all.
10. The Sub judice principle is carried at Standing Order No. 89 of the National Assembly Standing Orders 2013. The Order proceeds as follows:

(2) A matter shall be considered to be sub judice when it refers to active criminal or civil proceedings and the discussion of such matters is likely to prejudice its fair determination.
11. As indicated, the issues in the civil case and the Memorandum of Petition are completely different.
12. It is submitted that the Memorandum of Petition does not and is not sub judice, and the Petitioner having the right to petition Parliament under Article 37 and 119 of the Constitution of Kenya & Standing Order No. 219 of the National Assembly Standing Orders, 2013, deserves to be heard and merits the redresses sought.

13. The Petitioner is legitimately apprehensive, if noncomplying insulin is imported, the Petitioner shall egregiously suffer and so shall the public.

RE: PETITION TO PARLIAMENT ON IMPORTATION OF SUB-STANDARD DRUGS

Reference is hereby made to your letter Ref. KNA/DCH/CORR/2014(72) dated 19th September, 2014 addressed to me and whose contents I have noted and wish to respond as herein below:

(1) Criminal Case No. 4663 of 2009- Republic vs. Nawaz Gulam and William Chumba.

This criminal case was instituted by the Republic against the persons named above under Food Drugs and Chemical Substances Act Cap. 257 pursuant to a complaint which was lodged to the Police by Mr. Barnabas Bargoria after he alleged that he bought *Humulin 70/30* from Eldochem limited in Eldoret and was owned by the two persons who were charged in the above criminal case.

This case commenced on the 29th July 2009, when the accused took their pleas. Mr. Barnabas Bargoria and an officer from the Pharmacy and Poisons Board were among the persons who were lined up for hearing. **The accused persons where charged for importing and selling sub-standard drug namely *Humulin 70/30* contrary to the provisions of the Law.**

This case was dismissed on the 24th August, 2010 because the prosecution was not able to bring the exhibits which were with the officers who were based in Nairobi at NQCL despite signal having been sent to them. The exhibits were a certificate of analysis which was in the possession and custody of the Director NQCL, Mr: Hezekiah Chepkwony who was also listed as a witness in the said criminal case No. 4663 of 2009.

These exhibits (certificate of analysis) were the basis for the charges before court which read "Selling of Drug which is not the Quality Contrary to section 11 as read with section 36(1) (a) of the Food and Drugs and chemical substance Act, Cap. 254 Laws of Kenya". The particulars of the offence were:

(i) **Nawaz Gulam (ii) William Chumba;**

On the 28th day of April, 2009, at Eldochem Limited in Eldoret town within Uasin Gishu District of Rift Valley Province jointly sold to wit insulin vials (*Humilin 70/30* batch No. HIM 439), which does not meet the prescribed quality standards to Mr. Barnabas Bargoria (**See attached charge sheet in the said criminal case**).

Sir, from the said proceedings, you will take note that Pharmacy and Poisons Board availed an officer on the 25th May 2010, but the prosecutor was not ready to proceed as he informed the Court that he did not have the Court file neither the exhibits (**See page 6 of the Court proceedings attached to the Petition**).

In light of the above and Court proceedings attached to the Petition by the Petitioner, it is clear that Pharmacy and Poisons Board availed a witness namely Mr. James King'ori and who was listed as a witness, while Mr. Barnabas Bargoria never presented himself to Court neither did he give evidence despite being the complainant therein (**see page 7 of the court proceedings submission of Mr. Nyairo for accused persons attached on the petition**).

(2) ***Civil Case No. 309 of 2010- Barnabas Bargoria vs. Eldochem Limited, Statim Pharmaceuticals Limited and Pharmacy and Poisons Board.***

This civil suit was filed by Barnabas Bargoria on the 16th June 2011, after the criminal case had been dismissed. The said suit he claims the following against Pharmacy and Poisons Board that;

- (a) The 3rd Defendant licensed and authorized the second Defendant to source and supply pharmaceutically unfit *Humulin 70/30* for application by persons in Kenya including the Plaintiff.
- (b) The 3rd Defendant being the Authority established by Law to regulate and control importation, circulation and Manufacture of drugs and storage thereof permitted the second Defendant to source harmful *Humulin 70/30* and supply it for the application of the Plaintiff.
- (c) The 3rd Defendant being the Authority established by Law to regulate and control importation, circulation and manufacture of harmful *Humulin 70/30* to the Plaintiff in the instant and for the period that the Plaintiff has had it prescribed to him and applied by him much to the Plaintiff's detriment;
- (d) And the Plaintiff will extent necessary rely on the principle of *res ipsa Loquitor*;

And the Defendant and each of them by the acts aforesaid breached the duty of care owed to the Plaintiff **(See the plaint dated 25th May 2010 attached)**. This civil suit came for hearing on 23rd September, 2014 before Justice Sergon **(see page 3 of cause list attached)**.


The hearing did not proceed as Justice Sergon Court was not sitting and matters before it could not proceed and were ordered that new dates be taken at the registry for hearing.

We have already applied for the proceedings in the criminal case that was dismissed and shall be furnishing you with the same upon receipt from the Eldoret Law Courts **(See attached a letter requesting for proceedings from the said court)**.

Finally Sir, it is clear that the two cases above are all similar to the Petition that has been placed before Parliament by Barnabas Bargarora and the prayers are all similar.

The Petitioner is on a fishing expedition and he is not honest and the Petition is ill intended as not any other user of the said *Humulin 70/30* in that batch made any complaint and has failed to disclose material facts to the Hon. Members.

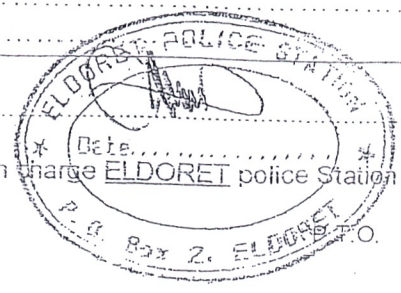

(*Service of summons shall be served through the Plaintiff's advocates offices*).
4. The Third Defendant is a public corporation established under section 5 of the Pharmacy and Poisons Act (Chapter 244 of the laws of Kenya) and has its principal office in Nairobi, within the Republic of Kenya. (*Service of summons shall be served through the Plaintiff's advocates offices*).
5. The First Defendant *inter alia* operates a dispensing chemist outlet in Eldoret, within the Republic of Kenya.
6. The Second Defendant *inter alia* carries on the business of sourcing of pharmaceutical drugs from abroad and sells or supplies the drugs in Kenya.
7. The Third Defendant is the regulatory Authority that licenses importation of pharmaceutical drugs into Kenya for purposes of supply and or sale to the general public and has the statutory obligation of ensuring the drugs so imported/sourced are fit for human prescription and safe.
8. The Plaintiff is a diabetic and has been Insulin dependent for the past twenty (20) years and which condition he has managed by taking prescribed Insulin namely Humulin 70/30
9. On or about the 28th May 2009, the Plaintiff bought Insulin namely Humulin 70/30 (hereinafter '*the drug*') from the First Defendant's dispensing chemist.

10. The said *drug* had been sourced by the Second Defendant from Egypt and had been so sourced with the license and authority of the Third Defendant.
11. The Plaintiff applied the drug as prescribed, and after application suffered extreme injury that was near fatal. The Plaintiff had to undergo emergency treatment at the Moi Teaching & Referral Hospital Eldoret.
12. The Plaintiff subsequently had the drug tested by the National Quality Control Laboratory; a statutory body established by section 35D of the Pharmacy and Poisons Act (Chapter 244 of the Laws of Kenya).
13. The said drug was found to be harmful and non-responsive to pharmaceutical standards.
14. The Plaintiff states that the Defendants each and all of them owed him a duty of care by ensuring that the drugs that are sourced, prescribed and sold to him were safe for application and adhered to pharmaceutical standards.
15. The Plaintiff further states that long application of *Humulin* 70/30 licensed, sourced and prescribed in the manner aforesaid has over time led to immense injury to him by exacerbating his health and leading to visual impairment.
16. The Plaintiff states that the Defendants and each of them breached the duty of care owed to him.

Particulars of the First Defendant's negligence

- (a) The First Defendant prescribed to the Plaintiff *Humulin* 70/30 that did not meet pharmaceutical standards;
- (b) The First Defendant failed and or neglected to check and or ascertain the pharmaceutical fitness of the drug before prescribing and selling it to the Plaintiff;
- (c) The First Defendant failed to advise the Plaintiff that the said *Humulin* 70/30 was pharmaceutically unfit for application;
- (d) The First Defendant being a dispensing chemist urged the Plaintiff to consume *Humulin* 70/30 while knowing or having reason or being obligated to ascertain that the drug was harmful to his health and pharmaceutically unfit for human utilization;
- (e) And the Plaintiff will to the extent necessary rely on the principle of *res ipsa Loquitur*

Particulars of the Second Defendant's negligence

- (a) The Second Defendant sourced pharmaceutically unfit *Humulin* 70/30 for commercial purposes, for human utilization in Kenya;
- (b) The Second Defendant failed and or neglected to ascertain first the pharmaceutical fitness of the *Humulin* 70/30 before sourcing it in Kenya for human application;

- (c) The Second Defendant sourced and supplied the unfit *Humulin 70/30* which was later on applied by the Plaintiff;
- (d) The Second Defendant has over time been sourcing and supplying *Humulin 70/30* that does not meet pharmaceutical standards and much to the detriment of the Plaintiff;
- (e) And the Plaintiff will to the extent necessary rely on the principle of *res ipsa Loquitur*

Particulars of the Third Defendant's negligence

- (a) The Third Defendant licensed and authorised the Second Defendant to source and supply pharmaceutically unfit *Humulin 70/30* for application by persons in Kenya including the Plaintiff;
- (b) The Third Defendant being the Authority established by law to regulate and control importation, circulation and manufacture of drugs and storage thereof permitted the Second Defendant to source harmful *Humulin 70/30* and to supply it for the application of the Plaintiff;
- (c) The Third Defendant being the Authority established by law to regulate and control importation, circulation and manufacture of drugs and storage thereof failed to control importation and supply of harmful *Humulin 70/30* to the Plaintiff in the instant and for the period that the Plaintiff has had it prescribed to him and applied by him much to the Plaintiff's detriment;
- (d) And the Plaintiff will to the extent necessary rely on the principle of *res ipsa Loquitur*

RESPONSES TO ISSUES RAISED BY THE PARLIAMENTARY HEALTH COMMITTEE IN THEIR LETTER DATED 13TH AUGUST 2014

1.1 Mandate of Pharmacy and Poisons Board.

The Pharmacy and Poisons Act, Cap 244 is an Act of Parliament to make better provision for the Control of the Profession of Pharmacy and trade in drugs and poisons.

The Pharmacy and Poisons Board is established as a body corporate, under the Pharmacy and Poisons Act, Cap 244 Laws of Kenya. The PPB is a pharmaceutical regulatory body within the Ministry of Health.

1.2 Services

 - One shall be from Community Pharmacy
 - One shall be from the Pharmaceutical Industry
 - One shall be from Hospital Practice
- (e) A representative from the Faculty of Pharmacy University of Nairobi.
- (f) A Pharmaceutical Technologist.

2.0 RESPONSE TO THE PETITION TO PARLIAMENT BY HON. HELLEN CHEPKWONY M.P ON BEHALF OF MR. BARNABAS BARGORIA.

I the Cabinet Secretary, Ministry of Health has read and understood the petition lodged by Hon. Hellen Chepkwony on behalf of Mr. Barnabas Bargoria and wish to state as follows;

THAT the Mandate of the Pharmacy and Poisons Board is to make better provision for the control of the profession of pharmacy and the trade in drugs and poisons as prescribed in the Laws of Kenya, The Pharmacy and Poisons Board Act Cap 244.

THAT I wish to state that there has never been laxity on the part of the Board to perform its legal duty or legal mandate and obligations as mandated by Cap 244 by the Laws of Kenya.

THAT all medicines or pharmaceuticals products manufactured locally or imported into the country must conform to internationally prescribed standards of quality, safety and efficacy for human consumption.

THAT on 2nd June 2009, Mr. Barnabas Bargoria contacted the Board verbally complaining about insulin (*Humulin 70/30*) he purportedly bought in a Eldochem as not being potent. He further claimed that the said drug nearly caused him fatal injury that landed him in hospital. As a result of this complain an investigation was initiated (**Annex 1**).

THAT 1600 vials of Humulin 70/30 batch No. HIM 439 manufactured by ELI LILLY – Switzerland was imported into the country by Statim Pharmaceutical company Nairobi. No other such complains was received in Kenya or around the world.

THAT after his complains the Board took the medicine from him and Eldochem and sent it to the National Control Laboratory for analysis and asked him to come back after 30 days for the results (**Annex 2**). The medicine was not maintained in cold chain when it was handed over to the officers of the Board by the complainant.

THAT the samples submitted for analysis to NQCL did not comply with the pharmacopeia parameters for assay of Insulin (**Annex 3**).

THAT the petitioner did not come back to the Board as advised but instead obtained the results from the Laboratory un-procedurally and started engaging directly with Eldochem Pharmacy and Statim Pharmaceutical Company without the knowledge of the Board (**Annex 4**).

THAT on 10th July 2009, the Board wrote to Statim Pharmaceuticals to recall Humulin 70/30 of the affected batch (**Annex 5**).

THAT after getting the results from NQCL we understood that the petitioner went to the police and filed a complaint against the purported owners of the chemist.

THAT the Board collected more samples from the quarantined product in the distribution chain, then took them to another WHO prequalified laboratory for analysis. This was to ensure the lives of the unsuspecting Kenyans was not threatened as alleged by the petitioner. The samples collected from quarantined product and distribution chain passed the analysis (**Annex 6**).

In addition, a certificate of analysis of the same batch No. KIM439 was obtained from the innovator company indicating compliance with the specifications (**Annex 7**).

This same product has been in the market and is still in the market to date and we have not received any other complaints (**Annex 8**).

THAT the manufacturing site was further inspected for complies with current PPB and WHO Good Manufacturing Practice requirement (**Annex 9**).

THAT we later received summons to appear in court and the Board sent two officers who appeared three different times but the matter could not proceed as the complainant had not appeared to testify all those times to lay his case to enable other witnesses to testify. The court asked our officers to stay away until further advised.

THAT if the case was ever terminated as alleged by the petitioner we assume it was on the part of the complainant who failed to appear in court whenever our witnesses were present.

THAT further, the allegation by the petitioner that the criminal case filed by the Republic on his behalf was dismissed on 25th May 2010 due to the lack of witnesses from the Board is not correct as the same day an officer from the Board was present in the court to take the witness stand as indicated in the proceedings laid before this Hon. House by the petitioner and could not proceed at the request of the prosecutor for reasons stated in the pleading. The matter was dismissed on the 24th August, 2010 and not as indicated by the petitioner who never attended court all times.

THAT the allegation by the petitioner that there is **no case pending before court**, which is subject matter of petition **is incorrect** as the petitioner filed case No. 309 of 2010 on 6th June 2010 in the High Court of Kenya and served the Board with the pleadings. The Board has since instructed its advocates to respond and the matter is coming for hearing on 23rd September, 2014 (**Annex 10**).

THAT in light of the above explanation, it's clear that the petitioner is not acting in good faith and has failed to give material facts to this Honorable House.

We pray to the Hon. Members to dismiss this petition as we await courts hearing and judgment.

3.0 Preventive Strategies Employed by the Board.

The Board has put in place several measures that are employed to mitigate against the risk of infiltration of substandard, spurious, falsified, falsely labeled, and suspected counterfeit (SSFFC) medicines in the country.

The measures that have been taken included but not limited to:

(a) Ensuring Compliance to Good Manufacturing Practices

This helps to ensure that companies marketing their products in Kenya meet the minimum good manufacturing standards to safe guard the patients. GMP was started in 2010 for all local and foreign manufacturers.

The Good Manufacturing Practices (*GMP*) guidelines are a series of general principles that must be observed during manufacturing. When a manufacturing company is setting up its quality program and manufacturing process, there may be many ways it can fulfill GMP requirements. It is the company's responsibility to determine the most effective and efficient quality process.

During the period July 2013 to 30th June 2014 the Board has done the following GMP inspections:

1. Local Manufacturing companies – a total of 22 companies have been inspected.
2. Foreign Manufacturing companies – a total of 153 companies have been inspected

(b) Development of New Regulation to Align them with the International Best Practices

The Board has revised the application form for the registration of drugs (*Form 1 of Drug Registration rules CAP 244*) and the guidelines, so as to align them with the international trends. The Board has adopted the CTD format for the registration of drugs and applications are done online.

This has helped the Board to better control the quality of drugs being allowed into the country and also to capture all the necessary information for given drugs.

Use of CTD has enabled the Board get access to more information (Post Marketing Surveillance) for use in the tracking of medicines safety in the market.

The Board is an active member and collaborates with the EAC partner states to harmonize drug registration requirements in the region.

The draft repeal of CAP 244 (for products and practice) is currently before the house. The repeal was necessitated by the new health policy, health bill, EAC harmonization and the various conflicting acts in the regulation of medicines and allied products to increase effectiveness and efficiency.

(c) Strengthening Post Marketing Surveillance

1. Training of Health Workers – 10,000 health workers trained.
2. Regular Post Marketing Surveillance – 9 PMS activities conducted since 2010 for Anti-Malarials, ARV, Anti-TBs, Reproductive health products, Cough Syrups, Herbal Reproductive Health products.
3. Cohort Events Monitoring – One for AL (Artemether Lumefantrine)
4. Online Reporting System (PV) – has been running for two years.
5. Electronic E-Shot System – Rapid communication to health care workers across the country.

6. WHO Rapid Alert System – Method of sharing information by WHO to member states on emerging health care issues worldwide.
7. Use of minilabs at ports of entry and regions. Currently there are twelve across country and the Board is targeting 47 counties in the next five years.

(d) Rapid Sequestration, Quarantine and Destruction of Expired and SSFFC Medical Products

1. Officers have been assigned to coordinate sequestrations, quarantine and destructions.
2. Logistical support provided; Vehicle, Driver.
3. Total of 397964Kg products have been destroyed and 148 certificates issued.

(e) Enhance Capacity of Inspectorate

1. 10 regional offices are operational.
2. Adequate staffing - Currently there are sixty (60) inspectors and a request for the redeployment of more inspectors is ongoing in order to increase coverage to all counties.
3. Increasing more ports of entry - The Board has eleven ports of entry that are manned by the inspectors and the Board is planning to increase the five more border points namely:
 - i. Taveta
 - ii. Moyale
 - iii. Mandera
 - iv. Kisumu Airport
 - v. Lokichogio

(f) Use of Electronic Systems

The Board has implemented or enhanced the following systems:

1. Online Retention of medicines for use in Kenya - All medicines from 2014 have been electronically submitted and evaluated for retention.
2. Kenya Electronic Single Window System - Online application of imports and exports of pharmaceutical products from 2014. This is part of the Government effort promote ease of doing business in Kenya.
3. GPS mapping of registered Premises.
