Article 127(2)(d) of the Constitution provides that the Parliamentary Service Commission shall consist of, among others, one man and one woman appointed by Parliament from among persons who are experienced in public affairs, but who are not members of Parliament.

Pursuant to Article 127(2)(d) of the Constitution and the First Schedule to the Parliamentary Service Act, 2019, the Clerk of the Senate/Secretary to the Parliamentary Service Commission, declared a vacancy for the position of female Non-MP Commissioner of the Parliamentary Service Commission and invited interested qualified persons to apply through an advertisement published in the Kenya Gazette, the Daily Nation and the Standard newspapers on Friday, 14th August, 2026 and on the website of Parliament.
