## **A. BACKGROUND TO THE SETTLEMENT SCHEME**

The Chepchoina Settlement Scheme in Trans Nzoia County was purchased by the Settlement Fund Trustees (SFT) from the Agricultural Development Corporation (ADC). The settlement process was carried out in two phases (Phase I and II).

**Phase I** of the settlement scheme had a total of 4,436 acres and was allocated in 1994 by the then Provincial Commissioner for Rift Valley. The allocations were on the basis of letters of offer that were issued to allottees before survey was undertaken. However, an initial survey of the scheme was carried out in 1994 but was not conclusive. Further, in 2006-7, re-surveying of the scheme was carried out taking into consideration the 1994 plan and concluded the rest of the area that had not been surveyed. A total of 663 plots emerged out of which 492 plots were allocated leaving a balance of 171 plots which were later on allocated except for seven plots which had court cases.

**Phase II:** The objective of Phase II settlement was to address intense community interests and shortcomings that arose from Phase I. It comprised of L.R. No.s 8026/1, 4140/9 and part Of 8026/2 totaling approximately 7,000 acres.

The settlement scheme began in 2011 and ended in 2012. A total of 1,681 beneficiaries were identified, vetted and approved by an expanded District Settler Selection Committee which comprised of twenty (21) publicly elected officials who were drawn from various communities as follows; Turkana (4), Pokot (4), Sabaot (2), Luhya (7), other minority ethnic communities (4). The area District Officer and chief were incorporated in the committee.

The criteria for land allocation by the Settlement Fund Trustees were based on a ratio of 60% and 40%, for local and other communities respectively. The list of beneficiaries were forwarded to the Ministry of Lands on the 17<sup>th</sup> June, 2011 and letters of offer prepared and signed on 6<sup>th</sup> February, 2012. The issuance of the letters of offer to the beneficiaries was conducted in a public *baraza* in the scheme on 23<sup>rd</sup> March, 2012 where the Minister for Lands presided over. In attendance were area leaders, the DC, area residents and other stakeholders.

Upon issuance of letters of offer, beneficiaries were shown their plots which they accepted by paying the STF loans.

## B. STATEMENT SOUGHT

Pursuant to Standing Order 45(2) (b) of the Senate, at the sitting of the Senate held on Tuesday 15<sup>th</sup> April 2014, Sen Catherine Nabwala Mukiite requested for a Ministerial Statement from the Chairman of the Standing Committee on Lands and Natural Resources on the criteria used in allocation of land to squatters in Chepchoina Settlement Scheme Phase II in Trans Nzoia County.

The Senator sought to know:

- a) The criteria used in the allocation of land to squatters in Chepchoina Phase II Settlement Scheme in Trans Nzoia County,
- b) The list of beneficiaries of the allocation,
- c) Explanation under which circumstances poor and landless squatters were not allocated land,
- d) Confirmation if there were any foreigners from neighbouring countries who were allocated land and the impact of these on insecurity in Trans Nzoia and
- e) The state of Landlessness in the country.

During the request for statement, Senators expressed interest in the matter and raised the following supplementary questions;

- a) **Senator Prof. Lonyangapuo** sought clarification on whether the list of allottees for Chepchoina Phase 1 of the 1990s still stands or had been amended, the list of the said foreigners who benefited from the allotment and the officers at the Ministry of lands who were involved in the malpractices.
- b) **The Senate Minority Leader, Senator Moses Wetangula** wanted to know whether the government criteria for allocation of land to the landless in the county had changed over time. He also wished to know how many public servants (DCs, DOs, Lands Officers) and other gainfully employed officers in government benefited from the allocation and whether the classification of poor and landless for purposes of allocation of land, includes those who earn salaries.
- c) **Sen. Henry Ndiema** requested to know the ethnic composition of land allottees and their county of residence as indicated in their identity cards.

### **C. RESPONSE TO THE STATEMENT**

On the 4<sup>th</sup> June, 2014, the Chairperson of the Departmental Committee on Land and Natural Resources responded to the statements sought and;-

- a) Tabled the entire list of original beneficiaries of allotment of Chepchoina Phase 2 Settlement Scheme,
- b) Stated that the criteria used in the allotment was through an allocation committee which comprised of 21 officials publicly elected who vetted and verified that the beneficiaries were landless poor squatters,
- c) Explained that not all eligible squatters benefited due to inadequacy and unavailability of land,
- d) Reported that there was no data on the number of landless people in Kenya and recommended that there was need for the national and County governments together with the National Land Commission (NLC) to establish a data base of the landless in Kenya and
- e) Further stated that the tabled list had no foreigners from any neighbouring countries and that the formula used by the Agricultural Development Corporation (ADC) was 60% local community and 40% from other landless Kenyans who were registered with the Settlement Fund Trustees (SFT)

### **D. DELIBERATIONS**

The following deliberations ensued and the Members;-

- a) Were concerned that the committee did not have data, records or documentation on the state of landlessness when such reports had been prepared as early as 1974,
- b) Stated that they had alternative lists which included beneficiaries from Uganda, District Commissioners, District Officers, Land Adjudicators and other affluent people,
- c) Indicated their willingness to furnish the committee with more information on the beneficiaries of the settlement scheme and
- d) Noted that the relationship between the settlement patterns and insecurity in Trans Nzoia could not be ascertained by the Ministry.

---

## **E. RESOLUTION.**

**The Senate resolved that the Committee interrogates the matter further and presents a comprehensive report on the issues raised to the House within 4 weeks.**

## **F. ACTION**

Pursuant to the Senate resolution, the Standing Committee on Land and Natural Resources invited the Cabinet Secretary responsible for Land and the Chairman of the National Land Commission to appear before the Committee on 15<sup>th</sup> and 17<sup>th</sup> July, 2014 respectively to respond to all matters raised pertaining to the allocation of land to squatters in Chepchoina Phase II Settlement Scheme in Trans Nzoia County.

## **G. MEETING WITH CABINET SECRETARY MINISTRY OF LANDS, HOUSING AND URBAN DEVELOPMENT.**

On 15<sup>th</sup> July, 2014 at 11.30am, the Cabinet Secretary Ministry of Lands, Housing and Urban Development Hon. Charity K. Ngilu appeared before the Standing Committee accompanied by the Director for Land Adjudication in the Ministry.

The following Members of Parliament who had shown interest in the matter were also present;- Sen. Mutula Kilonzo Jnr, M.P., Sen. Catherine Mukiite, M.P and Hon. Moroto.

Before the submissions by the Cabinet Secretary, the Committee noted that;-

- a) Some foreigners from Uganda benefited from the allocations while the poor, landless and needy people were left out in the allocation,
- b) Some of the original allottees of Chepchoina phase II had been displaced from their land and others issued the same,
- c) Public officers and able individuals had been allocated land at the expense of the poor and landless people,
- d) The land in question was initially owned by the ADC and there were squatters living on that land some of who were not considered during the phase I allotments,

- e) Allocations of land were done by two sources; ADC and Provincial Administration who had varying interests in the settlement,
- f) There was no land left for further allocation since the entire scheme was occupied and
- g) Allotment of land for Phase II was ongoing as late as 2014.

#### **H. RESPONSE FROM THE CABINET SECRETARY**

The Cabinet Secretary thanked the Committee and confirmed that the concerns raised in the statement were correct, weighty and required political leadership to offer solution and responded as follows;-

- a) That the matters raised in Chepchoina were very emotive than what could be established from the statement sought,
- b) That there were undeserving allottees in most settlement schemes and had received similar complaints from different parts of the Country,
- c) The criteria used in the settlement of poor and landless by the government in all schemes were in percentages of 60:40 for local community and others respectively,
- d) The Ministry was aware of the complaints in Chepchoina and appealed to all leaders not to incite their communities against others over the allotments,
- e) Requested the leaders to identify extra land on which to settle the landless who had been left out of the allocations in Phase I and Phase II,
- f) That the purpose of establishing the Scheme by government was to settle the poor and landless people and that the process was managed by the Provincial Administration and ADC which in part contributed to the current situation,

#### **I. MEETING WITH THE NATIONAL LAND COMMISSION**

On the 17<sup>th</sup> July, 2014 at 10.00am, the Chairman of the National Land Commission Mr Mohammed A. Swazuri appeared before the Standing Committee on Lands and Natural Resources accompanied by the Vice Chairperson and other officers from the Commission.

The following Senators were also In-Attendance;- Sen. Johnstone Muthama, M.P, Sen. Mutula Kilonzo Jnr, M.P. and Sen. Catherine Mukiite, M.P.

---

Before the submissions by the Chairman of the National Land Commission, the Committee noted that;-

- a) The issues of Chepchoina revolved around the criteria used in the allotment of land, the ethnic composition of the allottees in phase I & II and the displacement of original allottees in phase I & II,
- b) The allocation of land in Chepchoina Settlement Scheme favoured some communities at the expense of others,
- c) There were cases of double-allocation of land as a result of which some allottees have been displaced from their plots and other people occupied their land and
- d) There were three sources of allotment letters in all the phases; from ADC, the Provincial Administration and the Ministry of Lands.

The Committee requested the Commission to address the following issues;-

- a) Whether the original purpose of establishing the scheme had been secured and the state of landlessness per county,
- b) The number of squatters who had been living on the ADC farms but were left out during the allotment,
- c) Confirm whether phase III has been occupied and will be allocated as per the government schedule,
- d) The position of the Commission on allottees with allotment letters dated 1997 yet they did not get allocations in Phase I & II,
- e) Recommendations of the National Assembly on Chepchoina Settlement Scheme which were deliberated upon on 2<sup>nd</sup> October, 2013 and 30<sup>th</sup> April, 2014.

## **J. RESPONSE BY THE CHAIRMAN NATIONAL LAND COMMISSION**

The National Land Commission made their presentations as follows;

- a) The land for the entire scheme was acquired by the government from the ADC,
- b) The Commission is aware of the complaints in Chepchoina and had visited Trans Nzoia County and invited all leaders to a meeting to deliberate on the matter. However, the NLC delegation could not

- proceed to Chepchoina due to flared emotions and ethnic suspicion among the residents,
- c) That the purpose of establishing the Scheme by government was to settle the poor and landless people and that the process was managed by the Provincial Administration which in part contributed to the current situation,
  - d) That Chepchoina Phase I & II was planned, verified, surveyed, demarcated, allocated and registered in 2007 and 2009 respectively. They are awaiting issuance of titles to those who have cleared SFT loans,
  - e) The survey maps are completed and RIM's were published by the Director of Survey,
  - f) The criteria used in the settlement of poor and landless by the Government in all schemes including Chepchoina was in percentages c. 60:40 for local community and others respectively. However this was a practice rather than policy and was subject to manipulation,
  - g) The Commission could not ascertain if there were any foreigners from Uganda allocated land because all the allotments were done against Kenyan Identification cards,
  - h) The Commission's direction was to rectify the problems or injustices in land allocation by considering the intended objective of settlement schemes, target beneficiaries and the recommended acreage through the proposed Land Act and is in the process of drafting Regulations that prescribe procedures for land allocations in settlement schemes,
  - i) **Phase I** was located comprised of 3 public utilities and 660 plots (mainly 5 acres each) which were allocated to local communities as follows;
    - Pokot-569,
    - Sabaot-50,
    - Others (Marakwet, Turkana, Nandi)-40.
  - j) The scheme was planned, surveyed, registered and titles were issued by the District Registrar to those who had cleared SFT loans. The scheme is fully settled,

- ~~k) That Chepchoina Phase I & II was planned, verified, surveyed, demarcated, allocated and registered in 2007 and 2009 respectively. They are awaiting issuance of titles to those who have cleared SFT loans,~~
- l) The survey maps are completed and RIM's are published by the Director of Survey,
- m) **Phase II** comprised of 18 public utilities and 1663 plots (mainly 2.5-5.0 acres) which were allocated to local communities as follows;
- Pokot -600,
  - Luhya -452,
  - Turkans -226,
  - Saboot -202,
  - Others -183.
- n) Beneficiaries who had letters of allotment from ADC dated 1997 were vetted by the District Settler Selection Committee (DSSC) and were equally considered alongside other needy beneficiaries,
- o) The Scheme is planned and surveyed and the area lists are with the Chief Land Registrar awaiting issuance of titles to those who have cleared STF loans,
- p) The survey maps are awaiting publication by the Director of Survey,
- q) **Phase III** has a total acreage of 3000 acres and comprises of 900 plots and the process of allocation is ongoing though a court injunction has suspended the process,
- r) Planning and survey has been done but the process of allocation and production of letters of allotment is yet to be done due to the current case,
- s) Squatters have invaded the scheme with hope that they will be allocated land and
- t) The land charges for the beneficiaries are Ksh. 500 per acre and Ksh. 750 per parcel for the survey fees.



**K. RESOLUTIONS**

- a) There is need for the allocation of Land in Phase III to be resolved in an amicable manner,
- b) The need for political and administrative interventions to solve the matter in Phase III. The Ministry of Land, Housing and Urban Development and the National Land Commission to constitute an Independent Committee that will look into issues of allocations in Phase III. The Independent Committee to include *inter alia* key stakeholders and leaders from the area,
- c) The report of the Independent Committee be tabled before the Senate Committee,
- d) The road map for the next course of action in Phase III be determined after the current court case is heard and determined and
- e) There is need for the National Land Commission to re-vet the persons who had earlier been allocated plots in the scheme and did not get them for the purposes of consideration in Phase III or any other scheme elsewhere.

The chairman opened the meeting at 1.15p.m. and with a word of prayer from the Physical Planning Officer. This was followed by self-introduction by the members present.

The District Commissioner then gave a brief history of the scheme and explained that it was an Agricultural Development Co-operation farm before the Ministry of Lands acquired it. In his address to the members, the Project Manager explained that Chepchoina phase I has a total of 4,436 acres and was allocated in 1994 by the late provincial commissioner Rift Valley province, Mr. Ishmael Chelanga. That this allocations were on the basis of letters of offer being issued to allottees before survey could be undertaken. The Project Manager further explained that an initial survey of the scheme was carried out in 1994 but was not conclusive. In 2006 – 2007, resurveying of the scheme was carried out taking into consideration the 1994 plan and concluding the rest of the area that had not been surveyed.

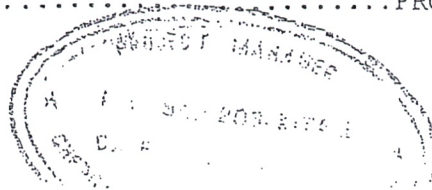
In his remarks, the Chairman told the members that a committee had been set up by his office to verify the letters of offer issued in 1994 alongside plot occupancy and that 492 plots and names had been verified. He therefore informed the members that the meeting was convened to discuss and deliberate on the list of beneficiaries so that it could be forwarded to the Director of Land Adjudication and Settlement for consideration. After a lengthy discussion the committee resolved that the list be adopted and there being no other business, the meeting dissolved at 2.30p.m. The list of 492 is herewith attached.

The meeting was called to order at 12.51 p.m. by the chairman and officially opened after a word of prayer by Mr. Richard Mulupi.

### MIN.11/2011 - OPENING REMARKS

The Chairman welcomed members to the meeting, followed by a brief session of self introduction. He went further to thank the area Member of Parliament for finding time to attend the meeting and notified the members of his decision to invite the Executive Members of the Vetting Committee to attend the session so as to present their list of beneficiaries and state the modalities they had used to identify them. He added further that they would be called at a later stage in the session to give their presentations.

### MIN.12/2011 - CONFIRMATION OF PREVIOUS MEETING'S MINUTES

The secretary read through the previous minutes of 19.1.2011. They were proposed for adoption by Jane N. Kaitano and seconded by Jean W. Songoi. Members confirmed that they were true records of the proceedings.

### MIN.13/2011 - MATTERS ARISING

From the attendance list of the meeting of 19.01.2011, the name of Jane N. Gaitano was corrected to read Jane N. Kaitano.

Under Min. 8/2011 the phrase "...the list were..." was corrected to read '...the list was...'

A concern was raised that the required distance needed for setting apart a riparian reserve was not observed. However, this was explained that as per the existing survey Act, parcels of land are measured to the centre line of the river and thus the requirement was met. The meeting resolved that beneficiaries of parcels neighbouring the riparian reserve would be advised by the Agriculture department on the agricultural practice to be observed on the riparian reserve. It was clarified that the scheme is approximately 10,348 acres.

Members adopted the survey plan as explained by the District Surveyor and further agreed that parcel sizes for allocation should range between 2.5 and 5 acres arable equivalent as per Min. 3/2009.

**MIN.14/2011 – VETTING COMMITTEE MEMBER'S REPORT**

The Chairman of the Vetting Committee reported that they had completed the vetting of 1,681 beneficiaries derived from the following communities; Pokots, Luhya, Sabaots and Turkanas as well as others from the minority tribes. This was confirmed by the representatives of the communities who were present. It was noted also that additional beneficiaries would be vetted for consideration in the remaining final phase of the scheme.

The Chairman of the vetting committee requested that the list be adopted by the D.S.S.C. and forwarded to Nairobi for allocation.

The meeting resolved that the Vetting Committee present their list to the D.C. through the District Land Adjudication and Settlement Office, and each page of the harmonized list be signed by the D.C. for onward transmission to the Director of Land Adjudication and Settlement for further action.

**MIN.15/2011 – PLOT OCCUPANCY**

The meeting resolved that since much of the farm has been ploughed and planted, the beneficiaries would be shown their plots, but would only occupy them after the harvest.

There being no other business, the meeting was closed at 3.45 p.m. after closing prayers by Ms Kaitano.

1 OPENING REMARKS

The District Commissioner welcomed members of the public to the Baraza and conveyed the apologies of the area member of parliament. He said that the MP has promised CDF to Nowyapong Primary school, extend piped water from Phase II. He also confirmed that Simon Sidii had been appointed to be the member of CDF.

He further confirmed that the number of plots in Phase III has been increased from 625 to 900 to cater for more beneficiaries. He promised that the District Physical Planner is to plan the trading centers created in the scheme so that more people can be allocated the plots.

2 ELECTION OF VETTING COMMITTEE

The DC informed the Baraza that the agenda of the day was to elect vetting committee members for Phase III. He said that the committee is not paid and its work is purely voluntary to help the people.

CONCLUDING REMARKS

The DC confirmed that the communities have elected their representatives and announced them to the public. They were endorsed by the public.

He said that now that the committee has been elected by the people, nobody should alter the names.

He said that the government has given this land to help the poor, so the committee should not go round soliciting money from the beneficiaries.

1. THAT an order of CERTIORARI be granted to remove to the High Court and QUASH the decisions of the Districts Land Adjudication/Settlement Office Trans Nzoia County through an administrative arm known as "*the Panel of Vetting/Verification Committee*" the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> Respondents by themselves, or their agents, servants or personal assigns from encroaching, trespassing, alienating, wasting, interfering, transferring, allocating all that parcel of land situated at *Chepchoina Settlement Scheme* within Trans Nzoia County to other outsiders and/or strangers and from evicting the legal allottees.
2. THAT an order of PROHIBITION be granted against the decision of the District Land Adjudication/Settlement Office Trans Nzoia County through an administrative arm known as "*the Panel of Vetting/Verification Committee*" the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> Respondents by themselves, or their agents, servants or personal assigns from encroaching, trespassing, alienating, wasting, interfering, transferring, allocating all that parcel of land situated at *Chepchoina Settlement Scheme* within Trans Nzoia County to other outsiders and/or strangers and from evicting the legal allottee.

d) Finally it was also to achieve free co-existence with other communities.

5. THE settlement was to be achieved in two phases, whereby in 1994, Phase I was accomplished successfully without any hitch, but logistical challenges in carrying out survey and demarcation caused delay in actualizing Phase II of the settlement.
6. INTERESTINGLY the delay in the Phase II of the settlement created an opportunity for land grabbers and corrupt government officials to interfere with the activities of settlement of the intended beneficiaries, whereby foreigners and unintended persons would pay bribes to be illegally and wrongfully settled on the land at the expense of the rightful and deserving persons.
7. FURTHER the illegal improper and wrongful persons settled on the said land and were issued with forged allotment letters in an attempt to regularize their illegal actions.
8. FOLLOWING a public outcry and in an attempt to arrest the illegality, a *Verification Committee* was established to assist the land officers in verification of the genuine cases and identify correct allottees of the land and sensitize and trace original allottees.
9. THE said Committee was to come up with the original allotment letters, photocopy of documentation and subsequently secure the letters issued by the Ministry of Lands.
10. NOW the Provincial Administration want to justify the grabbers from outside the area for instance from Uganda, Nairobi among other areas who had been illegally allotted lands within the *Chepchoina Settlement Scheme* by issuing them with fake and/or forged documents and Agricultural Development Corporation papers generated by computerization to be settled on this land.
11. THE Respondents continue to perpetuate such illegal and unlawful acts to the detriment of the rightful beneficiaries of the scheme.

#### PARTICULARS OF THE ILLEGAL AND UNLAWFUL ACTS BY THE RESPONDENTS

- a). Purporting to settle over one hundred and fifty thousand (150,000) people mainly from neighboring Uganda nation into Kenya onto these lands at the expense of the deserving Kenya nationals.

- b). ~~Committing such misdeeds in exchange of colossal amounts of money.~~
- c). Abrogating their official powers and duties as they are in the process of illegally evicting the Petitioners and the community members they represent from their rightful and legally allotted land.

12. **INFACT** the Pokot Indigeneous Task Force on Land Claims has on 2<sup>nd</sup> September 2013 wrote to the Chairman of the National Land Commission demanding back their land upon the expiry of the 99 year land lease in Trans Nzoia.

13. **SHOULD** the orders in this Judicial Review not be granted as being extremely urgent, the Petitioners are apprehensive that the machinations and the motive perpetrated by the Respondents herein are to ensure that the Petitioner's rights to continue enjoying the rights and interests their legally allotted land are curtailed.

14. **IT** is to the interest of Natural Justice, Equity and Conscience that this suit is certified as urgent and the orders sought granted as should that not happen then the suit will have been declared nugatory and overtaken by events thereof.

WHICH APPLICATION is further grounded upon the annexed Affidavit of CHRISTOPHER KURUTYON LONYALA and upon further grounds and reasons to be adduced at the hearing hereof.

(Annexed herein and marked as "CKL - 2" and "CKL - 3" "a", "b", "c", "d", "e", "f", "g", "h", "i" and "j" are lists of these legal allottees of land within Chepchoina Settlement Scheme and a bundle of the allotment letters respectively).~~

6. THAT as indicated above, the whole of the suit land under the scheme initially belonged to the Agricultural Development Corporation (Hereinafter referred to as "ADC") under the Agricultural Development Corporation Act, Cap 444 of the Laws of Kenya.
7. THAT arising from a lot of dangerous cases of insecurity arising from rampant cattle rustling, landlessness and food shortage perpetrated and affecting the pastoralists communities within the Trans Nzoia, West Pokot, Mount Elgon and Turkana, in 1994 there was a Presidential Decree ordering the settlement of the Pokot, Sabaot, Luhya, and Turkana Communities onto the formerly Agricultural Development Corporation.
8. THAT further to the above stated information, I know for sure that the aforesaid scheme was a conventional scheme following the aforementioned Presidential decree to settle the *Pokot, Sabaot, Maasai, Luhya and Turkana* communities for the following reasons:-
  - a). Some of the members of these communities were in one way or the other affected by the construction of the *Turkwel* dam, which covered over 41,000 acres of grazing land and loss of vegetation.
  - b). Further we being mainly pastoralists communities who depended on livestock for their livelihood, cattle rustling/raiding was very rampant and there was need to have us change and adopt and/or embrace cultivation agricultural practices.
  - c). There was also need to increase to achieve food security and realization within our communities.
  - d). Finally it was also to achieve free co-existence with other communities.
9. THAT additionally, the other set of legal allottees to land on to the Chepchoina Settlement Scheme were landless persons who were granted their letters of Allotment by the Agricultural Development Corporation and Provincial Commissioner Ismael Chelang'a. (Annexed hereto and marked as "CK - 4" (a), (b), (c) and (d) are some of the letters of allotment issued)

7. THAT settlement was to be achieved in two phases, whereby in 1994, Phase I was accomplished successfully without any hitch, but logistical challenges in carrying out survey and demarcation caused delay in actualizing Phase II of the settlement. (Annexed herein and marked as "CKL-5" is a copy of a Report on the Chepchoina Land Saga 1994 -2013 by the Pokot Indigenous task force on land claims and Boundary Disputes).
8. THAT it will also be noted that the bulk and most of the legal allottees to the land in *Chepchoina Settlement Scheme* who were initially employees on permanent and pensionable basis to the Agricultural Development Corporation and hence by settlement acquired rightful interest title to this land.
9. THAT interestingly the delay in the implementation of the settlement of Phase II of the settlement created an opportunity for land grabbers and corrupt government officials to interfere with the activities of settlement of the intended beneficiaries, whereby foreigners and unintended persons would pay bribes to be illegally and wrongfully settled on the land at the expense of the rightful and deserving persons.
10. THAT therefore, the so called Settlement Scheme and process for Phase II became a cash cow which was infiltrated and marred by wanton abuse of office, malice, greed, arbitrariness, corruption, and integrity purporting to issue land of two and half (2 ½) acres to these people matters by the following:-
  - a). The Provincial Administration offices such as the District Commissioner, District Officer and Chiefs demanded for bribes to allocate one land or as they allocated to their friends and relatives they purported to be settling people on 2 ½ acres each.
  - b). The Agricultural Development Corporation officials forged letters at a fee.
  - c). Ministry of land Personnel and surveyors gave their land or their friends and relatives.
11. THAT of course the above illegal, wrongful and unreasonable process caused so much confusion, anarchy, threats on evictions to the already legally allottees to these land and hence almost leading to pouring of blood shed and fighting over these natural resources.
12. THAT arising from huge public outcry and complain on 24<sup>th</sup> April 2007 in order to arrest and ameliorate the grave situation a so called "Verification

~~grabbers from outside the area for instance from Uganda, Nairobi among other areas who had been illegally allotted lands within the Chepchoina Settlement Scheme by issuing them with fake and/or forged documents and Agricultural Development Corporation papers generated by computerization to be settled on this land and in the process then evicting the legal allottees. (Annexed hereto and marked as "CKL - 9" is a list of all these illegal land grabbers and allottees at the expense of the genuine and legal allottees).~~

18. THAT it is the Respondents pretending to be acting and implementing the decision of the Committee who continue to perpetuate such illegal and unlawful acts to the detriment of the rightful beneficiaries of the scheme.

#### PARTICULARS OF THE ILLEGAL AND UNLAWFUL ACTS BY THE RESPONDENTS

- a). Misusing the mandate and legal authority of the Verification Committee to sanction such illegalities, irregularities and wrongfulness in order to justify the settlement of the strangers and illegal allottees;
- b). Purporting to settle over one hundred and fifty thousand (150,000) people mainly from neighbouring Uganda nation into Kenya onto these lands at the expense of the deserving Kenya nationals.
- c). Committing such misdeeds in exchange of colossal amounts of money.
- d). Abrogating their official powers and duties as they are in the process of illegally evicting the Petitioners and the community members they represent from their rightful and legally allotted land.

19. THAT I am advised by my Advocates on record which advise I verily believe to be true that the Provincial Administration have no Constitutional nor any legal statutory mandate to be dealing on any land matters leave alone pretending to be allocation, transferring, wasting the suit land, evicting and/or settling anybody into the suit land herein.


20. THAT as an indication of their complaint and being aggrieved by these deeds, the Applicants as "*The Pokot Indigenous Taskforce*" vide a letter dated 10<sup>th</sup> August 2013 wrote to the Parliamentary Select Committee on Land complaining and expressing their disappointment and displeasure in the crude, unprofessional and awkward manner in which the said Verification Committee and the Respondents herein were handling the investigations into the





THAT infact, the Pokot Indegeneous Task Force on Land Claims has on 2<sup>nd</sup> September 2013 wrote another letter to the Chairman of the National Land Commission demanding back their land upon the expiry of the 99 year land lease in Trans Nzoia. (Annexed herein and marked as "CKL - 11" is a copy of the said letter).
22. THAT should the orders in this Application not be granted as being extremely urgent, the Petitioners are apprehensive that the machinations and the motive perpetrated by the Respondents herein are to ensure that the Petitioners/Applicants' rights to continue enjoying the rights and interests their legally allotted land are curtailed.
23. THAT it is to the interest of Natural Justice, Equity and Conscience that this Petition and the orders sought granted as should that not happen then the application will be declared nugatory and overtaken by events thereof.
24. THAT what is stated hereinabove is true to the best of my knowledge, save as to matters deponed to on information and belief, the sources and grounds whereof have been specified and set out.

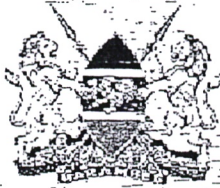


