## PREFACE

This is the 8<sup>th</sup> edition of the *Consolidated National Government Investment Report*. The report is compiled in compliance with Section 89 of the Public Financial Management Act, 2012. As in the earlier editions, the 2020/2021 FY edition provides information of the National Government involvement in State Corporations and Government Linked Corporations in four (4) main areas, namely (i) capital injection/equity participation; (ii) grants and subsidies; (iii) loans and guarantees; and (iv) revenue receipts.

This report has been prepared at the backdrop of the COVID-19 epidemic that resulted to disrupted business activities across all sectors of the economy, the effect of which was reduced disposable incomes and sluggish demand for goods and services. The State Corporation sector was not spared. The effect of the Covid 19 to the Kenyan economy accentuated long standing challenges in the State Corporations sector already characterized by low productivity, weak governance structures and going concern challenges. The effects of the Covid 19 pushed many State Corporations into financial distress and have sought government interventions to protect incomes, jobs and viability of the enterprises themselves.

To address the above challenges, the Government initiated a financial evaluation exercise on 19 State Corporations that were perceived to have the largest fiscal risk to the National Budget. It was envisaged that the evaluations will assist the Government take pro-active measures aimed at enhancement of the financial management and oversight of state enterprises and effective management of contingent liabilities. Other measures undertaken during the period included the development of the Strategy for Improving Financial Oversight of State Corporations. The objective of the Strategy is to enhance the National Treasury ability to anticipate, quantify, monitor, report, manage and mitigate fiscal risks from the State Corporation Sector and to build the National Treasury capacity to provide risk based oversight of State Corporations.

During the period under review, the National Treasury also took concrete measures on payment of pending bills by the State Corporation sector. This included the National Treasury directive to all CEOs of State Corporations to prioritize payment of Pending Bills and introduction of monthly reporting on the status of payment of outstanding obligations/pending bills by each State Corporation.

During the 2020/2021 FY, the National Treasury initiated the process of developing a Government Investments Management Information System (GIMIS). The System will help the National Treasury make good use of innovative IT solutions to improve the process of data collection, data analysis and reporting. The GIMIS will also enhance the transparency and completeness of State Corporations financial and operational performance and fiscal risk reporting. This is geared towards enhancing financial and operational oversight.

In 2020/2021 FY, internally generated funds by State Corporations stood at **Kshs. 677,932 million** compared with **Kshs. 674,627 million** in 2019/2020 FY. On the other hand, total transfers and subsidies to State Corporations in 2020/2021 FY was **Kshs. 377,990 million** in

2020/2021 FY comprising of **Kshs. 223,292 million** recurrent and **Kshs. 154,698 million** development. During 2020/2021 FY, profit/surplus declared by State Corporations increased by a big margin to **Kshs. 37,328 million** from a loss of **Kshs. 9,542 million** in 2019/2020 FY. The big increase was mainly attributed to NSSF that posted **Kshs. 35,015 million** surplus funds in 2020/2021 FY from **Kshs. 14,682 million** in 2019/20 FY, and Kenya Power that posted **Kshs. 943 million** profit in 2020/2021 FY from a loss of **Kshs. 7,508 million** in 2019/20 FY. The profit by Kenya Power was mainly attributed to cost containment measures and sealing of revenue leakages. During the review period, net assets increased marginally by 9.6 per cent from **Kshs. 2,986,717 million** in 2019/2020 FY to **Kshs. 3,281,881 million** in 2020/2021 FY. In 2020/2021 FY GOK received a total of **Kshs.49,570 million** from Government Investment in form of dividends, loans and interest payments and directors' fees.

Besides investment by way of shareholding, the National Government continued to provide resources for investment in hard infrastructure with a view to improving the productive capacity of the nation. During the year, loans procured by the State Corporations were mainly for Water sub-sector - **Kshs.20 billion**, and Energy sub-sector - **Kshs.13 billion**. These were loans procured on concessional terms by the government from development partners to support the development of key infrastructure in water & sewerage and energy. The total loan stock to State Corporations was **Kshs.1,236,337 million** as at 30<sup>th</sup> June 2021, of which total GoK loans amounted to **Kshs.944,511 million**. Of the GoK loans, an amount of **Kshs.569,023 million** relates to Kenya Railways Corporation. In 2020/2021 FY undischarged GOK guarantees decreased marginally from **Kshs.160,453 million** to **Kshs.157,220 million**, as a result of guaranteed entities meeting their obligations. On the other hand, contingent liabilities decreased from **Kshs.174,574 million** in 2019/2020 to **Kshs.108,552 million** in 2020/2021.

During 2020/2021 FY, the National Treasury continued in its efforts to institutionalize good governance in the management of public investments. In this regard and in order to get full value of public investments, the National Treasury issued Treasury Circular No. 20/2020 on Public Investments Management Guidelines. The purpose of the Guidelines is to provide a framework for an efficient and effective management of public investments. The Guidelines are designed to improve the management of public investments by ensuring that projects are thoroughly scrutinized and appraised and, only projects that have positive economic/social returns are pipelined for funding and implementation. The National Treasury also issued Treasury Circular No. 10/2020 on pending Bills. They were also required to put in place administrative measures to avoid further accumulation of pending bills. The National Treasury has also issued Guidelines on National Assets and Liabilities Management. The guidelines are aimed at promoting accountability on assets and liability management.

In line with the 2013 recommendations by the Presidential Taskforce to merger some State Corporations, the merger process is still on course albeit slow. In 2020/2021 FY the

Government did not complete the planned mergers, however the process of merging ICDC, TFC, and IDB Capital has been concluded in first quarter of 2021/2022 FY.

I wish to undertake that the government and National Treasury is desirous to undertake reforms in the management, operations, and governance of State Corporations to ensure they deliver on their mandate as well as make a reasonable return to the government.

As I conclude, I wish to thank all the Principal Secretaries as well as Chief Executive Officers of State Corporations for facilitating the submission of the required information in time. I also thank the Officers at the National Treasury who put in quality time and effort in ensuring that this report was ready within the set timelines.

Finally, I caution that these numbers are largely un-audited and therefore, care should be taken when using or interpreting them.

### **Legal Basis for the Consolidated National Government Investment Report**

The Consolidated National Government Investment Report is prepared in accordance with Section 89 of the Public Finance Management Act, 2012 which states as follows:

- (1) The Cabinet Secretary responsible for matters relating to public investments shall prepare and submit to the National Assembly, not later than four months after the end of each financial year, a consolidated report summarizing the extent of national government involvement or investment in, or funding of, all state corporations and government-linked corporations for that financial year.
- (2) The report under subsection (1) shall include information on-
  - a) the date of incorporation and objects of the corporation;
  - b) the amount of national government shareholding, directly or indirectly, in the state corporation;
  - c) any changes in the shareholding of the state corporation during the financial year;
  - d) the amount of any funding in the form of grants or subsidies provided by the national government to the state corporation or government-linked state corporations, excluding profit-making state corporation, during the financial year;
  - e) the amount of any loans made by the national government to the state corporation, and the amount of any guarantees issued by the national government in respect of the state corporation, during the financial year;
  - f) the cumulative amount of undischarged loans and guarantees in respect of the state corporation;
  - g) the amount of the profit/surplus or loss/deficit of the state corporation for the financial year;
  - h) the amount of any revenue received by the national government from the state corporation during the financial year, including dividends, interest and proceeds from any divestiture of assets of the state corporation;
  - i) the amount of payments made, or losses incurred, by the national government to meet contingent liabilities as a result of loans or guarantees during the financial year, including payments made in respect of guarantees, loan write-offs or waiver of interest on loans; and
  - j) An assessment of the financial and related non-financial performance of the state corporation for the financial year.
- (3) Once every three years, the Cabinet Secretary responsible for matters relating to public investments shall prepare a report on the assessment of the national government's continued involvement or investment in, or funding of, the state corporation or government linked corporation.
- (4) The Cabinet Secretary responsible for matters relating to public investments shall submit copies of the reports referred to in subsections (2) and (3) to the Cabinet Secretary, the Controller of Budget, the Commission on Revenue Allocation and to the Auditor-General

## State Corporations and Government Linked Corporations

1. The State Corporations Act, Cap 446, is the over-arching governing law on the establishment, fiduciary oversight on management and governance; and financial control of State Corporations.
2. State Corporations or Parastatals are legal entities established by Government or investments in which the government holds over fifty (50) per cent control or ownership. They implement priority government policies, projects and programmes in social, business and commercial sectors of the economy.
3. They are incorporated under the Companies Act or an enabling Act of Parliament in which whole or controlling shareholding belongs to the Government. State Corporations are therefore, distinct legal entities that are operationally autonomous from Government and may be self-financing through internally-generated funds, loans backed by their assets, partially funded or fully financed by the Exchequer.
4. State Corporations are categorized as commercial and non-commercial. Commercial State Corporations comprise:
  - a. Companies with GoK shareholding, through the Cabinet Secretary to the National Treasury as a body corporate, of more than 50%;
  - b. A body Corporate established to perform a strategic function profitably,
  - c. An entity that generally operates on commercial principles,
  - d. Generally self-financing and sustaining, except in financing investment for public policy objectives; and
  - e. Accountable to all stakeholders and the public through the relevant departmental and oversight committees of Parliament.
5. For the Commercial State Corporations with “public goods” mandate, the GoK is required to meet the full cost of those “public good” activities using budgetary resources approved by Parliament.
6. Non-Commercial State Corporations are expected to operate on a cost recovery basis and largely depend on monies appropriated by Parliament, levies and fees. They include regulatory agencies and statutory boards; research institutions; institutions of higher learning and referral hospitals. Non-Commercial State Corporations deliver services on behalf of line Ministries and are funded mainly through the National Budgets in form of grants or loans from the Government.
7. Besides State Corporations, the Government also invests in other organizations, commonly referred to as Government Linked Corporations (GLC). GLCs are entities in which the Government’s shareholding is fifty (50) per cent and below. The Government participates in GLCs primarily to correct market failures and also partake in profit sharing in profitable enterprises to augment public resources.
8. The investments in GLCs in particular target perceived high risk investments from the private sector perspective, but in themselves have a high impact to the economy.

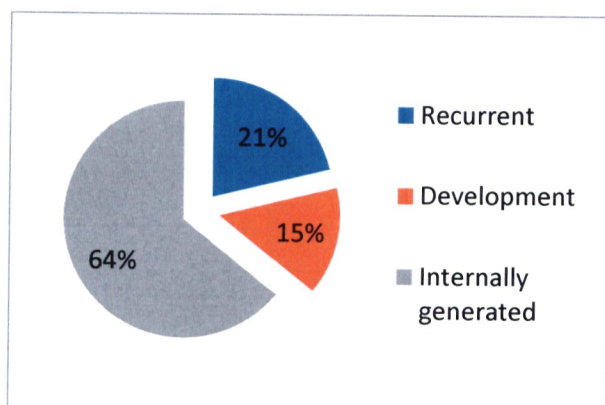
## I. Status of Government Involvement in State Corporations in 2020/2021 FY

1. A summary of the National Government involvement in Public Investments is as summarized in Schedule A. In 2020/2021 FY, the total GOK shareholding in nominal terms remained largely unchanged compared to the previous year at **Kshs. 103,462 million**.
2. The total revenues (internally generated funds) increased by 0.5 per cent from **Kshs. 674,742 million** in 2019/2020 FY to **Kshs. 677,932 million** in 2020/2021 FY. The total assets increased by 4.7 per cent from **Kshs. 5,216,893 million** in 2019/2020 FY to **Kshs. 5,462,671 million** in 2020/2021 FY. The increase is mainly attributed to the growth in infrastructure development projects under roads, energy, ICT and water. In the roads sector.

## II. Grants and Subsidies

3. Total grants and subsidies to State Corporations in 2020/2021 FY was **Kshs. 377,990 million**, a marginal increase from **Kshs. 374,250 million** in 2019/2020 FY. During 2020/2021 FY, 41% of total Government grants was for development while 59% was for recurrent. The total GOK grants to State Corporations accounted for 36% of total revenue while internally generated revenue was **Kshs. 677,932 million** in 2020/2021 FY.

Gov't Grants and Subsidies 2020/2021

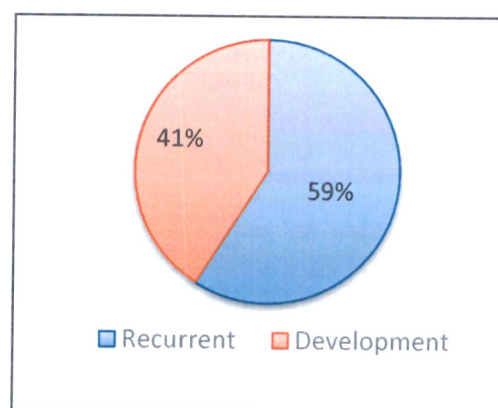
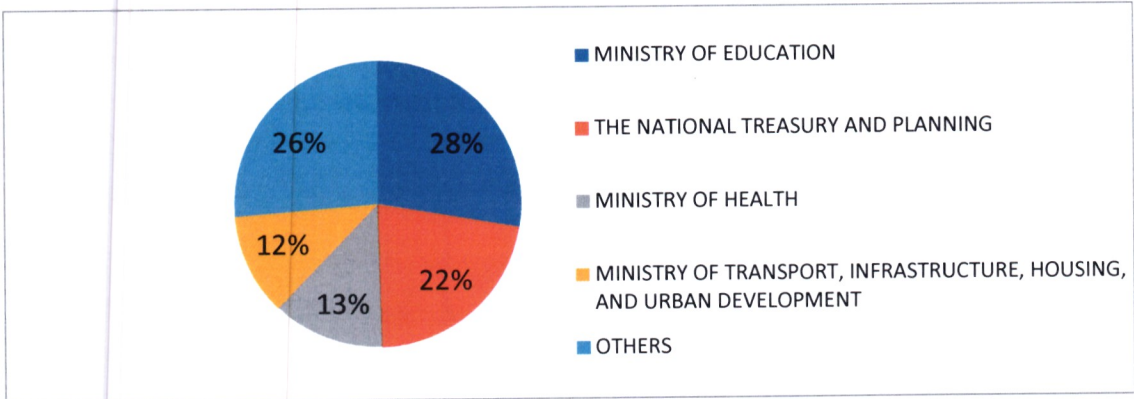


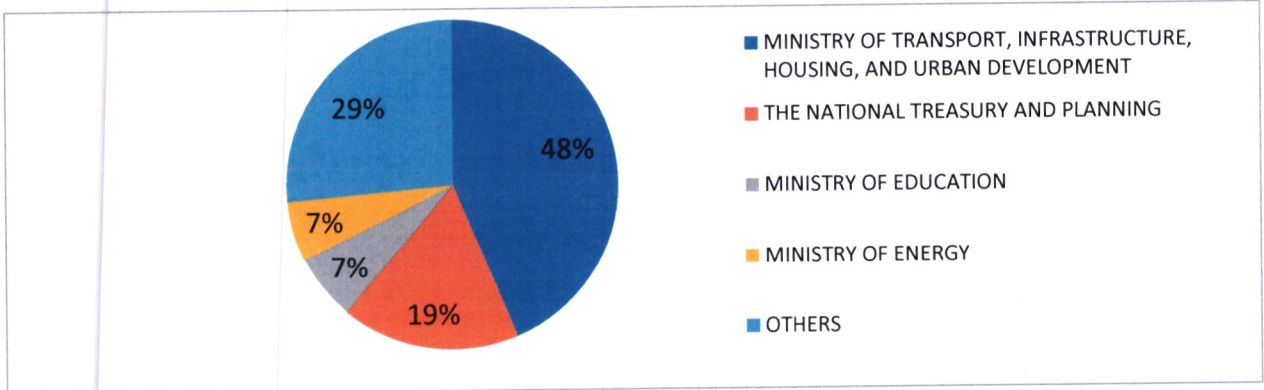
Figure 1: Internally Generated Revenue, GOK grants and subsidies in 2020/2021 FY

4. The State Corporations under the Ministry of Education received the highest transfers of recurrent grants at **Kshs. 61,824 million** in 2020/2021 FY accounting for 28% of total allocation. This allocation was mainly to public universities. State Corporations under The National Treasury and Planning received recurrent grants amounting to **Kshs 48,932 million**, accounting for 22% of total allocations. The Government recurrent grant to State Corporations under selected Ministries 2020/2021 FY.

5. In 2020/2021 FY, allocation of Government Development Grants to State Corporations under the Ministry of Transport, Infrastructure, Housing and Urban Development accounting for 48% of the total allocation at **Kshs. 74,806 million**. State corporations under The National Treasury and Planning received 19% of Development Grants in 2020/2021 FY at **Kshs 29,714 million** while those under the Ministry of Education and Ministry of Energy received 7% each. The remaining 29% was allocated to State Corporations in the other ministries. Government Development Grant to State Corporations under selected Ministries 2020/2021 FY is as indicated below in **Figure 3**: -

**III. Financial Performance**

6. Financial reporting by Commercial State Corporations is in accordance with the International Financial Reporting Standards (IFRS) while financial reporting by non-commercial State Corporations reports is in accordance with International Public Sector Accounting Standards (IPSAS). Consequently, commercial State Corporations reports as either having made a profit/loss while the non-commercial and regulatory bodies report a surplus/deficit. During 2020/2021 Financial Year, State Corporations posted accumulated profits/surplus amounting to **Kshs.37,328 million** compared to a loss of **Kshs.9,541 million** posted in 2019/2020 Financial Year. Commercial

State Corporations in 2020/2021 Financial Year posted net losses amounting to **Kshs.12,590 million** compared to a loss of **Kshs.38,085 million** posted in 2019/2020 Financial Year. The net loss is largely attributed to the continued loss-making trend by Kenya Railways Corporation (KRC) which posted a net loss of **Kshs.24,009 million** in 2020/2021 Financial Year compared to **Kshs.24,178 million** posted in 2019/2020 Financial Year. In the loss-making category was also Kenya Airport Authority that posted net loss of **Kshs.7,085 million** in the period under review. The State Corporations in the Ministry of Labour and Social Protection, Ministry of Energy, and Ministry of Treasury and Planning posted the highest profit/surplus at **Kshs.35,132 million**, **Kshs.19,297 million**, and **Kshs.15,547 million** respectively in 2020/2021 Financial Year.

#### IV. National Government Loans and Guarantees to State Corporations

7. The National Treasury has guaranteed a number of loans to State Corporations and Government linked Corporations. Details of outstanding guarantees as at June 30,2021 is tabulated below: -

8. As at June 30, 2021 total outstanding Government guaranteed debt was **Kshs.157,220 million** a decrease from **Kshs. 160,453 million** as at June 30, 2020. The decrease was mainly attributed to the repayment of the guaranteed loans by KenGen and KPA. During the 2020/21 FY, no call-ups were made to the National Treasury for settlement of guaranteed debt.
9. Total undischarged GOK loans to State Corporations stood at **Kshs.944,511 million** by the end of 2020/2021 FY compared with **Kshs. 933,599 million** in 2019/2020 FY. The increase was attributed to loans procured by the Government and on-lent to several entities among them; KenGen, and Athi Water Works Development Agency. Kenya Railways had the highest stock of undischarged GOK on-lent loans at **Kshs.569,023 million**.

#### V. Contingent Liabilities

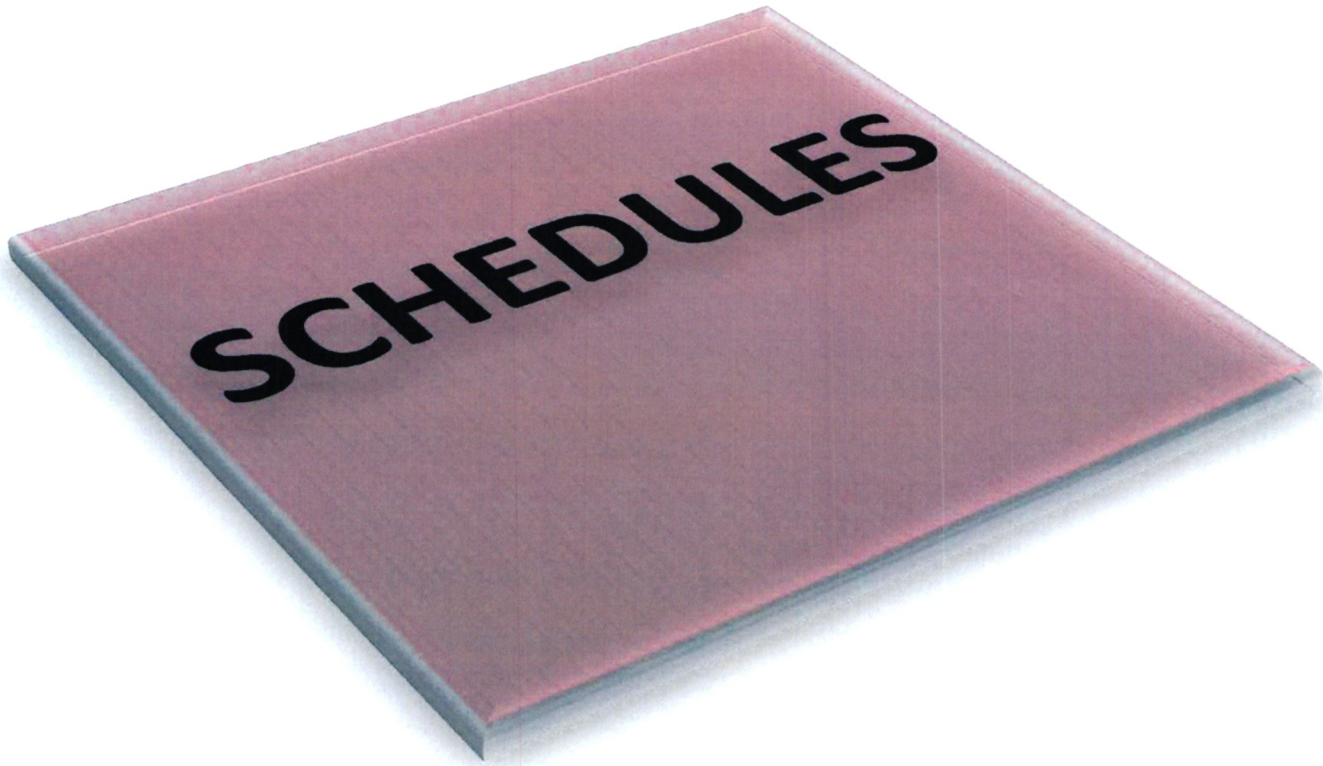
10. As the principal owner of all State Corporations, the Government is the natural underwriter of risk that they face. Analysis of contingent liabilities therefore, is important in understanding the extent of the Government fiscal risks exposure.
11. Contingent liabilities are potential liabilities that may occur depending on the outcome of uncertain future event and are generally not shown in the statement of financial position, but must be given

adequate disclosure. However, a contingent liability is only recorded in the financial statements if the contingency is probable and the amount of the liability can reasonably be estimated. Contingent liability can be explicit or implicit. Explicit contingent liabilities are specific government obligations established by law or a contract authorized by law. The government is legally mandated to settle such an obligation when it becomes due. On the other hand, implicit contingent liabilities represent a moral obligation or expected burden for the government not in the legal sense, but based on public expectations and political pressures e.g. GOK intervention in revival of Kenya Airways.

12. In 2020/2021 Financial Year, exposure in form of contingent liabilities was **Kshs.108,552 million** compared with **Kshs. 174,574 million** in 2019/2020 Financial Year. Out of the **Kshs. 108,552 million** total contingent liabilities, **Kshs. 40,000 million** was attributed to Kenya Broadcasting Corporations over claims that it breached a contract regarding the launching of a TV channel II and the digital migration process.

#### **VI. Revenue Receipts by National Government from State Corporations and Government-Linked Corporations**

13. The receipts by the National Treasury from State Corporations and Government-linked companies are in form of dividends, loan repayments, and interest on loans, surplus remittances and director's fees. In 2020/2021 Financial Year, total receipts by National Treasury amounted to **Kshs.49,570 million**. Receipts from dividends, surplus funds and directors' fees during this period were **Kshs.41,474 million** representing 84 per cent of total receipts. The highest amount of dividend was from Safaricom at **Kshs. 25,942 million**.
14. During the year under review, revenue receipts by Government from State Corporations in respect of Loan Repayment and Interest Charges amounted to **Kshs.6,048 million** and **Kshs.2,048 million** respectively.
