

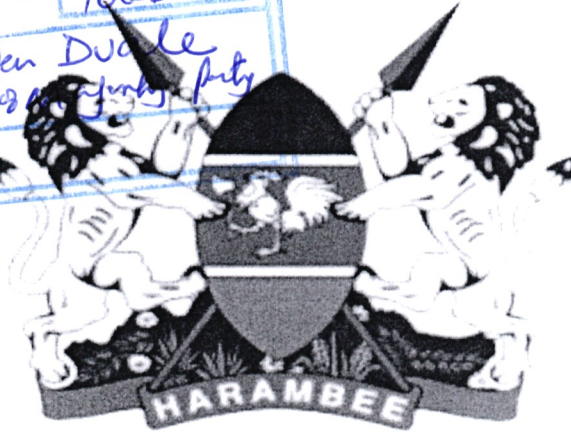

EXECUTIVE SUMMARY

Introduction

The Public Finance Management (PFM) Act 2012 Section 38 (1) (f) requires the Cabinet Secretary to submit to the National Assembly a statement specifying the measures taken by the National Government to implement any recommendation made by the National Assembly with respect to the budget for the previous financial year or years.

The National Treasury received the Public Accounts Committee (PAC) recommendations on the accounts of financial year 2015/2016 and thereafter requested Accounting Officers for Ministries, Departments and Agencies (MDAs) to implement recommendations made and submit actions taken within three months as required by the PFM Act 2012. This report contains general observations and responses received from the Accounting Officers on the implementation status of Public Accounts Committee recommendations.

1.0 General Observations

1.1 Budget Under Expenditure (Under Absorption)

Budget execution involves several aspects of planning, resource mobilization, realization and activity scheduling. The National Treasury expectation is that revenue targets would be achieved within the financial year as planned and exchequer issued for the voted provisions. However, revenue receipts may be affected by unforeseen circumstances which affect funding of activities slowing absorption.

To help alleviate budget under absorption the government has put in place measures on effective cash management through automation of revenue collection by Kenya Revenue Authority (KRA), project mapping and prioritization to curb duplication of projects and release tied up funds. This will sort out perennial budget under absorption.

1.2 Outstanding Imprest

The PFM Act 2012 and PFM Regulations 2015 have put in place regulations to manage advances including imprest. Accounting Officers are urged to implement guidelines put in place to avoid un-accounted for imprest and to recover as a priority outstanding imprest with interest existing at CBK rates. Annual circulars are issued on management of available finances including issuance and management of imprest and advances.

1.3 Pending Bills

During the year ended 30th June 2016, the Government Ministries and Departments made spirited effort to clear pending bills from 43.21 billion in 2015 to 20.4 billion

representing a decrease in pending bills of 53%. The Government is in the process of paying genuine pending bills and has put strategies for settlement of future obligations in a timely manner. Pending bills at the close of a financial year should make the first charge in the subsequent year's budget provisions to ensure prompt effective impartial and equitable provision of service envisaged in Section 7 of the public Service Act, 2015.

1.5 Maintenance of Accounting Records and presentation of Financial Statements

The National Treasury is mandated to put in place financial management system that improves effectiveness and efficiency in utilization of public funds. The National Treasury has upgraded capacity of the Integrated Financial Management Information System (IFMIS) to enable fast processing of data and safeguard the data integrity. National Treasury continuous to build skills of accounting staff on annual basis by training them on financial reporting both at National and County levels. Physical accounting records are maintained by respective accounting units which are guided by Regulation 100 and 119 of the PFM Act Regulations (2015)

1.6 Fixed Assets

In the past the government has been using cash based accounting method which discloses fixed assets and liabilities as an appendix to the main financial statements, this practice has continued to influence some MDAs over time.

The Public Sector Accounting Standard Board (PSASB) is in the process of developing a policy framework for recognition, valuation and recording of all public assets. This will require roll out of standards and guidelines on adaption of accrual based accounting standard which is planned to be effected in the financial year 2021/2022.

This will harmonise and standardise valuation, reporting and maintenance of asset registers. The National Treasury has established Assets and Liabilities Management Unit to register all Government assets and come up with policy guidelines on treatment of all categories of government assets.

1.7 Integrated Financial Management Information System (IFMIS)

The National Treasury has continuously re - engineered the IFMIS system and modified the existing modules to cater for expanded volume of data for both National and County government. This has created space, enhanced effectiveness and efficiency in data capture, processing and storage. Integrity of government data is an important aspect of financial management which calls for a reliable system which is not manipulate able. Audit on the IFMIS to determine its efficacy is carried out regularly and improvement done where necessary.

2.0 Statement on Outstanding Public Debt

The PFM Act (2012) requires the Cabinet Secretary, National Treasury to table a statement on the state of public debt outstanding at the end of every financial year. This is done annually and the statement submitted to National Assembly and to the Office of the Auditor General in line with legal timelines.

2.1. Statement on Audited Accounts of Revenue for the period ending 30th June 2016

The arrears of revenue due and uncollected increased from Kshs. 194,951,716,541.16 (approximately Kshs. 195 billion) as at 30th June 2015 to Kshs.380,600,178,374 (approximately Kshs. 381 billion) as at 30th June, 2016. The revenue arrears balance of Kshs.380,600,178,374 as at 30th June 2016 is made up of arrears for PAYE and other Income Tax of Kshs.295,096,178,722, arrears for VAT and Excise Taxes of Kshs. 47,717,166,529, arrears for loan redemptions of Kshs. 13,003,682,478 and arrears for loan interests of Kshs. 24,783,150,645. Collection of arrears of revenue is a continuous process and therefore as some arrears are being cleared additional debts arise through the following: -

2.1.1 Self-Assessment/VAT Penalties

- a. When returns of income are submitted, debt is created and debited in the period of year of income for Income Tax. Applicable interest and penalties are appropriately charged.
- b. Default penalties are charged on monthly basis where returns have not been submitted for

VAT

2.1.2 Additional Assessments

Additional assessments are issued when tax audit and investigations are concluded in various tax heads.

2.1.3 Estimated Assessments

Estimated assessments are issued when taxpayers have not submitted self-assessment returns or have not made declaration of income and tax due.

2.1.4 Accrual of Interest

For any outstanding tax balances, interest continue to accrue at 2% per month compounded up to 100% of the outstanding principal tax.

2.2 Demonstrable Efforts in Collecting Revenue Arrears

The Cabinet Secretary, National Treasury and the relevant institutions have made demonstrable efforts in collecting and accounting for tax revenue arrears for PAYE and Other Income Tax. The tax policy, reforms and administrative measures all geared towards collecting the arrears of revenue due and uncollected; sealing revenue loopholes; leveraging on ICT to harness the country's revenue potential, and use of alternative disputes resolutions (ADR) mechanism to resolve revenue related disputes.

Other measures put in place to address the increase in arrears of revenue are as follows:-

2.2.1 Demand Notice is issued on Tax that is not in dispute

This is the effective method commonly used.

2.2.2 Agency Notices

This is an enforced method used to collect tax from third parties where tax payers fail to pay when demand notice is issued.

2.2.3 Collection by Distrain

The commissioner appoints a Distrain Agent who is usually an Auctioneer/Bailiff to levy distress on the assets of the tax defaulter.

2.2.4 Use of Caveats/Charges on the Debtors Property

Commissioner of lands creates a caveat/charge debtors' property on request by the Commissioner of taxes. The caveat is not lifted until the outstanding tax is paid in full.

2.3. Waiver of Interest and Penalties

Upon request by the tax payer, the Commissioner General or the Cabinet Secretary for The National Treasury may waive interest and penalties either wholly, partly or reject depending on the mitigating factors advanced by the tax payer.

2.4 Write off/Abandonment of Tax

The Cabinet Secretary for the National Treasury may write off or abandon collectable tax on recommendation by the Commissioner General whereby the tax has become irrecoverable due to various convincing reasons.

3.0 IMPLEMENTATION STATUS ON PUBLIC ACCOUNTS COMMITTEE RECOMMENDATIONS FOR FINANCIAL YEAR 2015/2016

The Report of Public Accounts Committee on the Government of Kenya Accounts for the financial year 2015/2016 was tabled on the floor of National Assembly and adopted on 4th June 2019. The adopted report was received at the National Treasury on 14th June, 2019 vide letter Ref No. NA/DLP/TBO/RES.12/2019 dated 7th June, 2019.

The National Treasury vide letter Ref. No. AG.18/01/Vol. 14/ (87) of 1st August, 2019 advised the Accounting Officers to commence implementation of the Public Accounts Committee recommendations on paragraphs relating to their votes and thereafter submit a status report on the implementation to enable National Treasury prepare the Treasury Memorandum.

The responses from Ministries/Departments/Agencies were slow while in some cases inadequate information was provided, National Treasury had to keep reminding them. Failure by the ministries and State Departments to submit the status reports as required caused delay in the preparation of the Treasury Memorandum.

Responses from MDAs were received and captured in a tabular format indicating title of MDA, paragraph number, recommendation made and action taken to make the Treasury Memorandum for the financial year 2015/2016 as shown on pages 1 – 222.

Pursuant to section 38 subsection 1 (f) of the public Finance Management Act 2012, which requires the National Treasury to prepare a statement specifying measures taken by the national Government to implement any recommendations made by the National Assembly with respect to the budget for the previous financial years, the Treasury memorandum for the financial year 2015/2016 is hereby submitted.
