
DEPLOYMENT

REPORT TO THE NATIONAL ASSEMBLY ON THE DEPLOYMENT OF KENYA DEFENCE FORCES AT THE LIKONI CHANNEL, MOMBASA PURSUANT TO ARTICLE 241(3)(b) OF THE CONSTITUTION OF KENYA, 2010 AND SECTION 31(2) OF THE KENYA DEFENCE FORCES ACT

REASONS FOR DEPLOYMENT

On 29th September 2019, at the request of the Kenya Ferry Services Limited, the Kenya Defence Forces was deployed at the Likoni Channel, Mombasa County, to assist in a complex operation arising from an accident in which a civilian motor vehicle occupied by two passengers plunged into the Indian Ocean.

The Kenya Defence Forces through the Kenya Navy deployed specialized teams of divers and a boat unit on the same day. The operation is still on going.

PERIOD FOR WHICH THE KENYA DEFENCE FORCES IS EXPECTED TO BE DEPLOYED

The duration of the deployment of the Kenya Defence Forces at the Likoni channel will be determined by the exigencies of the operation and the National Security Council.

EXPENDITURE EXPECTED TO BE INCURRED

The expenditure to be incurred during the deployment shall be defrayed from the funds voted to the Ministry of Defence by the National Assembly for the Financial Year 2019/2020.
