

## 2.0 EXECUTIVE SUMMARY

This report contains the Committee's proceedings during the approval hearing of the nominees for the positions of Principal Secretaries for the Ministry of Devolution and ASAL and the State Department of Planning as requested by H.E the President and communicated to the House by the Speaker on Tuesday 13<sup>th</sup> February, 2018. The following were the nominees: -

1. Dr. Julius Monzi Muia - Nominee for Principal Secretary, Planning
2. Mr. Nelson Marwa Sospeter - Nominee for Principal Secretary, Devolution

During the approval hearings the nominees appeared before the Committee on **Wednesday 21<sup>st</sup> February, 2018** and the Committee examined their suitability based on the criteria set out by the Public Appointments (Parliamentary Approval) Act of 2011.

The nominees were interviewed on their education background, relevant experience, knowledge of sector issues and leadership and integrity.

The Clerk of the National requested for memoranda from the Public on suitability or otherwise of the nominees. However, by the close of deadline for submission, no memoranda had been submitted.

The Committee found the two nominees suitable for appointment having demonstrated so during the vetting exercise.

### 3.0 MANDATE OF THE COMMITTEE

The Departmental Committee on Finance & National Planning is one of the twelve Departmental Committees of the National Assembly established under *Standing Order 216* whose mandates pursuant to the *Standing Order 216 (5)* are as follows:

- a) To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- b) To study the programme and policy objectives of Ministries and departments and the effectiveness of their implementation;
- c) To study and review all the legislation referred to it;
- d) To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
- e) To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
- f) To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No.204 (Committee on appointments);**
- (fa) To examine treaties, agreements and conventions;
- g) To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
- h) To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
- i) To examine any questions raised by Members on a matter within its mandate.

In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider, Public finance, Monetary policies, Public debt, Financial institutions (excluding those in securities exchange), Investment and divestiture policies, Pricing policies, Banking, Insurance, Population revenue policies including taxation and National planning and development.

In executing its mandate, the Committee oversees the following government Ministries, namely:

- i. The National Treasury and Ministry of Planning and its SAGAs
- ii. Ministry of Devolution and ASAL and its SAGAs
- iii. Salaries and Remuneration Commission
- iv. Commission on Revenue Allocation
- v. Office of the Controller of Budget

### **3.5 COMMITTEE RECOMMENDATIONS**

The Committee having held approval hearings of the nominees regarding their suitability, observed that due process was followed on the recruitment process as provided for under the Article 155(3) (b) of the Constitution, the Public Appointments (Parliamentary Approval Act) (No.33 of 2011) and the evidence presented to the Committee and therefore found Dr. Julius Monzi Muia and Mr. Nelson Marwa Sospeter suitable and qualified to serve in the positions of Principal Secretary Planning, the National Treasury and Principal Secretary Devolution, Ministry of Devolution and ASAL respectively.

## **4.0 INTRODUCTION**

### **4.1 Message from H. E. the President**

Pursuant to Standing Order 42 (1), the Speaker on **Tuesday 13<sup>th</sup> February, 2018** communicated to the House a message from H.E. the President regarding the nominees to the positions of Principal Secretary Planning and Principal Secretary Devolution.

The Speaker further informed the House that H.E. the President was seeking the approval of the National Assembly on the said nominations before appointment.

In accordance with Standing Order 42(3) (c) the Speaker having read the Message from the President referred the names of the nominees together with their curriculum vitae to the Departmental Committee on Finance and National Planning to conduct approval hearings. The Speaker advised the Committee to conduct extensive public participation as provided for under Article 118 of the Constitution as well as the Public Appointment Parliamentary Approval Act (No.33 of 2011) and report to the House within 14 days.

### **4.2 Nomination and appointment process**

Article 155 (3) of the Constitution provides for the process through which the position is recruited. The Constitution provides that the recruitment of officers to public office should be conducted in a competitive, transparent and fair process before nomination for appointment by H.E. the President with the approval of the National Assembly.

The National Assembly having received the names of the nominees is obligated to conduct approval hearings and make a determination of the nominees' suitability or otherwise within fourteen days as provided for in section 8 (1) of the Public Appointments (Parliamentary Approval Act) (No.33 of 2011).

### **4.3 Committee proceedings**

During the approval hearings, the Committee held a total of three Sittings to examine and review the nominees' certificates, testimonial, consider public views and hold vetting meeting with the nominees.

## 5.0 BACKGROUND INFORMATION

### 5.1 Legal framework

1. Article 155 of the Constitution provides as follows—

*155. (1) There is established the office of Principal Secretary, which is an office in the public service.*

*(2) Each State department shall be under the administration of a Principal Secretary.*

*(3) The President shall—*

*(a) nominate a person for appointment as Principal Secretary from among persons recommended by the Public Service Commission; and*

*(b) with the approval of the National Assembly, appoint Principal Secretaries.*

*(4) The President may re-assign a Principal Secretary.*

*(5) A Principal Secretary may resign from office by giving notice, in writing, to the President.*

2. In light of this, H.E. the President has nominated the following persons for appointment as Principal Secretaries for Devolution and Planning;
  - i) Dr. Julius Monzi Muia - Nominee for Principal Secretary, Planning
  - ii) Mr. Nelson Marwa Sospeter - Nominee for Principal Secretary, Devolution

The Departmental Committee on Finance and National Planning has been assigned the role of conducting the vetting of the aforesaid nominees.

The following statutes/provisions will be paramount to the Committee as it executes this mandate:

- (i) The Public Appointments (Parliamentary Approval) Act (No. 33 of 2011);
- (ii) Chapter 6 of the Constitution on leadership and integrity;
- (iii) Article 232 of the Constitution on values and principles of public service;
- (iv) Article 10 of the Constitution on the national values and principles of governance;
- (v) The Leadership and Integrity Act (Cap. 182);
- (vi) The Public Service (Values and Principles) Act (No. 1A of 2015)
- (vii) The Public Officer Ethics Act (Cap. 183)

***The Public Appointments (Parliamentary Approval) Act (No. 33 of 2011)***

Section 7 of the Public Appointments (Parliamentary Approval) Act, Chapter 136 (PAPAA), provides for issues which the relevant House of Parliament (in this case, the National Assembly) is supposed to consider in relation to any nomination. These issues include:

- a) the procedure used to arrive at the nominee;*
- b) any constitutional or statutory requirements relating to the office in question; and*
- c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.*

Although the constitution does not specifically provide for the qualifications for appointment (or nomination) of a Principal Secretary, the schedule to the Public Appointments (Parliamentary Approval) Act provides for the criteria to guide the Committee. These are:

- Education, employment record;
- Public office, political activities and affiliations;
- Deferred income or future benefits;
- Sources of income, tax status, statement of net worth;
- Potential conflicts of interest;

- Pro bono or charity work;
- Whether the nominee has been charged in a court of law or convicted;
- Adverse mention in an investigatory report of a Parliamentary Committee or Commission.

During the approval hearing, section 6 of the Public Appointments (Parliamentary Approval) Act (PAPAA) provides important points, viz:

- ❖ An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background (section 6(7), PAPAA)
- ❖ The criteria specified in the Schedule shall be used by a Committee during an approval hearing for the purposes of vetting a candidate (section 6(8), PAPAA)
- ❖ Any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated (section 6(9), PAPAA)
- ❖ A candidate may, at any time, by notice in writing addressed to the Clerk, withdraw from the approval process and the candidate's nomination shall end (section 6(10), PAPAA).

### ***Chapter 6 of the Constitution (Leadership and Integrity)***

There are important provisions in Chapter 6 of the Constitution worth pointing out. Article 73 of the Constitution provides that the authority assigned to a State officer (a Principal Secretary being a state officer under Article 260 of the Constitution) is a public trust to be exercised in accordance to the Constitution, demonstrate respect for the people, bring honour to the nation and dignity to the office and promote public confidence in the integrity of the office. Also, the State officer shall have the responsibility to serve the people, rather than the power to rule them.

The guiding principles of leadership and integrity are listed as selection based on personal integrity, competence and suitability, objectivity and impartiality in decision making, selfless service based solely on the public interest, accountability and discipline and commitment in service to the people.

***The Leadership and Integrity Act***

The Leadership and Integrity Act provides a number of obligations to a State officer. These are, among others: to respect and abide by the Constitution and the law, public trust, performance of duties in an honest and accountable manner, professionalism, financial integrity, not to engage in activities that amount to abuse of office, not misuse public resources, accepting gifts that may compromise the officer's duties, wrongful or unlawful acquisition of property, conflict of interest e.t.c.

***Article 232 of the Constitution on Values and Principles of Public Service***

Article 232 of the Constitution provides for the values and principles of public service which include high standards of professional ethics; efficient, effective and economic use of resources; responsive, prompt, effective, impartial and equitable provision of services; involvement of the people in the process of policy making; accountability for administrative acts; transparency and provision to the public of timely, accurate information; fair competition and merit as the basis of appointments and promotions; representation of Kenya's diverse communities; and affording adequate and equal opportunities for appointment, training and advancement, at all levels of the public service of men and women; the members of all ethnic groups; and persons with disabilities.

***Article 10(2) of the Constitution on national values and principles of governance***

Article 10(2) of the Constitution provides for the national values and principles of governance which include patriotism, national unity, sharing and devolution of power, the rule of law, democracy and participation of the people; human dignity,

equity, social justice, inclusiveness, equality, human rights, non-discrimination and protection of the marginalised; good governance, integrity, transparency and accountability; and sustainable development.

***The Public Service (Values and Principles) Act***

Section 5 of the Public Service (Values and Principles) Act provides that a public officer shall maintain high standards of professional ethics, including, being honest; displaying high standards of integrity, transparency, accountability, respect to others, objectivity, patriotism, observance of rule of law. (Applies in future upon appointment)

***The Public Officer Ethics Act***

The Public Officer Ethics Act provides for obligations to be carried out by a public officer. These include professionalism, carrying out duties in accordance with the law, prohibition from unjust enrichment, avoiding conflict of interest, not using office as a venue for soliciting or collecting harambees; not acting for foreigners; care of property; political neutrality, not practicing nepotism or favouritism, giving impartial advice, conducting private affairs in a way that maintains public confidence, bar from sexual harassment, submission of declaration of income, assets and liabilities once every two years (section 26). (Applies in future after appointment)

**5.2 Qualifications for appointment of Principal Secretaries**

In conducting the Approval hearing, the Committee was guided by Article 155 (3) (b) of the Constitution, and the provisions of Section 7 of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011.

Article 73 of the Constitution provides that: (2) The guiding principles of leadership and integrity include— (a) *selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;* (b) *objectivity and impartiality in*

*decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices; (c) selfless service based solely on the public interest, demonstrated by— (i) honesty in the execution of public duties; and, (ii) the declaration of any personal interest that may conflict with public duties; (d) accountability to the public for decisions and for decisions and actions; and (e) discipline and commitment in service to the people.*

### **5.3 Message from H.E the President**

H. E the President on **Monday, 29<sup>th</sup> January, 2018** communicated the names of the nominees for the positions of Principal Secretary Planning and Principal Secretary Devolution to the Speaker for approval by the National Assembly pursuant to Article 115 (3) (b). The Speaker in his communication from the Chair issued on **Tuesday, 13<sup>th</sup> February, 2018** and pursuant to Standing Order No. 42 referred the names to the Departmental Committee on Finance and National Planning to conduct approval hearings and report within 14 days.

### **5.4 Notification to the nominees and 6 Clearance requirements**

The Clerk of the National Assembly vide letters **ref. NA/DC/FNP/2018 dated 14<sup>th</sup> February, 2018** wrote to the nominees informing them of their nomination by H.E The President and requested them to appear for vetting by the Departmental Committee on Finance and National Planning on **Wednesday, 21<sup>st</sup> February, 2018** in Committee Room 7, Main Parliament Buildings at 9:00 am and 10.30 am respectively. The Clerk further requested the nominees to bring with them clearance certificates from the Kenya Revenue Authority (KRA), the Higher Education Loans Board (HELB), Ethics and Anti-Corruption Commission (EACC), Office of the Registrar of Political Parties and Directorate of Criminal Investigations.

The Clerk also wrote to the Kenya Revenue Authority (KRA), the Higher Education Loans Board (HELB), Ethics and Anti - Corruption Commission (EACC) and Directorate of Criminal Investigations requesting for tax, loans, integrity and criminal record status of the nominees. The institutions wrote back to the National Assembly as follows;

1. The Kenya Revenue Authority (KRA) (letter Ref: KNA2/4/2018 (47)), the Directorate of Criminal Investigations (DCI) (letter Ref; DCI/CRO/SEC/6/7/2/A/VOL.VI/12), the Ethics and Anti-Corruption Commission (EACC) (letter Ref: EACC.7/10/5 VOL.V (102)) and the Higher Education Loans Board (HELB) (letter Ref: HELB/RR/112009/V/64) cleared both candidates.
2. The Office of the Registrar of Political Parties (ORPP) (letter Ref; RPP/ORG/34 Vol.II(13)) confirmed that both candidates were not members of a registered political party.

### **5.5 Request for Memoranda and Notification to the public**

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that *“any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated”*.

The Clerk of the National Assembly on **Wednesday, 14<sup>th</sup> February, 2018** placed a notification in the print media informing the general public of the intention of the Committee to conduct approval hearings, as provided for by Article 118 (1) (a) (b) and (2) of the Constitution and Section 6(4) of the Public Appointments (Parliamentary Approval) Act, (No.33 of 2011), which allows public participation in committee proceedings. The notification gave provision for the submission of memoranda, on the suitability or otherwise of the nominee, by **Tuesday, 20<sup>th</sup> February, 2018, at 5.00 pm**.

### **5.6 Submission of memoranda**

At the close of business **Tuesday, 20<sup>th</sup> February, 2018**, the Office of the Clerk, had not received an affidavit contesting the suitability of the two nominees.

## **6.0 APPROVAL HEARINGS**

The Committee conducted approval hearings for the nominees to the positions of Principal Secretary Planning and Principal Secretary Devolution on **Wednesday, 21<sup>st</sup> February, 2018**. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution, the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011) and the Standing Orders.

The Committee examined the nominees using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also considered the following in vetting the nominees:

- a. Academic qualifications
- b. Employment record and work experience
- c. Professional association
- d. Public office, political activities and affiliations
- e. Potential conflict of interest
- f. Suitability to the position
- g. Tax compliance
- h. Vision and leadership
- i. Integrity
- j. Expectations and Key priorities

### **6.1 DR. JULIUS MONZI MUIA**

Dr. Julius Muia had been nominated for the position of Principal Secretary in the State Department of Planning. He appeared before the Committee for vetting on **Wednesday, 21<sup>st</sup> February, 2018**. He was orally interviewed by the Committee and responded to questions during the vetting as follows:-

#### **6.1.1 Personal Background**

Dr. Julius Muia is a Kenyan citizen of identity card number 4827415 and was born in Makueni County in 1959.

### **6.1.2 Educational Background**

Dr. Muia hold a PhD in Finance (2012) and a Master of Business Administration (1984). He attained his Bachelor of Commerce in Accounting in 1981 at the University of Nairobi.

### **6.1.3 Professional Experience & Affiliations**

In terms of his professional experience and affiliations, Dr. Muia has undertaken the several professional courses including Certified Public Accountant – CPA (K) (1982), Certified Public Secretary – CPS (K) (1990), Associate Kenya Institute of Bankers – AKIB (2003) and Associate Chartered Institute of Arbitrators – ACI Arb (2012).

### **6.1.4 Work experience/ career progression**

Dr. Muia has a wealth of experience both in Public Service and private sector. Since November 2016 to date he has been the Director General for the Vision 2030 Delivery Secretariat. In addition to this, between 2008 and 2016 he was the Secretary, National Economic and Social Council (NESC). Dr. Muia worked as the Finance and Administration Director/Chief Operations Officer for the Housing Finance Company of Kenya between the years 2001 and 2008. Apart from having experience in the Public sector, he has also worked for private companies including Unga Group Limited, Kenya (Group Finance Director and Group Company Secretary- 1995 to 2001), Safari Parks Holdings Limited, Kenya (Finance Manager/Finance Director - 1992 to 1995), Lonrho Hotels Group, Kenya (Group Financial Controller -1992 to 1995), Price Water House Kenya and Manchester, UK (Audit Trainee/Supervisor/Manager -1984 to 1990), University of Nairobi (Graduate Assistant -1983 to 1984).

### **6.1.5 Awards, Distinctions and Others**

Dr. Julius Monzi Muia has received commendations to which he has received several awards including :-

7. 1979; "*Asian Community Academic Award*": Prize for best student in BCom Class first year in the University of Nairobi
8. 1982: "*DS Trivedi*" Prize for best student in CPA (K) final exams
9. 2012: EBS award: Elder of Burning Spear, Head of State Award for Delivery of Public Service
10. Participated in several Task Forces and Steering Committees on public policy
11. Supervised many researches and consultancies in support of national development

#### **11.1.1 Potential Conflict of interest**

The nominee informed the Committee that he was a part time lecturer at Strathmore University. He stated that he will not continue his part time classes to avoid any potential conflict of interest and to also concentrate on his duties as a PS.

#### **11.1.2 Clearance Requirements**

The Committee confirmed that the nominee had been cleared by Statutory bodies including the KRA, HELB, DCI and EACC, having obtained clearance certificates to that effect.

#### **11.1.3 Other Issues under consideration**

To examine suitability or otherwise of the nominee, the Committee posed several questions in the following thematic areas: -

### **12. Personal plan, vision in attainment of Vision 2030 and contribution to the realization of the Big Four Agenda**

He stated that his background and knowledge gained while formulating the vision 2030 at the Vision 2030 Delivery Board would enable him steer the State Department in implementation and delivery on Vision 2030 targets. Further as a technology expert he would incorporate ICT in the operations of the State Department to enhance service delivery. The nominee stated that through

Kenya Institute for Public Policy Research and Analysis (KIPPRA) which is an public institution under the Ministry charged with providing quality public policy advice to the Government of Kenya by conducting objective research and analysis, he would task the institute to carry out a research on key enablers to the Big Four Agenda and the linkages between the Big Four Agenda and the Vision 2030.

The nominee also stated that if appointed he would help to fast-track the validation, printing and launching of the MTP3 (2018-2022) and its final dissemination to the public, the MTP was key document in guiding national plans and also county plans.

### **13. Integrity and how he will handle issue of corruption**

He stated that he was a practicing ethical leader and had received an award for ethical leadership. He noted that there was need to seal the social and legal gaps with regards to integrity and corruption issues facing the public sector. He indicated that he would employ two measures if appointed to the State Department, that is, strict implementation of laws regarding integrity and corruption and establishment of an award for persons with good ethical behavior within the State Department. He reiterated that he would inform relevant authorities for their necessary action on any corruption matters touching of officers within the State Department. He observed that there was need to incorporate national values in socialization of citizens at the earliest stages of growth (childhood) to ensure these values strongly embedded in their characters.

### **14. Utilization of financial and human resources at the State Department**

He stated that he would apply his background in accounting and particularly internal controls to ensure there was prudent use of financial resources within the State Department. Further he stated that would he would leverage on networks with development partners to ensure capacity building of staff to enhance their knowledge in the mission and vision of the State Department to enhance service delivery.

He further informed the Committee that he would employ strong austerity measures if appointed and would ensure there was value for money in terms of deliverable outputs as opposed to

spending due to available budget lines.

### **15. Conflict of interest**

He noted that the first step in dealing with conflict of interest is recognition of the potential conflict of interest, subsequently upon recognition one should make a declaration on the conflict of interest to be seen and known by the relevant authorities and ensure this conflict of interest is documented.

### **16. Public Participation and Monitoring Evaluation**

The nominee informed the Committee that he would leverage on private sector finance to fund public participation exercise such as communication campaigns. He stated that while at the Vision 2030 Board there had been a series of communication campaigns through media such as vernacular radio stations and he would implement the same activities at the State Department.

He observed that dissemination of information on activities carried to the public was keep component of monitoring and evaluation as it gave an opportunity for public feedback on the same.

### **17. Harmonization of the County Integrated Plans and the Mid Term Plans**

He stated that the CIDP is drawn from the Mid Term Plan which is harmonized by the State Department of Planning with an objective of achieving the “Big Four” and the Vision 2030. He further stated that the State Department of Devolution had launched spatial planning in 2017 from which all counties are supposed to draw their spatial plan. If given a chance to serve as the Principal Secretary for Planning, he will ensure that this is implemented to the later.

22. He has never been charged in a court of law and has no potential conflict of interest.
23. He has never been dismissed from office on contravention of the provisions of Article 75 of the constitution that deals with conduct of state officer and has never been adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

MEMORANDUM OF THE *THIRDWAY ALLIANCE KENYA* TO THE VETTING COMMITTEE OF THE NATIONAL ASSEMBLY ON THE APPOINTMENT OF NATIONAL EXECUTIVE (CS, CAS, PS & AMBASSADORS) OUR PERSPECTIVE AND WHAT NATIONAL ASSEMBLY SHOULD CONSIDER BEFORE RECOMMENDING THEM FOR APPOINTMENT.

PREAMBLE

③

First, *Thirdway Alliance Kenya* (hereinafter "*Thirdway*"), a political party duly registered under our laws and which participated in the 2017 General Elections, welcomes the decision of President Uhuru Kenyatta to propose a Cabinet after such a long wait.

Secondly, we appreciate that Parliament is set to begin this long-awaited cabinet. Therefore, and pursuant to *Section 6(9)* of the *Public Appointments (Parliamentary Approval) Act 2011* and further to the provisions of *Article 119* of our 2010 Constitution, *Thirdway* shares below our party's perspective on the proposed nominees for Cabinet Secretaries (CSs), Permanent Secretaries (PSs), Ambassadors, and a newly created post of Chief Administrative Secretary (CAS). Even as we share our views herein, we, however, note that the Cabinet remains incomplete. We hope that Parliament would urge President Uhuru to finalize on his nominees. Any further delay, continues to create anxiety and delayed service delivery to Kenyans.

As Parliament now sits to vet these names, we provide our perspective as follows:

1. Role of the National Assembly

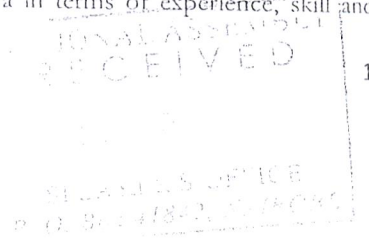
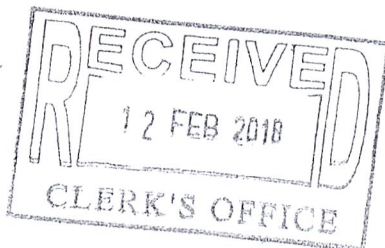
- a. We see the role of the National Assembly, as not just being about vetting the nominees, but also pointing the Executive to the right direction in as far as some national concerns are. We have documented those concerns in this memorandum. To this extent, parliament would be playing its oversight role over the Executive. We urge you not to look at party politics; rather what is in the best interest of Kenyans; it is the responsibility of the National Assembly to guide the president on the best public servants to serve Kenyans.

③ COMMITTEE CLERKS  
 Pls bring to the attention of your respective committees

The need to observe chapter 6 of our Constitution & justification for appointments.

- a. Ch.6 of our Constitution speaks to "responsibilities of leadership", and that in selecting such State Officers, regard shall be had to their "competence and suitability", and in the particular instance, to perform a function as a CS, PS, and Ambassadors, amongst others.
- b. *On suitability & competence.* To use two examples in order to illustrate this issue, we do not see a clear justification for the transfer of a CS like Amb. Amina Mohammed to the Education Ministry. Her long, painstaking experience as CS Foreign Affairs will be a great loss to Kenya in terms of experience, skill and

resources. This is because she will have to learn how to manage a new Education docket. Assuming, the transfer was occasioned by her non-performance at the Foreign Affairs docket, why transfer her to the very crucial Education ministry where she has had no experience at all? Similarly, there is no clear justification for the appointment of Dr. Matiang'i as CS for Interior. This is because, he has arguably done an exemplary job as CS Education. At the same time, he has also received wide criticism both locally and internationally for his alleged contribution to the violation of human rights, including recent failure to obey court orders, and shutdown of media houses without compliance with *Article 24* of our Constitution.

- c. *Underperformance:* We urge your Committee to consider the performance, as well as underperformance by some CSs, PSs, who are now either transferred to a new docket or proposed for Ambassadorial appointment. You may want to interrogate the performance track record of each nominee. If on a balance of probability, a CS/PS never performed to expectation, you should reject such a name (*see also issue of integrity & corruption below*). We believe there are many Kenyans with skill, expertise, competence and who are suitable to serve in our public service.
- d. *On qualifications.* It is not clear what justification was used by the President to propose some nominees into Cabinet. Our proposal is that each of the nominees should produce before you, at least, a certified degree certificate from a recognized university. Kenya has so many learned and qualified individuals. We cannot appoint people into our public service, especially at such level as CS, PS and Ambassadors with questionable education credentials.
- e. *Integrity & corruption:* Our reading of the *Auditor General Reports* worryingly indicates that over 20 government departments could not account for public funds; neither could they demonstrate value for money. As you vet some of the returnee CSs and PSs, as well as those nominated for Ambassadorial appointments, it would be prudent to consider the findings of the *Auditor General* in the Ministries/departments they held prior to their now nomination for yet another appointment. For instance, the *Auditor General Reports* for the years 2013/14 and 2014/15 show that various ministries incurred unsupported Expenditure of KES 66,782,697,987 and KES 7,321,277,260 respectively. Additionally, various ministries incurred expenditure amounting to KES 14,435,690,489 whose value for money could not be established. We insist that accounting of public money is paramount, and any nominee whose previous ministry or department could not account for funds must be rejected with recommendation that such individuals be investigated and prosecuted; and money to be recovered.

### 3. The Gender Rule.

- a. We have observed that President Uhuru Kenyatta overlooked the obligation in our Constitution to ensure the gender rule (1/3 or 2/3) in all key government appointments is met. So far, only 6 women have been appointed to CS positions out of the available 22 slots as well as Ambassadorial positions. This is below the threshold minimum of 30% required in our Constitution. This vetting Committee would agree that continued relegation of women in public appointments fuels inequality and disunity with a majority of Kenyan population who are women and

youth. A progressive government would ensure that it has equal representation of capable women and men for a more harmonious and balanced leadership. Continual denial of the rights of women is no longer tolerable. For the sake of Wanjiku and Atieno, *Thirdway* proposes that there be inclusion of many more capable women into the Cabinet and parliament using all resources under the government's power and control.

4. **The Youth Factor.**

- a. The obvious and rather glaring omission of the youth, 35 years old and below is unfortunate and unacceptable. It must be remembered that our population is more than 70% youth. Young people are excelling in various fields such as IT, communication, Sports, trade and others placing Kenya on the map in many areas including scientific inventions. The Jubilee government must create space for more young and brilliant minds to manage high level government portfolios with introduction of electronic and modern technology to improve public participation.

5. **Special Interest Groups (SIG).**

- a. It is our observation that SIGs (persons living with disabilities, extreme minorities, etc.) have been left out of the list of nominees. The obvious omission of people living with disability is a key area of concern as this group of people deserve to head one or two cabinet positions. We know that disability is not inability and many people are actually victims, for example, of health and transportation failures. Therefore, it would benefit this country to appoint them into cabinet and other sectors where they can contribute lasting solutions. Their continued under-representation is a culture we can no longer be proud of, as a country.

6. **Observance of Art. 130 of the Constitution.**

- a. The Cabinet, being the National Executive of our Republic, is required to meet the provisions of our Constitution in *Article 130* that "*the composition of the national executive shall reflect the regional and ethnic diversity of the people of Kenya*".
- b. The diversity and inclusivity clause in our Constitution has not been overlooked. At first glance, and without necessarily going into detail, it is clear that the list is ethnically imbalanced and overly generous to members of one or two communities whilst completely omitting and ignoring others. With the current political temperatures and divisive politics that is polarizing communities in our country (principally because of exclusion from government), it only good for our Country to ensure ethnic balancing is achieved in these appointments. We do not expect the government to increase the number of positions to fulfil this requirement; however, an effort must be evident to ensure inclusivity and representativeness of all groups of Kenyans as far as possible.
- c. *Thirdway formula on ethnic and regional balancing.* We propose that the President nominates his first 22 nominees for CS positions from 22 different ethnic groups of Kenya; then his second 22 nominees for PS positions from another 22 different ethnic groups of Kenya. That way, the President would have fulfilled both the ethnic and regional diversity of the people of Kenya. His Cabinet would be the true face of Kenya. We believe this would help President Kenyatta build a better legacy and good precedent for future presidents.

7. "Recycling" of certain names in public service.
  - a. "Recycling" or "rewinding" of personalities makes for a retrogressive society devoid of new ideas, ways of approaching important issues and problem-solving. We must make space for new faces and personalities who should be carefully selected based on their professional experience and less on their political influence, which is a role best left to MPs to deliver. If someone is today not deemed to have done a better job at Cabinet level, why transfer them to an ambassadorial position?
8. Incomplete Cabinet list.
  - a. We observe that the Cabinet remains incomplete. Our view is that this opens up space for unnecessary speculation and negative competition, which following a five-month long wait is clearly unhealthy for the country. All positions should be announced simultaneously and in good time, so as to minimize opportunities for canvassing and irregular appointments due to the need to pay political debts.
9. Creation of Chief Administrative Secretary ignored need for transparency & a public consultation process.
  - a. *Funding and void CAS is to fill:* We have asked ourselves these questions: which constitutional bodies gave their approval and advised the president to create the CAS category and for what specific reason? How does government plan to fund this role? Which void does the post of CAS fill in the current public service?
  - b. *Non-compliance with Procedure & consultation under Article 132:* While we appreciate that it is the right of the President in *Article 132* to create a new position in the public service, we also believe that the right and constitutional procedure in creating this new position was overlooked. This makes the position of CAS unconstitutional. The creation of the CAS post ought to have been preceded by a recommendation from the Public Service Commission (PSC). It is only then that the President can create a position in the public service.
  - c. *Public participation:* In addition to the foregoing, it also means that the principle of public participation was overlooked. The Kenyan general public ought to have been given the chance to give views whether this post is necessary under the circumstances; or not.
  - d. *Increased wage bill:* Kenyans are currently unhappy with the huge bill in our public sector including in devolved counties. We believe that the position of CAS is already going to come with another wage bill at a time when we are concerned about cost cutting.
  - e. *Replication of & conflict over duties:* In fact, we believe that the CAS position would replicate the Assistant Minister position that was scrapped in previous regimes. In fact, this post is already introducing an additional bureaucracy through yet another middle level tier of management. We also see this post as a recipe for conflict between the CS and CAS on the one hand, and CAS and PS on the other. It is worth noting that efficient companies and governments around the world are currently obliterating the "middleman/woman" role due to high costs and

unnecessary bureaucracy, which affects service delivery. Our position is that it is an unnecessary addition to an already bloated government. Kenyans cannot sustainably carry this additional expense with our already highly indebted country. We are an already overburdened citizenry. The CAS positions must, therefore, be rejected with no additional names presented in this category until it is properly justified and resources identified to sustain it. Retaining this post will actually prompt high taxes on an already heavily taxed Kenyan worker.

10. Need for a Lean Government.

- a. Our party holds the view that a lean government in all its levels, is economically desirable for Kenya including, but not limited, to our current over representation in Parliament. A large government is a huge wage bill to the taxpayer. This huge wage bill robs Kenyans of development money (e.g. to ensure adequate water, healthcare, food, security, roads, education, electricity, etc.). Kenyans have expressed support for this view and we will continue to push for consultations and conversations with the Jubilee administration, as well as with Parliament at all levels, on how best to reduce the burden of government on Kenyans. Rather, government must work to create opportunities and support efforts of citizens while conserving funds for essential needs and releasing funds for development and for service provision to the Kenyan people guaranteeing our future prosperity and growth.

**Conclusion:** Lastly, we thank the Vetting Committee for the opportunity to share our party's views on this important national exercise. We remain optimistic that Parliament will take this views into consideration. We also take this early chance to urge parliament to steer the country towards constructive political conversation. Parliament may want to consider our proposed National Conversation with a 14-point agenda.
