ON 2ND APRIL 2025**

Pursuant to Article 241(3)(b) of the Constitution of Kenya, 2010 read with sections 31(1)(a) and (c) of the Kenya Defence Forces Act (KDF Act), Cap 199, the undersigned hereby informs you that on 7th April 2025, the Kenya Defence Forces deployed to assist the Ministry of Interior and National Administration and the County Government of Mombasa in the emergency response to the eleven-storey building at Kilifi Corner Fayaz Estate along Abdel Nasser Road, Mombasa County that begun sinking on 2nd April 2025 endangering adjacent residential and commercial buildings.

In accordance with the requirements of section 31 (2) of the KDF Act, the particulars of the deployment are as detailed hereunder:

- 1. Reason for Deployment.** To assist the Ministry of Interior and National Administration and the County Government of Mombasa in the emergency response to the eleven-storey building at Kilifi Corner Fayaz Estate along Abdel Nasser Road, Mombasa County that begun sinking on 2nd April 2025.
- 2. Place of deployment.** Junction of Abdel Nasser road and Light House road on plot No. Mombasa/Block XLVI/195 - Mombasa Island, Mvita Sub-County, Mombasa County.
- 3. Period of Deployment.** Three (3) days; subject to good weather.
