COMMUNICATION FROM THE CHAIR

ON THE MEETING OF THE STANDING COMMITTEE ON FINANCE,
COMMERCE AND BUDGET WITH THE GOVERNOR OF THE CENTRAL
BANK OF KENYA

1. **Honourable Senators**, as you may be aware, on 10th February, 2016, the Senate Minority Leader sought a statement from the Chairperson of the Standing Committee on Finance, Commerce and Budget regarding the continued issuance, by the Central Bank of Kenya, of currency bearing portraits of individuals, in contravention of the Constitution of Kenya.
2. On Wednesday, 24th February, 2016, the Chairperson of the Standing Committee on Finance, Commerce and Budget issued a response on the matter. However, the response was not satisfactory going by the number of interventions raised by Senators. I therefore directed the Committee to convene a meeting for all interested Senators and invite the Governor of the Central Bank of Kenya to respond to issues raised.
3. **Honourable Senators**, I wish to inform you that the Standing Committee on Finance, Commerce and Budget has convened a meeting of all Senators to deliberate on the matter. The Governor of the Central Bank of Kenya, Dr. Patrick Njoroge, has confirmed his attendance.
4. The meeting will be held tomorrow, **Thursday, 3rd March, 2016** in the Senate Chamber, Main Parliament Building starting at **10.00 am**. I therefore urge all Honourable Senators to attend.
