FOREWORD BY THE CHAIRPERSON

Hon. Speaker,

The Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bill No. 46 of 2022), sponsored Sen. Samson Cherargey, MP was published *vide* Kenya Gazette on 28th October, 2022. The Bill was read a First Time in the Senate on Thursday, 7th December, 2023 and thereafter stood committed to the Standing Committee on Labour and Social Welfare for consideration.

The Bill proposes amend the Public Service (Values and Principles) (Amendment) Act, Cap. 185A to provide for submission of annual reports by national and county governments entities outlining the number of employees highlighting-

- (a) Gender;
- (b) Age;
- (c) County of birth;
- (d) County of residence; and
- (e) Whether they are persons living with disabilities.

Hon. Speaker,

Pursuant to Article 118 of the Constitution and standing order 145 (5) of the Senate Standing Orders, the Committee published an advertisement in the Daily Nation and Standard Newspapers on Saturday, 9th December, 2023, inviting members of the public to submit written memoranda to the Committee on the Bill. The advertisement was also posted on the Parliament website and social media platforms. Following the call for submissions, the Committee received written memoranda from stakeholders.

The Committee proceeded to consider the Bill extensively, scheduled and held meetings with various stakeholders including the Ministry of Public Service, Performance and Delivery Management, the Public Service Commission, the Council of Governors and the County Assemblies Forum. The minutes of the Committee in considering the Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bill No. 46 of 2022) are annexed to this Report as *Appendix 2*.

The Committee received amendments to the Bill from some of the above mentioned stakeholders, and this Report by the Committee is therefore an account of the deliberations, including its resolutions and Committee Stage Amendments attached to the Report as *Appendix 1*.

CHAPTER ONE: INTRODUCTION

1.0 Background

1. The Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bill No. 46 of 2022) sponsored by Senator, Samson Cherargey, MP, was published *vide* Kenya Gazette dated 28th October, 2022. The Bill was introduced in the Senate by way of First Reading on 7th December, 2023 and thereafter stood committed to the Standing Committee on Labour and Social Welfare for consideration. A copy of the Bill is annexed to this Report as *Appendix 3*.
2. Pursuant to the provisions of Article 118 of the Constitution and Standing Order 145 (5) of the Senate Standing Orders, the Committee published an advertisement in the Daily Nation and Standard Newspapers on 8th December, 2023, inviting members of the public to submit written memoranda to the Committee on the Bill. A copy of the advertisement is attached as *Appendix 4*. The advertisement was also posted on the Parliament website and social media platforms.
3. Following the call for submissions, the Committee received written memoranda from various stakeholders including the Ministry of Public Service, Performance Management and Delivery Management and the Public Service Commission.
4. The Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bill No. 46 of 2022) seeks to amend the Public Service (Values and Principles) Act, Cap. 185A to provide for submission of annual reports by national and county governments entities outlining the number of employees highlighting-
 - (a) Gender;
 - (b) Age;
 - (c) County of birth;
 - (d) County of residence; and
 - (e) Whether they are persons living with disabilities.

1.1. Overview of the Bill

5. The Bill proposes to amend section 16(3) by inserting new paragraph (da) to mandate the national and county governments provide annual reports to Parliament and County Assemblies on human resource establishment including
—
 - (a) Gender;
 - (b) Age;

- (c) County of birth;
- (d) County of residence; and
- (e) Whether they are persons living with disabilities;
- (f) The definition of “out of work hours”.

1.2. Consequences of the Bill

6. The Bill will facilitate the National and County governments to implement Article 10 of the Constitution on national values and principles of governance and Article 232 of the Constitution on values and principles of public service respectively. The Bill will also enable Parliament and County governments to oversight National and County government entities to ensure that their human resource establishment takes into consideration ethnic composition of the country, minorities and marginalized groups, persons with disabilities and the youth.

CHAPTER TWO: PUBLIC PARTICIPATION ON THE BILL

2.0 Committee Undertakings

7. The Committee published an advertisement in the Daily Nation and Standard newspapers on Friday, 8th December, 2023, inviting members of the public to submit written memoranda on the Bill. The advertisement was also posted on the Parliament website and social media platforms. A copy of the advertisement is annexed to this Report as *Appendix 4*.
8. Subsequently, during consideration of the Bill, the Committee also resolved to invite submissions from the key stakeholders, including –
 - a) The Ministry of Public Service, Performance and Delivery Management;
 - b) The Public Service Commission;
 - c) The Council of Governors; and
 - d) The County Assemblies Forum.
9. In response to the said invitations, the Committee received submissions from the Ministry of Public Service, Performance and Delivery Management, Council of Governors and the Public Service Commission.
10. Copies of the written submissions are attached to this Report as *Appendix 6(a) – (d)*. Additionally, a matrix analysing the stakeholder submissions clause-by-clause is annexed as *Appendix 5*.
11. The Committee proceeded to consider the Bill extensively, together with the stakeholder submissions received thereon.

2.1 Overview of Stakeholder Submissions on the Bill

12. Below is an overview of the stakeholder submissions on the Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bill No. 46 of 2022).
13. The Ministry of Public Service, Performance and Delivery Management submitted as follows –
 - a) Include human resource management function in the definition of “authorized officer”, with the justification being that this will bring clarity on the role of authorized officer in the public service or Commission service.
14. The Public Service Commission submitted as follows –
 - a) Exclude “public offices” from reporting. This is to stop duplication of reports as all public officers are under service Commissions.

CHAPTER THREE: COMMITTEE OBSERVATIONS AND RECOMMENDATIONS

3.0 Committee Observations on the Bill

15. Having considered the Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bill No. 46 of 2022) and the submissions received thereon, the Standing Committee on Labour and Social Welfare therefore noted that the Union of Civil Servants had not made any submissions on the Bill.

3.1 Committee Recommendations

16. Arising from the above observations, the Committee **recommends** that the Senate passes the Public Service (Values and Principles) (Amendment) Bill, 2022 (National Assembly Bills No. 46 of 2022) with the following amendments –

- a) That Clause 3 of the Bill be amended by deleting paragraph (a); and
- b) That clause 2 of the Bill be amended by deleting the definition of the term “authorized officer” and substituting therefor the following definition –
“Authorised officer” means an officer appointed within public service or service Commission to perform a human resource management function with public service or service Commission.





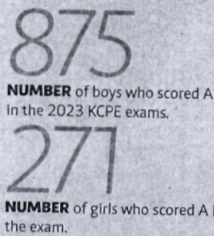

MPs have raised concerns over the decline in the number of female students sitting national examinations.

National Assembly's education committee said the number of boys who sat this year's Kenya Certificate of Primary Education (KCPE) was higher than girls.

"We have noted in the past especially between 2013 and 2022, there has been some regression in gender parity in these exams," Manderla South MP Haro Abdul stated.

He added that, "This year it looks like there is a reversal in gender



increased by 100,579 compared to their female counterparts at only 72,130 in comparison with last year.

While announcing the results, Education CS Ezekiel Machogu this year had the highest number of candidates since it was the last KCPE examination before the transition to Competency Based Curriculum.

"It was not a natural population. They took advantage of the window we gave to register for the examination. It affected the normal gender parity," he said.

Turkana, Garissa, Wajir and Manderla counties indicated a huge gap of between 56 to 62 per cent in favour of male students.

The data also indicate that in all counties apart from Tana River, Kajiado, Busia, Isiolo, and Nairobi female candidates were slightly more than male by less than one percent.

However, Machogu said male candidates performed better than their female counterparts. About 875 boys scored A against 271 girls, some 1,962 girls and 4,445 boys scored A-.

parity where boys have out-shined girls," Abdul said.

The legislator regretted that the government was doing little to remedy the problem of girls accessing basic education and their retention.

According to Kenya National Examinations Council, out of 689,798 pupils who registered for this year's KCPE examination, 685,017 sat the papers.

"This partnership will enable graduates to access job opportunities in the marine sector and cruise ship industry. The school will also contribute to the enhancement of safety in our inland waters, especially Lake Victoria and other water bodies," the CS noted.

Murkomen spoke at a time scores of lives have been lost following El Nino rains that have affected North Eastern, Upper and Lower Eastern, Nyanza and the Coast.

He said the launch of the courses, which were developed through collaboration with International Maritime

Organisation and Kenya Maritime Authority was a major milestone in the journey towards realising a sustainable Blue Economy and expanding its contribution to national development.

"These standards will also facilitate quality management and safety of Kenya's water ways which will in turn promote regional integration and trade," the CS said.

Murkomen said the government is focused on efficient utilisation of water bodies, including Lake Victoria and has undertaken several initiatives towards revamping blue economy.

He added: "I salute the 12 graduands in the first cohort of this important safety training programme. As a former university lecturer, I know what innovation, creativity and energy young Kenyans can bring to the labour market when given a chance to acquire knowledge and skills."

1.0 INTRODUCTION

1. The County Assemblies Forum (CAF) is the coordinating body of the 47 County Assemblies in Kenya. The primary mandate of CAF is to promote networking and synergy among the 47 County Assemblies, coordinate intergovernmental relations and enhance good practice in legislative development. Our Mission is to provide effective leadership and coordination of the 47 County Assemblies and through policy and legislative action, promote a conducive working environment for all its members, and in that way deliver quality services to the people.

2.0. As one of the pillars of the devolved government system, CAF is committed to engaging in processes that provide for the strengthening of Separation of powers among County entities under the devolved system

2.1. BACKGROUND

2.2. The principal object of this Bill is to amend the Public Service (Services and Principles) Act to require all state organs in the national and County Governments and state corporations to submit annual reports on details of Human Resources in constitutional commissions, independent offices and County public service boards and County Assembly Service Boards. The Reports should contain details outlining the total number of employees and highlighting their gender, age, County of Birth and county of residence

2.3. The justification is that it will facilitate the public service values and principles that require the public service to reflect Kenya's diverse communities and afford adequate and equal opportunities for the appointment of women and men, members of the ethnic group and persons with disabilities pursuant to Article 232 of the Constitution. By receiving annual reports, legislatures can discharge the oversight role bestowed upon them as they will be able to analyse and query non-compliant state organs.



3.0. GENERAL COMMENTS.

- 3.1. The proposed Bill rightly emphasizes the importance of diversity and inclusivity within the public service. Requiring annual reports on the demographics of the workforce, including gender, age, and ethnicity, is a commendable step towards ensuring fair representation and equal opportunities for all citizens.
- 3.2. The Bill represents a significant stride towards providing financial autonomy for County Assemblies. Since the inception of Devolution in 2013, County Assemblies have sought greater control over their financial resources to better serve their constituents. This Bill addresses this long-standing concern and acknowledges the importance of empowering local governance structures.
- 3.3. Mandating public entities to submit annual reports to Parliament will strengthen accountability in the public service. This measure aligns with the principles of transparency and oversight, empowering legislatures to analyze and address non-compliance issues within state organs. It fosters a culture of accountability and responsible governance.
- 3.4. The Bill's focus on addressing underrepresentation, especially in terms of the two-thirds gender rule and the employment of persons with disabilities, is a positive step. By setting clear standards and requiring progress reports, the legislation aims to correct historical imbalances and create a more balanced and equitable public service.
- 3.5. Requiring annual reports from all state organs and public entities may impose an additional bureaucratic burden on these organizations. The resources and time spent on compiling and submitting these reports could be better utilized in improving actual diversity and inclusivity measures within the public service.
- 3.6. While the intentions behind the Bill are noble, there is a concern that enforcing diversity quotas may lead to tokenism, where individuals are appointed merely to meet numerical targets rather than based on merit. This could compromise the quality and effectiveness of public service delivery.
- 3.7. The Forum is of the view, that issues of diversity and inclusivity should be addressed through cultural shifts and voluntary initiatives within organizations rather than strict legislative mandates. Imposing such requirements may not necessarily result in genuine transformation and could be perceived as an infringement on the autonomy of state organs.
- 3.8. CAF appreciates the opportunity to contribute to this Bill and on the basis of the foregoing proposes the following amendments:
