CHAIRPERSON'S FOREWORD

This report contains the proceedings of the Departmental Committee on Justice and Legal Affairs during the approval hearing of Dr. David Adang Oginde, nominee for appointment as the Chairperson of the Ethics and Anti-Corruption Commission (EACC) as forwarded by H.E. the President and communicated to the House by the Speaker on Wednesday 15th March, 2023.

Pursuant to Section 10 of the EACC Act, 2011, the Head of Public Service vide a letter of Ref. No. OP/CAB.1/12A dated 19th January, 2023 declared the Office of the Chairperson of the Ethics and Anti-Corruption Commission vacant. Consequently, the PSC placed an advertisement in the print media and its website on 20th January, 2023 inviting applications from qualified persons for nomination to the Office.

In the exercise of his powers conferred by Article 250 (2) (c) of the Constitution, Section 11(2) of the Ethics and Anti-Corruption Commission Act, 2011 as read together with Sections 3 and 5 of the Public Appointments (Parliamentary Approval) Act 2011, H.E. The President vide his Message, No. 5 of 2023, notified the National Assembly of the nomination of Dr. David Adang Oginde as Chairperson of Ethics and Anti-Corruption Commission. The Rt. Hon Speaker vide Communication No. 007 of 2023 made on Wednesday 15th March, 2023 conveyed to the House the Message from H.E. the President and subsequently referred the name of the nominee, his *Curriculum Vitae*, and the Report of the Public Service Commission on the nominee's recruitment to the Departmental Committee on Justice and Legal Affairs for approval hearing. While referring the matter to the Committee, the Speaker directed that the Committee undertakes the vetting exercise within twenty-eight (28) days pursuant to Section 8 of the Public Appointments (Parliamentary Approval) Act, 2011. The Rt. Hon. Speaker further directed the Clerk of the National Assembly to notify the nominee and the general public of the time and place of holding the approval hearing, by placing advertisements in two newspapers of nationwide circulation and the Parliamentary Website.

In compliance with Article 118 (b) of the Constitution and Section 6 (4) of the Public Appointments (Parliamentary Approval) Act, 2011, the Clerk of the National Assembly placed an advertisement in the print media on Thursday 23rd March, 2023 informing the public of the nomination, date, time and place of the approval hearing. He invited the public to submit memoranda by way of written statements on oath (*affidavit*) on the suitability of the nominee in conformity with section 6 (9) of the Public Appointments (Parliamentary Approval) Act, 2011. The memoranda were to be received on or before Monday 3rd April, 2023 at 5.00 p.m. (East African Time). By the close of the submission deadline, the Committee had not received any memorandum against the nominee's suitability.

The Clerk of the National Assembly also wrote to the Kenya Revenue Authority (KRA), Ethics and Anti-Corruption Commission (EACC), Directorate of Criminal Investigations (DCI), Higher Education Loans Board (HELB) and Office of the Registrar of Political Parties (ORPP) seeking references and background checks relating to the suitability of the nominee.

The nominee appeared before the Committee on Wednesday 5th April, 2023 for the approval hearing. The Committee examined his suitability based on the criteria set out in section 7 of the Public Appointments (Parliamentary Approval) Act, 2011. In addition, the Committee examined his academic credentials, relevant experience, knowledge of sector issues and on leadership and integrity. The Committee paid due regard to the procedure used to arrive at the nominee, the constitutional or statutory requirements relating to the office in question and the suitability of the nominee for the appointment proposed having regard to whether the nominees' abilities, experience and qualities meet the needs of the State Department.

Report of the Departmental Committee on Justice and Legal Affairs on the Approval Hearing of the Nominee for Appointment as Chairperson of the Ethics and Anti-Corruption Commission

Committee Recommendation

The Committee, having held the approval hearing of the nominee regarding his suitability, observed that due process was followed on the recruitment process as provided for under Section 10 of the Ethics and Anti-corruption Act, 2011 and Sections 3 and 5 of the Public Appointments (Parliamentary Approval) Act, 2011. The Committee, therefore, recommends that the National Assembly **approves** the nomination of Dr. David Adang Oginde for appointment as Chairperson of the Ethics and Anti-Corruption Commission.

1 PREFACE

1.1 Establishment and Mandate of the Committee

1. The Departmental Committee on Justice and Legal Affairs is one of twenty departmental committees of the National Assembly established under **Standing Order 216** whose mandate pursuant to the **Standing Order 216 (5)** is as follows:

- i. *To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;*
- ii. *To study the programme and policy objectives of ministries and departments and the effectiveness of the implementation;*

- v. *To study, assess and analyse the relative success of the ministries and departments as measured by the results obtained as compared with their stated objectives;*

- vii. *To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments);*
- viii. *To examine treaties, agreements and conventions;*
- ix. *To make reports and recommendations to the House as often as possible, including recommendations of proposed legislation;*
- x. *To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and*
- xi. *To examine any questions raised by Members on a matter within its mandate.*

2 BACKGROUND INFORMATION

2.1 Legal Framework

6. Section 10 of the Ethics and Anti-Corruption Commission Act, 2011 provides for the procedure of appointment as chairperson of the Commission. It stipulates that:

“(1) Whenever a vacancy arises in the membership of the Commission, the Public Service Commission shall, within fourteen days—

(a) invite applications from persons who qualify for nomination and appointment by advertisement in at least two daily newspapers of national circulation;

(b) consider the applications received to determine their compliance with the provisions of the Constitution and this Act;

(c) shortlist the applicants;

(d) conduct interviews of the shortlisted persons in public;

(e) shortlist three qualified applicants for each vacancy; and

(f) forward the names of the qualified persons to the President.

(2) The President shall, within fourteen days of receipt of the names of successful applicants forwarded under subsection (1)(f), select the person to fill the vacancy in the Commission and forward the name of the person to the National Assembly for approval.

(3) The National Assembly shall, within twenty-one days of the day it next sits after receipt of the name of an applicant under subsection (2), vet and consider the applicant, and may approve or reject applicants for any or all vacancies in the Commission.”

7. In light of this, H.E. The President nominated Dr. David Adang Oginde for appointment as Chairperson of EACC.

8. The Departmental Committee on Justice and Legal Affairs was assigned the role of conducting the approval hearing of the aforesaid nominee.

9. The Committee was guided by the following provisions of the Constitution and statutes in executing its assignment:

- i. Article 10 of the Constitution on the national values and principles of governance;

- ii. Chapter 6 of the Constitution on leadership and integrity;
- iii. Article 77 of the Constitution on restriction on activities of State Officers;
- iv. Article 78 of the Constitution on dual citizenship;
- v. Article 118 of the Constitution on public participation;
- vi. Article 124(4) of the Constitution on consideration of persons for appointment to public office;
- vii. Article 232 of the Constitution on values and principles of public service;
- viii. The Public Appointments (Parliamentary Approval) Act (No. 33 of 2011);
- ix. The Leadership and Integrity Act (Cap. 182);
- x. The Ethics and Anti-Corruption Commission Act (No. 22 of 2011); and
- xi. The Public Officer Ethics Act (Cap. 183).

2.2 Notification of Nomination

10. Pursuant to Section 10 (1) of the Ethics and Anti-Corruption Commission Act, 2011, the Public Service Commission invited applications from suitably qualified persons for the position of Chairperson of the EACC. The advertisement was published in the print media, and on the Public Service Commission's Website on 20th January, 2023 with a closing date of 2nd February, 2023. A total of eighty-nine (89) applications were made, of which fourteen (14) candidates were shortlisted and interviews conducted on the 27th and 28th February, 2023 at Commission House.
11. Consequently, a list of three (3) successful candidates was transmitted to H.E. the President by the Public Service Commission and on 13th March, 2023, H.E. The President nominated Dr. David Adang' Oginde for appointment as the Chairperson of the EACC.
12. The Public Service Commission vide its Report (*Annexure 3*) noted that it adhered to all provisions of the Constitution in the process of advertising, shortlisting and interviewing the candidates including, merit, gender, ethnic and regional balance.

2.3 Message from H.E. the President

13. H.E. the President on 13th March, 2023 communicated the name of the nominee for appointment to the position of Chairperson of the EACC to the Speaker of the National Assembly for approval by the House pursuant to Article 250 (2)(b) of the Constitution as read with Section 10(2) of the Ethics and Anti-Corruption Commission Act, 2011.

Report of the Departmental Committee on Justice and Legal Affairs on the Approval Hearing of the Nominee for Appointment as Chairperson of the Ethics and Anti-Corruption Commission

14. The Rt. Hon. Speaker in his Communication issued on Wednesday 15th March, 2023 and pursuant to Standing Order No. 42 referred the name of the nominee to the Departmental Committee on Justice and Legal Affairs to conduct approval hearings and submit its report within twenty-eight (28) days.

2.4 Notification to the House and Referral to the Departmental Committee on Justice and Legal Affairs

15. Pursuant to the provisions of Standing Order 42(1), the Speaker, vide Communication No. 007 of 2023 dated **Wednesday 15th March, 2023**, informed the House of the Message from H.E. the President regarding the nomination of the Chairperson of the EACC for approval by the National Assembly.

16. Pursuant to section 8(1) of the Public Appointment (Parliamentary Approval) Act, 2011 and Standing Order 45(1), the name and curriculum vitae of the nominee were referred to the Departmental Committee on Justice and Legal Affairs for approval hearing and reporting to the House on or before Tuesday 11th April, 2023.

17. While referring the matter to the Committee, the Speaker directed that the Committee undertakes the approval process within twenty-eight (28) days pursuant to Section 8 of the Public Appointments Parliamentary Approval Act, 2011. The Speaker further directed the Clerk of the National Assembly to notify the nominee and the general public of the time and place of holding the approval hearing.

2.5 Notification to the Public

18. Article 118 of the Constitution provides that Parliament shall facilitate public participation and involvement in the legislative business and other business of Parliament and its Committees.

19. Section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011 provides that the clerk shall notify the public of the time and place for holding an approval hearing at least seven days before the hearing.

20. Further, Section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011 provides that *“any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated”*.

21. Pursuant to Article 118 of the Constitution as read together with Section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011, the Clerk of the National Assembly placed an advertisement in the print media on **Thursday 23rd March, 2023** inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominee in conformity with Section 6(9) of the Act. The advertisement indicated that the submissions were to be received by Monday 3rd April, 2023 at 5.00 pm (East African Time). At the close of the submission deadline, the Committee had not received any memorandum for or against the suitability of the nominee.
22. Further, pursuant to Article 118 of the Constitution, Section 6(4) of the Public Appointment (Parliamentary Approval) Act, 2011 and provisions of Standing Order 45(3), the Clerk of the National Assembly placed advertisements in the local dailies notifying the general public and inviting the nominee to attend an approval hearing on Wednesday 29th March, 2023 in the Mini Chamber at county Hall at 10.00am. Through an addendum published on Thursday 23rd March, 2023, the date of the approval hearing was changed to **Wednesday 5th April, 2023** in the Mini-Chamber at County Hall at 10.00am.

2.6 Notification to the Nominee

23. The Clerk of the National Assembly vide the advertisement placed in the print media and letter Ref. NA/DDC/JLAC/2023/029 dated 27th March, 2023 invited the nominee for the approval hearing in accordance with Section 6(3) of the Public Appointments (Parliamentary Approval) Act, 2011.

2.7 Clearance and Compliance Requirements

24. On 22nd March, 2023, the Clerk of the National Assembly vide letters of Ref No. NA/DDC/JLAC&SP/VETT/2023/001, NA/DDC/JLAC/VETT/2023/002, NA/DDC/JLAC&S P/VETT/2023/003, NA/DDC/JLAC/VETT/2023/004, NA/DDC/JLAC/VETT/2023/005 wrote to DCI, EACC, HELB, KRA and ORPP requesting for reports concerning the nominee on the following matters:
 - a) Criminal records;
 - b) Ethics and integrity;
 - c) Higher education loan repayments;
 - d) Tax compliance; and

e) Political party affiliations.

25. The following institutions wrote back to the National Assembly clearing the nominee: DCI vide letter Ref No. CI/CRO/SEC/6/7/2/A/VOL.XII/90 dated 28th March, 2023; EACC vide letter Ref No. EACC.7/10/5 VOL XXII (183) dated 27th March, 2023; HELB vide letter Ref No. HELB/RR/112009/22/211 dated 14th April, 2023; KRA vide letter Ref No. KRA/5/1002/5(8557) dated 29th March, 2023; and ORPP vide letter Ref No. RPP/ORG/34 VOL. IV (64) dated 24th March, 2023.

2.8 Issues for Consideration during the Approval Hearings

26. Section 6(7) and (8) of the Public Appointment (Parliamentary Approval) Act, 2011 provides that:

(7) An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

(8) The criteria specified in the Schedule shall be used by a Committee during an approval hearing for the purposes of vetting a candidate.

27. In addition, Section 7 of the Act stipulates the issues for consideration as:

a) The procedure used to arrive at the nominee;

b) Any constitutional or statutory requirements relating to the office in question; and

c) The suitability of the nominee for the appointments proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made.

28. While conducting the approval hearing, the Committee was guided by the provisions of Section 6(7) and (8) and Section 7 of the Public Appointments (Parliamentary Approval) Act, 2011.

a) Procedure for Nomination

29. Section 10 (2) of the Ethics and Anti-Corruption Commission Act, 2011 confers upon the President the power to nominate a person for appointment from a list of persons recommended by the Public Service Commission.

30. Section 5(1) of the Public Appointment (Parliamentary Approval) Act, 2011 further requires that the appointing authority, upon nominating a person for appointment, notifies the relevant House of Parliament.

31. In light of this, pursuant to Section 10(2) of the Ethics and Anti-Corruption Commission, 2011 as read together with Section 5(1) of the Public Appointments (Parliamentary Approval) Act, 2011, the President notified the National Assembly of the nomination of Dr. David Adang' Oginde for appointment to the Office of Chairperson of the EACC.

b) Constitutional and Statutory Requirements

32. The Committee was guided by the following provisions of law which act as a guide on the requirements for appointment to the State Office:

i. National Values and Principles of Governance

33. Article 10 of the Constitution provides for the national values and principles of governance which State Officers must abide by in discharging their mandate. They include: patriotism; national unity; sharing and devolution of power; the rule of law; democracy and participation of the people; human dignity; equity; social justice; inclusiveness; equality; human rights; non-discrimination and protection of the marginalized; good governance; integrity; transparency and accountability; and sustainable development.

ii. Conduct of State Officers

34. Article 77 of the Constitution outlines that a full-time State officer must not participate in any other gainful employment and that any appointed State officer must not hold office in a political party.

35. Moreover, the Constitution under Article 78 further stipulates that a State officer must not hold dual citizenship but instead shall be a citizen of Kenya only.

36. Article 232 provides for the values and principles of public service as: high standards of professional ethics; efficient, effective and economic use of resources; responsive, prompt, effective, impartial and equitable provision of services; involvement of the people in the process of policy-making; accountability for administrative acts; transparency and provision to the public of timely, accurate information; fair competition and merit as the basis of appointments and promotions; representation of Kenya's diverse communities; and affording adequate and equal opportunities for appointment, training and advancement, at all levels of the public service of men and women, members of all ethnic groups and persons with disabilities.

37. The Public Officer Ethics Act, Cap 183 outlines the obligations of a public officer as: professionalism; carrying out duties in accordance with the law; prohibition from unjust enrichment; avoiding conflict of interest; not using the office as an avenue for soliciting or collecting harambees; not acting for foreigners; care of property; political neutrality, not practising nepotism or favouritism; giving impartial advice; conducting private affairs in a way that maintains public confidence; bar from sexual harassment; submission of a declaration of income, assets and liabilities once every two years.

iii. Qualifications for Appointment as EACC Chairperson

38. Section 5 of the Ethics and Anti-Corruption Commission Act provides for the qualifications for appointment as chairperson of the Commission. It states as follows:

“ 5. Qualifications for appointment as chairperson or member

(1) A person shall be qualified for appointment as the chairperson if that person—

(a) meets the requirements of Chapter Six of the Constitution;

(b) holds a degree from a university recognized in Kenya;

(c) has knowledge and experience of not less than fifteen years in any of the following fields—

(i) ethics and governance;

(ii) law;

(iii) public administration;

(iv) leadership;

(v) economics;

(vi) social studies;

(vii) audit;

(viii) accounting;

(ix) fraud investigation;

(x) public relations and media; or

(xi) religious studies or philosophy; and

(d) has had a distinguished career in their respective field.

(2) A person shall be qualified for appointment as a member of the Commission if that person—

(a) meets the requirements of Chapter Six of the Constitution.

(b) holds a degree from a University recognized in Kenya;

(c) has knowledge and experience of not less than ten years in any of the following fields—

(i) ethics and governance;

(ii) law;

(iii) public administration;

(iv) leadership;

(v) economics;

(vi) social studies;

(vii) audit;

(viii) accounting;

(ix) fraud investigation;

(x) public relations and media; or

(xi) religious studies or philosophy; and

(d) has had a distinguished career in their respective field.

(3) A person shall not be qualified for appointment as a chairperson or as a member if the person—

(a) is a member of a governing body of a political party;

(b) is an undischarged bankrupt;

(c) has been convicted of a felony; or

(d) has been removed from public office for contravening the provisions of the Constitution or any other law.

(4) Subsection (3)(a) shall cease to apply to a person after two general elections have been held since the person ceased to hold such office. ”

iv. Leadership and Integrity

39. The Committee, in determining the suitability of the nominee, was also guided by Section 5 of the Ethics and Anti-Corruption Commission Act, 2011 as read with the provisions on leadership and integrity as stipulated under Chapter Six of the Constitution and the Leadership

and Integrity Act, 2012. In particular, Article 73(2) of the Constitution provides that the guiding principles of leadership and integrity include:

- a) selection based on personal integrity, competence and suitability, or election in free and fair elections;
- b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices;
- c) selfless service based solely on the public interest, demonstrated by —
 - i. honesty in the execution of public duties; and
 - ii. the declaration of any personal interest that may conflict with public duties;
- d) accountability to the public for decisions and actions; and
- e) discipline and commitment in service to the people.

40. Article 75 of the Constitution requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties. This Article further prohibits a State Officer who has been removed from office under it from holding any other State Office.

41. Article 77(1) of the Constitution prohibits a full-time State Officer from participating in any other gainful employment.

42. Article 77(2) of the Constitution prohibits an appointed State officer from holding office in a political party. Article 78 of the Constitution disqualifies persons who are not Kenyan Citizens from appointment as State Officers. Further, a State Officer is barred from holding dual citizenship.

43. In addition, the Committee considered Section 10 of the Leadership and Integrity Act, 2012 in particular which provides that –

A State officer shall, to the best of their ability—

- (a) carry out the duties of the office efficiently and honestly;*
- (b) carry out the duties in a transparent and accountable manner;*
- (c) keep accurate records and documents relating to the functions of the office; and*
- (d) report truthfully on all matters of the organization which they represent.*

c) Suitability of the nominee for the proposed appointment having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is made

44. The suitability of the nominee was assessed after scrutiny of his background, academic credentials and professional qualifications, work and professional experience, personal integrity as well as his performance during the approval hearing conducted on Wednesday 5th April, 2023.

3 APPROVAL HEARING

45. The Committee conducted an approval hearing for the nominee on Wednesday 5th April, 2023 and was guided by, among others, the Ethics and Anti-Corruption Commission Act, 2011, the Public Appointments (Parliamentary Approval) Act, 2011 and the National Assembly Standing Orders.

3.1 Approval Hearing of Dr. David Adang Oginde – Nominee for EACC Chairperson

46. Dr. David Adang Oginde appeared before the Committee and was orally interviewed by the Committee to examine his suitability or otherwise. The Committee noted the following:

Personal Background

47. The nominee is a male Kenyan citizen of Identification Card Number 5334523 and does not hold any other citizenship. He was born on 10th November, 1959.

Academic and Professional Qualifications

48. The nominee holds a Doctorate of Philosophy in Organizational Leadership from The Regent University USA; Master of Arts in Leadership from the Pan Africa Christian University; a Certificate in Professional Mediation from the Pan Africa Christian University; a Postgraduate Certificate in Biblical Studies from the Trinity International University USA and a Bachelor of Architecture from the University of Nairobi.

Work and Professional Experience

49. The nominee has worked in the following capacities:

- a) as Founder and President of The Catalead Associates Ltd from 2020 to date;
- b) as a Director for Administration, Senior Pastor, Deputy Bishop and Presiding Bishop of Christ is the Answer Ministries (CITAM) from 1997 to 2020; and
- c) as Bible Study Secretary and National Director of the Fellowship of Christian Unions (FOCUS) from 1986 to 1997.

Professional Associations

50. The nominee submitted that he is a member of the Hesabika Trust, Global Kingdom Partnership Network, Africa Arise and the Association of Evangelicals in Africa.

Honours and Awards

51. The nominee indicated that he was awarded Runner Up, CEO of the Year in 2016 as well as the Champions of Governance Award.

Published Writing

52. The nominee has published six books and various articles in The Standard local newspaper.

Public Office, Political Activities and Affiliations

53. The nominee submitted that he has held the following public offices:

- a) Member of the National Parenting Taskforce, Evangelical Alliance of Kenya Representative from 2022 to date;
- b) Council Chairperson of Mama Ngina University College from December 2021 to date; and
- c) Member of the IEBC selection Panel in 2016.

54. The nominee submitted that he has never been an official of any political party nor is he a member of any political party.

Potential Conflict of Interest

55. The nominee declared that he currently does not have any persons or matters that would present a potential conflict of interest should he assume the position of Chairperson of the EACC. He further informed the Committee that should such conflict arise he would declare the same in writing to the appointing authority in accordance with the law.

Sources of Income and Net-worth

56. The nominee estimated his net worth to be Kshs. 170 Million with the sources of income being training and consultancy services of Kenya Shillings Three Million (Kshs. 3,000,000) and rental income of Kenya Shillings Four Million and Eight Hundred Thousand (Kshs. 4,800,000) for the calendar year preceding his nomination to this Office. He added that for the year 2023, his sources of income included training and consultancy services of Kenya Shillings Seven Hundred and Fifty Thousand (Ksh. 750,000) and rental income of Kenya Shillings One Million Four Hundred Thousand (Kshs. 1,400,000).

Pro-bono/Charity Work

Report of the Departmental Committee on Justice and Legal Affairs on the Approval Hearing of the Nominee for Appointment as Chairperson of the Ethics and Anti-Corruption Commission

57. The nominee is involved in charity work through the Evangelical Alliance of Kenya by donating his time and resources to the church and society. He also stated that he provides personal support to the church and church projects by donating between Kenya Shillings Four Hundred Thousand to Six Hundred Thousand (Kshs. 400,000-600,000) per year and individuals in need by donating approximately Six Hundred Thousand Kenya Shillings per annum (Kshs. 600,000 p.a).

Integrity

58. The nominee demonstrated integrity in public service. He has neither been charged in a court of law nor mentioned in any investigatory reports of Parliament or any Commission of Inquiry in the last three (3) years. Further, he has never been dismissed or otherwise removed from office for contravention of the provisions of Article 75 of the Constitution.

3.2 General and Sector-Specific Questions to Dr. David Adang' Oginde

59. The Committee posed several questions to the nominee on his knowledge of the Office of EACC Chairperson. The nominee responded as follows: -

On the harmonious working of the Commission and its Secretariat

60. The nominee underscored the need for a cohesive spirit between the Commission and its Secretariat. He informed the Committee that, if approved, he would ensure the distinct separation of roles of the two i.e. the governance role of the Commission and the management role of the Secretariat by providing direction, policies and principles significant to realising the Commission's mandate, vision and mission.

On safeguarding the Commission from political patronage

61. The nominee noted that promoting integrity is a collective effort that involves all Kenyans. He further stated that he would adopt an all-inclusive and participatory approach in which the general public and the private sector join hands to curb corruption. He emphasized that cultural change is significant to realizing a corruption-free society to end the weaponization of the war against corruption.

On his published works where he opined that there could be an inter-religious war in the country

62. The nominee clarified that in his article he was calling upon religious leaders to take up the mantle to address the intolerant attitude towards people of different faiths. He added that he is

friends with various religious leaders and does not bear any ill feelings towards those who subscribe to a different religion. Furthermore, he noted that he was part of the Inter-Religious Council of Kenya in 2021 where he worked with various religious leaders of different faiths.

On pragmatic solutions to curb corruption

63. The nominee emphasized the need for cultural change in combating corruption. He stated that transforming the minds of Kenyans towards building an ethical society is vital in eradicating the vice and instead promoting integrity.
64. He also stressed he would adopt a zero-tolerance approach against corruption. He proposed that the timeframe taken to decide high-impact corruption cases be reduced and that such cases are decided expeditiously likening it to the time frame for Presidential Election Petitions.
65. He highlighted the significance of political goodwill in the fight against corruption and stated that he would work with other State officers to voluntarily lead by example by being champions for integrity. He emphasized their voluntariness as opposed to forcefulness as what, in his opinion, would yield better results.
66. The nominee also intimated to the Committee that while the Commission is mandated to combat corruption, it is also vested with the mandate to promote ethics and promote integrity and thus opined that he would focus more on promoting integrity by collaborating with the relevant agencies in the fight against corruption.

On what makes him fit for the Office

67. The nominee reiterated his deep concern and passion for the welfare of the country and an aim to make positive impactful change hence his application to be appointed to the Office of the EACC Chairperson. He added that out of his numerous publications, a considerable number were on corruption. Furthermore, he informed the Committee that he believed he could carry out and execute the responsibilities of the Office in his capacity, not only as a religious leader but also as a concerned and able Kenyan.

On whether there is a lacuna in existing legislation

68. The nominee stated that there is a lacuna to the extent that there is a multiplicity of roles in various institutions in combating corruption. He added that this weakens the fight against corruption and proposed that the mandate to deal with corruption issues exhaustively be limited

to one institution, the Commission, to ensure a seamless process from the investigation up until the conclusion of corruption allegations to seal the current loopholes that enable offenders to get away with corruption.

69. Citing Singapore as an example to emulate, he added that he would urge Parliament to amend the relevant legislation to make the Commission a one-stop shop for dealing with corruption issues.

On religious institutions being used as conduits for money-laundering

70. The nominee underscored that crime is unlawful and consequences for the same should apply to all regardless of who the culprits are. He stated that all monies received by religious institutions are meant for charity and must not be used for any other causes except that which they are meant for. He assured the Committee that, if approved, he would have zero tolerance for corruption and deal with all culprits in accordance with the law.

On poor investigation of corruption cases hence their unsuccessful prosecution

71. The nominee informed the Committee that it is vital that proper investigations be conducted before taking such cases to court to ensure the successful prosecution and conviction of offenders.

72. He further stated that he was of the view that undue regard to mere technicalities be overlooked in prosecuting corruption cases and instead due regard paid to the substantive issues.

On the top-down approach to fighting against corruption

73. The nominee believed that leaders are ideal role models and that their seriousness in the fight against corruption will encourage other citizens to follow suit.

On whether there is an internal affairs department that polices police officers

74. The nominee reiterated the significance of a good checks and balances system within the police force by emphasizing the need for an internal self-checking mechanism to promote accountability.

On Alternative Dispute Resolution (ADR) mechanisms to curb corruption instead of imprisonment

75. The nominee noted that ADR is a good mechanism to curb corruption provided that the illegally acquired assets can be traced.

On whether he would be willing to step down if he was unable to make impactful change

76. The nominee stated that should he be unable to realize impactful change in the fight against corruption, he would willingly resign and allow another person the opportunity to serve Kenyans.

4 COMMITTEE OBSERVATIONS AND FINDINGS

77. Pursuant to Section 6(7) and (8) and Section 7 of the Public Appointments (Parliamentary Approval) Act, 2011, the Committee made the following observations with regard to the following issues for consideration:

4.1 Procedure for Nomination

78. Pursuant to Section 10 (2) of the Office of the Ethics and Anti-corruption Act, 2011, the Committee observed that the procedure used to arrive at the nominee was lawful and in compliance with the values and principles of public service under Article 232(1)(g) and (h) of the Constitution.

79. Further, the Committee found that the nominee was recommended to the President for appointment as required by the law.

4.2 Constitutional and Statutory Requirements

80. The Committee found as follows:

- a) That the nominee is a Kenyan citizen and is not a citizen of any other country and therefore meets the requirement of Article 78(1) of the Constitution;
- b) That the nominee, being a holder of a Bachelor's Degree in Architecture from The University of Nairobi, meets the requirements of Section 5(1)(b) of the Ethics and Anti-Corruption Commission Act, 2011.
- c) That the nominee has the requisite knowledge and experience of over fifteen years in leadership and social studies hence meets the requirements of Section 5(1)(c) of the Ethics and Anti-Corruption Commission Act.
- d) That the nominee demonstrated an aspiration for integrity in public service and thus meets the requirements of Chapter Six of the Constitution on leadership and integrity;
- e) The nominee, having been cleared by KRA, HELB, EACC, DCI, ORPP, with regard to tax compliance, higher education loan repayments, ethics and integrity, criminal records and political party affiliations has met the statutory requirements for appointment to the Office.

4.3 Suitability of the nominee for the proposed appointment having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is made

81. The suitability of the nominee was assessed after scrutiny of his background, academic credentials and professional qualifications, work and professional experience, personal integrity as well as his performance during the approval hearing conducted on Wednesday 5th April, 2023 and the Committee observed that:

- a) The nominee possesses the relevant experience for the position of EACC Chairperson. The nominee is an active participant in public policy and public life and has written numerous scholarly articles on leadership and governance. A background in public policy and experience in public service are critical tools for any person discharging the role of the EACC Chairperson.
- b) The nominee exhibited great zeal and passion in the fight against corruption. He identified cultural change and imparting values as one of the key solutions in combating corruption.

5 COMMITTEE RECOMMENDATIONS

82. Having considered the suitability, capacity and integrity of the nominee, and pursuant to Section 10 (3) of the Ethics and Anti-Corruption Act, 2011 and Section 8(2) of the Public Appointments (Parliamentary Approval) Act, 2011, the Committee recommends that the National Assembly **approves** the appointment of **Dr. David Adang Oginde** to the position of Chairperson of the Ethics and Anti-Corruption Commission of the Republic of Kenya.

Bishop Dr. David Oginde, the nominee for appointment to the position of the Chairperson, Ethics and Anti-Corruption Commission appeared before the Committee and submitted as follows:

On personal background, the nominee stated that he was a male adult, a Kenyan citizen residing in Nairobi County

On education qualifications, the nominee stated that he holds PhD in Organizational Leadership from Regent University, USA; Master of Arts in Leadership from Pan Africa

Christian University; Certificate in Professional Mediation from Pan Africa Christian University; Diploma in Management from Kenya Institute of Management; Post graduate certificate in Biblical studies from Trinity International University, USA; Bachelor of Architecture from University of Nairobi

On special engagements, the nominee stated that he is the founder and president of Catalead Associates Limited; member Global Steering Committee of the 4-14 Window Movement; Chairperson of the Pastors Track; member Global Steering Team of the Global Kingdom Partnership Network (GKPN); vice chairperson, Executive Board of the Association of Evangelicals in Africa (AEA); president, Association of Evangelical in Africa (AEA) East Africa region; Chairperson, Pentecostal Assemblies of Africa (PAOA)

On government engagements, the nominee stated that he is a member, Inter-faith Council on National Response to Covid -19 Pandemic; member, selection Panel for the Independent Electoral and Boundaries Commission (IEBC)

On church engagements, the nominee stated that he is the vice chairperson of the Association of Evangelicals in Africa; president of the East Africa region of the Association of Evangelicals in Africa; Chairman, Evangelical Alliance of Kenya; Vice chairman, Evangelical Alliance of Kenya; Trustee, Hesabika Trust; Chairperson the Kenya Church Taskforce

On teaching experience and employment, the nominee pointed out that he is the Chairperson, University Council, Mama Ngina University College; Chancellor at Pan Africa Christian (PAC) University; Lecturer, PhD Organizational Leadership at Pan Africa Christian University; Lecturer, Masters of Arts in Leadership at Pan Africa Christian University; Chairperson, Governing Council at Pan Africa Christian University; Adjunct Lecturer, Masters in Communication & leadership; Graduate Studies in Leadership Development and Management at Daystar University; Adjunct Lecturer, Graduate Studies, Biblical Foundations for Christian Service at Daystar University; Adjunct Lecturer, Church Administration and Leadership at Grace College

On work experience, the nominee pointed out that he served as the Christ is the Answer Ministries (CITAM) Presiding Bishop, 2010-2020; Deputy Bishop, 2009-2010; Senior Pastor, CITAM Karen and CITAM Valley Road, 2001-2009; Director for Administration, 1997-2001; National Director at Fellowship of Christian Unions (FOCUS), 1992-1997; Bible Study Secretary 1986-1992

On honours and awards, the nominee indicated that he was awarded Runner Up, CEO of the Year as well as the Champions of Governance Award.

On published writing, the nominee indicated that he had published six books and various articles in The Standard local newspaper.

On potential Conflict of Interest, the nominee declared that he currently does not have any persons or matters that would present a potential conflict of interest should he assume the position of Chairperson of the EACC. He further informed the Committee that should such conflict arise, he would declare the same in writing to the appointing authority in accordance with the law.

On the harmonious working of the Commission and its Secretariat, the nominee stated that, if approved, he would ensure the distinct separation of roles of the two i.e. the governance role of the Commission and the management role of the Secretariat by providing direction, policies and principles significant to realising the Commission's mandate, vision and mission.

On religious institutions being used as conduits for money-laundering, the nominee underscored that crime is unlawful and consequences for the same should apply to all regardless of who the culprits are. He stated that all monies received by religious institutions are meant for charity and must not be used for any other causes except that which they are meant for. He assured the Committee that, if approved, he would have zero tolerance for corruption and deal with all culprits in accordance with the law.

On safeguarding the Commission from political patronage, the nominee noted that promoting integrity is a collective effort that involves all Kenyans and that he would adopt an all-inclusive and participatory approach in which the general public and the private sector join hands to curb corruption. He emphasized that cultural change is significant to realizing a corruption-free society to end the weaponization against corruption.

On poor investigation of corruption cases hence their unsuccessful prosecution, the nominee informed the Committee that it is vital that proper investigations be conducted before taking such cases to court to ensure the successful prosecution and conviction of offenders. He further stated that he was of the view that undue regard to mere technicalities be overlooked in prosecuting corruption cases and instead due regard paid to the substantive issues.

On what makes him fit for the Office, the nominee reiterated his deep concern and passion for the good welfare of this country and an aim to make positive impactful change hence his application to be appointed to the Office of the EACC Chairperson. The nominee further stated that he believed he could carry out and execute the responsibilities of the Office in his capacity, not only as a religious leader but also as a concerned and able Kenyan.

On the top-down approach to fighting against corruption, the nominee stated that leaders are ideal role models and that their seriousness in the fight against corruption will encourage other citizens to follow suit.

On whether he would be willing to step down, the nominee stated that where impactful change in the fight against corruption is not realized, he would willingly resign and allow another person the opportunity to serve Kenyans.

On whether there is an internal affairs department that polices police officers, the nominee pointed out the significance of a good checks and balances system within the police force by emphasizing the need for an internal self-checking mechanism to promote accountability.

FOCUS is an organization working with students in the universities and colleges in Kenya providing leadership training, guidance, and counseling. It is affiliated to the International Fellowship of Evangelical Students (IFES).

Eventually he became the Presiding Bishop of CITAM, a post he held for his full term of ten years, before handing over and getting into consultancy. This was a major responsibility where he was handling a budget of over one billion shillings, a task which he performed with distinction.

In all these areas of service, he has exemplified a character of integrity and consistency which have made all the institutions he has served in to maintain very good public reports. Having done a PhD in Leadership, this has enhanced his already acquired Biblical-based leadership principles and values, which have enabled him to put structures of accountability in place in the institutions that has led which have been most helpful. With the wide experience in people relationship, I trust that this would make his leadership very fruitful.

I am sure that with him at the helm of Ethics and Anti-Corruption Commission as the chairman, this will take the country to new heights in the preservation and proper utilization of the resources of the people of Kenya. For this reason, I do highly recommend him for this position.
