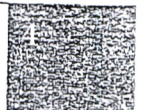
## 1.2 COMMITTEE MANDATE

The Departmental Committee on Education, Research and Technology was established by Standing Order No. 216 of the Standing Orders of the National Assembly and mandated, amongst other things,

- a) Investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
- b) study the programme and policy objectives of Ministries and departments and the effectiveness of the implementation;
- c) study and review all legislation referred to it;
- d) study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
- e) investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
- f) to vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments); and
- g) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation.

## 2.0 BACKGROUND

The Teachers Service Commission (TSC) is an independent constitutional commission established pursuant to the provisions of Article 237 of the Constitution. The appointment of the Chairperson and Members of the



Commission is provided for under Sections 5 and 8 of the Teachers Service Commission Act No.20 of 2012.

The Selection Panel (constituted pursuant to the Teachers Service Commission Act No. 20 of 2012) conducted interviews on the people shortlisted for the positions of Chairperson and members of the Commission. The panel awarded marks with regards to how each of the nominees performed (score sheet herewith annexed).

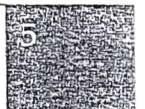
In addition, pursuant to Section 8(7) of the Teachers Service Commission which states that the President shall-

*"Within seven days of receipt of the names forwarded under subsection (6), nominate one person and eight others for appointment as Chairperson and members of the Commission and forward the names to the National Assembly for approval".*

On Wednesday, 18<sup>th</sup> September, 2013, the Speaker of the National Assembly made a communication regarding the message from His Excellency The President, nominating the following to serve as members of the Teachers Service Commission:-



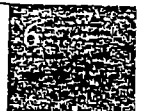

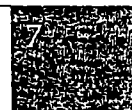
### 3.0 CONSIDERATION OF THE NOMINEES TO THE TEACHERS SERVICE COMMISSION

#### 3.1 ESTABLISHMENT OF THE COMMITTEE

The Departmental Committee on Education, Research and Technology was established under Standing Order No. 216(5) with the mandate to consider for approval by the House, appointments of nominees of the Members of the Teachers Service Commission under Article 237 of the Constitution and Section 8 of the Teachers Service Commission Act No. 20 of 2012.

#### 3.2 APPOINTMENT PROCESS OF THE MEMBERS OF THE TEACHERS SERVICE COMMISSION

- i) H.E. the President, in accordance with the provisions of section 8 (7)) of Teachers Service Commission Act No. 20 of 2012, forwarded to the Speaker of the National Assembly, the names of the six (6) nominees; Mr. Kiragu wa Magochi Mr. Albert Fred Ekirapa Ms. Jacinta A. Kapiyo Mr. William Mwita Makubo, Mr. Muthuri Nkoroi and Mr. Mwijuma Mwinyipembe vide a letter dated 8<sup>th</sup> July, 2013 for vetting and approval for appointment by the National Assembly as Members of the Teachers Service Commission.
- ii) On Wednesday, 18<sup>th</sup> September, 2013, the Honourable Speaker in a communication referred the names of the nominees to the Departmental Committee on Education, Research and Technology for vetting and reporting to the House.
- iii) On Friday, September 20<sup>th</sup> 2013, an advertisement was placed in the print media inviting the public to submit memoranda by way of affidavit on the suitability or otherwise of the six (6) nominees in conformity with Section 6(9) of the Public Appointments (Parliamentary Approval) Act 2011. The submissions were to be received latest by 26<sup>th</sup> September, 2013 at 5.00 p.m.



#### 4.0 VETTING PROCESS

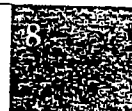
In conducting the vetting process, the Departmental Committee on Education, Research and Technology examined the nominees against the following criteria, amongst others, as set out in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011.

- (i) Academic qualifications
- (ii) Employment record
- (iii) Professional affiliations
- (iv) Potential conflict of interest
- (v) Knowledge of the relevant subject
- (vi) Overall suitability for the position
- (vii) Tax compliance
- (viii) Integrity

During its Sittings held on Friday, 27<sup>th</sup> September, 2013 the Committee conducted face to face interview of the six (6) nominees.

#### 4.1 MR. KIRAGU WA MAGOCHI

Mr. Kiragu wa Magochi appeared before the Committee on Friday, 27<sup>th</sup> September, 2013. He was nominated to serve as a Chairperson of the TSC. He was born in 1954 in Muranga County. He is currently working with the Ministry of Education Science and Technology as the Acting Education Secretary. He Holds a Masters of Education Degree from Kenyatta University and a Bachelor of Education Degree from the University of Nairobi. He has undertaken the following professional courses including professional and Continuing Education (Managing Staff in the learning organization). The selection panel scored him position 2 with 78.1 %, second from the leading candidate who scored 80.3 %.



The Committee examined him on general and specific thematic areas which the nominee responded as follows:-

**(i) Qualification vis a viz his appointment**

Mr. Kiragu wa Magochi informed the Committee that he has contributed immensely on teacher developmental programmes by developing a manual on teacher advisory centres (TACs). He has also undertaken several training opportunities that have prepared him adequately for his role as a chairperson. The opportunity to start his career as an untrained graduate and rising through the ranks to become an acting educational secretary, has prepared him adequately to perform his responsibilities. He was also instrumental in setting the TSC Act, 2013 and therefore he will ensure that it is implemented to the letter.

**(ii) Reforms in the Teachers Service Commission**

Mr. Magochi stated that TSC was established in 1967 and has not been expanded to cope with the increased number of schools. He noted that if appointed as chairperson of TSC he would embark on the review of TSC structure to enable it cope with the current number of schools.

**(iii) Integration of ICT in information management**

Mr. Kiragu noted that there was need to embrace ICT in data management as a way of improving efficiency especially in recruitment of teachers. To this end, he would ensure that an up to date databank of all trained teachers is maintained.



**(iv) Decentralization of TSC services**

Mr. Magochi stated that there was need to transfer TSC structures with commensurate resources to ensure that teacher management is well implemented.

**(v) Indiscipline cases amongst teachers**

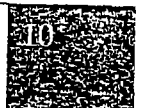
Mr. Kiragu wa Magochi stated that he will ensure that teachers who are implicated in carnal knowledge against pupils are dealt with in accordance with the existing laws. He will work closely with relevant state organs to eliminate these vices.

**(vi) Improving standards of teaching**

Mr. Kiragu wa Magochi stated that having worked as the coordinator for the *Education for All* in Africa he has gained a wealth of experience which will ensure quality teaching standards are realized. He stated that quality assurance requires cooperation between the Ministry of Education, Science and Technology and TSC.

**(vii) Performance contracting**

Mr. Kiragu wa Magochi stated that performance contracting is an effective way of monitoring performance for all. He stated that if appointed as chairperson, he was ready to introduce the same and not only for teachers but also to TSC secretariat. He will also ensure that he engages all the stakeholders in decision making to ensure that the concept of performance contracting is not misunderstood.



## **MR. ALBERT FRED EKIRAPA**

Mr. Albert Fred Ekirapa appeared before the Committee on Friday, 27<sup>th</sup> September, 2013. He was nominated to serve as a Member of the Commission. He is 53 years old and was born in Busia County. He is currently working with the Ministry of Education Science and Technology as a senior Deputy Director of Education (Directorate of Secondary and Tertiary Education). He holds Masters degree in Education (Education Administration) from the University of Nairobi and a Bachelor of Education Science degree (B. Ed Science) from Kenyatta University. The selection panel ranked him position 9 with a mean score of 65.1%.

The Committee examined the nominee on general and specific thematic areas which the nominee responded as follows:-

### **(i) Qualification vis a viz his appointment**

Mr. Fred Ekirapa stated that having worked in a hardship area especially in Turkana enabled him to strengthen his character as a manager. It exposed him to challenges that are faced by teachers in these areas.

### **(ii) Current shortage of teachers**

Mr. Albert Fred Ekirapa stated that the right to quality education is guaranteed as a basic human right and hence government should increase the budgetary allocation to employ more teachers so as not compromise the quality of education. He will continuously engage the Committee to lobby for more allocation from the National Treasury. He noted that a teacher contributes 75 % of learning hence the need to recruit more teachers to cover the shortfall. He noted that there was need to evaluate distribution of teachers across the country to ensure equity. He would also that all teachers have equal work load to avoid some teachers being overworked. He noted the need to decentralize governmental to ensure that other regions have the same facilities like Nairobi so



as to make as attractive as Nairobi. This would ensure that concentration of teachers in developed towns is reduced.

#### **(iii) Hardship areas**

He stated that there was need to review the system of mapping of hardship areas to be based on schools as opposed to the current system whereby it is based on educational zones. He singled out areas Northern Kenyan where teachers in specific schools should be considered.

#### **(iv) Staffing and transfers**

He stated that the recruitment exercise should not prioritize locals only but rather all trained and qualified teachers irrespective of their background. He emphasized the need to embrace meritocracy in the process of recruitment. He further noted that he would ensure that replacement of teachers is done immediately a vacancy arises through natural attrition and not annually as it is currently being done. If appointed, Mr. Ekirapa noted that he would ensure that TSC employs relief teachers to stand in the gap whenever teachers apply for leaves. He emphasized on the need to involve the county Directors whenever transfers are being effected. In the case of teachers requesting for transfer to be with their families, he stated that he would formulate a policy on the same so as to eliminate discrimination.

#### **(v) Remuneration for teachers**

Mr. Albert Fred Ekirapa stated that if appointed as a member of TSC he would ensure that teacher's allowance and benefits are harmonized with those of other civil servants. This would go a long way in boosting the morale of teachers.

#### **(vi) Improving performance in Public primary schools**



Mr. Ekirapa stated that he would focus on improving the quality of education in public primary schools by building the capacity of teachers so as to undertake quality assurance at school level. The teachers would work hand in hand with the quality assurance officers from TSC. This would ensure that public schools compete fairly with private schools like they did in the past.

**(vii) Corruption**

Mr. Albert Ekirapa stated that he would ensure that he puts in mechanism to promote transparency and accountability especially during recruitment. He would ensure that the processes of recruitment are computerized to eliminate corruption. He stated that cases of corruption will be investigated by the Commission and immediate action is taken against officers found engaging in these vices.

**(viii) Overlapping functions of quality assurance officers from both the Ministry of Education, Science and Technology and the Teachers Service Commission**

Mr. Ekirapa stated that the functions of quality assurance officers from the Ministry of Education, Science and Technology and the Teachers Service Commission were complimentary in nature hence there was no need for conflict in discharge of mandate. He further stated that although TSC was an independent Commission, there was need for the institution to work closely with the Ministry to avoid duplication of roles.

**MS. JACINTA A. KAPIYO**

Ms. Jacinta A. Kapiyo appeared before the Committee on Friday, 27<sup>th</sup> September, 2013. She has been nominated to serve as a Member of the Commission. She was born in 1957 and hails from Homabay County. She is currently working with the Ministry of Education Science and Technology as a Deputy Director of Education. She is currently pursuing a Ph. D in Education and

Planning at Catholic University of East Africa. She Holds a Masters of Education (Education planning, Administration and Curriculum Development) Degree from Kenyatta University and a Bachelor of Education Degree from University of Nairobi. She has undertaken several professional courses including introduction to Educational management for Secondary Schools, certificate in education management. She has also published several books that have contributed positively in the education sector. She was ranked by the selection panel at position 4 with a mean score of 69.4%.

The Committee examined the nominee on general and specific thematic areas which the nominee responded as follows:-

#### **Qualification vis a viz his appointment**

Ms. Jacinta A Kapiyo informed the Committee that her educational and work backgrounds had prepared her for the task ahead, having dealt with issues of teacher management for the last 28 years. She has also published several books and had excellent leadership and managerial skills hence she would be able to effectively discharge her duty as a member of TSC.

#### **Irregular teacher promotion**

Ms. Jacinta Kapiyo stated that teacher promotion as a result of sexual favours is rampant and if appointed to serve in TSC she would ensure necessary disciplinary measures are taken against those involved.

#### **Management of resources**

Ms. Jacinta Kapiyo stated she would encourage school heads /Principals to pursue relevant financial management courses in order to understand how to keep proper audited books of account. She also added that she would ensure



necessary measures are in put in place to ensure principals who engage in misappropriation of funds are held responsible.

### **Reforms in the Teachers Service Commission**

She stated that she would consult with the different organs of the Commission including the secretariat to identify the gaps in the teacher management policy. She would encourage the other commissioners to work as a team in order to improve teacher management and enhance quality teaching standards. She also stated that if appointed to serve in TSC she would leverage on ICT in management of teachers.

### **Challenges facing education sector**

Ms. Jacinta A. Kapiyo stated that the education sector was being faced with several challenges including teacher shortage, lack of proper infrastructure and high enrolment. She added that if appointed to serve in the commission, she would work with the relevant Government institutions to provide adequate allocation to the education sector in order to employ more teachers and put up necessary infrastructure.

### **Performance in Public schools**

Ms. Jacinta stated that public primary schools have continued to perform dismally compared to private primary schools. She emphasized on the need to enhance quality assurance to meet required standards of teaching. She would also provide conducive working environment for teachers in public schools to improve the quality of teaching.

## Relationship between with the Committee on Education, Research and Technology

Ms. Jacinta acknowledged the role played by the Committee of Education, Science and Technology in the ensuring increased budgetary allocation to the education sector. She assured the Committee that if appointed to serve in TSC, she would work closely with the Committee to ensure that TSC receives adequately budgetary allocation to address the issue of shortage of teachers as well their terms and conditions of service.

## Early childhood Development Education (ECDE) in the context of devolved system of governance

Ms. Jacinta A. Kapiyo hailed the new system of devolved government especially on early childhood development. However, she noted the need for TSC to be fully mandated to employ and manage the ECD teachers as stipulated by the TSC Act. This would not only ensure that children receive quality education but also ensure ECD teachers have uniform terms and conditions of service across the country. She further added that the County Governments should embark on putting up necessary infrastructure.

## Abconding of duty by teachers

Ms. Jacinta A. Kapiyo noted that desertion of duties is punishable by the TSC Act. She emphasized on the need for teachers to take their duties seriously as teachers' contribution to the knowledge is crucial. She stated that if appointed to serve in TSC, she would implement performance appraisal so as to ensure that performance of individual teachers is closely monitored.

### **MR. WILLIAM MAKUBO MWITA**

Mr. William Mwita Makubo appeared before the Committee on Friday, 27<sup>th</sup> September, 2013. He had been nominated to serve as a Member of the Commission. He was born in 1956 and comes from Migori County. He is currently working with the Ministry of Education Science and Technology as a Head of Department (Bursaries and Grant Section). He holds a Master of Business Administration (MBA) (Strategic Management) from the University of Nairobi and a Bachelor of Education, B. Ed (Maths) from University of Calgary Alberta, Canada. The selection panel ranked him position 16 with a mean score of 44.4%. However, as stipulated by the TSC Act, only thirteen names were forwarded by the selection panel.

The Committee examined the nominee on general and specific thematic areas which the nominee responded as follows:-

#### **Qualification vis a viz his appointment**

Mr. William Makubo Mwita informed the Committee that his distinguished performance while working in Taranganya Secondary School earned him a Distinguished Service Medal (DSM) by the office of President. He was able to put up a school library, laboratory and install a generator even without the support from the Government.

### **MR. JAMES MUTHURI NKOROI**

Mr. Muthuri Nkoro appeared before the Committee on Friday, 27<sup>th</sup> September, 2013. He has been nominated to serve as a Member of the Commission. He was born in 1960 and comes from Meru County. He is currently working with the Teachers Service Commission as a County Director, Samburu County. He holds a Master of Science (Applied Mathematics) Degree from JKUAT and a Bachelor of

Education (B. Ed) Science (Double Mathematics) Degree from Kenyatta University. The selection panel ranked him position 12 with a mean score of 58.6 %.

The Committee examined the nominee on general and specific thematic areas which the nominee responded as follows:-

#### **Qualification vis a viz his appointment**

Mr. Muthuri Nkoroi Informed the Committee that he had started his career as a head teacher and rose through the ranks to become a County Director of Education. This had given wealth of experience on teacher management hence he would effectively discharge his duties as a Member of TSC. While working as staffing officer in Nairobi he was managed to stabilise the staffing levels with fairness as the guiding principle. As a County Director in Samburu County, he was able to improve the performance in Kenya Certificate of Secondary Education (K.C.S.E)

#### **Sexual Harassment of pupils**

Mr. Muthuri Nkoroi stated that issues of sexual harassment on students should be investigated and teachers found engaging in these vices should be interdicted to pave way for investigation. He noted the need to sensitize parents/ guardians on the rights of children to avoid compromise by these errant teachers.

#### **Relationship between the Commissioners and the Secretariat of TSC**

Mr. Nkoroi stated that he would ensure that the TSC Commissioners work closely with the Secretariat of the TSC to deliver the mandate of the Commission. He noted that teamwork was key in efficient management of teachers.

#### **Role of the Ministry of Education, Science and Technology and TSC**

Mr. Muthuri Nkoroi stated that the relationship between the Ministry and TSC should be complimentary in nature. The Ministry was responsible for curriculum development while TSC's mandate was on teacher management. He noted that for the education sector to yield better results there ought to be synergy between the two institutions

#### **MR. MWIJUMA MWINYIPEMBE**

Mr. Mwijuma Mwinyipembe appeared before the Committee on Friday, 27<sup>th</sup> September, 2013. He has been nominated to serve as a Member of the Commission. He was in 1955 and comes from Mombasa County. He is currently working with the Ministry of Education Science and Technology as the acting Director of Quality Assurance. He holds a Masters of Education (Administration) Degree from Kenyatta University and a Bachelor of Education (Arts) Degree from Kenyatta University. He has undertaken several professional courses. He has participated in several Publications in the education sector. The selection panel ranked him position 1 with a mean score of 72.6%. He sat in last selection panel representing the Permanent Secretary. He stated that he had no undue advantage over other candidates, having sat in the previous selection panel, since the panel had other new members.

The Committee examined the nominee on general and specific thematic areas which the nominee responded as follows:-

#### **Quality assurance**

Mr. Mwijuma Mwinyipembe informed the Committee that the Basic Education Act, 2013 section 66 gives powers to the quality assurance and standards officers to enter at any time any basic education and training institution with or without notice to ensure compliance with education standards and regulations.

### **Core agenda in the next 100 days**

Mr. Mwijuma Mwinyipembe assured the Committee that he would lobby the Committee to initiate a legislation mandating the Board of Management to closely supervise schools to enhance quality of teaching.

### **Errant and indisciplined teachers**

Mr. Mwijuma Mwinyipembe informed the Committee that since there is already an existing Act of Parliament he will see to it that teachers caught abusing students are interdicted and if found guilty they are convicted. He also stated that he would embark on creating awareness to parents who may be vulnerable to compromise.

### **Admission policy of Teachers Training College (TTC)**

Mr. Mwijuma Mwinyipembe stated that the minimum requirement for qualification to join TTC is a good policy since it would ensure that TTC churn out quality teachers. However, he noted that there was room for consultation to thrush out issues to reach consensus.



## 5.0 COMMITTEE'S OBSERVATIONS

### 5.1 MR KIRAGU WA MAGOCHI:-

The Committee having considered his curriculum vitae and heard his oral submission during the vetting exercise/interview, made the following observations:-

- (i) He had been nominated to serve as a Chairperson of the TSC.
- (ii) He was born in 1954 in Muranga County.
- (iii) He is currently working with the Ministry of Education Science and Technology as the Acting Education Secretary in charge of coordinating, supervising and overseeing effective and efficient operations of the directorates including other duties (as contained in his curriculum vitae)
- (iv) He rose through the ranks from untrained teacher in Mirichu Secondary School.
- (v) He Holds a Masters of Education Degree from Kenyatta University and a Bachelor of Education Degree from the University of Nairobi.
- (vi) He has undertaken the following professional courses including professional and Continuing Education (Managing Staff in the learning organization) from University of Portsmouth, UK and Staff Performance Appraisal from Kenya Institute of Administration (KIA).
- (vii) He has participated in teacher developmental programmes by developing a manual on teacher advisory centres (TACs).
- (viii) He was awarded with a presidential award – Moran of the Burning Spear (MBS) in 2011.
- (ix) The selection panel scored him position 2 with 78.1 %, second from the leading candidate who scored 80.3 %.
- (x) He was interviewed twice by the selection panel i.e on 16<sup>th</sup> October, 2012 and 2<sup>nd</sup> August, 2013.

- (xi) He has been rejected twice by Parliament, however he was cleared by a High Court ruling (herewith annexed) on account that he was eligible for a second interview since previous rejection by the National Assembly was not in itself a bar to subsequent application.
- (xii) He has never been charged in a Court of Law, has been cleared by Ethics & Anti-corruption Commission (EACC), has fully complied with chapter six (6) on integrity and has fully complied with his tax obligation.

- b. He holds Master of Education degree (Education Administration) from the University of Nairobi and a Bachelor of Education Science degree (B. Ed Science) from Kenyatta University.



- c. The selection panel ranked him position 9 with a mean score of 65.1%.
- d. He has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with her tax obligation.
- e. He has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

### 5.3 MS. JACINTA A KAPIYO

The Committee having considered her curriculum vitae and heard her oral submission during the vetting exercise/interview, made the following observations:-

- i) She has been nominated to serve as a Member of the Commission.
- ii) She was born in 1957 and hails from Homabay County.
- iii) She started her career as a teacher at Agoro Sare High School rising through the ranks.
- iv) She is currently working with the Ministry of Education Science and Technology as a Deputy Director of Education.
- v) She is currently pursuing a Ph. D in Education and Planning at Catholic University of East Africa. She Holds a Masters of Education (Education planning, Administration and Curriculum Development) Degree from Kenyatta University and a Bachelor of Education Degree from University of Nairobi.
- vi) She is also a Member of the Technical University of Kenya Council
- vii) She has undertaken several professional courses including introduction to Educational management for Secondary Schools, certificate in education management among others.

- viii) She has also authored books including Co-Author, The Evolving World, History & Government Form I-IV (Revised) & Teachers' Guide (OUP) among others.
- ix) She was ranked by the selection panel at position 4 with a mean score of 69.4%.
- x) She has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with her tax obligation.
- xi) She has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

#### 5.4 MR. WILLIAM MWITA MAKUBO

The Committee having considered his curriculum vitae and heard his oral submission during the vetting exercise/interview, made the following observations:-

- i) He had been nominated to serve as a Member of the Commission.
- ii) He was born in 1956 and comes from Migori County.
- iii) He is currently working with the Ministry of Education Science and Technology as a Head of Department (Bursaries and Grant Section).
- iv) He holds a Master of Business Administration (MBA) (Strategic Management) from the University of Nairobi and a Bachelor of Education, B. Ed (Maths) from University of Calgary Alberta, Canada.
- v) The selection panel ranked him position 16 with a mean score of 44.4%. However, as stipulated by the TSC Act, only thirteen names were forwarded by the selection panel, hence he was not in the list forwarded to the H.E President for nomination despite his name being sent to Parliament for approval.



- xii) He has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with her tax obligation.
- xiii) He has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

## 5.5 MR. JAMES MUTHURI NKOROI

The Committee having considered his curriculum vitae and heard his oral submission during the vetting exercise/interview, made the following observations:-

- i) He has been nominated to serve as a Member of the Commission.
- ii) He was born in 1960 and comes from Meru County.
- iii) He started his career as a head teacher in Igoki Secondary School, Meru County.
- iv) He is currently working with the Teachers Service Commission as a County Director, Samburu County.
- v) He holds a Master of Science (Applied Mathematics) Degree from JKUAT and a Bachelor of Education (B. Ed) Science (Double Mathematics) Degree from Kenyatta University.
- vi) The selection panel ranked him position 12 with a mean score of 58.6 % hence his name was forwarded to the H.E. for nomination.
- vii) He has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with her tax obligation.
- viii) He has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state

officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

#### 5.6 MR. MWIJUMA MWINYIPEMBE

The Committee having considered his curriculum vitae and heard his oral submission during the vetting exercise/interview, made the following observations:-

- i) He had been nominated to serve as a Member of the Commission.
- ii) He was born in 1955 and comes from Mombasa County.
- iii) He is currently working with the Ministry of Education Science and Technology as the acting Director of Quality Assurance.
- iv) He holds a Masters of Education (Administration) Degree from Kenyatta University and a Bachelor of Education (Arts) Degree from Kenyatta University. He has undertaken several professional courses.
- v) He has participated in several Publications in the education sector.
- vi) The selection panel ranked him position 1 with a mean score of 72.6%.
- ix) He sat in the previous selection panel representing the Permanent Secretary. He has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with her tax obligation.
- x) He has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

## 6.0 GENERAL OBSERVATIONS

The Committee made the following general observations:-

- 1) The Committee observed that a list of seven (7) names for the position of Chairperson was forwarded to the President in contravention of the TSC Act Section 8 (6) (d) which stipulates that a list of 3 names be forwarded to the President.
- 2) The Committee observed that the name of Mr. William M. Mwita was forwarded to the National Assembly for approval, despite his name not being among the thirteen (13) names forwarded to the H.E the President by the Selection Panel. This contravened the TSC Act which states that the President shall nominate from the thirteen names submitted to him by the Selection Panel.
- 3) The Committee observed that the selection panel displayed bias because of allowing Mr. Mwijuma Mwinyipembe who was former fellow panellist to appear for the second interview and ranked him position one (1) overall.
- 4) The Committee observed that Five (5) out of six (6) nominees were employees of the Ministry of Education, Science and Technology indicating a mass exodus of senior officials from the Ministry to TSC.
- 5) The Committee observed that the list lacked a mix of professionals, with all the nominees having a background in education.
- 6) The Committee observed that the nominees presented did not depict transitional leadership since majority of the nominees were over 55 years of age.
- 7) The Committee observed that special interest groups like persons with disabilities were not considered despite being in the list forwarded to the President.
- 8) The Committee observed that the list did not meet the constitutional requirement of regional balance.



## 7.0 RECOMMENDATIONS

Pursuant to Section 8(7) of the Teachers Service Commission Act No. 20 of 2012 and Standing Order No. 45 and based on the Committee observations, the Committee recommends that:-

- (i) Fresh advertisement is carried out for the positions of Chairperson and Members of the Teachers Service Commission.
- (ii) Fresh selection panel be constituted as per the TSC Act.
- (iii) Finally, this House rejects following six (6) nominees for appointment by H.E. the President as Chairperson and Members of the Teachers Service Commission.







## 1.0 Introduction

The Selection Panel for the appointment of Members of the Teachers Service Commission was convened on 12<sup>th</sup> July, 2013 pursuant to Section 8(1) of the Teachers Service Commission Act, 2012. The Membership of the Panel comprised the following:-

## 1.1 Vacant Positions

Five (5) positions of Members of the Commission fell vacant arising from the expiry of the term of Commissioners on 14<sup>th</sup> June, 2013. His Excellency the

President declared the five (5) vacancies vide Gazette Notice No. 9396 of 9<sup>th</sup> July, 2013 and appointed the Selection Panel.

## **1.2 Advertisement of Positions**

Advertisement of five (5) vacant positions of Members of the Commission was published in the Daily Nation and Standard Newspaper editions of 15<sup>th</sup> July, 2013 with a closing date of 26<sup>th</sup> July, 2013.

## **2.0 Applications**

The Panel received a total of two hundred and fifty four (254) applications for the position of Members.

### **2.1 Shortlisting of Applicants for Interviews**

The Panel adopted shortlisting criteria that took into account the following:

- (i) Qualifications;
- (ii) Relevance and level of experience;
- (iii) Regional balance;
- (iv) Gender;
- (v) Representation of persons with disability; and
- (vi) Integrity.

Shortlisting of candidates was done on 31<sup>st</sup> July, 2013 and sixteen (16) applicants were shortlisted for the position of Member.

### **2.2 Publication of Applicants**

Names of all applicants, their qualifications and shortlisted candidates were published in Daily Nation and Standard Newspapers editions of 1<sup>st</sup> August, 2013. The list of shortlisted candidates, their qualifications and regions are in **Appendix I** of this Report.

### **2.3 Interviews and Ranking**

Interviews of candidates for the position of Member were conducted on 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> August, 2013. The candidates were ranked in order of performance as per the list attached as **Appendix II**.

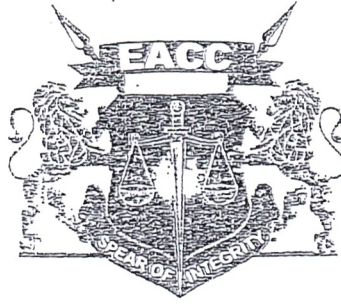



# REPORT OF THE SELECTION PANEL FOR THE APPOINTMENT OF CHAIRPERSON OF THE TEACHERS SERVICE COMMISSION

## 1.0 Introduction

The Selection Panel for the appointment of Chairperson of the Teachers Service Commission was convened pursuant to Section 8(12) of the Teacher Service Commission Act, 2012. The Membership of the Panel comprised the following:-

The Ministry of Devolution and Planning provided facilitation and support to the Panel. This included provision of an interview venue at Harambee House.

## 1.1 Vacant Position

The position of Chairperson fell vacant last year. Five applicants were shortlisted, interviewed and names of three candidates recommended and forwarded to the President for appointment on 18<sup>th</sup> October 2012.

Out of the three candidates recommended for appointment, H. E. the President forwarded Mr. Kiragu Wa Magochi's name to Parliament for approval. However, the nominee was rejected twice by Parliament. The TSC Act 2012 requires that there be new interviews for selection of Chairperson Teachers Service Commission.

## **1.2 Advertisement**

Advertisement of the position of Chairperson of the Teachers Service Commission was published in the Daily Nation and Standard Newspapers on 25<sup>th</sup> June, 2013 with a closing date of 8<sup>th</sup> July, 2013.

## **2.0 Applications**

The Panel received a total of thirty five (35) applications for the position of Chairperson.

### **2.1 Shortlisting of Applicants for interview**

The Panel adopted shortlisting criteria that took into account the following:-

- i. Qualifications;
- ii. Relevance and level of experience;
- iii. Regional balance;
- iv. Gender; and
- v. Disability.

The shortlisting of Candidates was done on 10<sup>th</sup> July, 2013 and five (5) applicants were shortlisted for the position of Chairperson. The Panel requested for clearance of the shortlisted candidates from the Ethics and Anti-corruption Commission. A copy of the clearance letter dated 10<sup>th</sup> July, 2013 is attached.

### **2.2 Publication of Applicants**

Names of the applicants, their qualification and the names of shortlisted candidates were published in the Daily Nation and Standard Newspapers on 11<sup>th</sup> July, 2013.

### **2.3 Interviews and Ranking**

Interviews of the shortlisted candidates for position of Chairperson were conducted on 15<sup>th</sup> July, 2013 and 2<sup>nd</sup> August, 2013 as follows:

#### **a) First Interview on 15<sup>th</sup> July, 2013**

Out of five (5) shortlisted candidates, only two candidates Prof. George Imbanga Godia, CBS and Mr. Robert Masese Momanyi were interviewed on 15<sup>th</sup> July, 2013 and ranked in order of performance as per the list attached in Appendix I.

The three other candidates who were shortlisted were not interviewed. This was because of a Court ruling on Petition No. 334 of 2013 dated 15<sup>th</sup> July, 2013 by Judge D. S. Majanja whose ruling was delivered to the Panel while the interviews were in progress.

These included:-

1. Dr. Lydia N. Nzomo
2. Mr. Simon M. Kavisi
3. Mr. Mbarak Said Twahir

Following advice from the Office of the Attorney General and Department of Justice, the Panel informed Dr. Lydia N. Nzomo, Mr. Kiragu Wa Magochi and Mr. Mbarak Said Twahir of the court ruling.

Members also informed Mr. Kiragu Wa Magochi that he could not be re-interviewed since his name had twice been rejected by the National Assembly.

#### **b) Second interview on 2<sup>nd</sup> August, 2013.**

The Panel in its meeting held on 22<sup>nd</sup> and 23<sup>rd</sup> July 2013 was informed that there was a further judgement on Petition No.370 of 2013 delivered by Judge D.S. Majanja at the Nairobi High Court on 22<sup>nd</sup> July 2013. The judgement directed that Mr. Kiragu Wa Magochi was eligible for interview and consideration since previous rejection by the National Assembly was not in itself a bar to subsequent application.


In view of the above judgements, members resolved that:-

1. The appointing authority should extend the period of the selection process in accordance with Section 8 (18) of the Teachers Service Commission Act, 2012;
2. Mr. Kiragu wa Magochi be invited for interview on 2<sup>nd</sup> August, 2013.
3. Dr. Lydia N. Nzomo, Mr. Mbarak Said Twahir and Simon Kavisi be briefed on the court judgement on 2<sup>nd</sup> August, 2013.

The Panel met on 2<sup>nd</sup> August, 2013 and (a) interviewed Mr. Kiragu Wa Magochi - his performance is as per Appendix II attached (b) Briefed Dr. Lydia N. Nzomo, Mr. Mbarak Said Twahir and Mr. Simon M. Kavisi on the two court Judgements.

The Panel submits the following seven (7) applicants not three (3) as required by TSC Act Section 8 (6) (d) shortlisted from fresh interviews and those included as per Petition No. 334 of 2013 and Petition No. 370 of 2013 of Nairobi High Court in order of merit.

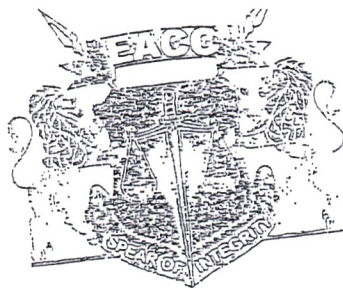

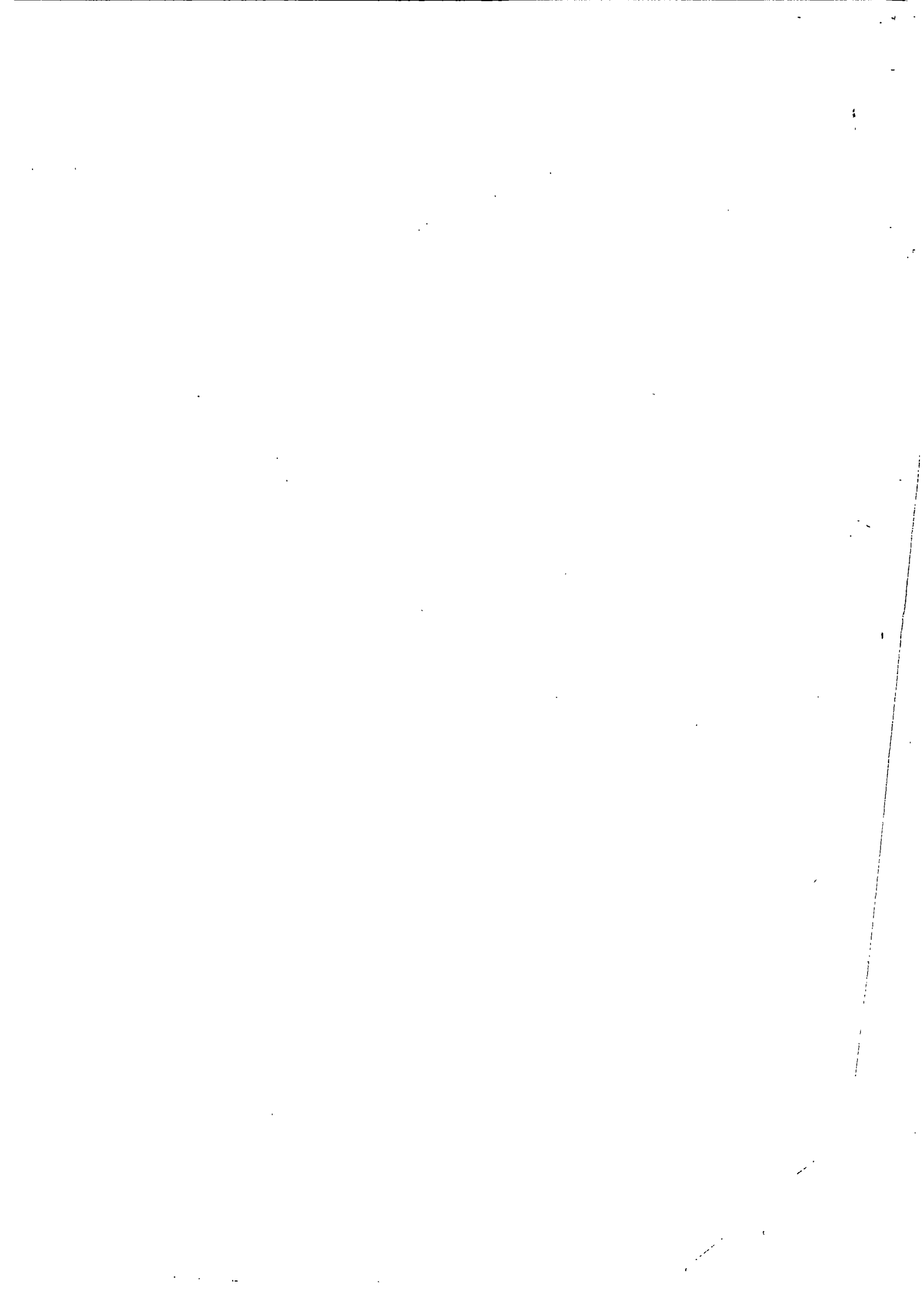

# **TSC ACT SECTION 8**

- (b) has knowledge and experience of at least fifteen years in matters relating to education and training; and
  - (c) meets the requirements of Chapter Six of the Constitution.
- (2) A person shall be qualified for appointment as a member if such person—
- (a) holds a degree from a university recognized in Kenya;
  - (b) has knowledge and experience of at least ten years in matters relating to any of the following fields—
    - (i) education;
    - (ii) governance;
    - (iii) management; or
    - (iv) law; and
  - (c) meets the requirements of Chapter Six of the Constitution.

(3) In appointing members of the Commission, the President shall ensure that at least two-thirds of the members have experience in education.

#### **7. Disqualification from membership**

A person shall not be qualified for appointment as a chairperson or member if the person—

- (a) is a serving member of Parliament or County Assembly;
- (b) is a serving member of a governing body of a political party;
- (c) is a member of a local authority; or
- (d) has been found in accordance with any law to have misused or abused a State office or public office or in any way to have contravened Chapter six of the Constitution.

#### **8. Procedure for nominations and appointment**

(1) Within fourteen days of the commencement of this Act, or whenever a vacancy arises in the Commission, the President in consultation with the Prime Minister shall by notice in the *Gazette* declare a vacancy and constitute a selection panel for the purpose of selecting suitable candidates for appointment as the chairperson or member of the Commission.

- (2) The selection panel constituted under subsection (1) shall consist of—
- (a) a chairperson not being a public officer appointed by the President;
  - (b) the Cabinet Secretary in the Ministry responsible for matters relating to education or his representative;
  - (c) the Attorney General or his representative;
  - (d) the Cabinet Secretary in the Ministry responsible for public service or his representative;
  - (e) one person nominated by the Federation of Kenya Employers;
  - (f) two persons, one man and one woman, nominated by the registered trade unions representing the interests of registered teachers;
  - (g) one person nominated by a recognised association of private schools; and

(h) a prominent educationist not serving in Government appointed by the Cabinet Secretary.

(3) A person appointed under subsection (2)(f) shall not be a serving official of the nominating union.

(4) The chairperson shall convene the first meeting of the selection panel within seven days of his or her appointment.

(5) The selection panel shall, within seven days of convening, invite applications from persons who qualify for nomination and appointment as chairperson or member of the Commission by advertisement in at least two daily newspapers of national circulation.

(6) The selection panel shall within seven days of receipt of applications under subsection (5)—

- (a) consider the applications to determine their compliance with the provisions of the Constitution and this Act;
- (b) shortlist the applicants;
- (c) interview the shortlisted applicants; and
- (d) submit the names of three qualified applicants for the position of chairperson and thirteen qualified applicants for the position of a member to the President.

(7) The President shall, within seven days of receipt of the names forwarded under subsection (6), nominate one person and eight others for appointment as chairperson and members of the Commission and forward the names to the National Assembly for approval.

(8) The National Assembly shall, within twenty one days of its sitting, consider each nomination received under subsection (7) and approve or reject any of them.

(9) Where the National Assembly approves the nominees, the Speaker of the National Assembly shall, within five days forward the name of the approved applicants to the President for appointment.

(10) The President shall, by notice in the *Gazette*, appoint the chairperson and members approved by the National Assembly within seven days of receipt of the approved nominees from the Speaker of the National Assembly.

(11) Where the National Assembly rejects any nominee, the Speaker shall within five days communicate its decision to the President and request the President to submit fresh nominations from amongst the persons shortlisted and forwarded by the selection panel under subsection (6).

(12) If the National Assembly rejects any or all of the subsequent nominees submitted by the President for approval under subsection (10), the provisions of subsections (5) and (6) shall apply.

(13) The panel shall stand dissolved upon the appointment of the chairperson and members under subsection (10).

(14) Where the provisions of subsection (11) apply, the panel shall continue to exist but shall stand dissolved upon the requisite appointments being made.

(15) The ministry responsible for public service shall provide secretariat services to the panel.

(16) In nominating or appointing a person as a member of the Commission, the panel and the President shall—

- (a) observe the principle of gender equity, ethnic and other diversities of the people of Kenya, and shall ensure equality of opportunity for persons with disabilities; and
- (b) take into account the national values and principles set out in Articles 10, 27 and 232 of the Constitution.

(17) Until after the first general election under the Constitution, the President shall in nominating persons for appointment as chairperson or member of the Commission act in consultation with the Prime Minister.

(18) Despite the foregoing provisions of this section, the President, in consultation with the Prime Minister may by notice in the *Gazette*, extend the period specified in respect of any matter under this section by a period not exceeding twenty-one days.

(19) Subject to this section, the panel may determine its own procedure.

#### **9. Oath of office**

The chairperson, members and the Secretary shall each make and subscribe before the Chief Justice the oath or affirmation set out in the First Schedule.

#### **10. Vacancy**

(1) The office of the chairperson or member shall become vacant if the holder—

- (a) dies;
- (b) by a notice in writing addressed to the President resigns from office;
- (c) is convicted of a criminal offence and sentenced to a term of imprisonment of not less than six months; or
- (d) is removed from office in accordance with Article 251 of the Constitution.

(2) The President shall notify every resignation, vacancy or removal as the case may be in the *Gazette* within fourteen days of such vacancy.

(3) Where a vacancy occurs in the membership of the Commission under subsection (1), the appointment procedure provided for in section 8 shall with necessary modifications, apply.

(4) A member appointed under subsection (3) shall serve for a non-renewable term of six years.

#### **11. Functions of the Commission**

In addition to the functions set out in Article 237 of the Constitution, the Commission shall—

- (a) formulate policies to achieve its mandate;

PUBLIC APPOINTMENTS (PARLIAMENTARY APPROVAL) ACT

[Date of assent: 11th November, 2011.]

[Date of commencement: 14th November, 2011.]

An Act of the Parliament to provide for procedures for parliamentary approval of constitutional and statutory appointments and for connected purposes

1. Short title

This Act may be cited as the Public Appointments (Parliamentary Approval) Act, 2011.

2. Interpretation

In this Act, unless the context otherwise requires—

“appointing authority” means any person who, under the Constitution or any other law, is required to make an appointment for which the approval of Parliament is required;

“appointment” includes any re-appointment to the same body, whether or not in the same capacity;

“candidate” means a person who has been proposed or nominated for appointment to a public office;

“Clerk” means the Clerk of the relevant House of Parliament; and

“Committee” means the relevant committee of Parliament or such other Committee as the Speaker may, for good reasons, direct.

3. Exercise of powers of appointment

An appointment under the Constitution or any other law for which the approval of Parliament is required shall not be made unless the appointment is approved or deemed to have been approved by Parliament in accordance with this Act.

4. Notification of vetting requirements

Any advertisement inviting applications for nomination for appointment to an office to which this Act applies shall indicate that candidates so nominated shall be required to appear before a committee of Parliament for vetting.

5. Notification of nomination

(1) An appointing authority shall, upon nominating a person for an appointment to which this Act applies, notify the relevant House of Parliament accordingly.

(2) A notification under subsection (1) shall be—

- (a) in writing;
- (b) be lodged with the Clerk of the relevant House of Parliament.

(3) A notification of appointment shall be accompanied by information concerning the nominee, having regard to the issues mentioned in section 7.

(4) For purposes of this Act, a notification of nomination shall be deemed to be duly given on the day on which it complies fully with subsections (2) and (3).

#### 6. Approval hearing

(1) Upon receipt of a notification of appointment, the Clerk shall invite the Committee to hold an approval hearing.

(2) The Committee shall determine the time and place for the holding of the approval hearing and shall inform the Clerk.

(3) The Clerk shall notify a candidate of the time and place for the holding of an approval hearing.

(4) The Committee shall notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing.

(5) Subject to this Act, all Committee proceedings on public appointments shall be open and transparent.

(6) Despite subsection (5), a Committee may, on its own motion or on the application of a candidate or any other concerned person, determine that the whole or part of its sittings shall be held in camera.

(7) An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

(8) The criteria specified in the Schedule shall be used by a Committee during an approval hearing for the purposes of vetting a candidate.

(9) Any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated.

(10) A candidate may, at any time, by notice in writing addressed to the Clerk, withdraw from the approval process and the candidate's nomination shall thereupon lapse.

#### 7. Issues for consideration

The issues for consideration by the relevant House of Parliament in relation to any nomination shall be—

- (a) the procedure used to arrive at the nominee;
- (b) any constitutional or statutory requirements relating to the office in question; and
- (c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

**8. Period for consideration and report**

(1) Unless otherwise provided in any law, a Committee shall consider a nomination and table its report in the relevant House for debate and decision within fourteen days from the date on which the notification of nomination was given in accordance with section 5.

(2) At the conclusion of an approval hearing, the Committee shall prepare its report on the suitability of the candidate to be appointed to the office to which the candidate has been nominated, and shall include in the report, such recommendations as the Committee may consider necessary.

**9. Failure of Parliament to act on nomination**

If, after expiry of the period for consideration specified in section 8, Parliament has neither approved nor rejected a nomination of a candidate, the candidate shall be deemed to have been approved.

**10. Rejection of nomination**

Where the nomination of a candidate is rejected by Parliament, the appointing authority may submit to the relevant House the name of another candidate, and the procedure for approval specified in this Act shall apply accordingly.

**11. Notification of decision**

The Clerk shall notify the appointing authority of the decision of the relevant House of Parliament within seven days of the decision.

**12. Powers of the committee**

(1) The committee shall have power to summon any person to appear before it for the purpose of giving evidence or providing information during approval hearing.

(2) For purposes of subsection (1), the committee shall have the same powers as the High Court to—

- (a) enforce the attendance of witnesses and examine them on oath, affirmation or otherwise;
- (b) compel the production of documents; and
- (c) issue a commission or request to examine witnesses abroad.

(3) Any person who—

- (a) disobeys any order made by a committee for attendance or for production of papers, books, documents or records; or
- (b) refuses to be examined before, or to answer any lawful and relevant question put by, a committee,

commits an offence and shall be liable, on conviction, to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding one year, or to both.

- (d) The submission of false information in the questionnaire is an offence and may result in prosecution.

- (f) The nominee must answer all the questions.



