## INTRODUCTION

The Constituencies Development Fund Act, 2013 Section 29 stipulates that the Board shall, on a monthly basis, submit a report to the National Assembly Select Committee detailing the following;

- a) A summary of the project proposals received from the constituencies in the preceding month and indicating the approval status of such projects;
- (b) A summary of the status of disbursements of funds to the constituencies for that preceding month;
- (c) A summary of the status of disbursements from the Treasury to the National Account;
- (d) Any restriction imposed on a constituency account in accordance with the Act.

Section 30 of the CDF Act 2013 further stipulates that the Board shall ensure that the list of projects forwarded to it by each constituency is, upon approval, funded in accordance with the Act.

The report submitted for the month of February, 2015 covered details of Project Proposals for 2014/15 Financial Year and status of disbursement of funds as at 28<sup>th</sup> February, 2015. This report covers updates on Project Proposals for 2014/15 Financial Year and the status of disbursement of funds as at 31<sup>st</sup> March, 2015.

A. SUMMARY OF PROJECT PROPOSALS RECEIVED FROM THE CONSTITUENCIES

(i) PROJECTS PROPOSALS FOR 2014/15 FINANCIAL YEAR

The CDF Board has deliberated on projects' proposals from two hundred and ninety (290) Constituencies with West Mugirango being the last project proposal to be deliberated on by the Board in its meeting held on 1<sup>st</sup> April, 2015.

Below is a summary of Board's resolution on the West Mugirango Project Proposal;

D. RESTRICTION IMPOSED ON A CONSTITUENCY ACCOUNT

The CDF Board management has imposed a temporary freeze on;

- (i) Kabete Constituency's bank account in order to ensure prudent management of funds during the electioneering period.
- (ii) Roysambu Constituency on request by the Ethics and Anti Corruption Commission. This is meant to conserve the funds pending an investigation being conducted by the Commission in the Constituency.

During the time of the freeze, only urgent and inevitable expenditures shall be allowed through the bank account, but with written authorization of the Chief Executive Officer, CDF Board.


