**THE DEMISE OF THE HON. KAMOTI MWAMKALE, MP, MEMBER
FOR RABAI CONSTITUENCY**

Honourable Members,

It is with deep sorrow that I notify all Members and the general public of the sudden demise of the Member for Rabai Constituency, **the Hon. Kamoti Mwamkale, MP**, who passed on last night, Sunday, 29th May 2022, through a tragic road accident that occurred along the Mombasa-Malindi Highway.

Honourable Members, the late Hon. Mwamkale has served two terms of Parliament, having been first elected in 2013. Until his demise, the late Hon. Mwamkale was an active Member of the Departmental Committee on Justice and Legal Affairs and the Select Committee on Delegated Legislation.

Honourable Members, the National Assembly, Rabai Constituency and indeed the nation, have lost an astute and dependable leader who served his people with utmost dedication. On your behalf, on behalf of the staff of the National Assembly and indeed on my own behalf, I wish to convey heartfelt condolences to the family of the late Hon. Kamoti Mwamkale, the people of Rabai Constituency, all his relatives and friends.

Honourable Members, and in line with the Parliamentary Service Commission's *Bereavement Policy*, I have constituted an *Ad-Hoc* Committee to assist the family and coordinate the interment arrangements. 
1. The Hon. Aisha Jumwa, MP;
