## FOREWORD BY THE CHAIRPERSON

**Honourable Speaker,**

On 6<sup>th</sup> March, 2024, the Speaker of the Senate reported that a Petition had been received from Ms. Christine Njoki Mweru regarding incomplete investigations and failure to arrest and prosecute suspects involved in the abduction and disappearance of her husband, Mr. Joshua Gichuki Mwangi. She stated that, while the person suspected of involvement in the disappearance of her husband and in the murder of another person was well known, he remained at large and seemingly beyond the reach of the Director of Criminal Investigations and the Director of Public Prosecutions.

The Petitioner therefore prayed that the Senate investigates the matter with a view of ensuring that the relevant bodies in charge of investigation and prosecution do their work, and ensure that justice was done to enable the family find closure on the disappearance of their kin in the hands of known suspects.

**Honourable Speaker,**

The Committee embarked on its consideration of the matter and, upon receiving the Petitioner's testimony, invited written responses to the Petition from the Director of Public Prosecutions, the Director of Criminal Investigations, the Independent Policing Oversight Authority and the Commission on Administrative Justice. The Committee also held a meeting with the four entities and the Petitioner to interrogate their respective responses and submissions on the matter. A summary of these responses and deliberations is set out at Chapter Two of this Report.

Having considered the Petition, received the testimony by the Petitioner, and considered the written and oral submissions by the DCI, ODPP, IPOA and CAJ, the Committee observed that there had indeed been an unreasonable delay in arresting and charging the person suspected of involvement in the disappearance of Mr. Joshua Gichuki Mwangi. This must have caused apprehension and distress on the part of the Petitioner that justice would not be done. However, following intervention by the Senate, the suspect was apprehended and charged with the offence of abduction with intent to murder with respect to Joshua Gichuki Mwangi.

**Honourable Speaker,**

The Committee therefore recommends that the Director of Public Prosecutions and the Director of Criminal Investigations undertake criminal proceedings in the two cases at the High Court and the Chief Magistrate's Court against Mr. Dennis Ndubi Mauda

and avail witnesses and evidence in court against the suspect. We also recommend that the DCI continues its investigations into the disappearance of Mr. Joshua Gichuki Mwangi who remains missing.

The Committee further affirms that, in accordance with Article 27 and Article 47 of the Constitution, all Kenyans are entitled to receive timely and efficient services from government authorities and agencies, irrespective of their means or social status. It is the duty of government authorities to proactively serve all citizens—without discrimination and without the need for external prompting—even in cases that do not attract public attention or media coverage. This upholds the constitutional guarantee of equal protection and benefit of the law, as well as the right to non-discriminatory access to public services for every individual.

**Honourable Speaker,**

I take this opportunity to thank the Petitioner, the Director of Public Prosecutions, the Director of Criminal Investigations, the Independent Policing Oversight Authority and the Commission on Administrative Justice for their detailed submissions which assisted the Committee in its deliberations and determination on the Petition. I commend the Members of the Committee for their diligence in executing this assignment, and thank the offices of the Speaker and Clerk of the Senate for the support extended to the Committee which made the consideration of the Petition successful.

## CHAPTER ONE: INTRODUCTION

### 1.1 Right to Petition Parliament

1. The right to present petitions to public authorities is provided for at Article 37 of the Constitution. Article 119(1) further provides that '*Every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legislation.*'
2. Parliament enacted the Petition to Parliament (Procedure) Act (No. 12 of 2012) to make provision for the procedure for the exercise of this right. Further, Part XXVII of the Standing Orders of the Senate also makes provision of how this right may be exercised.

### 1.2 Summary of the Petition

3. At the sitting of the Senate held on Wednesday, 6<sup>th</sup> March, 2024, the Speaker of the Senate reported that a Petition had been received from Ms. Christine Njoki Mweru regarding incomplete investigations and failure to arrest and prosecute suspects involved in the abduction and disappearance of Mr. Joshua Gichuki Mwangi. A copy of the Petition is attached to this Report as *Annex 2*.
4. The salient issues contained in the Petition were that –
  - a) on 3<sup>rd</sup> February, 2020, Mr. Joshua Gichuki Mwangi, (the Petitioner's husband), left their home in the company of Mr. Dennis Ndubi Mauda, aboard their vehicle of number plate KCS 481F;
  - b) on 4<sup>th</sup> February, 2020, barely 24 hours after their departure, the said vehicle was found abandoned in Ruaka;
  - c) the Petitioner made an official report about the disappearance of her husband on 4<sup>th</sup> February, 2020 and, on 13<sup>th</sup> February, 2020, she received a call from the investigating officer that the suspect, Mr. Dennis Ndubi Mauda, had been summoned to record a statement at Kabete Police Station;
  - d) the Petitioner on several occasions wrote to the Director of Criminal Investigations to follow up on her husband's case, but received unsatisfactory responses;
  - e) the case was afterward transferred from the original police station with jurisdiction to the Nairobi Area, Directorate of Criminal Investigations offices to be assisted by the now defunct Special Crimes Unit where the Petitioner met uncooperative officers; and,

- f) on 5<sup>th</sup> June, 2023, the Office of the Director of Public Prosecutions directed that the Office of the Directorate of Criminal Investigations have the Petitioner and her daughters record further statements regarding the disappearance of Mr. Joshua Gichuki Mwangi; and
  - g) the issues presented in this Petition were raised with the relevant bodies, including the Commission on Administrative Justice, the Independent Policing Oversight Authority, the Inspector General of Police, the Internal Affairs Unit, the Ministry of Interior and Security and the Office of the Director of Public Prosecutions, all of which had borne no fruits.
5. The Petitioner therefore prayed that the Senate –
- i) Investigates this matter with a view of ensuring that the relevant bodies in charge of investigation and prosecution give their account on why justice has never been served; and,
  - ii) Ensures that justice is served on the matter to enable the family to find closure on the disappearance of Mr. Joshua Gichuki Mwangi in the hands of known suspects
6. Pursuant to Standing Order 238(1), the Speaker committed the Petition to the Standing Committee on Justice, Legal Affairs and Human Rights for consideration.

## CHAPTER TWO: CONSIDERATION OF THE PETITION

### 2.1 Introduction

7. Upon committal of the Petition, the Standing Committee proceeded to invite the Petitioner who presented her testimony before the Committee on Wednesday, 24<sup>th</sup> April, 2024.
8. The Committee further invited and received written responses from –
  - a) the Office of Director of Public Prosecutions (ODPP);
  - b) the Directorate of Criminal Investigations (DCI);
  - c) the Independent Policing Oversight Authority (IPOA); and
  - d) the Commission on Administrative Justice (CAJ).
9. Additionally, the Committee held a meeting on Wednesday, 9<sup>th</sup> October, 2024 with the ODPP; DCI, CAJ and the Petitioner to deliberate on the Petition.
10. A summary of the responses and submissions by the said entities is set out below.

### 2.2 Response by the Directorate of Criminal Investigations

11. The Directorate of Criminal Investigations submitted that the circumstances of the matter entailed two cases comprising the offense of murder contrary to section 203 as read with section 204 of the Penal Code and abduction with intent to murder contrary to section 258 of the Penal Code. The murder case was pending before the High Court in Nairobi vide Criminal Case No. HCCRC/E008/2020 while for the abduction the case was pending before Milimani Chief Magistrate court in Criminal Case No. 142/56/2024 and Court File No. E 402/2024.
12. On the facts of the case, the DCI submitted that –
  - a) Two missing persons' reports were made on 4<sup>th</sup> and 5<sup>th</sup> February, 2020, at Kabete Police Station, that is –
    - i) by Christine Njoki Mweru, wife to the missing Joshua Gichuki Mwangi, a Kikuyu male adult (missing); and
    - ii) by Phanice Asiko Muhando, wife to Ben Maxwell Anyira, a Luhya male adult (deceased).
  - b) The reports indicated that the two men failed to return home from 3<sup>rd</sup> February, 2020 at about 8.00 pm when they were last seen.

- c) Investigations were initially commenced by DCI Dagoretti but were later taken over by RCIO Nairobi following a complaint by Christine Njoki Mweru of a slow pace of investigations.
- d) On 3<sup>rd</sup> February, 2020, Joshua Gichuki Mwangi, Ben Maxwell Anyira (deceased) and Denis Ndubi Mauda, a Luhya male adult (who has since been charged with murder pending before court) were together throughout the day moving from one location to another while aboard motor vehicle registration number KCS 481F Toyota Succeed belonging to and driven by Joshua Gichuki Mwangi.
- e) On the evening of the same day, the 3<sup>rd</sup> February, 2020, both Joshua Gichuki Mwangi and the deceased went back to their homes and informed their spouses separately that they were going to assist the suspect to rush a sick wife to hospital. It turned out that this was a plot by both Joshua Gichuki Mwangi and the deceased to hoodwink their spouses so that they could stay away from homes to continue with their planned unknown mission that would run late into the night.
- f) Joshua Gichuki Mwangi returned to his house at Riruta at about 7.30 pm and was later after about 30 minutes, followed by the suspect - Denis Ndubi Mauda who was not known to his family. The suspect pretended to be a neighbour seeking help from the said Joshua Gichuki to take his sick wife to the hospital which Gichuki Mwangi obliged, and they left in a hurry.
- g) Evidence gathered indicated that the suspect was not a resident of the locality of the victims and had no sick wife as claimed by the victims when he went to the house of Joshua Gichuki.
- h) The following day, on 4<sup>th</sup> February, 2020, an unknown body (that was after about three weeks identified as that of Ben Maxwell Anyira) was found dumped on a thicket along Ndeiya road off Nairobi-Mai Mahiu Road, by police officers from Ngubi Patrol Base of Kijabe Police Station. The body was collected and booked at City Mortuary in Nairobi. A post-mortem conducted on the body revealed the cause of death was a result of head injury due to sharp and blunt force trauma, an indication that the deceased was murdered before the body was dumped.
- i) Joshua Gichuki remains missing to date.
- j) Denis Ndubi Mauda, the suspect, being the last known person in physical contact with the two victims, was investigated whereby evidence was collected and analyzed. He was reasonably suspected to have played a key role in the disappearance of the two men. The case file was forwarded to the ODPP recommending the two offenses against the suspect i.e. that of Murder contrary to Section 203 as read with Section 204 of the Penal code

and Abduction with intent to Murder contrary to Section 258 of the Penal code.

- k) However, the ODPP recommended only the Charge of murder leading to the arrest and arraignment of the accused before the High Court at Nairobi - Criminal Division in criminal case number HCCRC/E008/2020 which is pending before the High Court.

13. The Directorate of Criminal Investigations further submitted that –

- a) Following further complaints by the Petitioner, Ms. Christine Njoki Mweru, a separate duplicate file was prepared and forwarded to the Director of Public Prosecution in respect of the missing Joshua Gichuki Mwangi vide Inquiry File No. 23 of 2021.
- b) The ODPP upon independently reviewing the file directed through a letter referenced: ODPP/HQ/ CAM/3/00077 dated 5<sup>th</sup> June, 2023 that the suspect be charged with the offence of Abduction with intent to Murder contrary to section 258 of the Penal code.
- c) Upon receiving the directives from the ODPP, the investigators made every effort to trace, arrest, and arraign the suspect. Investigating officers travelled to his rural home at Mungatsi in Busia County and to Mumbuini in Kirinyaga County where he was suspected to be residing.
- d) The suspect who was out on bond in the murder case at the High Court, had been hiding since then taking advantage of the fact that court mention dates were being conducted virtually, therefore, he did not need to appear physically in court. However, they did not succeed in effecting the arrest.
- e) On 12<sup>th</sup> September, 2023, the investigators informed the ODPP of the progress of the efforts being made to arrest the suspect and requested for their Intervention in arranging for a physical court attendance of the suspect on 24<sup>th</sup> October, 2023 but unfortunately it did not materialize.
- f) The suspect was eventually arrested on 15<sup>th</sup> April, 2024 and charged on 16<sup>th</sup> April, 2024, where he pleaded not guilty.
- g) The case is now pending before court and was scheduled for mention on 25<sup>th</sup> October, 2024 for confirmation of supply of evidence to the defense. The case was scheduled for next hearing on 25<sup>th</sup> November, 2024 before Court No. 8 at Milimani Law Courts.

14. A copy of the written response by the Directorate of Criminal Investigations is attached to this Report as *Annex 3*.

### 2.3 Response by the Office of the Director of Public Prosecutions

15. The Office of the Director of Public Prosecutions submitted that –
- a) Following a complaint received from Ms. Christine Mweru, the ODPP wrote to the CCIO Nairobi Area on 13<sup>th</sup> January, 2021 directing that they provide a status report within 14 days.
  - b) On 30<sup>th</sup> June, 2022, the DCI Regional Coordinator Nairobi informed the ODPP that the duplicate file was transmitted to DCI Headquarters. Later the duplicate police file was resubmitted to the ODPP for perusal and advice, through a letter dated 6<sup>th</sup> July, 2022.
  - c) On 20<sup>th</sup> February 2023, after careful and thorough perusal of the inquiry file, the ODPP directed further investigations to be conducted by the DCI and the file to be resubmitted for perusal.
  - d) On 5<sup>th</sup> June, 2023, the ODPP directed further areas of investigations to be carried out and, upon completion, the suspect by the name Dennis Ndubi Mauda, be charged with the offense of abduction of Joshua Gichuki Mwangi contrary to Section 256 as read with Section 258 of the Penal Code, Laws of Kenya.
  - e) On the same date, the ODPP informed the complainant, Ms. Christine Njoki Mweru, to liaise with the investigator and her two daughters to record further statements.
  - f) As a result, the DCI vide a letter dated 12<sup>th</sup> September 2023 addressed to the ODPP Homicide division, stated that the investigation team had recorded a further statement of the complainant and her two daughters, registered High Court Criminal Case No. HCCRC/E008/2020 before the High Court of Kenya at Nairobi against Dennis Ndubi Mauda for the murder.
  - g) However, the suspect, Dennis Ndubi Mauda was still at large and the investigating team was tracing him and affecting arrest.
  - h) The DCIO was required to comply with the directions to arrest Denis Ndubi Mauda and present him before the appropriate Chief Magistrate Court to face charges of abduction, as indicated in the letter dated 5<sup>th</sup> June, 2023.
16. At the meeting with the Committee held in October 2024, the ODPP further submitted that the Office had filed Criminal Case No. HCCRC/E008/2020 in the High Court against Denis Ndubi Mauda for the offence of murder against Ben Maxwell Anyira, and that the matter was ongoing in Court.
17. A copy of the written response by the Office of the Director of Public Prosecutions is attached to this Report as *Annex 4*.

## 2.4 Submissions by the Independent Policing Oversight Authority

18. The Independent Policing Oversight Authority submitted that –
- a) On 8<sup>th</sup> October, 2020, the Authority received a complaint from Ms. Christine Njoki Mweru against the Directorate of Criminal Investigations. The complaint pertained to the DCI's failure to act on a report concerning the kidnapping of one Joshua Gichuki Mwangi, which allegedly occurred on 3<sup>rd</sup> February, 2020, at his home in Riruta. The complaint was registered under reference No. IPOA/CMU/2283/2020.
  - b) Upon receipt, the Case Intake Committee reviewed the case and recommended a preliminary inquiry to ascertain the facts and gather more information regarding the complaint.
  - c) On 10<sup>th</sup> October, 2020, the Authority recorded a detailed statement from Ms. Mweru. During this session, she provided information about the DCI's failure to act on her report regarding the kidnapping of Joshua Gichuki Mwangi. The Authority categorized her complaint as a case of police inaction.
  - d) Since the alleged perpetrators of the kidnapping were not police officers, the Authority clarified that it does not have the mandate to investigate the alleged abduction by civilians. However, it can look into the alleged failure by the DCI to investigate the report and ensure that the matter is investigated.
  - e) On 27<sup>th</sup> October, 2020, the authority requested the DCI for immediate action on the matter.
  - f) On 4<sup>th</sup> February, 2021, officers from the Authority visited the office of the DCI to obtain a status update on the investigation into Joshua Gichuki Mwangi's kidnapping and to confirm that the investigation was actively underway.
  - g) On 8<sup>th</sup> February, 2021, the DCI informed the Authority that the investigation was active and being handled by the DCI Regional Coordinator for the Nairobi Area Region.
  - h) On 6<sup>th</sup> May, 2021, officers from the Authority visited Nairobi Area office. They met with the Deputy Regional Criminal Investigations Officer (RCIO) and the Investigating Officer (IO) handling the case, confirmed that the investigation was ongoing and that the DCI officers were in continuous communication with Ms. Mweru.
  - i) Ms. Mweru was briefed on these findings and advised to follow up with the Nairobi Area office directly. However, she requested that an officer from the Authority accompany her for support which request was acceded to by the Authority.

- j) Later, on 23<sup>rd</sup> August, 2021, Ms. Mweru, accompanied by IPOA officers, visited the Nairobi Area office, during which they were informed that one suspect had been apprehended and arraigned in court.
  - k) Despite this progress, the complainant expressed dissatisfaction because six other persons allegedly involved in the kidnapping were still at large.
  - l) Therefore, on 25<sup>th</sup> October, 2021, the Authority wrote to the Regional Criminal Investigations Officer (RCIO) for the Nairobi Area, formally requesting the case file and a cover letter.
  - m) On 3<sup>rd</sup> June, 2022, the complainant informed the Authority that the matter had been taken to court. The Authority sent a letter to the ODPP on 8<sup>th</sup> June, 2022, seeking confirmation that the case was under their review.
19. The Authority informed the Committee that the consequence of the foregoing was that:
- a) The Authority followed up and monitored investigations by the DCI into the matter and established that the DCI conducted investigations into the complaint by Ms. Christine Njoki Mweru.
  - b) The case was forwarded to the Office of the Director of Public Prosecutions and was now before the Milimani Law Courts, Court File No. E402/2024. The matter was coming up for a Hearing on 16<sup>th</sup> July, 2024.
  - c) With the matter currently in court, the Authority, under Section 26 of the IPOA Act, was statutory barred from investigating any matter which is the subject of proceedings before a court of law or judicial tribunal.
20. A copy of the written response by the Independent Policing Oversight Authority is attached to this Report as *Annex 5*.

## 2.5 Submissions by the Commission on Administrative Justice

21. The Commission on Administrative Justice submitted that –
- a) Following a complaint received from Ms. Mweru, the Commission wrote to the DCI on 6<sup>th</sup> June, 2024 and later issued to the DCI a Notice to Show Cause dated 24<sup>th</sup> July, 2024.
  - b) As a result, the DCI responded to the Notice to Show Cause, indicating that the matter was filed in Court under Milimani CM CR. Case No. E402 of 2024 wherein the accused Denis Ndubi Mauda was charged with the offence of Abduction with intent to Murder contrary to section 258 of the Penal Code. The hearing was scheduled for 26<sup>th</sup> September, 2024.
  - c) The Commission received a letter on 15<sup>th</sup> October, 2024 from the ODPP confirming that the matter was in court and called upon Ms. Mweru to

cooperate with the ODPP by availing herself and her witnesses. Ms. Mweru had so far been advised accordingly.

22. A copy of the written response by the Commission on Administrative Justice is attached to this Report as *Annex 6*.

## CHAPTER THREE: OBSERVATIONS

### 3.1 Committee Observations

23. Having considered the Petition, received the testimony by the Petitioner, and considered the written and oral submissions by the DCI, ODPP, IPOA and CAJ, the Standing Committee on Justice, Legal Affairs and Human Rights observes that –
- a) While the person suspected of involvement in the disappearance of Mr. Joshua Gichuki Mwangi and in the murder of Mr. Ben Maxwell Anyira was arrested and charged with the murder of the latter within a reasonable period, there appears to have been undue delays in arresting and charging the suspect with the offense of abduction of Mr. Joshua Gichuki Mwangi. This must have reasonably caused apprehension and distress on the part of the Petitioner that justice would not be done.
  - b) Once the subject Petition was presented to the Senate, the suspect was apprehended and charged in Court with the offence of abduction of Mr. Joshua Gichuki Mwangi. The Committee found it curious that, until then, the Directorate of Criminal Investigations indicated that they could not trace the suspect for purposes of effecting arrest.
  - c) At the time the Committee met with the DCI, ODPP, IPOA and CAJ in October 2024, the proceedings in both matters were ongoing, that is the murder case in respect of Mr. Ben Maxwell Anyira and the abduction with intent to murder case, in respect to Mr. Joshua Gichuki Mwangi.
24. The Committee affirms that, in accordance with Article 27 (*Equality and Freedom from Discrimination*) and Article 47 (*Fair Administrative Action*) of the Constitution of Kenya, all Kenyans are entitled to receive timely and efficient services from government authorities and agencies, irrespective of their means or social status. It is the duty of government authorities to proactively serve all citizens—without discrimination and without the need for external prompting—even in cases that do not attract public attention or media coverage. This upholds the constitutional guarantee of equal protection and benefit of the law, as well as the right to non-discriminatory access to public services for every individual.

## CHAPTER FOUR: RECOMMENDATIONS

### 4.1 Committee Recommendations

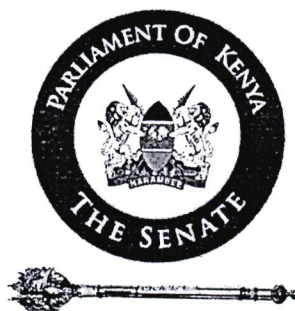
25. Arising from its Observations as set out in the preceding Chapter, the Standing Committee on Justice, Legal Affairs and Human Rights recommends that –

    - i) undertake criminal proceedings in *High Court Criminal Case No. E008 of 2020* before the High Court of Kenya at Nairobi against Dennis Ndubi Mauda for the offence of Murder of Ben Maxwell Anyira and in *Milimani CM Criminal Case No. E402 of 2024* against Dennis Ndubi Mauda for the offence of Abduction with intent to murder with respect to Joshua Gichuki Mwangi; and
    - ii) submit a status report to the Senate **every six months** from the tabling of this Report until the conclusion of the two matters.
  
  - b) the Directorate of Criminal Investigations to –
    - i) continue with investigations into the disappearance of Mr. Joshua Gichuki Mwangi, noting that has never been found and is still categorised as a case of disappearance;
    - ii) cooperate with the Office of the Director of Public Prosecutions in availing witnesses and evidence in *High Court Criminal Case No. E008 of 2020* before the High Court of Kenya at Nairobi against Dennis Ndubi Mauda for the offence of Murder of Ben Maxwell Anyira and in *Milimani CM Criminal Case No. E402 of 2024* against Dennis Ndubi Mauda for the offence of Abduction with intent to murder with respect to Joshua Gichuki Mwangi; and
    - iii) submit a status report to the Senate **every six months** from the tabling of this Report until the conclusion of the two matters.



The Committee commenced consideration of the Petition by Ms. Christine Njoki Mweru concerning incomplete investigations by the Office of the Directorate of Criminal Investigations and no prosecution by Office of the Director of Public Prosecutions to investigate, arrest and prosecute suspects involved in the abduction and disappearance of her husband Mr. Joshua Gichuki Mwangi.

Upon invitation by the Session Chairperson, the Petitioner, Ms. Christine Njoki Mweru proceeded to submit her testimony. Ms. Njoki submitted –

- a) that on the 3<sup>rd</sup> February, 2020 Mr. Joshua Gichuki Mwangi received a call while he was at home from Mr. Dennis Ndubi Mauda a man who claimed to be a neighbor and had a sick wife who needed help to urgently be taken to hospital what was later discovered to be false. They then left in the husband's vehicle KCS 481F which was not a taxi but personal car never to return again;
- b) that due setbacks by investigative officers assigned to the case, the matter was transferred from the original police station at Kabete to the Nairobi Area, Directorate of Criminal Investigation offices to be assisted by the now defunct Special Crimes Unit where she met uncooperative officers throughout;
- c) that she further sought help of the Commission of Administrative Justice (CAJ), Independent Policing Oversight Authority (IPOA), The Inspector General of Police, The Internal Affairs Unit, The Ministry of Interior Security and the Office of the Director of Public Prosecution (ODPP), where all these offices had written to the office of the DCI to follow up on the matter. However there had been no positive action by the office of the DCI despite the intervention of all these offices;
- d) that Mr. Dennis Ndubi Mauda, is currently facing murder charges related to a different person, Mr. Ben Anyira, who had accompanied Mr. Joshua Gichuki Mwangi to take the alleged sick wife of Mr. Dennis Ndubi Mauda to hospital;
- e) that on the 5<sup>th</sup> of June 2023, the office of the Director of Public Prosecutions (ODPP) directed the office of the Directorate of Criminal Investigations (DCI) to have Ms. Christine Njoki Mweru and her daughter record further statements into the offence of abduction with intent to murder contrary to Section 258 of the Penal Code, but nothing has been done;
- f) that she had gone through a lot of frustration in seeking investigation, arrest and prosecution of suspects involved in the abduction and disappearance of her husband Mr. Joshua Gichuki Mwangi; and

g) that the previous week, she received a text message from the Directorate of Criminal Investigations (DCI) stating that one of the suspects, Mr. Dennis Ndubi Mauda, had been arrested but released on bond.



I, the undersigned, **Christine Njoki Mweru** a Kenyan citizen of P.O. Box 53000-00200 a resident of Nairobi County in the Republic of Kenya;

**DRAW the attention of the senate to the following:**

1. **THAT**, on the 3<sup>rd</sup> of February 2020 while at home in Riruta my husband Joshua Gichuki Mwangi left home in the company of one Dennis Ndubi Mauda a man who claimed to be a neighbor and had a sick wife who needed urgent help to be taken to hospital .a fact later discovered to be false, they left aboard our vehicle KCS 481F never to return again.
2. **THAT**, on the 4<sup>th</sup> February 2020 barely 24hrs since they left my husband's car KCS 481 F was found in Ruaka abandoned.
3. **THAT**, on 4<sup>th</sup> February 2020 I made an official report about the disappearance at Kabete Police the station nearest to our home and the vehicle KCS 481 F was driven to Kabete Police and an O.B No.61 of 4<sup>th</sup> FEBRUARY 2020 was issued.
4. **THAT**, on 13<sup>th</sup> February 2020 I received a call from the investigating officer assigned to the matter that he had traced the suspect Dennis Ndubi Mauda who was later on summoned to record a statement at Kabete Police station.
5. **THAT**, I have on several occasions written to the Director of Criminal Investigations in a bid to follow up on my husband's case and have always been receiving inconclusive responds.
6. **THAT**, I believe that due to mismanagement and set backs mainly by investigative officers assigned to this case the matter was transferred from the original police station with jurisdiction at Kabete to the Nairobi Area ,Directorate of Criminal Investigations offices to be assisted by the now defunct Special Crimes Unit where I met un cooperative officers throughout.
7. **THAT**, I also sought the help of The Commission of Administrative Justice (office of the Ombudsman), IPOA, The Inspector General of Police, The Internal Affairs Unit, The Ministry of Interior Security and the Office of the

8. **THAT**, despite the intervention of all these good offices, there has been no positive action by the Directorate of Criminal Investigation in regard to my husband's disappearance including no arrests, no one been brought forward to be charged in relation to the abduction and or disappearance of my husband.
9. **THAT**, I have all documents evidence to support all of my correspondence with the investigative bodies in regard to the disappearance and abduction of my husband.
10. **THAT**, one of the suspects I have referred to in paragraph one (1) is currently facing a murder charge related to a different person via **HCCRC E008/2020 (High Court Milimani Nairobi.)**
11. **THAT** on the 5<sup>th</sup> of June 2023, the office of the Director of Public Prosecutions Directed the Office of the Directorate of Criminal Investigations to have myself and my daughters record further statements into the offence of Abduction with intent to Murder Contrary to Section 258 of the Penal Code but nothing has been done.
12. **THAT**, I have made the best efforts to have this matter addressed by the relevant authorities all of which have failed to give a satisfactory response.
13. **THAT**, none of the issues raised in this petition is pending in any court of law.

Reference is made to your letters Ref. SEN/DGAC/DGC/JLAHRC/2024/14/35 (b) dated 30<sup>TH</sup> September, 2024 and Ref: SEN/DGAC/DGC/JLAHRC/2024/14/37 (b) dated 11<sup>th</sup> October, 2024 on the above subject matter.

Brief circumstances of matter are that these are twin cases comprising the offence of Murder contrary to Section 203 as read with Section 204 of the Penal code and Abduction with intent to Murder contrary to Section 258 of the Penal code. The murder case is pending before High Court in Nairobi vide Criminal case No. HCCRC/E008/2020 while for the abduction the case is pending before Milimani Chief Magistrates court in criminal case No. 142/56/2024 and Court file No. E 402/2024.

Brief facts of the cases are that two missing persons' reports were made on 4<sup>th</sup> and 5<sup>th</sup> February, 2020 respectively at Kabete Police Station by Christine Njoki Mweru - wife to the missing Joshua Gichuki Mwangi, a Kikuyu male adult (missing) and Phanice Asiko Muhando - wife to Ben Maxwell Anyira a Luhya male adult (deceased) that the two men failed to return home from the 3<sup>rd</sup> February, 2020 at about 2000hrs when they were last seen. Investigations were initially commenced by DCI Dagoretti but were later taken over by RCIO Nairobi following a complaint by the said Christine Njoki Mweru of a slow pace of investigations.

Investigations established that on 3<sup>rd</sup> February, 2020, Joshua Gichuki Mwangi, Ben Maxwell Anyira (deceased) and Denis Ndubi Mauda, a Luhya male adult (who has since been charged with murder pending before court) were together throughout the day moving from one location to another while abode motor vehicle registration number KCS 481F Toyota Succeed belonging to and driven by Joshua Gichuki Mwangi. In the evening of same day, the 3<sup>rd</sup> of February, 2020, both Joshua Gichuki Mwangi and the deceased went back to their homes and informed their spouses separately that they were going to assist the suspect to rush a sick wife to hospital. It turned out that this was a plot by both Joshua Gichuki and the deceased to hoodwink their spouses so that they could stay away from homes in order to continue with their planned unknown mission that would run late into the night.

Joshua Gichuki Mwangi returned to his house at Riruta at about 1930 hours and was later on after about 30 minutes, followed by the suspect - Denis Ndubi Mauda who was not known to his family. The suspect pretended to be a neighbour seeking for help from the said Joshua Gichuki to take his sick wife to hospital which Gichuki Mwangi obliged and they left in a hurry. Evidence gathered indicated that the suspect was not a resident of the locality of the victims and had no sick wife as claimed by the victims when he went to the house of Joshua Gichuki.

The following day of 4<sup>th</sup> February, 2020, unknown body (that was after about three weeks identified as that of Ben Maxwell Anyira) was found dumped on a thicket along Ndeiya road off Nairobi Mai Mnahiu road, by police officers from Ngubi Patrol Base of Kijabe Police Station. The body was collected and booked at City Mortuary in Nairobi.

Post mortem conducted on the body revealed the cause of death was as a result of *head injury due to sharp and blunt force trauma*, an indication that the deceased was murdered before the body was dumped. Joshua Gichuki remains missing to date.

Denis Ndubi Mauda - the suspect, being the last known person in physical contact with the two victims, was investigated whereby evidence was collected and analysed. He was reasonably suspected to have played a key role in the disappearance of the two men. The case file was forwarded to the ODPP recommending the two offences against the suspect i.e that of Murder contrary to Section 203 as read with Section 204 of the Penal code and Abduction with intent to Murder contrary to section 258 of the Penal code. However, the ODPP recommended only the Charge of murder leading to arrest and arraignment of the accused before the High Court at Nairobi - Criminal Division in criminal case number HCCRC/E008/2020 that is pending before the High Court.

Following further complaints by the Petitioner, Christine Njoki Mweru, a separate duplicate file was prepared and forwarded to the Director of Public Prosecution in respect of the missing Joshua Gichuki Mwangi vide Inquiry file No. 23 of 2021. The ODPP upon independently reviewing the file directed through letter referenced: ODPP/HQ/CAM/3/00077 dated 5\* June, 2023 that the suspect be charged with the offence of Abduction with intent to Murder contrary to section 258 of the Penal code. Upon receiving the directives from the ODPP, the investigators made every effort to trace, arrest and arraign the suspect.


Investigating officers travelled to his rural home at Mungatsi in Busia County and to Mumbuini in Kirinyaga County where he was suspected to be residing. The suspect who was out on bond in the murder case at the High Court, had been in hiding since then taking advantage of the fact that court mention dates were being conducted virtually therefore, he did not need to appear physically in court. However, they did not succeed in effecting the arrest.

On the 12<sup>th</sup> September, 2023, through letter referenced: CID/C/CRI/6/4/VOL.49/3, the investigators informed the ODPP of the progress of the efforts being made to arrest the suspect and also requested for their Intervention in arranging for a physical court attendance of the suspect on the 24<sup>th</sup> October, 2023 but unfortunately it did not materialize. The suspect was eventually arrested on the 15<sup>th</sup> April, 2024 and charged on 16<sup>th</sup> April, 2024, where he pleaded not guilty. The case is now pending before court and

is scheduled for mention on 25<sup>th</sup> October, 2024 for confirmation of supply of evidence to the defence. The case is scheduled for hearing 25<sup>th</sup> November,2024 before court no.8 Milimani Law court.

In refence to your letter ref: SEN/DGAC/DGC/JLAHRC/2024/14 (b) dated 2<sup>nd</sup> April,2024 I wish to confirm that we did not appear before the committee on 25/4/2024 after receiving communication from the office of the clerk that there would be no sitting following the official opening of the Bunge towers on the material date and regarding letter ref:SEN/DGAC/DGC/JLAHRC/2024/14/35(b) dated 30<sup>th</sup> September,2024 our response was sent through the office of the Inspector General on 7<sup>th</sup> October,2024. However, any inconvenience caused is highly regretted.

**A. INTRODUCTION**

I write in reference to the above matter and acknowledge receipt of letters  
Ref. No. CAJ/POL/015/3668/2019-FN dated 14<sup>th</sup> and 18<sup>th</sup> July 2022.



In the aforesaid letters you have alleged that:

1. The Office of the Director of Public Prosecutions (ODPP) has never given a substantive response to the complaint by Julius Onkware Akunga on behalf of Patricia Akunga since 29<sup>th</sup> June 2020.
2. The alleged omission constitutes failure to act in discharge of a public duty under section 2(1)(b), unresponsive official conduct under section 8(b) and ineptitude and ineptitude within the public service under section (d) of the Commission on Administrative Justice Act.

As a consequence thereof, you have given a 14 days' notice to the Director of Public Prosecutions (DPP), to show cause why his name should not be entered in the Register of Malfeasant Public Officers. You have given further notice that the commission may take other action which may include issuance of summons to compel the DPP's attendance before the Commission and produce documents or give information or adjudicate on the complaint.

Your letter of purported notice to show cause which is devoid of any legal basis is obviously instigated by persons whose sole aim is to taint the name and the person of the DPP and the ODPP.

Whereas I am not under any legal obligation to explain my decision on whether or not to charge by dint of Article 157(10) of the Constitution of Kenya which provides that the DPP shall not be under the direction or control of any person or authority, including the Commission herein, it is in the public interest that I have taken the liberty to outline our position as ODPP as hereunder:

## **B. CONSTITUTIONAL MANDATE AND INDEPENDENCE OF THE ODPP**

1. Article 157(10) of the Constitution provides that:

**“The Director of Public Prosecutions shall not require the consent of any person or authority for the commencement of criminal proceedings and in the exercise of his or her powers or functions, shall not be under the direction or control of any person or authority.”**

2. The foregoing independence of the DPP and ODPP has been reinforced through various court pronouncements, to wit:

a) **Director of Public Prosecutions v Chrysanthus Okemo & 4 others (Petition 14 of 2020) [2021] KESC 13 (KLR) (Crim) (5 November 2021),**

b) **Diamond Hasham Lalji and another versus Attorney General and 4 others (2018) eKLR,**

c) **Nairobi High Court Petition No. E266 OF 2020, Okiya Omtatah Okoiti versus the Director of Public Prosecutions and 3 others,**

d) **Engineer Geoffrey K. Sang versus Director of Public Prosecutions and 4 others (2020) eKLR.**

### **C. MANDATE OF THE COMMISSION**

3. We have analysed the provisions of Article 252 of the Constitution on the functions of Commissions and Independent Offices which provisions are clear that, the Commission on Administrative Justice does not have the powers either to cite the DPP or issue the notice to show cause as it has purported to issue in the case herein. This is the same position under the provisions of section 8 and the Regulations made thereunder which the Commission has relied on as a basis to issue the notice to show cause.
4. We reiterate that the Office of the Director of Public Prosecutions is an **Independent Constitutional Office** established pursuant to article 157 of the Constitution to exercise the state powers of prosecution. Under Article 157(10) The Director of Public Prosecutions shall not require the consent of any person or authority for the commencement of criminal proceedings and in the exercise of his or her powers or functions, shall not be under the direction or control of any person or authority.
5. The Commission on Administrative Justice (CAJ) on the other hand is established under Section 3 of the Commission on Administrative Justice Act no. 23 of 2011 and its functions under Section 8 *inter alia* include;

a) investigate any conduct in state affairs, or any act or omission in public administration by any State organ, State or public officer in National and County Governments that is alleged or suspected to be prejudicial or improper or is likely to result in any impropriety or prejudice; (section 3(a))

b) investigate complaints of abuse of power, unfair treatment, manifest injustice or unlawful, oppressive, unfair or unresponsive official conduct within the public sector; (section 3(b))

c) inquire into allegations of maladministration, delay, administrative injustice, discourtesy, incompetence, misbehaviour, inefficiency or ineptitude within the public service; (Section 3(d))

6. The Commission, being a Commission established under an Act of Parliament (Commission on Administrative Justice Act) has no powers to oversight the Director of Public Prosecutions who is a holder of an Independent Constitutional Office because the hierarchy of laws does not either permit or envisage such as this would be tantamount to interfere and/or control which is contrary to the express provision Article 249(2) of the Constitution which stipulates:

***“The commissions and the holders of independent offices—***

***(a) are subject only to this Constitution and the law; and***

***(b) are independent and not subject to direction or control by any person or authority.”***

7. By purporting to direct and oversight the DPP with regards to a criminal matter, the Commission is acting *ultra-vires* its parent Act which provides under Section 30(1) that:

***Limitation of jurisdiction***

***“The Commission shall not investigate-***

***(b) a criminal offence;***

- (c) a matter pending before any court or judicial tribunal;
- (d) the commencement or conduct of criminal or civil proceedings before a court or other body carrying out judicial functions;
- (g) anything in respect of which there is a right of appeal or other legal remedy unless, in the opinion of the Commission, it is not reasonable to expect that right of appeal or other legal remedy to be resorted to;
- (h) any matter for the time being under investigation by any other person or Commission established under the Constitution or any other written law." (Emphasis added).
8. Evidently from the foregoing, the Commission has no powers to discharge oversight authority over either the DPP or the ODPP as doing so would be in flagrant contravention of the Constitution and the Commission on Administrative Justice Act, 2011.

#### **D. ACCOUNTABILITY OF THE OFFICE OF THE DPP**

9. The independence of the ODPP is bolstered by sections 6 and 7 of the ODPP Act, which provide that the ODPP is only accountable to the President and Parliament.
10. The only other institution that exercises oversight authority over the ODPP in regard to the discharge of his constitutional mandate is the judiciary by way of either Judicial Review or Constitutional petitions.
11. Pursuant to the aforesaid powers, vide a letter dated 12<sup>th</sup> August 2020, Parliament sought for a written response on the subject matter which the DPP substantively responded to vide a letter dated 19<sup>th</sup> August 2020. Copies of the two letters are attached hereto for ease of reference.
12. The National Assembly was satisfied by the response provided by the DPP and has never pursued the issue further.

13. In light of the foregoing, it is appalling that the commission which has no powers to oversight the ODPP is issuing unsubstantiated threats.

14. Owing to the Constitutional independence of the ODPP as illustrated above coupled with the fact that the DPP is only accountable to the President, Parliament and the Judiciary, the commission has no legal basis upon which it can issue a notice to show cause howsoever, whatsoever.

#### **E. POWERS OF THE DPP TO DIRECT INVESTIGATIONS**

15. Article 157(4) of the Constitution bestows upon the Director of Public Prosecutions (DPP) powers to direct the Inspector General of the National Police service and any other investigating agency to investigate any information or allegation of criminal conduct which directions should be complied with. The Article stipulates:

**“The Director of Public Prosecutions shall have power to direct the Inspector-General of the National Police Service to investigate any information or allegation of criminal conduct and the Inspector-General shall comply with any such direction.”**

16. Article 157(4) is buttressed by section 5 sub section 2(b) of the Office of the Director of Public Prosecutions Act which gives powers to the DPP to direct investigative agencies to conduct investigations by providing that:

**“The Director shall exercise State powers of prosecution and may—**

**(b) direct that investigations be conducted by an investigative agency named in the direction.”**

17. As shall be demonstrated below, since 2018, the ODPP gave directions on several occasions to the National Police Service to undertake investigations into certain identified outstanding areas which investigations were not undertaken until 1<sup>st</sup> December 2021 when the inquiry file was resubmitted and a decision made to prosecute named suspects.

18. Having directed the police to conduct further investigations, the onus was upon the investigators to undertake such investigations and resubmit the inquiry file with completed investigations.
19. As a consequence of the foregoing, the threat to cite the DPP for any alleged acts is unfounded and baseless and shall be met with the full force of law.

## **F. RESPONSE TO THE COMPLAINTS**

### **BACKGROUND**

#### **a) Nature of the Matters**

20. Julius Onkware Akunga made complaints in respect of two cases namely:
  - i. DCI Marani Cr. No. 645/223/2018  
Investigations into fraudulent transfer of land parcel No. West Kitutu/Mwamonari/38  
and Ob No. 46/22/11/2021.
  - ii. DCI Kitutu Central Cr. No. 642/165/2022  
Offence: Assault contrary to section 251 of the Penal Code.

The subject matter and the circumstances of the two cases are unrelated.

#### **i. Land Case**

21. In respect of investigations into fraudulent transfer of land parcel number West Kitutu/Mwamonari/38, the inquiry file was initially submitted to ODPP Kisii on or about **20<sup>th</sup> July 2016** for perusal and advice.
22. Vide a letter dated **20<sup>th</sup> July 2016** (copy attached), ODPP Kisii directed the DCI Marani Division to advise the parties to seek recourse in a succession court as opposed to criminal prosecution on the grounds that the case revolves around the estate of their late father.

23. The inquiry file was re-submitted by the DCI, Marani Division, to the ODPP on **2<sup>nd</sup> April 2018**(copy attached) for perusal and advice.
24. Vide a letter dated **30<sup>th</sup> May 2018**, ODPP, Kisii County gave consent to prosecute but identified certain outstanding areas which required to be covered. A copy of the letter dated 30<sup>th</sup> May 2028 is attached.
25. Following numerous letters of complaint to the DPP by Patricia Kerubo Akunga, the ODPP Headquarters called for a detailed status report from the ODPP, Kisii vide a letter dated **20<sup>th</sup> March 2019**(copy attached).
26. Vide a letter dated **19<sup>th</sup> June 2019**(copy attached), ODPP Kisii forwarded the inquiry file accompanied by a brief on the same. In the brief, ODPP Kisii recommended that the subject matter be dealt with by a civil or succession court and a withdrawal of the criminal case.

#### **b) Withdrawal of the First Criminal Case**

27. Upon receipt of the inquiry file, the prosecution case was reviewed in accordance with the National Prosecution Policy whereupon critical gaps were noted that necessitated a review of the previous decision to prosecute. Consequently, vide a letter dated **25<sup>th</sup> March 2020**(Copy attached), the ODPP directed that the criminal case be withdrawn and the identified outstanding areas be covered. The inquiry file was returned to ODPP Kisii with directions for the outstanding areas to be covered and the inquiry file resubmitted for perusal and further directions.
28. The CCIO Kisii County received the directions to cover the outstanding areas vide a letter dated 23<sup>rd</sup> April 2020 (see letter dated 6<sup>th</sup> May 2020 from the CCIO to the SCCIO, Marani Division).
29. The file was resubmitted by the SCCIO Marani Division to ODPP Kisii after a period of **16 months** vide a letter dated 10<sup>th</sup> August 2021(copy attached).

30. Upon perusal of the resubmitted inquiry file, the ODPP Kisii observed that the outstanding areas which had been identified previously had not been covered and communicated the same to the CCIO Kisii County vide a letter dated **3<sup>rd</sup> September 2021**(copy attached).

**c) Recharging of the Suspects**

31. The CCIO Kisii resubmitted the inquiry to ODPP Kisii vide a letter dated **11<sup>th</sup> November 2021**(copy attached) indicating that the outstanding areas highlighted had been covered.

32. Upon perusal of the inquiry file, ODPP Kisii vide a letter dated **1<sup>st</sup> December 2021**(copy attached) directed the police to charge the following suspects with the offences listed below:

33. Vide a letter dated **19<sup>th</sup> May 2022**(copy attached), the CCIO Kisii confirmed that, on 9<sup>th</sup> and 14<sup>th</sup> February 2022, three out of the five suspects named were arrested and charged in court, namely:

- a. Charles Ondieki Bosire,
  - b. Huron Ngare Mokua; and
  - c. Charles Ogendi Osoro.
34. The investigating officer in the aforesaid letter dated 19<sup>th</sup> May 2022 has stated that one Julius Onkware Akunga, who is the complainant in this case has been interfering with the investigations and has hindered the arrest of the remaining two suspects being John Barongo Nyaboro and William Siro Nyaboro who are brothers to Patricia Akunga (mother of the complainant) and uncles to the complainant herein (Julius Onkware Akunga).
35. The criminal case is pending trial in court and is fixed for mention on 24<sup>th</sup> August 2022 for a pre-trial conference.

#### ii. Assault Case

36. In respect of the assault case, upon receipt of the inquiry file, the ODPP analysed the evidence and concluded that there was no sufficient evidence to prosecute the suspect.
37. The decision was communicated to ODPP Kisii County and copied to the Commission vide a letter Ref. No. ODPP/CAM/13/2/25 dated **12<sup>th</sup> July 2022**. A copy of the letter and proof of delivery is attached for ease of reference.

#### G. WHETHER THE DPP RESPONDED TO THE COMMISSION

38. In your letter dated 18<sup>th</sup> July 2022, you acknowledge having received two letters dated 29<sup>th</sup> June 2020 and 26<sup>th</sup> April 2022 from the ODPP.
39. From our records, the ODPP responded to the Commission's first letter dated 23<sup>rd</sup> September 2019 vide a letter dated **29<sup>th</sup> June 2020** (which you have acknowledged receipt of), addressed to ODPP Kisii County and copied to the Commission.
40. The next correspondence from the commission to the ODPP was vide a letter dated 1<sup>st</sup> April 2022 which the ODPP responded to vide a letter dated **26<sup>th</sup> April 2022** (which you have acknowledged receipt of), in which we indicated that the subject matter was receiving the attention of the DPP and a response would be furnished to the Commission.

41. On 14<sup>th</sup> June 2022, the Commission wrote to the DPP inquiring an update in regard to the complaint filed by Julius Onkware Akunga of behalf of Patricia Akunga. The ODPP responded substantively to one of the complaints relating to an assault case vide a letter Ref. No. ODPP/CAM/13/2/25 dated **12<sup>th</sup> July 2022**. A copy of the letter is attached hereto.
42. In respect of the second limb of the complaint touching on fraudulent transfer of land, the ODPP wrote a letter Ref. No. ODPP/CAM/13/2/25 dated **19<sup>th</sup> July 2022** addressed to ODPP Kisii and copied to the Commission. In the letter, the ODPP pointed out that this was an old matter and directed the Head of ODPP Kisii to direct the police to cover the outstanding areas within 21 days and resubmit the inquiry file. A copy of the letter is attached for ease of reference.
43. It is clear from the foregoing that the ODPP has been in constant communication with the Commission. Consequently, the allegations that the DPP has failed to act in the discharge of public duty, is unsubstantiated, devoid of merit and tantamount to a malicious attempt by the Chairperson of the Commission to taint and malign the name of the DPP and the image of the ODPP in the eyes of right-thinking members of the public.

#### **H. MALICIOUS COMPLAINT BY JULIUS ONKWARE AKUNGA AGAINST THE ODPP**

44. Vide a letter dated **16<sup>th</sup> May 2022** addressed to the DPP and copied to the Commission amongst other public offices, Julius Onkware Akunga acknowledged that he was aware that criminal charges had been preferred against some of the suspects. The complainant even knew the case numbers of the criminal cases and when the matters were coming up in court.
45. The above notwithstanding, the complainant went ahead to complain that recommendations to charge the suspects have never been acted upon because of:


*“Negligence, unwillingness, ignorance and/or lack of interest by the Office of the DPP, Kisii, despite several attempts over the same by the correspondences between me and the office of the*

46. Evidently the complaint by Julius Onkware Akunga is made in bad faith, malicious and despicable and should be treated as such and not acted upon.
47. Regrettably, the Commission has accepted to be enjoined in a malicious scheme by third parties to maliciously malign my name and the ODPP for ulterior motive.

**I. CONCLUSION**

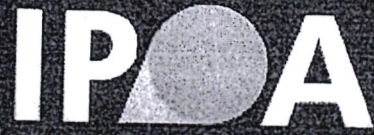
48. We have discharged our Constitutional duty by making the decision whether or not to charge in respect of the two complains and we have all along been in communication with the complainants herein and the Commission.
49. The complaint by Julius Onkware Akunga on behalf of Patricia Kerubo against me and the ODPP is devoid of merit, is malicious, unsubstantiated, without any legal basis, justification, and/or objective.
50. I take great exception to the insinuation in your letter dated 18<sup>th</sup> July 2022 that the undersigned has failed to act in the discharge of public duty, has been unresponsive, inefficient and ineptitude.
51. The threat to take any action against me is ill advised, misconceived, without legal basis and shall attract serious legal challenge from our part with the risk of the necessary attendant consequences on your part including but not limited to pecuniary or other available reliefs.

## **1. INTRODUCTION**

The Independent Policing Oversight Authority (herein after the Authority) is a statutory body established by Cap 86 of the Laws of Kenya (hereinafter IPOA Act). The main aim of the Authority is to provide civilian oversight over the work of the National Police Service. The objectives of the Authority are to; a) hold the Police accountable to the public in the performance of their functions; b) give effect to the provision of Article 244 of the Constitution; and c) ensure independent oversight of the handling of complaints by the Service.

The Authority commends and appreciates the Senate for its diligent oversight over public institutions including the Authority which by this submission provides an unreserved response to the Senate Standing Committee on Justice, Legal Affairs, and Human Rights, as requested in your letter dated May 16, 2024 and **[Ref. SEN/DGAC/DGC/JLAHRC/2024/22(b)]**. This response aligns with the Authority's mandate to ensure police accountability.

### **1.1 Protection of Right to Life**

Right to life is protected by our Constitution under Art. 26 which states “(1) Every person has the right to life, and (3) A person shall not be deprived of life intentionally, except to the extent authorized by this Constitution or other written law.” This therefore constitutionally prohibits extrajudicial killings in Kenya.

Enforced disappearance as per the International Convention for the Protection of All Persons from Enforced Disappearance<sup>1</sup> is the “arrest, detention, abduction or any other form of deprivation of liberty by agents of the State or by persons or groups of persons acting with the authorization, support or acquiescence of the State, followed by a refusal to acknowledge the deprivation of liberty or by concealment of the fate or whereabouts of the disappeared person, which place such a person outside the protection of the law”. Article 1 of the Convention states “No one shall be subjected to enforced disappearance”. Unfortunately, Kenya has not ratified this Convention.

## **2. MANDATE OF THE AUTHORITY**

The Authority draws its functions from the IPOA Act, key among these being to investigate any complaints related to disciplinary or criminal offences committed by any member of the National Police Service, whether on its own motion or on receipt of a complaint, and make recommendations to the relevant authorities. Such complaints include those of police inaction whereby, as in the present case, a complainant alleges that police officers have failed to carry out their functions under

investigation. If the Authority does not conduct an investigation itself, it will refer the complaint to another agency with appropriate jurisdiction and oversee that investigation. The legal basis for these investigations can be found in Sections 6(a), 7(a), 24 and 29 of the IPOA Act, 2011 and Sections 35(j) and 87(4) (e) of the NPS Act, 2011.

### **3. SUBMISSIONS BY THE AUTHORITY**

Based on the pertaining situation presented above, the Authority makes the following submissions:

#### **3.1 Complaint by Christine Njoki Mweru**

- a) On October 8, 2020, the Authority received a complaint from Christine Njoki Mweru ("the complainant") against the Directorate of Criminal Investigations (DCI). The complaint pertained to the DCI's failure to act on a report concerning the kidnapping of one Joshua Gichuki Mwangi, which allegedly occurred on February 3, 2020, at his home in Riruta. *(Attached herewith and Marked as Exhibit 1 is a copy of the Complainant)*
- b) The Authority registered this complaint on October 8, 2020, under Reference No. IPOA/CMU/2283/2020. Upon receipt, the Case Intake Committee reviewed the case and recommended a preliminary inquiry to ascertain the facts and gather more information regarding the complaint.
- c) On October 10, 2020, the Authority recorded a detailed statement from the complainant. During this session, she provided information about the DCI's failure to act on her report regarding the kidnapping of Joshua Gichuki Mwangi. This statement was crucial for the Authority's understanding of the specifics of the complaint and the timeline of events. Subsequently, the Authority categorized her complaint as a case of police inaction. Since the alleged perpetrators of the kidnapping were not police officers, the Authority clarified that it does not have the mandate to investigate the alleged abduction by civilians. However, it can look into the alleged failure by DCI to investigate the report and ensure that the matter is investigated. *(Attached herewith and Marked as Exhibit 2 is a copy of the Complainant's Statement).*

#### **3.2 Status update on action taken by the Authority after receipt of the complaint**

- a) On October 27, 2020, the Authority formally wrote to the Director of the Directorate of Criminal Investigations (DCI), highlighting the complaint and requesting immediate action. *(Attached herewith and Marked as Exhibit 3 is a copy of the letter sent to the DCI).*
- b) On February 4, 2021, officers from the Authority visited the office of the Director of Public Complaints at the DCI. Their purpose was to obtain a status update on the investigation into Joshua Gichuki Mwangi's kidnapping and to confirm that the investigation was actively underway.



- c) On February 8, 2021, the DCI responded to the Authority's inquiries vide a letter indicating that the investigation was active and being handled by the DCI Regional Coordinator for the Nairobi Area Region. *(Attached herewith and Marked as Exhibit 4 is a copy of the said letter).*
- d) On May 6, 2021, to ensure thorough follow-up, officers from the Authority visited the Nairobi Area office. They met with the Deputy Regional Criminal Investigations Officer (RCIO) and the Investigating Officer (IO) handling the case. The Authority confirmed that the investigation was ongoing and that the DCI officers were in continuous communication with the Complainant. The complainant was briefed on these findings and advised to follow up with the Nairobi Area office directly. However, she requested that an officer from the Authority accompany her for support which request was acceded to by the Authority.
- e) On August 23, 2021, the complainant, accompanied IPOA officers, visited the Nairobi Area office. During this visit, they were informed that one suspect had been apprehended and arraigned in court. However, despite this progress, the complainant expressed dissatisfaction because six other persons allegedly involved in the kidnapping were still at large.
- f) On October 25, 2021, the Authority wrote to the Regional Criminal Investigations Officer (RCIO) for the Nairobi Area, formally requesting for the case file and a covering letter. *(Attached herewith and Marked as Exhibit 5 is a copy of the said letter).*
- g) On June 3, 2022, the complainant informed the Authority that the matter had been taken to court. The Authority sent a letter to the ODPP on June 8, 2022, seeking confirmation that the case was under their review. *(Attached herewith and Marked as Exhibit 6 is a copy of the said letter).*

#### 4. CONCLUSION

The consequence of the foregoing is that;


- a) The Authority followed up and monitored investigations by the DCI into the matter and established that the DCI conducted investigations into the complaint by Ms. Christine Njoki Mweru.
- b) The case was forwarded to the Office of the Director of Public Prosecutions (ODPP) and is now before the Milimani Law Courts, Court File No. E402/2024. The matter is coming up for Hearing on **16<sup>th</sup> July 2024**.
- a) With the matter currently in court, the Authority pursuant to Section 26 of the IPOA Act, is statutory barred from investigating any matter which is the subject of proceedings before a court of law or judicial tribunal.

The Authority has done its best in realization of its mandate, by establishing that the police conducted extensive investigations into the matter by apprehending and charging the suspect/s in the matter in court.



The Authority remains steadfast in its mission to uphold the principles of good governance, thereby contributing to a more accountable and responsive police force for the benefit of all Kenyan citizens.

The Authority thanks the Senate Standing Committee on Justice, Legal Affairs and Human Rights (JLAHRC) and appreciates the opportunity granted to submit its submissions. Through such accountability measures, a professional and disciplined Service will be realized as articulated under Article 244 of the Constitution.

**CAJ SUBMISSIONS TO THE SENATE STANDING COMMITTEE ON JUSTICE, LEGAL AFFAIRS AND HUMAN RIGHTS ON THE PETITION BY CHRISTINE NJOKI MWERU REGARDING INCOMPLETE INVESTIGATIONS AND FAILURE TO PROSECUTE SUSPECTS INVOLVED IN THE ABDUCTION AND DISAPPEARANCE OF MR. JOSHUA GICHUKI MWANGI**

**Introduction**

The Commission on Administrative Justice (CAJ) is a Constitutional entity established under Article 59(4) of the Constitution and the Commission on Administrative Justice Act, 2011. The Commission has a mandate, *inter-alia*, to investigate any conduct in state affairs or any act or omission in public administration in any sphere of Government and complaints of abuse of power, unfair treatment, manifest injustice or unlawful, oppressive, unfair or unresponsive official conduct.

Further, the Commission is the oversight agency of the right to access to information as provided for by the Access to Information Act, 2016.

In the conduct of its functions, the Commission has powers to conduct investigations on its own initiative or on a complaint made by a member of the public, issue Summons and require that statements be given under oath, adjudicate on matters relating to Administrative Justice, obtain relevant information from any person or Governmental authorities and to compel production of such information.

**Background**

The Commission received a letter ref SEN/DSEC/DGAC/JLAGRC/2024/22(a) dated 16<sup>th</sup> May 2024 from the Clerk of the Senate inviting the CAJ to a meeting of the Committee on 23<sup>rd</sup> May 2024 at 9:00am.

The Committee is presently considering a Petition concerning incomplete investigations by the DCI and failure to prosecute suspects involved in the abduction and disappearance of Mr. Joshua Gichuki Mwangi which was presented in the Senate on 6<sup>th</sup> March 2024, and subsequently committed to the Committee.

The Senate letter invited the CAJ to submit any representations on the Petition.

### **Brief Facts of the Complaint:**

1. On **25<sup>th</sup> June 2020**, the complainant lodged a complaint with the Commission alleging failure by the DCI to finalize investigations and apprehend a suspect by the name Dennis who was the last person with her husband who disappeared on the night of 3<sup>rd</sup> February 2020. **A copy of the complaint is enclosed herewith, marked "Complaint Annexure "1"**.
2. The complainant averred that on the night of 3<sup>rd</sup> February 2020, a neighbour by the name Dennis came to her home and sought the assistance of her husband in rushing his sick wife to hospital using her husband's car. They left the house at around 8 pm and he did not return. Her call to her husband around 5.am went unanswered and later on his car was found abandoned at a car wash in Ruaka.
3. She reported the matter to Kabete Police Station under OB Number 61 and the matter was later transferred to Nairobi Area but the suspect was never arrested and the investigations have been undertaken at a very slow pace. She indicated that she has made several follow ups with the DCI as well as the Office of the Director of Public Prosecutions but the matter remained unresolved.

### **Action Taken by CAJ**

4. The Commission initiated an inquiry vide letter Ref: *CAJ/POL/015/3850/20-KWK* dated 20<sup>th</sup> August 2020 to the Director of Criminal Investigations inquiring on the allegations of delay in concluding investigations and effecting arrest of the suspect. **A copy of the CAJ inquiry letter is enclosed herewith, and marked "Annexure 2"**.
5. By a letter Ref: *DC/SEC/COMP/3/2/13/VOL.XXVII/65* dated 15<sup>th</sup> October 2020, the Director DCI referred the matter to Nairobi RCIO raising concerns over the slow pace of investigations and failure to arrest the suspect, instructing the RCIO to ensure that investigations are concluded and arrest effected. This was followed by a reminder under letter Ref: *DCI/SEC/COMP/3/2/13/VOL.XXIX/19* dated 4<sup>th</sup> December 2020 from DCI to Nairobi RCIO. **Copies of the letters dated 15<sup>th</sup> October 2020 and 4<sup>th</sup> December 2020 are enclosed herewith, and marked "annexure 3(a) and 3(b)"**.
6. In the course of our inquiry, the Commission noted that a number of other agencies were seized of the matter and were pursuing the same with DCI such as the Office of the Director of Public Prosecutions who vide their letter Ref: *ODPP/MUR/2020/72* dated 13<sup>th</sup> January 2021 requisitioned for a status update from the Nairobi CCIO on the investigations carried out to enable the ODPP respond to the complainant. Similarly, IPOA equally intervened as evident in their letter Ref: *IPOA/CMU/2283/2020* dated 27<sup>th</sup> October 2020 where IPOA called the DCI's attention on the matter and raised

concern over a nine months delay in taking action on the matter. **Copies of the ODPP and IPOA letters are enclosed herewith, and marked "annexure 4a and 4b".**

7. In a bid to ensure speedy investigations into the matter, the Commission sought the intervention of the Director, Internal Affairs Unit vide a letter dated 25<sup>th</sup> January 2021 after which the Director Internal Affairs vide a letter Ref NPS/IAU/SEC/3/2/13/VOL.VI/88 dated 27<sup>th</sup> January 2021 informed the complainant that the matter was under investigations by the Special Service Unit of the DCI requesting her to be patient as they waited the outcome of the investigations. **Copies of the IAU letter to complainant is enclosed herewith, and marked "annexure 5a"**. Further, the IAU vide a letter Ref: **NPS/IAU/SEC/3/2/13/VOL.VI/98(annexure 5b)** assured the Commission that the DCI was handling the matter and that investigations were at an advanced stage.
8. The Commission made further follow ups on this matter vide letter dated 30<sup>th</sup> November 2021 to DCI, 9<sup>th</sup> January 2023 to IAU, 13<sup>th</sup> February 2023 to the Director of Public Prosecutions and 26<sup>th</sup> October 2023 to DCI, after which the ODPP directed the DCI to identify and address the gaps in the investigations and resubmit the Police file to the DPP for further action. The ODPP further advised the complainant vide a letter dated 5<sup>th</sup> June 2023 to liaise with the IO for purposes of recording further statements. **Copies of the letters are enclosed herewith and marked "Annexure 6"**
9. Fundamentally, in the course of the inquiry, the Commission noted that the Office of the Director of Public Prosecutions was substantively seized of the matter and had issued various correspondence as cited above to the DCI directing the DCI to expedite investigations. This called the attention of the Commission to section 30(h) of the CAJ Act which ousts the mandate of the Commission where a matter is active before another agency. Section 30(h) reads "**The Commission shall not investigate any matter for the time being under investigation by any other person or Commission established under the Constitution or any other written law.**"
10. Nevertheless, the Commission's file for this matter remains open and the Commission will continue liaising with ODPP and DCI in the interest of justice to ensure the suspect is brought to justice.
11. Further, the Commission has been at all times in communication with the complainant who has indicated that the ODPP was pursuing the matter with the DCI.

#### **Analysis by CAJ**

12. The Commission has carefully considered this matter and noted that there has been a multi-agency intervention from various institutions such as the IPOA, IAU, Office of the Inspector General of Police and the ODPP and all agencies have played their role to ensure that justice is done.

13. In particular, the ODPP directed the DCI to address the gaps in investigations and return the Police file for further action and asked the complainant to record further statements. In these circumstances, the Commission could not direct further action by the ODPP following an advisory from the DPP to the Commission in a different matter regarding their prosecutorial independence under Article 157(10) of the Constitution 2010 and the ODPP Act. **Enclosed herewith is a copy of the DPP's Advisory Letter Ref: ODPP/CAM/13/2/25 dated 28<sup>th</sup> July 2022 to the Commission regarding independence of DPP's prosecutorial powers.**

14. The Commission further noted that the mandate over conducting criminal investigations rests with the National Police Service, DCI and on this, the DPP was also seized of.

#### **Conclusion and Recommendation:**


- i. The Commission discharged its mandate as provided in the CAJ Act 2011.
- ii. Upon analysis of the Complaint received, the CAJ noted that the issues raised revealed a possible case of criminal action and therefore referred the matter to the DCI for redress in accordance with their mandate. The Commission further sought the intervention of the ODPP and the Internal Affairs Unit to ensure expeditious resolution of the matter.

It is worth noting that under section 30 (b) and (h) of the CAJ Act, the CAJ shall not investigate a criminal offence, and any matter for the time being under investigation by any other person or Commission established under the Constitution or any other written law. On this basis, the CAJ jurisdiction was ousted.

Further, the Constitution provides under Article 157 (10) that "The DPP..... shall not be under the direction or control of any person or authority..."

- iii. The CAJ procedure is that once its mandate is ousted, the Commission does not undertake further inquiry on the issues.

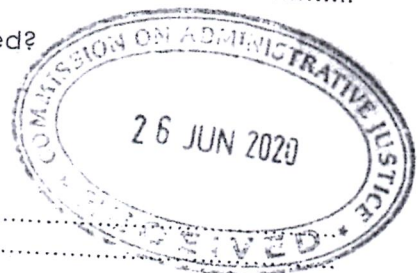

The Independent Policing Oversight Authority is in receipt of a complaint from Christine Njoki Mweru. The complainant alleges that on 3<sup>rd</sup> February 2020, her husband, Joshua Gichuki Mwangi, was picked from their home by an alleged 'Baba Dennis.' The said Baba Dennis, introduced himself as a neighbor and requested Joshua Gichuki Mwangi, to assist him take his wife to hospital as he owns a car. The two left around 8.00 pm. The complainant alleges that since then, her husband never came back home. His vehicle, Toyota Succeed KCS 481F was found dumped at an open car wash near Rosellyne Riveria in Ruaka.

The complainant then, together with her brother in law, went and reported the matter to Kabete Police Division. However, they did not receive much help. This forced her to write to your office, where she was then referred to the Special Crime Unit for further assistance through a letter **REF: DCI/IB/SEC/4/4/1/VOL.LXVII/8/** dated 3<sup>rd</sup> April 2020. The complainant also reported the matter to Nairobi Area DCI who took up the matter, investigated and found six suspects. However, she alleges that since then, the suspects have not been arrested and taken to court. The main suspect, who picked her husband from home, however, was arrested and presented before the High Court, **Court File No: HCCRC/E08/2020**, where he was charged with the murder of one Ben Maxwell Anyilla, who was also picked the same day her husband was picked, but not the disappearance of Joshua Gichuki Mwangi.

The complainant is aggrieved as it has now been 9 months and her husband is yet to be found. She alleges that she has been to your offices on various dates to follow up the matter but has received no help.

After a careful consideration of the said complaint, the Authority is of the opinion that your good office is better placed to deal with the said complaint. Accordingly, the same is hereby referred to you for your perusal and appropriate action.

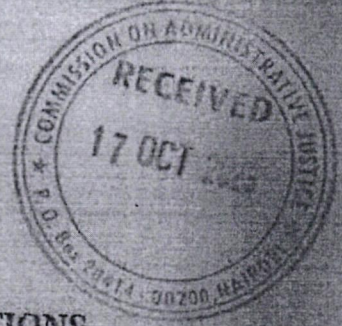


