## 1.0 INTRODUCTION

Article 127 of the Constitution of Kenya, 2010 establishes a Parliamentary Service Commission with functions with responsibilities as are set out in Article 127 (6) (a) to (e) and the Parliamentary Service Act. These include the following:-

- a) providing services and facilities to ensure the efficient and effective functioning of Parliament;
- b) constituting offices in the parliamentary service and appointing and supervising office holders;
- c) preparing annual estimates of expenditure of the parliamentary service and submitting them to the National Assembly for approval and basically exercising budgetary control over the service;
- d) undertaking programmes to promote the ideals of parliamentary democracy;
- e) performing other functions –
  - i) necessary for the wellbeing of the members and staff of Parliament; or
  - ii) prescribed by national legislation.

Article 127(2) & (3) of the Constitution provides that the Parliamentary Service Commission shall consist of the following Members -

(2)(a) the Speaker of the National Assembly, as chairperson;

(b) a vice-chairperson elected by the commission from among its members

(c) seven members appointed by Parliament from among its members as follows:-

- (i) four shall be nominated equally from both Houses by the party or coalition of parties forming the national government, of who at least two shall be women; and
- (ii) three shall be nominated by the Parties not forming the national government, at least one of whom shall be nominated from each House and at least one shall be a woman; and

*(d) one man and one woman appointed by Parliament from among persons who are experienced in public affairs but are not members of Parliament.*

(3) The Clerk of the Senate shall be the Secretary of the Commission.

## **2.0 VACANCY IN THE POSITION OF MALE NON-MEMBER OF PARLIAMENT COMMISSIONER**

The position of the male Non-Member of Parliament Commissioner under Article 127 (2)(d) became vacant following the resignation of Hon. (Dr.) Abdullahi Ibrahim Ali, with effect from 7<sup>th</sup> February, 2017 for purposes of contesting for an elective position in the General Elections that took place on 8<sup>th</sup> August 2017.

## **3.0 APPROVAL OF PROCEDURE FOR APPOINTMENT OF THE NON-MEMBER OF PARLIAMENT COMMISSIONER**

Neither the Constitution nor the Parliamentary Service Act provide for the procedure to be used in filling a vacancy under Article 127(2)(d) of the Constitution. Consequently therefore, at its 236<sup>th</sup> Meeting held on 9<sup>th</sup> February, 2017, the Commission considered and adopted the procedure in Annex I for appointment of the non-Member of Parliament Commissioner under Article 127 (2) (d) as indicated below -

- (a) That upon a vacancy arising in the membership of the Commission under Article 127(2)(d) of the Constitution, the Commission shall, within **fourteen (14)** days of the occurrence of the vacancy, by notice in the Gazette and at least two (2) daily newspapers of national circulation, declare a vacancy and invite interested qualified persons to apply.
- (b) Any person qualified in accordance with the Constitution may make an application within **fourteen (14)** days of the publication of the notice.

- (c) The Parliamentary Service Commission shall, within **fourteen (14)** days after the last date of submission of application under paragraph 2, consider the applications, shortlist, conduct interviews and recommend -
- (i) in respect of a vacancy of a member who is a woman, the name of one female applicant qualified for the position;
  - (ii) in respect of a vacancy of a member who is a man, the name of one male applicant qualified for the position.
- (d) The names of the persons recommended under paragraph 3 shall be submitted to the National Assembly and the Senate for approval and appointment in accordance with the Standing Orders of the respective Houses.
- (e) If both Houses of Parliament approve the names recommended under paragraph 3, the Commission shall, within seven days after the approval, publish the name in the Gazette.
- (f) Where one or the two Houses of Parliament reject the names recommended under paragraph 3, the Speaker of the relevant House shall communicate the decision to the other House and request for a fresh nomination by the Commission.
- (g) In submitting a new nominee under paragraph 6, the Commission shall within **seven (7)** days, submit to the National Assembly and the Senate a fresh nomination from amongst the persons shortlisted by the Commission under paragraph 3.
- (h) If either or both of the Houses of Parliament rejects any or all of the subsequent nominees submitted by the Commission for approval under paragraph 7, the provisions of paragraphs 1 to 6 shall apply.
- (i) A person is qualified to be appointed a member of the Parliamentary Service Commission under Article 127(2)(d) if-
- (i) the person is a citizen of Kenya;
  - (ii) holds a degree from a university recognized in Kenya;
  - (iii) has at least ten years' experience in public affairs; and

- (iv) meets the requirements of leadership and integrity set out in chapter 6 of the Constitution.
- (j) In addition the persons qualified to be appointed a member of the Parliamentary Service Commission are expected to-
  - (i) demonstrate experience or interest in consolidating and advancing the ideals and objectives of Parliamentary democracy;
  - (ii) demonstrate adherence to the national values and principles set out in Article 10 of the Constitution;
  - (iii) reflect the regional and ethnic diversity of the people of Kenya.

#### **4.0 ADVERTISEMENT AND LONG-LISTING FOR THE VACANT POSITION OF MEMBER OF THE PARLIAMENTARY SERVICE COMMISSION**

The Parliamentary Service Commission (PSC) invited applications in two (2) local dailies of national circulation from persons who qualify for appointment for the vacant position of the male non-Member of Parliament Commissioner.

The advertisement was published on Wednesday, 25<sup>th</sup> April 2018 and closed on Friday, 18<sup>th</sup> May, 2018. (See Annex II) A total of one hundred and forty two (142) applications were received and long-listed. (See Annex III)

The Board of Senior Management considered the long-list report at its 153<sup>rd</sup> Meeting held on 28<sup>th</sup> May, 2018 and recommended that –

**Considering the strict timelines set out in the Rules of Procedure for the Appointment of Non-Member of Parliament Commissioner, the Members Welfare Committee of the Parliamentary Service Commission considers the long-list report and short-lists the applicants based on the set qualifications and submits the names of short-listed applicants to the Commission for consideration and approval.**

At its 92<sup>nd</sup> Meeting held on 5<sup>th</sup> June, 2018, the Commission Committee on Members Welfare considered the long-list report and noted as follows –

- (i) That the fourteen (14) days period within which the Commission is required to consider the applications, short-list applicants, conduct interviews and recommend a name of the suitable candidate for the position, lapsed on 3<sup>rd</sup> June, 2018.
- (ii) Further, that the timelines were set by the Commission as part of the Rules of Procedure and may be extended.

Based on the foregoing, the Committee resolved that -

- (i) Members of the Board of Senior Management present under the chairmanship of Commissioner Dr. Lonah Mumelo short-lists fifteen (15) applicants in accordance with the requirements set out in the Rules of Procedure for the Appointment of Non-Member of Parliament Commissioner adopted by the Commission at its 236<sup>th</sup> Meeting held on 9<sup>th</sup> February, 2017, and submit a report to the Committee at a meeting scheduled for Tuesday, 12<sup>th</sup> June, 2018.
- (ii) Thereafter the Committee considers the short-list report and forwards its recommendations to the Parliamentary Service Commission for its consideration.

## **5.0 SHORT-LISTING OF APPLICATIONS**

In accordance with the Rules of Procedure for the Appointment of Non-Member of Parliament Commissioner adopted by the Commission at its 236<sup>th</sup> Meeting held on 9<sup>th</sup> February, 2017, a person is qualified to be appointed a member of the Parliamentary

Service Commission under Article 127(2)(d) if the person possesses the following qualifications -

- (i) is a **citizen** of Kenya;
- (ii) holds a **degree** from a university recognized in Kenya;
- (iii) has at least **ten years'** experience in public affairs; and
- (iv) meets the requirements of leadership and integrity set out in **Chapter 6** of the Constitution.

At its 245<sup>th</sup> Meeting held on 28<sup>th</sup> June, 2018, the Commission short-listed the following candidates for the position of non-Member of Parliament Parliamentary Service Commissioner in accordance with the criteria -

The Commission further resolved to interview the short-listed candidates at an interview set for Thursday, 19<sup>th</sup> July, 2018.

## **6.0 PUBLICATION OF LONG-LISTED AND SHORT-LISTED APPLICANTS AND CALL FOR INTERVIEWS**

On 12<sup>th</sup> July, 2018, the Commission published in two papers of national circulation (The Daily Nation and the Standard Newspaper), names of all 142 applicants who applied for the position of non-Member of Parliament Commissioner. (See Annex IV). The publication further invited the six (6) short-listed candidates for oral interviews to be held on Thursday, 19<sup>th</sup> July, 2018 as per the schedule below –

## 8.0 ORAL INTERVIEW RESULTS



The Parliamentary Service Commission is established under Article 127 of the Constitution of Kenya to among other things, provide services and facilities to ensure the efficient and effective functioning of Parliament. Article 127 of the Constitution provides that the Parliamentary Service Commission shall consist of, among others, one man and one woman appointed by Parliament from among persons who are experienced in public affairs, but are not members of Parliament.

The Commission now invites applications for one (1) vacant position for the male non-MP Member of the Parliamentary Service Commission under Article 127(2)(d) of the Constitution. The vacancy is to be filled by Parliament as provided for under Article 127(2)(d) of the Constitution. Please note that there is currently no vacancy for the one woman Commissioner under Article 127(2)(d) of the Constitution and accordingly no qualified male candidates are eligible to apply.

A person is qualified to be appointed as a member of the Parliamentary Service Commission under Article 127(2)(d) if the person –

- (a) is not a Member of Parliament;
- (b) is a citizen of Kenya;
- (c) holds a degree from a university recognized in Kenya;
- (d) has at least ten years experience in public affairs; and
- (e) meets the requirements of leadership and integrity set out in chapter 6 of the Constitution.

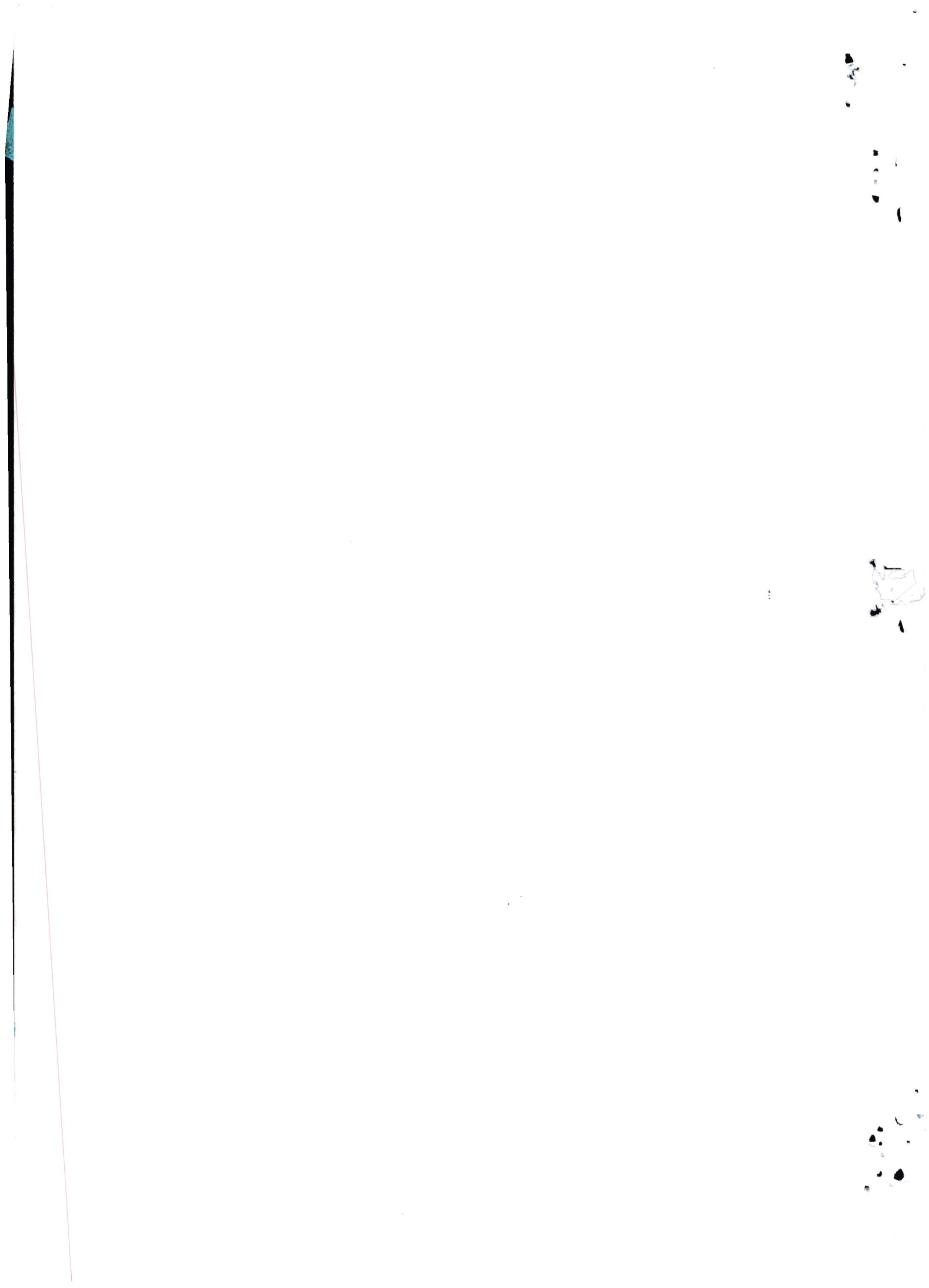
