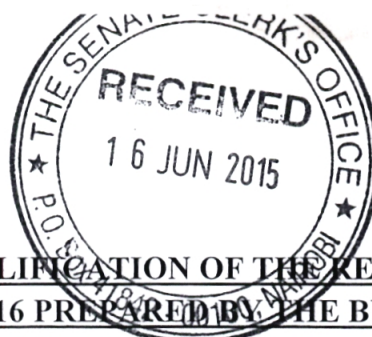

[Standing Order 220 of the Senate Standing Orders]

I, the undersigned, on behalf of the Chairpersons of all Sectoral Committees of the Busia County Assembly and being the elected Ward Representative of Namboboto Ward within Busia County do hereby submit my Petition pursuant to Article 119 of the Constitution of Kenya for due consideration and determination of the issues of concern stated herein below;

I HEREBY DRAW the attention of the Senate to the following:

- **THAT** there are 8 Standing Sectoral Committees which were formed pursuant to Standing Order 191 of the Busia County Assembly Standing Orders.
- **THAT** Standing Order 207 thereof provides for the budget making process in the County Assembly and specifically that each select committee shall consider, discuss and review the estimates according to its mandate and submit its report to the County Budget and Appropriations Committee within twenty one (21) days after being laid before the County Assembly.
- **THAT** I am further aware that before laying its report on the Budget Estimates before the County Assembly, the County Budget and Appropriations Committee must take into account the recommendations of the Select Committees and the views of the County Executive Committee Member responsible for Finance pursuant to Standing Order 207 (5).

**PETITION TO THE SENATE FOR NULLIFICATION OF THE REPORT ON BUDGET
ESTIMATES FOR THE FY 2015/2016 PREPARED BY THE BUSIA COUNTY
ASSEMBLY BUDGET AND APPROPRIATIONS COMMITTEE**

- **THAT** I am aware that the Busia County Assembly Budget and Appropriations Committee proceeded to prepare a report on the Budget Estimates for the Financial Year 2015/2016 without requesting for, collecting or even taking into account the views of any of the select committees of the County Assembly which is contrary to law.
- **THAT** I drafted a Motion and forwarded it to the Clerk of the County Assembly which Motion was received on 8th June 2014 for onward transmission to the County Assembly Business Committee but before the same could reach the floor of the House, steps were purportedly taken to send the Chairpersons of Sectoral Committees to air their views before the Budget and Appropriations Committee.
- **THAT** even so, the recommendations of the Select Committees were not received within 21 days of tabling of the Budget Estimates before the Assembly as required by law.
- **THAT** it is against this backdrop that the Petitioner herein do seek the intervention of the Senate to nullify the report on budget estimates for the Financial Year 2015/2016 prepared by the Busia County Assembly Budget and Appropriations Committee.

THAT despite involving the Speaker of the County Assembly, the Deputy Speaker and the Clerk of the Assembly little or nothing has been done to ensure that the Budget Making process is conducted in accordance with the County Assembly Standing Orders and related Statutes and a resolution made to the effect of nullifying the report or in the alternative, stopping the report writing process to ensure the views of the Select Committees are incorporated.

THAT I do confirm that the issues in respect of which this petition is made are not pending before any court of law, constitutional or legal body.

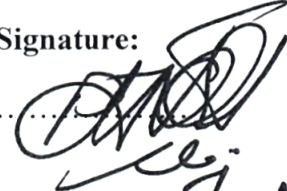
HEREFORE, your humble petitioner prays that the Senate;
