

## **CHAIRPERSON'S FOREWORD**

Pursuant to Article 132 (2) (e) of the Constitution and section 5 of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, H.E. the President, forwarded to the National Assembly, a notification of appointment containing the names and Curriculum Vitae of six (6) Ambassador/High Commissioner nominees on 20<sup>th</sup> May, 2019. This was for consideration and approval by the National Assembly for subsequent appointment as Ambassador/High Commissioner.

On Wednesday, 29<sup>th</sup> May, 2019, the Speaker Conveyed the names of nominees of persons for appointment as Ambassadors and High commissioners in line with the resolution of the House passed on Thursday May 9<sup>th</sup> 2019, that required the Speaker to refer any names of nominees for appointment to a state office, that they may be received by the Speaker during the recess period, to the relevant Committee(s) without having to cause a recall of the House to convey the names. Indeed the Departmental Committee on Defence and Foreign Relations, received the names of the nominees on Wednesday, 29<sup>th</sup> May, 2019, for vetting and reporting to the House within fourteen (14) days.

Pursuant to the provisions of Section 13 of the Public Appointments (Parliamentary Approval) Act, 2011 relating to extension of period for consideration of nominees for appointment to a public office, the House resolved to extend the period for consideration of the nominees submitted by H.E. the President for appointment to the Accra, Berlin, Bern, Dakar, Rome, and Kuwait City Missions by a period of fourteen (14) days from 12<sup>th</sup> June, 2019.

The Committee held three (3) sittings for vetting and thereafter held four (4) sittings for preparation and adoption of the report. Six nominees appeared before the Committee on 10<sup>th</sup> June, 2019 and were vetted in accordance with the provisions of the Constitution, the Public Appointments (Parliamentary Approval) Act, No. 33 of 2011 and the National Assembly Standing Orders on their suitability or otherwise for appointment as Ambassadors/High Commissioners.


The Committee deliberated on the nominees duly filled questionnaires in accordance with Section 6 (8) of the Public Appointments (Parliamentary Approval) Act, curricula vitae, reports from relevant authorities, submissions made by the nominees including their oral submissions during the vetting at the sittings held on Monday, 10<sup>th</sup> June, 2019.

The Committee, in compliance with the Constitutional and other legal requirements established procedures for vetting, ensured that its meetings were open to the public and covered by the media.

May I take this opportunity to thank all Members of the Committee for their input and valuable contributions during the deliberations and vetting exercise. I also take this opportunity on behalf of the Committee to thank the Offices of the Speaker and of the Clerk of the National Assembly for the logistical support accorded to it during the exercise. As a Committee, we also appreciate the role played by the media following its coverage of the proceedings, thus enhancing accountability, transparency and ensuring the participation of the public.

## 1.0 PREFACE

### 1.1 Establishment of the Committee

1. The Departmental Committee on Defence and Foreign Relations is established pursuant to Standing Order 216 (1).

### 1.2 Mandate of the Committee

2. The Committee is mandated under Standing Order 216 (4) and (5) to inter alia:
  - a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
  - b) study the programme and policy objectives of ministries and departments and the effectiveness of the implementation and effectiveness of the implementation;
  - c) study and review all legislation referred to it;
  - d) study, assess and analyze the relative success of the ministries and departments as measured by the results obtained as compared with their stated objectives;
  - e) investigate and inquire into all matters relating to the assigned ministries and departments as they may deem necessary, and as may be referred to them by the House;
  - f) vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments);**
  - g) examine treaties, agreements and conventions;
  - h) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;

- i) consider reports of Commissions and independent offices submitted to the house pursuant to the provisions of Article 254 of the Constitution; and
  - j) Examine any questions raised by Members on a matter within its mandate.
3. In executing its mandate, the Committee oversees the following Ministries and Departments:
- i. Ministry of Defence;
  - ii. Ministry of Foreign Affairs;
  - iii. Ministry of East African Community and Regional Development; and
  - iv. National Intelligence Service.
4. According to Schedule II of the Standing Orders, the Committee is mandated to consider the following subjects:
- i. Defence;
  - ii. Intelligence;
  - iii. Foreign Relations;
  - iv. Diplomatic and Consular Services;
  - v. International Boundaries including territorial waters and international Relations; and
  - vi. Agreements, Treaties and Conventions.

## **2.0 BACKGROUND**

### **2.1 Establishment of the Office of High Commissioners/Ambassadors**

7. The Office of Ambassador/High Commissioner is an Office under the Ministry of Foreign Affairs. The duties of Ambassadors and High Commissioners include-
- a) advancement and protection of Kenya's interests in host Countries and Countries of accreditation through innovative Diplomacy;
  - b) promotion of Kenya's influence in international decision making;
  - c) protection of Kenya's sovereignty and territorial integrity;
  - d) promotion and strengthening of bilateral/multilateral co-operation/ties;
  - e) promotion of sub-regional, regional and international integration and cooperation; and
  - f) promotion of public Diplomacy, among other duties.

### **2.2 Nomination of High Commissioners and Ambassadors**

8. Article 132(2) (e) of the Constitution confers upon the President the power to nominate, and subject to approval by the National Assembly, appoint Ambassadors and High Commissioners. It provides that -

*“The President shall nominate and, with the approval of the National Assembly, appoint and may dismiss- ...(e) High Commissioners, Ambassadors and Diplomatic and Consular Representatives”*

### **2.3 Notification of nomination**

9. In accordance with the provisions of Article 132(2) (e) of the Constitution and section 5 of the Public Appointments (Parliamentary Approvals) Act, His Excellency the President vide a letter dated 20<sup>th</sup> May, 2019 under reference number OP.CAB.14.1A (*Annexure 1*) forwarded to the National Assembly, for consideration and approval, the notification of nomination of the following six (6) persons for appointment as Ambassadors and High Commissioners to

#### **2.4 Committal to the Departmental Committee of the nominations**

10. Pursuant to the resolution of the House passed on Thursday, 9<sup>th</sup> May, 2019, that mandated the Speaker to refer any names of nominees for appointment to a state office, that may be received by the Speaker during the recess period, to the relevant Committee(s) without having to cause a recall of the House to convey the names. The Speaker referred the names of Amb. Purity Wakiuru Muhindi, Amb. Jackline Lumumba Yonga, Amb. Lemarron Kaanto, Hon. Halima Abdille Mohamud, Amb. Andrew Maina Kihurani, and Amb. Eliphaz Mugendi Barine that His Excellency the President, by way of letter dated 20<sup>th</sup> May, 2019 had nominated for appointment as Ambassadors/High Commissioners subject to approval by the House pursuant to Article 132 (2) (e) of the Constitution.

11. The Speaker of the National Assembly pursuant to a the aforementioned House resolution referred the names of the nominees and their curricula vitae to the Departmental Committee on Defence and Foreign Relations to conduct approval hearings on 29<sup>th</sup> May 2019.

#### **2.5 Notification to the public and request for memoranda**

12. The Clerk of the National Assembly placed an advertisement in the print media

on Thursday, 30<sup>th</sup> May, 2019 (*Annexure 2*) inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011 which provides that “*any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated*”. The advertisement indicated that the submissions were to be received by Wednesday, 5<sup>th</sup> June, 2019 at 5.00 pm.

13. Pursuant to the provisions of Article 118 of the Constitution, Section 6(4) of the Public Appointments (Parliamentary Approval) Act and Standing Order 45(3), the Clerk of the National Assembly on Thursday, 30<sup>th</sup> May, 2019 (*Annexure 3*), *through the print media*, notified the general public of the intention of the Departmental Committee on Defence and Foreign Relations to conduct the vetting of the nominees on Monday, 10<sup>th</sup> June, 2019.

## **2.6 Notification to the nominees**

14. On 31<sup>st</sup> May, 2019, the Clerk of the National Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, notified the nominees of the date, time, and place for holding the Approval hearings (*Annexure 3*).

## **2.7 Clearance requirements**

15. On 30<sup>th</sup> May, 2019 the Clerk of the National Assembly wrote to the Ethics and Anti-Corruption Commission (EACC), Kenya Revenue Authority (KRA), the Directorate of Criminal Investigation (DCI), the Higher Education Loans Board (HELB), and the Registrar of Political Parties (RPP) requesting for information (*Annexure 4*) with respect to the nominees on the following -

- (a) matters touching on integrity;
- (b) tax compliance;
- (c) loan repayments; and
- (d) political affiliations.

### **2.7.1 Higher Education Loans Board**

16. The Higher Education Loans Board vide a letter under ref. HELB/RR/112009/KNA dated 6<sup>th</sup> June, 2019 (*Annexure 5*) confirmed that there were no outstanding loans balances by the nominees.

### **2.7.2 Kenya Revenue Authority**

17. The Kenya Revenue Authority did not submit a response to confirm whether the six (6) nominees were all tax compliant. However, all the nominees have tax compliant certificates confirming that they are all tax compliant.

### **2.7.3 Ethics and Anti-Corruption Commission**

18. The Ethics and Anti-Corruption Commission vide a letter under ref. EACC.7/10/5 VOL.IX (124) dated 7<sup>th</sup> June, 2019 (*Annexure 6*) confirmed that there were no outstanding issues or ongoing investigations against the six (6) nominees.

### **2.7.4 The Directorate of Criminal Investigations**

19. The Directorate of Criminal Investigations vide a letter under ref. DCI/CRO/SEC/6/7/2/A/VOL.VI/101 dated 4<sup>th</sup> June, 2019 (*Annexure 7*) confirmed that the six (6) Ambassador/High Commissioner nominees applied for police clearance certificates on diverse dates and were genuinely issued with clearance certificates.

### **2.7.5 Registrar of Political Parties**

20. The Office of the Registrar of Political Parties vide a letter under Ref No. RPP/ORG/34 Vol III (50) dated 3<sup>rd</sup> June, 2019 (*Annexure 8*) confirmed that according to the records held by the office as at 3<sup>rd</sup> June, 2019, the six (6) nominees were not officials of a registered political party.

### **2.8.1 Issues for consideration in conducting the Approval hearing**

21. The Committee observed that the issues for consideration in relation to the nomination and approval exercise are as provided under section 7 of the Public Appointments (Parliamentary Approvals) Act, as follows-

- a) the procedure used to arrive at the nominee;
- b) the constitutional and statutory requirements relating to the office in question; and
- c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made.

#### ***(a) Procedure used to arrive at the nominee***

22. The Committee observed that Article 132(2) (e) of the Constitution vests the power to nominate persons for appointment as Ambassadors and High Commissioners in the President.

#### ***(b) Constitutional and Statutory requirements***

23. The Constitution, in addition, sets out requirements on Leadership and Integrity Act, 2012 regarding the appointment of persons to public office.

24. The Committee, in determining the suitability of the nominees, took into consideration the provisions on leadership and integrity as outlined under Chapter Six of the Constitution. In particular, the Committee took cognizance of the following provisions-

- i. Article 73 (2) of the Constitution which provides that the guiding principles of leadership and integrity include –
  - (a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
  - (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
  - (c) selfless service based solely on the public interest, demonstrated by —
    - (i) honesty in the execution of public duties; and
    - (ii) the declaration of any personal interest that may conflict with public duties;
  - (d) accountability to the public for decisions and actions; and
  - (e) discipline and commitment in service to the people.
- ii. Article 75(1) of the Constitution that requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties and Article 75(3) of the Constitution that prohibits a State Officer who has been removed from office under that Article from holding any other State Office.
- iii. Article 77(1) of the Constitution that prohibits a full time State Officer from participating in any other gainful employment.
- iv. Article 77(2) of the Constitution that prohibits an appointed State officer from holding office in a political party.
- v. Article 78 of the Constitution that disqualifies persons who are not Kenyan Citizens and persons holding dual citizenship from appointment as State Officers.

*a) Suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made*

- i. The Committee observed that suitability of the nominee should be evaluated holistically taking into account the nominee's academic credentials, professional training, experience, background and personal qualities as well as the performance of the nominee during the approval hearing.
- ii. The Committee's observations and resolutions as per the specific nominees are contained in the respective parts relating to those nominees in this report.

### **2.8.2 Memoranda from members of the public**

25. Section 6(9) of the Public Appointments (Parliamentary Approvals) Act, provides that *any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold office to which the candidate has been nominated.*

26. The Clerk of the National Assembly placed an advertisement in the print media on Thursday 30<sup>th</sup> May, 2019 inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act.

27. By close of business on Wednesday 5<sup>th</sup> June, 2019 at 5.00 p.m., the Committee had received eight (8) written statements of which six (6) met the requirements as stipulated in section 6(9) of the Public Appointment Parliamentary Approval Act and the other two (2) did not meet the requirements of the said section.

28. Pursuant to Section 6(9) of the Public Appointment Parliamentary Approval Act,

the Committee received memoranda from the following—

- a) Dr. Adan Yunis Sheik a Resident of Wajir who is the Regional Coordinator and member of National Executive Council (NEC) of the Supreme Council of Kenya Muslims (SUKPEM), for Hon. Halima Abdille Mohamud, he vouched to her character, her patriotism and her ability to lead;
- b) Mr. Isaac Were, a Resident of Nairobi who is a lecturer at the University of Nairobi consents to the nomination of Hon. Halima as Ambassador;
- c) Deaf Girls Foundation recommends Hon. Halima to be appointed as the High Commissioner/Ambassador and consent to her nomination;
- d) Edisonwoods Consulting Group (ECG) Ltd, signed for by Mr. Edwins L. Saka, the Managing Director who strongly recommends Hon. Halima as Ambassador;
- e) Timira Bishar a Resident of Garissa who is the Chief Officer County Affairs- County Government of Garissa gives strong consent for Hon. Halima's nomination, appointment or confirmation to any Government office; and
- f) Jimale Mohamud a Resident of Wajir states that Hon. Halima has helped in various youth programmes, participated in peace initiatives, has made efforts to reduce radicalization and drug abuse. He therefore recommends her for appointment.

29. The Committee noted that the following memoranda did not meet the threshold pursuant section 6(9) of the Public Appointment Parliamentary Approval Act—

- a) Memoranda for Hon. Halima Abdille by Dubay Abdi a resident of Wajir and the Vice Chairperson of Maendeleo ya Wanawake Organization and Advisor to the Governor Wajir County. The officer did not sign the written statement; and
- b) Recommendation of Hon. Halima Abdille for the Appointment as High

Commissioner/Ambassador from George Gilbert Advocates. The memorandum was disqualified because it was not a statement on oath but a recommendation of her appointment.

## **2.9 Withdrawal from the approval process**

30. Section 6(10) of the Public Appointments (Parliamentary Approvals) Act, provides that *a candidate may, at any time, by notice in writing addressed to the Clerk, withdraw from the approval process and the candidate's nomination shall thereupon lapse*.

31. Pursuant to Section 6(10) of the Public Appointments (Parliamentary Approvals) Act, no nominee notified the Clerk of his/her withdrawal from the approval process.

### **3.0 APPROVAL HEARINGS/ VETTING OF NOMINEES FOR APPOINTMENT TO THE POSITION OF AMBASSADOR/ HIGH COMMISSIONER**

32. The Departmental Committee on Defence and Foreign Relations held a pre-vetting meeting on Monday, 10<sup>th</sup> June, 2019 at 8:00 a.m. to deliberate on the approval hearings, review documents, testimonials and nominees duly filled questionnaires.

33. In conducting the approval hearings, the Committee examined the nominees against the following criteria as set out in the Public Appointments (Parliamentary Approval) Act-

- i. Academic qualifications;
- ii. Employment record;
- iii. Professional affiliations;
- iv. Potential conflict of interest;
- v. Knowledge of the relevant subject;
- vi. Overall suitability for the position;
- vii. Integrity;
- viii. Vision and leadership; and
- ix. Expectations and key priorities.

### **3.1 AMB. PURITY WAKIURU MUHINDI – NOMINEE FOR POSITION OF AMBASSADOR, DAKAR, SENEGAL**

34. Amb. Purity Wakiuru Muhindi appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 9:30 am and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the

Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows-

### **Citizenship, Date and Place of Birth**

35. The nominee is a Kenyan Citizen; She was born in Molo in 1960. Her National Identity Card number is 0904926.

### **Academic and Professional Qualifications**

36. She holds a Bachelor of Arts degree in Political Science and Sociology from University of Nairobi (1983), a Post Graduate Diploma in Mass Communication from University of Nairobi (1998), Post Graduate Diploma in International Relations from University of Nairobi (1986) and Master of Arts degree in New Media Governance and Democracy from University of Leicester (2013). In the course of her career, she has attended the following trainings, courses and programmes:

- a) Seminar on US Foreign Policy and decision Making, Washington, DC.
- b) Advanced French Language Certificate Course, Kenya Institute of Administration.
- c) Strategic Leadership Development Programme
- d) Professional Mediators Certification (MTI)

### **Employment records and Work Experience**

37. On employment and work experience, the nominee informed the Committee that; she has a work experience of thirty-two (32) years in the Ministry of Foreign Affairs. She started her career as an Assistant Secretary III under the European Division, (1984). She rose through the ranks in the Ministry of Foreign Affairs to the position of Director of Africa and African Union. She has served in the following Missions abroad:

- a) Ambassador of Kenya to the Kingdom of Sweden.
- b) Deputy Head /Head of Chancery in the Kenya Embassy in Paris.
- c) First Secretary in Kenya Embassy Stockholm, Sweden.
- d) Second Secretary in Kenya Embassy Stockholm, Sweden

**Professional Association.**

38. The nominee is a member of the Certified Professional Mediators, Mediation Training Institute of East Africa (MTI)

**Honors and Awards**

39. She is a recipient of the Moran of the Burning Spear (MBS), (2011). She is also a recipient of the President Award Scheme- Bronze, Silver and Gold Awards, (1976-1978). She was also awarded the Special Mention in the Outward Bound Mountain School, (1976).

**Public Office, Political Activities and Affiliations**

40. She does not hold any position and is not a member of any political party.

**Statement of Net Worth**

41. Her financial net worth is Twenty Million Shillings (**Kshs. 20,000,000**). Her source of income is her Salary.

**Leadership and suitability**

42. The nominee joined Ministry of Foreign Affairs in 1983 and has since worked in various departments in the Ministry including European, Americas, Protocol Directorate, Middle East and International Organisations desks. She was also posted to missions in Stockholm and Paris during her tenure at the Ministry. She further mentioned to the Committee that she was responsible for the African Directorate at a time when the country's policy was geared towards deepening bilateral and multilateral relations with Africa and the African Union.

43. She informed the Committee that Dakar, Senegal, is a new mission and she has the requisite experience having served as a head of mission, Director of Africa directorate and AU. Further, knowledge of the French language makes her the perfect candidate for the position.

44. She mentioned that she has never had any audit queries in the missions she served. She is confident that she will not misuse public resources given to any mission she will serve in.

### **Bilateral relations**

45. Senegal's historical significance as the capital of French West Africa has maintained its important position as a hub of economic and cultural affairs in the present French West Africa. Senegal is also a member of ECOWAS, a regional hub composed of a population of over three hundred million people; a niche market that Kenya is keen on tapping. She informed the Committee that Dakar will be the first mission in a West African francophone country and it will act as a gateway to opportunities for Kenya in that region.

46. She affirmed that there is potential in Senegal in terms of trade, education, exchange in culture and language especially Kiswahili. The country is also party to the AfCFTA agreement and a signatory to the Pan African Agenda 2063. Therefore, both countries espouse ideas of promoting intra-trade in Africa and will ultimately enhance, trade relations and opportunities for Kenyans. She added that Kenya will benefit from the experience in the fields of oil, gas and blue economy.

### **Challenges in Multilateral Stations**

47. She informed the Committee that she has never worked in a multilateral station but a multilateral desk within the Ministry. She however mentioned that the main

challenges facing any multilateral station is networking and advocating a country's agenda. She pointed out successes such as Kenya's participation in the development and adoption of SDGs.

48. She also observed that the Ministry has advocated for smart embassies that work within the budgetary allocations provided as opposed to shutting down embassies abroad. She mentioned that it is advantageous for a country to scale down its operations in a mission rather than shutting it down because re-opening a mission is quite expensive.

### **Potential Conflict of Interest**

49. She has no interests that are likely to present potential conflicts of interest.

### **Pro-Bono/Charity Work/ Donations to Charity**

50. She has participated in charitable activities such as:-

- i. Prisons Outreach Ministry, youth mentoring and support for the clergy, as a member of the Loresho PCEA Community Church and the Woman's Guild.
- ii. Donation of food and other stuff, to the Kikuyu Home for the aged
- iii. Contribution to worthy causes like Red Cross or Media appeals.
- iv. Fees payment for three students, two of them through high school to university and for the third from high school to Diploma College (about 1.7M). She is also paying fees for a needy boy student, totaling to about Kshs. 100,000 so far.
- v. Connected water to Murinduko Primary School in Embu valued at Kshs. 180,000 in addition to mentoring young officers at the Ministry.

**Committee observations on the suitability of Amb. Purity Wakiuru Muhindi to serve as Ambassador**

51. The Committee having considered the nominee's filled questionnaire, her curriculum vitae and having heard her oral submission during the approval hearing, made the following observations on her suitability for appointment as Ambassador; THAT the nominee –

- a) is a Kenyan citizen and does not hold dual citizenship.
- b) holds Bachelor of Arts degree in Political Science and Sociology from University of Nairobi (1983), a Post Graduate Diploma in Mass Communication from University of Nairobi (1998), Post Graduate Diploma in International Relations from University of Nairobi (1986) and Master of Arts degree in New Media Governance and Democracy from University of Leicester (2013). In the course of her career, she has attended a seminar on US Foreign Policy and Decision Making, Advanced French Language Certificate Course, Strategic Leadership Development Programme, and Professional Mediators Certification;
- c) satisfies the requirements of Chapter 6 of the Constitution on leadership and integrity having been cleared by the DCI and the EACC;
- d) has never been charged in a Court of Law for the last three years;
- e) as stipulated in Article 75(1) of the Constitution, she has no potential conflict of interest
- f) satisfies the requirements of Article 77(1) of the Constitution in that she does not intend to participate in any other gainful employment;
- g) does not hold office in any political party hence satisfies the provisions of Article 77(2) of the Constitution;

- h) Has never been dismissed from office under Article 75 of the Constitution for contravention of the provisions of Articles 75(1) (conflict of interest), 76(financial probity), 77(restriction of State Officers);

### **3.2 AMB. JACKLINE LUMUMBA YONGA – NOMINEE FOR POSITION OF AMBASSADOR, ROME, ITALY**

52. Amb. Jackline Lumumba Yonga appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 10:30 am and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows -

#### **Citizenship, Date and Place of Birth**

53. The nominee is a Kenyan Citizen. She was born in Kisumu in 1961. Her National Identity Card number is 3543003.

#### **Academic and Professional Qualifications**

54. She holds a Masters degree in Human Resource management from Poona University (1985) and holds a Bachelor of Arts Degree in Economics and History from the University of Jabalpur, both from India (1983). In the course of her career, she attended the following training courses and programmes-

- a) International Labour Organization Conference (ILO) Geneva Switzerland.
- b) Pensions Reforms Annual conferences- World Bank Institute, U.S.A.
- c) Change Management and Human Resource, United Kingdom.
- d) Certificate course in Environmental Information System, Germany.
- e) Computer Application Data Management course, KIA, Nairobi.
- f) Interpersonal Management Skills for Middle Women managers, KIA, Nairobi.

g) Certificate course in Financial Management, India.

### **Employment records and Work Experience**

55. Amb. Jackline Lumumba Yonga is a career public servant with over thirty-three years (33) of work experience. She started her career at the Ministry of Health as a Personnel Officer II in 1985 up to 1989. She has held various positions in the public sector and currently holds the position of Director, Middle East Directorate, at the Ministry of Foreign Affairs. She has served in the following missions abroad;

- a) Deputy High Commissioner, Kenya High Commission London, United Kingdom.
- b) Deputy Head of Mission, Kenya High Commission in Malaysia.
- c) Ambassador/ Deputy Head of Mission Kenya High Commission, London.

### **Memberships**

56. She is a member of the following organizations;

- i. Catholic Women's Association (CWA)
- ii. National Council for Persons with Disabilities;
- iii. Holy Trinity Church - Kileleshwa, Nairobi.

### **Public Office, Political Activities and Affiliations**

57. She does not hold any position and is not a member of any political party.

### **Leadership and suitability**

58. The nominee informed the Committee that she is a career civil servant who has served in various capacities in the civil service. She has a vast wealth of experience in government service, which is suited for an ambassador. She stated that she will be accredited to Greece, Poland, Cyprus and Malta. She is currently in charge of the Middle East Directorate at the Ministry of Foreign Affairs.

59. She is in the process of publishing her memoir but has participated in formulating several policy documents relating to public service.

### **Bilateral relations**

60. The bilateral relationship between Italy and Kenya existed for decades. Kenya can benefit from Italy in coffee and leather commodities through the provision of a platform where producers of the commodities are linked with marketers and consumers. She however noted that Kenya needs to bridge the gap on value addition of the same commodities.

61. Kenya has a work force that is committed, with a high work ethic and highly educated, attributes that are endearing to a nation that values craftsmanship. She mentioned that given the opportunity to work in Italy, she would link up with TVETs, fashion and design schools and seek opportunities for skilled and semi-skilled youth currently unemployed.

62. Malta is known for blue economy, therefore there is need to borrow best practices as Kenya is planning to expand its blue economy. She affirmed that there is room for improvement on matters trade between Greece and Poland.

### **Peace Building and fight against corruption**

63. The nominee appreciated the Committee for noting her membership with CWA (Catholic Women Association). She confirmed that she prescribes to the notions of peace building and tolerance around the world as espoused by Pope Francis and noted that Kenya ascribes to the same aspirations in matters pertaining to peace as provided in the Kenya Foreign Policy.

64. On matters concerning the fight against corruption, the nominee informed the Committee that she would adhere to the objectives of the Anti-Corruption and Economic Crimes Act and further sensitise personnel in the mission on the Leadership and Integrity Act. This, in her view, would act as a deterrence to

commit such acts and also pin point loopholes in her mission if appointed that she intends to address.

### **Statement of Net Worth**

65. Her financial net worth is thirty million Kenya shillings (**Kshs. 30,000,000**). Her source of income is her salary and house rents totalling to three million and four hundred thousand Kenya shillings, (**Kshs. 3,400,000**) per annum.

### **Potential Conflict of Interest**

66. She has no interests that are likely to present potential conflicts of interest.

### **Pro-Bono/Charity Work/ Donations to Charity**

67. She has participated in charitable activities such as, charity work through Catholic Women Association, visiting the sick and giving food donations to orphanages.

### **3.3 VETTING OF HON. HALIMA ADBILLE MOHAMUD- NOMINEE FOR POSITION OF AMBASSADOR – KUWAIT CITY, KUWAIT**

69. Hon. Halima Abdille Mohamud appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 11:30 a.m. and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows-

#### **Citizenship, Date and Place of Birth**

70. The nominee is a Kenyan Citizen. She was born in 1988 in Wajir. Her National Identity Card number is 25322209.

### **Leadership and Suitability of the Nominee**

77. She informed the Committee that Members of Parliament make good ambassadors due to their experience in Parliamentary diplomacy. Her experience as Chairperson in the Committee on Labour and Vice Chairperson of the Education Committee in the Senate enabled her to lead delegations to different events and foreign trips. Parliamentary diplomacy is very clear in legislation, oversight and representation.

78. She informed the Committee that she is the best candidate for the appointment to Kuwait because as a young leader she understands their cultural dynamics, the religion of the nation and matters youth radicalization. She appreciated that the appointing authority had confidence in her abilities to represent Kenya in Kuwait.

### **Trade**

79. In regards to export of meat, she informed the Committee that Kuwait lifted the ban on meat from Kenya in 2018. She asserted that if approved, she will look into the relationship between Kenya and Kuwait and follow up on bilateral trade agreements between the two countries in order to maximize on opportunities.

### **Mistreatment of Kenyans in Kuwait**

80. On mistreatment of Kenyans in the Middle East, she stated that there is no legal framework to guide employment of Kenyans in Kuwait and that unlicensed agents largely contribute to the problem. She further stated that she will ensure that a database of all Kenyans in Kuwait is created in order to understand their challenges and engage the Kuwait government on treatment of Kenyans within their country.

### **Gulf Geopolitics**

81. On matters gulf geopolitics, the nominee stated that she will uphold the Kenyan position. However, where diplomatic issues arise, she will consult with the Ministry of Foreign Affairs.

### **Radicalization and Religious Misrepresentation**

82. The nominee stated that Kenya and Kuwait have the same concerns over terrorism. The proximity to the waterways in the gulf brings concerns of radicalization. If approved, she will engage the youth through the Kuwait Official Development Assistance, to empower the Kenyan youth.

### **Areas of collaboration between Kenya and Kuwait**

83. On matters collaboration, Kenya has benefited from the Kuwait Fund for Arab Development, which has established Umma University in Kajiado County and a school in Nyamira in Borabu. Other development projects include Bura irrigation and Nano Madogashe. The nominee believes further relations can be created in health, labour and employment.

### **Employment**

84. The nominee informed the Committee that the population of Kuwait is approximately 3 million. If approved, she will assist skilled and semi-skilled labour penetrate into the Kuwait labour market. Kuwait is also rich in oil and petroleum, therefore, she will if appointed facilitate exchange programmes for students and promote petroleum engineering courses in Kenya.

### **Potential Conflict of Interest**

85. She informed the Committee that she has no interests that are likely to present potential conflicts of interest.

### **Pro-Bono/Charity Work/ Donations to Charity**

86. The nominee stated that she has participated in charitable activities such as Volunteering for the Kenya Red Cross, took part in charity to help the orphaned and the needy, taught Wajir Girls Secondary as a BOG teacher and paid fees for disadvantaged groups during her tenure as Member of Parliament.

### **Committee observations on the suitability of Hon. Halima Abdille Mohamud to serve as Ambassador**

87. The Committee having considered the nominee's filled questionnaire, her curriculum vitae and having heard her oral submission during the approval hearing, made the following observations on her suitability for appointment as Ambassador; THAT the nominee—

- a) is a Kenyan citizen and does not hold dual citizenship;
- b) holds a Bachelor of Education (Science) degree from Kenyatta University (2011). She is pursuing a Master of Arts degree in Gender and Development Studies (Project Management Option) from the University of Nairobi. In the course of her career, she attended the following training courses and programmes Certificate in Entrepreneurship Skills and Business Planning, Certificate in Computer Studies, Certificate in Project Management and Proposal Writing
- c) satisfies the requirements of Chapter 6 of the Constitution on leadership and integrity;
- d) has never been charged in a Court of Law for the last three years;
- e) as stipulated in Article 75(1) of the Constitution, she has no potential conflict of interest;

- f) satisfies the requirements of Article 77(1) of the Constitution in that she does not intend to participate in any other gainful employment;
- g) does not hold office in any political party hence satisfies the provisions of Article 77(2) of the Constitution;
- h) has never been dismissed from office under Article 75 of the Constitution for contravention of the provisions of Articles 75(1) (conflict of interest), 76(financial probity), 77(restriction of State Officers) and 78(2) (dual citizenship) of the Constitution.

### **3.4 AMB. LEMARRON KAANTO – NOMINEE FOR POSITION OF AMBASSADOR, BERLIN, GERMANY**

88.Amb. Lemarron Kaanto appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 12.30pm and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows-

#### **Citizenship, Date and Place of Birth**

89.The nominee is a Kenyan Citizen. He was born in 1971 in Kajiado. His Identity Card (ID) number is 10882022.

The nominee responded to questions during the vetting as follows-

70. The nominee is a Kenyan Citizen. She was born in 1988 in Wajir. Her National Identity Card number is 25322209.

### **Public Office, Political Activities and Affiliations**

74. She was a Senator in the 11<sup>th</sup> Parliament, which was a political office.

75. She was a member of the ODM party at the 11<sup>th</sup> Parliament and run on a Jubilee party ticket for the August, 2017 general elections. She however stated that she currently does not have any linkage with any political office.

### **Statement of Net worth**

76. Her financial net worth is thirty-five million Kenya shillings (**Kshs. 35,000,000**).

97. He has over twenty years (22) working experience in non-profit organizations, private sector, international organizations and the public. At the international level, he has served as a Stakeholder Council Member of the Global Reporting Initiative (GRI), an international industry standards organization based in Amsterdam, Netherlands. He has also been a member of CSR Extractives in Developing Areas (CEIDA) research group based in ESADE University, Spain.

98. In January 2015, he was posted to Kenya's Embassy in Algeria as Deputy Head of Mission before joining Kenya High Commission in Pretoria in the same capacity on 1<sup>st</sup> September, 2015 to date.

99. He stated that his experience in diplomatic missions has been able to anchor him in diplomacy in terms of administration of an Embassy, Kenya's foreign policy, art of diplomacy and issues of leadership.

#### **Benefits of the mission in Berlin**

100. The nominee informed the Committee that he will seek opportunities for students to access education in Germany. Kenya has a partnership with Germany on education therefore; he will enhance further education opportunities for Masters and PhD students.

#### **Multiple Accreditation**

101. The nominee stated that he is only accredited to Germany. He will be posted only to Berlin. Germany is not accredited to other countries

#### **Investor Confidence**

102. He informed the Committee that he will pursue the instruments that will enforce better investor confidence such as the agreement on double taxation that is being negotiated. Economic diplomacy is a key mandate of Ambassadors which fosters investor confidence in Kenya.

#### **Security of Kenyans in South Africa**

103. The nominee stated that he will ensure that xenophobia against Kenyans in Germany will not happen. He added that Kenyans in South Africa are safe despite social media reports. The Mission in South Africa has established a Committee with the leadership of the Kenyan Diaspora in South Africa to ensure the safety of Kenyans.

104. On matters pertaining to access South Africa Visa, he mentioned that since 2015 tremendous progress has been made. In 2017 an agreement was reached in order to allow civil servants with ordinary passports to travel to South Africa without visa. In April 2019, a Technical Committee was created to look into a visa free regime between Kenya and South Africa.

### **EU-Kenya Relations**

105. In relation to the Schengen visa, he informed the Committee that Africa is driving towards the same through the Africa Continental Free Trade Area (ACFTA) to facilitate easier movement of people. Schengen visa is an advantage as it facilitates easier movement of people with one visa across many nations.

### **Balance of Trade**

106. He informed the Committee that balance of trade is in favour of Germany with 31 billion Kenyan shillings. He noted that Germany, one of the largest economies in the world has a comparative advantage in renewable energy, automobiles, solar and manufacturing that Kenya can leverage on to become a competitive market.

### **Double Taxation**

107. He informed the Committee that there is a double taxation agreement, which was signed by the two countries and has addressed investor confidence. This can be witnessed through an increase of German Companies operating in Kenya such as Bayer, Henkel and recently Lufthansa airlines operating to Mombasa since 2015.

### **Big Four Agenda**

108. He asserted that the main focus of the mission is to leverage on the opportunities in Germany with regard to the Big Four Agenda in Kenya. The specific areas of focus will be in manufacturing and renewable energy. In human development, Germany is strong in its TVETs. He informed the Committee that

there is an agreement between Kenya and Germany on TVETs. In addition, Germany is keen on supporting centres of excellence in Kenya. This will in turn support Kenyan youth on employment. Strengthening of TVETs will also support the Big Four Agenda in terms of manufacturing, affordable housing among other sectors. Kenya will also borrow on the German models where Germany links their TVETs to other institutions.

### **Tourism**

109. The nominee informed the committee that he would pursue innovative ways of encouraging tourists from Germany to Travel to Kenya. He noted that Lufthansa and Condo airlines, have begun flight operations between Germany and Kenya. Increased tourism will earn the country youth employment and investments to the country.

### **Statement of Net Worth**

110. His financial net worth is Ninety million Kenya shillings (**Kshs. 90,000,000**). His source of income is his salary/allowances, rental income and sales from livestock.

### **Potential Conflict of Interest**

111. He has no interests that are likely to present potential conflicts of interest.

### **Pro-Bono/Charity Work/ Donations to Charity**

112. He has participated in charitable activities such as; contribution to church activities amounting to **Kshs.100,000**, fees and bursaries amounting to **Kshs. 200,000**, other donations amounting to **Kshs.200,000**.

**Committee observations on the suitability of Amb. Lemarron Kaanto to serve as Ambassador.**

113. The Committee having considered the nominee's filled questionnaire his curriculum vitae and having heard his oral submission during the approval hearing, made the following observations on his suitability for appointment as Ambassador; THAT the nominee –

- a) is a Kenyan citizen and does not hold dual citizenship;
- b) holds a Bachelor of Arts (Honors) degree in Sociology from the University of Nairobi (1995), a Post Graduate Diploma in Food Security and Nutrition from Wageningen University in the Netherlands (2002) and a Post Graduate Diploma in Human Rights & Gender Equality from Uppsala University in Sweden (2009). Andrew Maina Kihurani appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 2:30 p.m and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows-

#### **Citizenship, Date and Place of Birth**

115. The nominee is a Kenyan Citizen who was born in Kajiado in 1962. His National Identity Card number is 0462213

#### **Academic and Professional Qualifications**

116. He holds a Bachelor of Arts degree (1985), and Post-Graduate Diploma in International Relations (1988) both from the University of Nairobi. In the course of his career, he has undertaken the following trainings, courses and programmes:

- a) National Defense College Course.
- b) Strategic Leadership Development Program

## **Employment records and Work Experience**

117. On employment and work experience, the nominee informed the Committee that he has work experience of over thirty-two (32) years. He started his career as an Assistant Secretary II in the Ministry of Foreign Affairs in 1986 and rose through the ranks from Assistant Secretary III to the position of an Ambassador/Deputy Permanent Representative of Kenya Permanent Mission to the United Nations, Geneva. He has served in the following missions abroad:

- (i) Second Secretary, the Kenya High Commission in Ottawa, Canada.
- (ii) Assistant Secretary I for Asia and Australasia Division.
- (iii) Assistant Secretary I for Africa and African Union Division.
- (iv) Assistant Secretary I for Americas Division.
- (v) First Secretary , Kenya High Commission in Windhoek, Namibia.
- (vi) First Secretary , the Kenya Embassy in Tel Aviv, Israel.
- (vii) Second/First Counsellor, Deputy Chief of Protocol, Protocol Division.
- (viii) First Counsellor and subsequently the Principal Counsellor , Kenya Embassy in Berlin.
- (ix) Appointed Ambassador in the Ministry of Foreign Affairs on 19<sup>th</sup> December, 2012.

## **Statement of Net worth**

118. His financial net worth is eighty-nine million Kenya shillings (**Kshs. 89,000,000**). His source of income is foreign service allowance of (**Chf 218,569**), Employment Salary amounting to Kshs. 4,806,310 and rental income amounting to **Kshs, 2,452,440 per annum**.

## **Kenya as an Investment Hub**

119. He informed the Committee that a number of investors have shown interest in Kenya due to the open investment policy that makes all aspects of the economy

accessible. This is one of the factors that will allow the Swiss who are good in chemical, pharmaceutical, finance, tourism and agricultural areas to look at Kenya as a worthy partner.

120. Areas of engagement between Kenya and Switzerland include:

- a) Pharmaceutical Areas that will focus mainly on manufacturing;
- b) Finance and related activities;
- c) Tourism through the Ministry of Tourism to Market Kenya; and
- d) Agriculture.

#### **Benefits of a Mission in Bern**

121. He informed the Committee that the mission in Bern, will facilitate bilateral relations between Switzerland and Kenya and offer consular services to the Kenyan citizens and others in Switzerland.

#### **Fight against Corruption in the Mission**

122. In 2018, Kenya and Switzerland signed an agreement on the Framework for the return of assets of corruption and crime. The framework enables the government of Kenya to pursue the return of proceeds of crime and corruption that have been hidden in Switzerland. In 2017, the two countries signed a Memoranda of Understanding on Criminal Matters to facilitate the reclamation of money. He informed the Committee that there is a technical committee that comprises of representatives from;

- a) The Executive arm of the National Government
- b) The Ministry of Treasury
- c) The State law office
- d) Ethics and Anti-Corruption Commission (EACC).
- e) Assets recovery Agency

123. The Committee is mandated to :-

- a) identify where such Assets have been located in Switzerland;
- b) identify institutions and organizations to repatriate those funds;
- c) in consultation with the Swiss government to ensure that the reclaimed resources are advanced to particular development.
- d) Monitor the funds that have been reclaimed from Switzerland and the utilization of the same.

124. He asserted that if approved and appointed he would work closely with the Committee to ensure that Kenya gains more value for the money reclaimed.

### **Balance of Trade**

125. The balance of Trade is in favor of Switzerland where Kenya exports and imports goods worth 3 Billion and 10 billion respectively. He pointed out the following measures that could be undertaken to improve the current trade imbalance;

- a) To work closely with the manufacturers and exporters to see what value can be added on to improve the volume;
- b) encourage more investors from Switzerland to Kenya.

### **His role in the attainment of the Big Four Agenda**

126. In order for Kenya to realize the Big Four Agenda, the nominee informed the Committee that there is need to promote trade and improve on manufacturing. He mentioned that the country needs to seek investors from Switzerland who are ready to set up industries in the country that focus on manufacture of pharmaceuticals, notably Novartis and Roche which have already established a laboratories in the country.

### **Potential Conflict of interest**

127. The nominee stated that he has no interests that are likely to present potential conflicts of interest.

### **Pro-Bono/Charity Work/ Donations to Charity**

128. He informed the Committee that he has participated in charitable activities such as:-

- a) Contributions to church constructions amounting to **Kshs. 90,000.**
- b) Contributions for hospital fees amounting to **Kshs. 170,000**

The nominee responded to questions during the vetting as follows-

132. He holds a Bachelor of Arts degree in Anthropology (1989), and Post-Graduate Diploma in International relations (1993) both from the University of Nairobi. He also holds a Master's Degree in International relations from the University of Annamalai, India (2012). In the course of his career, he undertook the following trainings/ courses and programmes:

- c) Administrative Officers Induction Course (KIA);

133. He has work experience of over twenty six (26) years. He began his career as an Assistant Secretary Cadet, Africa Division, Ministry of Foreign Affairs,

(1991). He was later appointed as a Deputy head of Mission of Kenya to New Delhi, India. Subsequently he was appointed as the Director, Liaison (Parliamentary and County Affairs) a position that he holds to-date. His career progression is as summarized below;

These areas of strength include tea, animal products and technological sharing that would resolve challenges that Kenya and the larger Africa faces.
135. The nominee mentioned that on fostering relationship between Kenya and Ghana he will see to it that the existing Memoranda of Understanding are implemented to enhance bilateral relations.

### **His role in the attainment of the Big Four Agenda**

136. The nominee informed the Committee that to realise the Big Four Agenda, Kenya needs to exploit the potential presented by the ratification of the TFTA and AfCFT agreements in the following sectors, housing, healthcare and food security.

### **Corruption**

137. The nominee stated that Corruption is a punishable offense in both Kenya and Ghana. He further stated that if approved and appointed he would not tolerate such occurrences at the Mission.

### **Benefits of the Mission in Accra, Ghana.**

138. He informed the Committee that as a policy directive all upcoming embassies will operate as smart embassies, that consist of a lean establishment of staff who are to multi-task .

### **Statement of Net worth**

139. The nominee informed the Committee that his financial net worth is thirty seven million Kenya shillings (**Kshs. 37,000,000**). His source of income is his salary and rent income amounting to two million Kenya shillings (Kshs. 2,000,000) p.a..

### **Potential Conflict of Interest**

140. He informed the Committee that he has no interests that are likely to present potential conflicts of interest.

### **Pro-Bono/Charity Work/ Donations to Charity**

141. He has participated in charitable activities such as:-

Donation of money amounting to **Kshs. 300,000**, Makuri Development Forum, as an alumni member of Murumuti Kenyakuni Secondary School, he has donated

**Kshs. 200,000**, in community church fundraising events he has made donations amounting to **Kshs. 250,000**.

**Committee observations on the suitability of Amb. Eliphaz Mugendi Barine to serve as High Commissioner**

142. The Committee having considered the nominee's filled questionnaire, his curriculum vitae and having heard his oral submission during the approval hearing, made the following observations on his suitability for appointment as High Commissioner, THAT the nominee –

- (a) is a Kenyan citizen and does not hold dual citizenship;
- (b) holds a Bachelor of Arts degree in Anthropology (1989), and Post-Graduate Diploma in International relations (1993). He also holds a Master's Degree in International relations (2012). In the course of his career, he undertook the following trainings/ courses and programmes: Strategic Leadership Development Programme; Administrative Officers Exams; Administrative Officers Induction Course.
- (c) satisfies the requirements of Chapter 6 of the Constitution on leadership and integrity having been cleared by the DCI and the EACC;
- (d) has never been charged in a Court of Law for the last three years;
- (e) has no potential conflict of interest as stipulated in Article 75(1) of the Constitution;
- (f) satisfies the requirements of Article 77(1) of the Constitution in that he does not intend to participate in any other gainful employment;
- (g) does not hold office in any political party hence satisfies the provisions of Article 77(2) of the Constitution;
- (h) has never been dismissed from office under Article 75 of the Constitution for contravention of the provisions of Articles 75(1) (conflict of interest),

76 (financial probity), 77(restriction of State Officers) and 78(2) (dual citizenship) of the Constitution.

#### 4.0 GENERAL COMMITTEE OBSERVATIONS

143. The Committee having vetted all the nominees' made the following general observations –

- a. THAT, ALL the six nominees namely; the **Amb. Purity Wakiuru Muhindi, Amb. Jackline Lumumba Yonga, Hon. Halima Abdille Mohamud, Amb. Lemarron Kaanto, Amb. Andrew Maina Kihurani, and Amb. Eliphaz Mugendi Barine**, are Kenyan citizens and do not hold dual citizenship;
- b. THAT, the nominees presented their academic credentials and professional Certificates and demonstrated their experience in accordance with the provisions of Section 6(7) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011;
- c. THAT, none of the nominees has been charged in a Court of Law or mentioned adversely in a Parliamentary Committee report or Commission of inquiry in the last three years;
- d. THAT, all the nominees satisfy the requirements of Article 77(1) in that they do not intend to participate in any other gainful employment;
- e. THAT, all the nominees do not hold office in any registered political party hence satisfy the provisions of Article 77(2) of the Constitution.
- f. THAT, none of the nominees has been dismissed from office under Article 75 of the Constitution for contravention of the provisions of Articles 75(1) (conflict of interest), 76(financial probity), 77(restriction of State Officers) and 78(2) (dual citizenship) of the Constitution;
- g. THAT, the Committee did not receive any memoranda contesting the suitability of the six (6) nominees.

- h. THAT, the Committee received six written statements on oath (affidavit) in support of the suitability of the **Hon. Halima Abdille Mohamud**.
- i. THAT, the appointing authority took into consideration the principles of gender balance, persons living with disabilities, youth and marginalized communities in nominating persons for Ambassadorial positions.
- j. THAT, none of the nominees, had notified the Clerk of the National Assembly of withdrawal from the approval process as outlined under Section 6(10) of the Public Appointments (Parliamentary Approvals) Act 2011;

## **5.0 COMMITTEE RECOMMENDATIONS**

144. Having considered the suitability, integrity of the nominees, and pursuant to Article 132(2)(e) of the Constitution and Standing Order 216 (5) (f), the Committee recommends that the National Assembly approves the nomination by His Excellency the President, of -

- 1. Amb Purity Wakiuru Muhindi for appointment as an Ambassador to Dakar, Senegal;**
- 2. Amb. Jackline Lumumba Yonga for appointment as an Ambassador to Rome, Italy;**
- 3. Hon. Halima Abdille Mohamud for appointment as an Ambassador to Kuwait City, Kuwait;**
- 4. Amb. Lemarron Kaanto for appointment as an Ambassador to Berlin, Germany;**
- 5. Amb. Andrew Maina Kihurani, for appointment as an Ambassador to Bern, Switzerland; and**
- 6. Amb. Eliphaz Mugendi Barine for appointment as an High Commissioner to Accra, Ghana.**

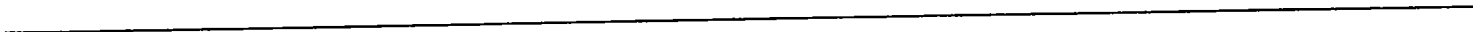




The Chairperson called the meeting to order at 8.20am. Prayer was read by Hon. Richard Tong'i MP. The agenda of the meeting was adopted having been proposed and seconded by the Hon. Patrick Makau, MP and Hon. Peter Mwathi, MP respectively.

The Committee was informed of the receipt of the nominations from H.E the President. The Chairperson further informed the Committee that the names were subsequently referred to the Departmental Committee on Defence & Foreign Relations by the Speaker of the National Assembly pursuant to the resolution passed by the House on Thursday, May 9<sup>th</sup> 2019 that required him to refer any names of nominees for appointment to a state office that he may have received during the recess period, to the relevant Committee(s) without having to cause a recall of the House to convey the names. The Committee is mandated to vet and consider the suitability or otherwise of the nominees for appointment and submit its report to the House for approval.

3. EACC, HELB, DCI and the Registrar of Political Parties had cleared all the nominees . KRA was yet to submit a response on the same.
4. Section 6(9) of the Public Appointments (Parliamentary Approvals) Act, which provides that *any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold office to which the candidate has been nominated.* In this regard, the meeting was informed that the Clerk of the National Assembly placed an advertisement in the print media on Thursday 30<sup>th</sup> May, 2019 inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act.
5. By close of business on Wednesday 5<sup>th</sup> June, 2019 at 5.00p.m the Committee had received eight written statements on oath in respect of the suitability of Ho. Halima Abdille for appointment as an Ambassador. However, two of them were disqualified for not having been signed by the author and the other one was a recommendation letter and not a statement on oath.

Consequently the Committee resolved that:-



### MIN.NO.DC.DFR/2019/150: PRELIMINARIES/REMARKS BY THE CHAIRPERSON

The Chairperson called the meeting to order at 9.30am. Prayer was read by Hon. Richard Tong'i MP.

In conducting the vetting process, the Committee on Defence & Foreign Relations examined the nominees against criteria that included the following as set out in the Public Appointment (Parliamentary Approval) Act, 2011

- (i) Academic Qualifications
- (ii) Employment Records
- (iii) Professional Affiliations
- (iv) Potential Conflict of interest
- (v) Knowledge of relevant subjects
- (vi) Expectations and Key priorities
- (vii) Overall suitability for the position
- (viii) Integrity
- (ix) Vision and Leadership

### MIN.NO.DC.DFR/2019/151: VETTING OF AMB. PURITY MUHINDI- NOMINEE TO DAKAR

Amb. Purity Wakiuru Muhindi appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 9:30 am and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows-

- i. The nominee is a Kenyan Citizen. She was born in Molo in 1960. Her National Identity Card Number is 0904926.
- ii. She holds a Bachelor of Arts degree in Political Science and Sociology from University of Nairobi (1983), a Post Graduate Diploma in Mass Communication from University of Nairobi (1998), Post Graduate Diploma in International Relations from University of Nairobi (1986) and Master of Arts degree in New Media Governance and Democracy from University of Leicester (2013).
- iii. Ms. Purity Muhindi is a career public servant with over 32 years of experience and held various positions in the public sector. She started her career as an Assistant Secretary III under the European Division, (1984). She rose through the Ranks to the position of Director of Africa and African Union in the Ministry of Foreign Affairs. She has served in the following Missions abroad; Ambassador of Kenya to the Kingdom of Sweden, deputy Head /Head of Chancery in the Kenya Embassy in Paris, first Secretary in Kenya Embassy Stockholm, Sweden and lastly as a second Secretary in Kenya Embassy Stockholm, Sweden.
- iv. She is a member of the Certified Professional Mediators, Mediation Training Institute of East Africa(MTI)
- v. She has various awards and honors; Moran of the Burning Spear (MBS), (2011), President Award Scheme- Bronze, Silver and Gold Awards, (1976-1978) and the Special Mention in the Outward Bound Mountain School, (1976).
- vi. The nominee informed the Committee that she is not a member of any political party.
- vii. Her financial net worth is Twenty Million Shillings (**Kshs. 20,000,000**). Her source of income is her Salary.
- viii. The nominee joined Ministry of Foreign Affairs in 1983 and has since worked in various departments in the Ministry including European, Americas, Protocol Directorate, Middle East and International Organisation desks. She was also posted to missions in Stockholm and Paris during her tenure at the Ministry. She further mentioned to the Committee that she was responsible for the African Directorate at a time when the country's policy was geared towards deepening bilateral and multilateral relations with Africa and the African Union.
- ix. She informed the Committee that Dakar, Senegal, is a new mission and she has the requisite experience as a head of mission, Director of Africa directorate and AU. Further, knowledge of the French language makes her the perfect candidate for the position.
- x. Further she mentioned that she has never had any audit queries in the missions she served. She is confident that she will not misuse public resources given to any mission she will serve in.

- xi. As regards to Bilateral Relations the nominee stated that Senegal's historical significance as the capital of French West Africa has maintained its important position as a hub of economic and cultural affairs in the present French West Africa. It is also a member of ECOWAS a regional hub composed of a population of over three hundred million; a niche market Kenya is keen on tapping. She informed the Committee that Dakar will be the first mission in a West Africa francophone country and it will act as a gateway to opportunities for Kenya in that region.
- xii. She affirmed that there is potential in Senegal in terms of trade, education, exchange in culture and language especially Kiswahili. The country is also party to the AfCFT agreement and a signatory to the Pan African Agenda 2063. Therefore, both countries espouse ideas of promoting intra-trade in Africa and will ultimately enhance, trade relations and opportunities for Kenyans. She added that Kenya will benefit from the experience in the fields of oil, gas and blue economy.
- xiii. She further stated that she has never worked in a multilateral station but a multilateral desk within the Ministry.
- xiv. The nominee mentioned that the main challenges facing any multilateral station is networking and advocating a country's agenda. She pointed out successes such as Kenya's participation towards SDGs.
- xv. She also observed that the Ministry has advocated for smart embassies that work within the budgetary allocations provided as opposed to shutting down embassies abroad and that it is advantageous for a country to scale down its operations in a mission other than shutting it down because re-opening a mission is quite expensive.
- xvi. In regards to Pro-bono/Charity/Donations she informed the Committee that she has participated in charitable activities such as; Prisons Outreach Ministry, youth mentoring and support for the clergy, as a member of the Loresho PCEA Community Church and the Woman's Guild, donation food and other stuff, to the Kikuyu Home for the aged, contribution to worthy causes like Red Cross or Media appeals, fees payment for three students, two of them, high school to university and for the third, high school to Diploma College (about 1.7M), she is also paying fees for a needy boy student, totaling to about Kshs. 100,000 so far and also connected water to Murinduko Primary School in Embu valued at Kshs. 180,000, in addition to mentoring young officer at the Ministry.

**MIN.NO.DC.DFR/2019/152: VETTING OF AMB. JACKLINE LUMUMBA YONGA-  
NOMINEE FOR POSITION OF AMBASSADOR TO  
ROME, ITALY**

Amb. Jackline Lumumba Yonga appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 10:30 am and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to questions during the vetting as follows –

- i. The nominee is a Kenyan Citizen. She was born in Kisumu in 1961. Her National Identity Card number is 3543003.
- ii. She holds a Masters degree in Human Resource management from Poona University (1985) and holds a Bachelor of Arts Degree in Economics and History from the University of Jabalpur, both from India (1983).
- iii. Ms. Jackline Lumumba Yonga is a career public servant with over thirty-three years (33) of work experience. She started her career at the Ministry of Health as a Personnel Officer II in 1985 up to 1989. She has held various positions in the public sector and currently holds the position of Director, Middle East Directorate, at the Ministry of Foreign Affairs. She has served in the following missions abroad; Deputy High Commissioner for London, United Kingdom station, Deputy Head of Mission, Kenya High Commission in Malaysia and as an Ambassador/ Deputy Head of Mission in London.
- iv. She is a member of the following organizations; Catholic Women's Association (CWA), National Council for Persons with Disabilities and lastly Holy Trinity Church- Kileleshwa, Nairobi.
- v. She informed the Committee that she does not hold any position and is not a member of any political party.
- vi. The nominee informed the Committee that she is a career civil servant who has served in various capacities in the civil service. She has a vast wealth of experience in government service, which is suited for an ambassador. She stated that she will be accredited to Greece, Poland, Cyprus and Malta and that she is currently in charge of the Middle East Directorate in MFA.
- vii. She is in the process of publishing her memoir but has participated in formulating several policy documents relating to public service.
- viii. On Bilateral Relations the nominee informed the Committee that the relationship between Italy and Kenya have existed for decades. She further stated that Kenya can benefit from Italy in coffee and leather commodities through the provision of a platform where producers of the commodities are linked with marketers and consumers of the same; however she said that Kenya needs to bridge the gap on value addition of the same commodities.

- ix. She noted that Kenya has a work force that is committed, with a high work ethic and highly educated, attributes that are endearing to a nation that values craftsmanship. She mentioned that given the opportunity to work in Italy and would therefore link up with the TVETs, fashion and design schools and seek opportunities for skilled and semi-skilled youth currently unemployed.
- x. The nominee appreciated the Committee for noting her membership with CWA (Catholic Women Association). She confirmed that she prescribes to the notions of peace building and tolerance around the world as espoused by Pope Francis and noted that Kenya ascribes to the same aspirations in matters pertaining to peace as provided in the Kenya Foreign Policy.
- xi. On matters concerning the fight against corruption, the nominee informed the committee that she would adhere to the objectives of the Anti-Corruption and Economic Crimes Act and further sensitise personnel in the mission on the Leadership and Integrity Act. This, in her view, would act as a deterrence to commit such acts and also pin point loopholes in her mission if appointed that she intends to address.
- xii. Her financial net worth is thirty million Kenya shillings (**Kshs. 30,000,000**). Her source of income is her salary and house rents per annum totalling to three million and four hundred thousand Kenya shillings, (**Kshs. 3,400,000**).
- xiii. She has no interests that are likely to present potential conflicts of interest.
- xiv. The nominee has participated in charitable activities such as, charity work through Catholic Women Association, visiting the sick and giving food donations to orphanages.

**MIN.NO.DC.DFR/2019/153: VETTING OF HON. HALIMA ABDILLE  
MOHAMUD- NOMINEE FOR POSITION OF  
AMBASSADOR- KUWAIT CITY, KUWAIT**

Hon.Halima Abdille Mohamud appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 11:30 a.m and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to several questions during the vetting as follows-

- i. The nominee is a Kenyan Citizen. She was born in 1988 in Wajir. Her National Identity Card number is 25322209.
- ii. She holds a Bachelor of Education (Science) from Kenyatta University (2011). She is pursuing a Master of Arts degree in Gender and Development Studies (Project Management Option) from the University of Nairobi.

- iii. Hon. Halima Abdille Mohamud is public servant with over five years of experience and has held various positions in the public sector and was previously a nominated Senator from August 2013 to August 2017.
- iv. The nominee was a Senator in the 11<sup>th</sup> Parliament, which was a political office. She was also a member of the ODM party at the 11<sup>th</sup> Parliament and run on a Jubilee party ticket for the August 2017 general elections. She however stated that she currently does not have any linkage with any political office.
- v. Her financial net worth is thirty five million Kenya shillings (**Kshs. 35,000,000**). Her source of income is her salary and allowances.
- vi. She informed the Committee that Members of Parliament make good ambassadors due to their experience with Parliamentary diplomacy. Her experience as Chair in the Committee on Labour and Vice Chair of the Education Committee in the Senate enabled her to lead delegations to different events and foreign trips. Parliamentary diplomacy is very clear in legislation, oversight and representation.
- vii. The nominee informed the Committee that she believes that she is the best candidate for the appointment to Kuwait because as a young leader she understands their cultural dynamics, the religion of the nation and youth radicalization. She appreciated that the appointing authority had confidence in her abilities to represent Kenya in Kuwait.
- viii. In regards to export of meat, Kuwait lifted the ban on meat from Kenya in 2018. She asserted that if approved, she will look into the relationship between Kenya and Kuwait and follow up on bilateral trade agreements between the countries in order to maximize on opportunities.
- ix. On the issue of mistreatment of Kenyans in the Middle East, she stated that there is no legal framework to guide employment of Kenyans in Kuwait and unlicensed agents largely contribute to the problem. She stated that she will ensure that she creates a database of all Kenyans in Kuwait in order to understand their challenges and engage the Kuwait government on treatment of Kenyans within their country.
- x. The nominee stated that she will uphold the Kenyan position. However, where diplomatic issues arise, she mentioned she will consult with the Ministry of Foreign Affairs.
- xi. On Radicalization and Religious Misrepresentation she stated that Kenya and Kuwait have the same concerns over terrorism. The proximity to the waterways in the gulf brings concerns of radicalization. If approved, she will engage the youth through the Kuwait Official Development Assistance, to empower the youth of Kenya.
- xii. On matters collaboration, Kenya has benefited from the Kuwait Fund for Arab Development, which has established Umma University in Kajiado County and a school in Nyamira in Borabu.

Other development projects include Bura irrigation and Nano Madogashe. The nominee believes further relations can be created in health, labour and employment.

- xiii. She informed the Committee that the population of Kuwait is approximately 3 million. If approved, the nominee will assist skilled and semi-skilled labour penetrate into the Kuwait labour market. Further she indicated that Kuwait is rich in oil and petroleum, therefore she will facilitate exchange programmes for students and promote petroleum engineering course in Kenya.
- xiv. She has no interests that are likely to present potential conflicts of interest.
- xv. She has participated in charitable activities such as:-Volunteering for the Kenya Red Cross, took part in charity to help the orphaned and the needy, taught Wajir Girls Secondary as a BOG teacher and also paid fees for disadvantaged groups during her tenure as Member of Parliament.

FOR POSITION OF AMBASSADOR- BERLIN**

Amb. Lemarron Kaanto appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 12.30pm and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to several questions during the vetting as follows-

- i. The nominee is a Kenyan Citizen. He was born in 1971 in Kajiado. His Identity Card (ID) number is 10882022.
- ii. He holds a Bachelor of Arts (Honors) in Sociology from the University of Nairobi (1995), a Post Graduate Diploma in Food Security and Nutrition from, Wageningen University in the Netherlands (2002) and a Post Graduate Diploma in Human Rights & Gender Equality from Uppsala University in Sweden (2009). He also holds an Executive Master of Business Administration in Leadership & International Business Development, Coopenhagen Business School (2012), Masters of Arts in Sociology from Catholic University of Eastern Africa (2017)and is currently pursuing a PhD in Social Transformation from North West University, South Africa as from March (2019).
- iii. He has work experience of over twenty-two (22) years. He began his career a Project Development Manager in March 1996. He rose through the ranks of the corporate ladder to become Corporative affairs and community development manager for TATA Chemicals Magadi Limited (2014). He was the Coordinator of Information centre for Extractor in United Nations Development Programme (UNDP) in Kenya up to 2015. He was later appointed the

- Ambassador/Deputy Head of Kenyan Missions for the government of Kenya from January 2015 to August 2015 in Algeria and September 2015 to date in South Africa.
- iv. He has been awarded the following awards; ISTR/Wits African PhD Seminar, Sponsored by Africa Centre Philanthropy and Social investment Witwatersrand University, South Africa (May 2019), Early Doctoral Programme (EDP) The 9<sup>th</sup> Summer Doctoral School: African Doctoral Academy (ADA).
  - v. He is a member of the following Associations; International Society for Third-Sector Research, Global Reporting Initiative, Stakeholder Council, National Environmental Management Authority Assessor, Centre for Extractives Industries in Developing Areas.
  - vi. In regards to published writings the nominee indicated that he has published a paper on “Implications of Soda Ash Mining on the Livelihood of Indigenous Maasai Community: A Case of Tata Chemicals Magadi, Kajiado County”, Kenya. Editing Oversight Empirical Consultant International Limited, Kaanto, L., Ndolo M., and Ndongo, B., 2018.
  - vii. He has served in the following offices and capacities to date; Deputy Head of Mission, South Africa, Director, Oloolaiser Water and Sewerage Company, Board Member, Olkejuado High School, Board Member, Olooseos Secondary School, Board Member, Masai Technical Training Institute, Board Member, Bissil Girls Secondary School, Director, Ewaso Ngiro South Development Authority, Director, Agricultural Development Corporation and a Member, Kajiado District Environmental Committee.
  - viii. In regards to Leadership and Suitability he has over twenty years (20) working experience in non-profit organizations, private sector, international organizations and the public sector. At the international level, he has served as a Stakeholder Council Member of the Global Reporting Initiative (GRI), an international industry standards organization based in Amsterdam, Netherlands. He has also been a member of CSR Extractives in Developing Areas (CEIDA) research group based in ESADE University, Spain. In January 2015, he was posted to Kenya’s Embassy in Algeria as Deputy Head of Mission before joining Kenya High Commission in Pretoria in the same capacity on 1<sup>st</sup> September, 2015 to date. He affirms that his experience in diplomatic missions has been able to anchor him in diplomacy in terms of administration of an Embassy, Kenya’s foreign policy, art of diplomacy and issues of leadership.
  - ix. The nominee mentioned he will seek opportunities for students to access education in Germany. Kenya has a partnership with Germany on education therefore; he will enhance further education opportunities for Masters and PhD students.
  - x. He stated that he is only accredited to Germany and will be posted only to Berlin. Germany is not accredited to other countries

- xi. He informed the Committee that he will pursue the instruments that will enforce better investor confidence such as the agreement on double taxation that is being negotiated. Economic diplomacy is a key mandate of Ambassadors which fosters investor confidence in Kenya.
- xii. He informed the Committee that; he will ensure that xenophobia against Kenyans in Germany will not happen. He added that Kenyans in South Africa are safe despite social media reports. The Mission in South Africa has established a Committee with the Kenyan leadership in Diaspora to ensure the safety of Kenyans.
- xiii. On matters pertaining to access South Africa Visa, he mentioned that since 2015 tremendous progress has been made. In 2017 an agreement was reached in order to allow civil servants with ordinary passports to travel to South Africa without visa. In April 2019, a Technical Committee was created to look into a visa free regime between Kenya and South Africa.
- xiv. In relation to the Schengen visa, he informed the Committee that Africa is driving towards the same through the CFTA to facilitate easier movement of people. Schengen visa is an advantage as it facilitates easier movement of people with one visa across many nations.
- xv. He informed the Committee that balance of trade is in favour of Germany with 31 billion Kenyan shillings. He noted that Germany, one of the largest economies has a comparative advantage in renewable energy, automobiles, solar and manufacturing that Kenya can leverage on to become a competitive market.
- xvi. On double taxation the nominee informed the Committee that there is a double taxation agreement, which was signed and has addressed investor confidence. This can be witnessed through an increase of German Companies operating in Kenya such as Bayer, Henkel and recently Lufthansa airlines operating to Mombasa since 2015.
- xvii. In regards to the big four agenda, he asserted that the main focus of the mission is to leverage on the opportunities in Germany regard to the Big Four Agenda in Kenya. The specific areas of focus will be in manufacturing and renewable energy. In human development, Germany is strong in its TVETS. He informed the Committee that there is an agreement between Kenya and Germany on TVETS. In addition, Germany is keen on supporting centres of excellence in Kenya. This will in turn support Kenyan youth on employment. Strengthening of TVETS will also support the Big Four Agenda in terms of manufacturing, affordable housing among other sectors. Kenya will also borrow German models where Germany links their TVETS to their institutions.
- xviii. In regards to tourism the nominee indicated that Lufthansa and Condo airlines, having begun flight operations between Germany and Kenya, he further informed the committee that he would pursue innovative ways of encouraging tourists from Germany to Travel to Kenya. It will earn the country youth employment and investments to the country.

- xix. His financial net worth is Ninety million Kenya shillings (**Kshs. 90,000,000**). His source of income is his salary/allowances, rental income and sales from livestock.
- xx. He has no interests that are likely to present potential conflicts of interest.
- xxi. The nominee indicated that he has participated in charitable activities such as; contribution to church activities amounting to **Kshs.100,000**, fees and bursaries amounting to **Kshs. 200,000**, other donations amounting to **Kshs.200,000**.

The Chairperson called the meeting to order at 2.30pm. Prayer was read by Hon. Richard Tong'i MP.

In conducting the vetting process, the Committee on Defence & Foreign Relations examined the nominees against criteria that included the following as set out in the Public Appointment (Parliamentary Approval) Act, 2011

- (i) Academic Qualifications
- (ii) Employment Records
- (iii) Professional Affiliations
- (iv) Potential Conflict of interest
- (v) Knowledge of relevant subjects
- (vi) Expectations and Key priorities
- (vii) Overall suitability for the position
- (viii) Integrity
- (ix) Vision and Leadership

**MIN.NO.DC.DFR/2019/157: VETTING OF AMB. ANDREW KUHURANI - NOMINEE TO BERN**

Amb. Andrew Maina Kihurani appeared before the Committee on Monday, 10<sup>th</sup> June, 2019 at 2:30 p.m and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to several questions during the vetting as follows-

- i. The nominee is a Kenyan Citizen who was born in Kajiado in 1962. His National Identity Card number is 0462213
- ii. He holds a Bachelor of Arts degree (1985), and Post-Graduate Diploma in International Relations (1988) both from the University of Nairobi.
- iii. He has experience of over thirty-two (32) years. He started his career as an Assistant Secretary II in the Ministry of Foreign Affairs in 1986 and rose through the ranks from Assistant Secretary III to the position of an Ambassador/Deputy Permanent Representative of Kenya Permanent Mission to the United Nations, Geneva.
- iv. He has served in the following missions abroad:
  - (i) Second Secretary of the Kenya High Commission of Ottawa, Canada.
  - (ii) Assistant Secretary I for Asia and Australasia Division.
  - (iii) Assistant Secretary I for Africa and African Union Division.
  - (iv) Assistant Secretary I for Americas Division.
  - (v) First Secretary to the Kenya High Commission in Windhoek, Namibia.
  - (vi) First Secretary for the Kenya High Commission in Tel Aviv, Israel.
  - (vii) Second/First Counsellor, Deputy Chief of Protocol, Protocol Division.
  - (viii) First Counsellor and subsequently the Principal Counsellor in Kenya Embassy in Berlin.
  - (ix) Appointed Ambassador in the Ministry on 19<sup>th</sup> December 2012.
- v. His financial net worth eighty nine million Kenya shillings (**Kshs. 89,000,000**). His source of income is foreign service allowance of (**Chf 218,569**), Employment Salary of amounting to p.a Kshs. 4,806,310, and rental income amounting to p.a **Kshs, 2,452,440**.

- vi. He informed the Committee that a number of investors have shown interest in Kenya due to the open investment policy that makes all aspects of the economy accessible. This is one of factors that will allow the Swiss who are good in chemical, pharmaceutical, finance, tourism and agricultural areas to look at Kenya as a worthy partner. Areas of engagement include; Pharmaceutical Areas that will focus mainly on manufacturing, Finance and related activities, Tourism through the Ministry of Tourism to Market Kenya and Agriculture
- vii. The nominee informed the Committee that the mission in Bern, will facilitate bilateral relations between Switzerland and Kenya and will also offer consular services to the Kenyan citizens and others in Switzerland.
- viii. In regards to the fight against corruption the nominee informed the Committee that in 2018, Kenya and Switzerland signed an agreement on the Framework the return of assets of corruption and crime in Kenya. The framework enables the government of Kenya to pursue the return of proceeds of crime and corruption that have been hidden in Switzerland. In 2017, the two countries signed a Memoranda of Understanding on Criminal Matters to facilitate the reclamation of money. He mentioned that there is a technical committee that comprises of representatives from; The Executive arm of Government, The Ministry of Treasury, The State law office, Ethics and Anti-Corruption Commission (EACC) and the Assets recovery Agency.
- ix. Further he stated the committee mandate would be to ; identify where such Assets have been located in Switzerland; identify institutions and organizations to repatriate those funds, in consultation with the Swiss government to ensure that the reclaimed resources are advanced to particular development and to monitor the funds that have been reclaimed from Switzerland and there utilization of the same.
- x. He asserted that if approved and appointed he would work closely with the committee to ensure that Kenya gains more value for the money reclaimed.
- xi. On balance of Trade the nominee indicated that it is in favor of Switzerland where Kenya export and import goods worth 3 Billion and 10 billion respectively.

He pointed out the following measures that could be undertaken to improve the current trade imbalance;

- a. To work closely with the manufacturers and exporters to see what value can be added on to improve the volume;
  - b. encourage more investors from Switzerland to Kenya.
- xii. In order for Kenya to realize the Big Four Agenda, the nominee informed the Committee that there is need to promote trade and improve on manufacturing. He mentioned that the country needs to seek investors from Switzerland who are ready to set up industries in the country that focus on manufacture of pharmaceuticals, notably Novartis and Roche which has already established a laboratories in the country.
- xiii. He has no interests that are likely to present potential conflicts of interest.
- xiv. The nominee informed the Committee that he has participated in charitable activities such as: Contributions to church constructions amounting to **Kshs. 90,000** and Contributions for hospital fees amounting to **Kshs. 170,000**

Amb. The nominee responded to questions during the vetting as follows-


- i. The nominee is a Kenyan Citizen. He was born in Tharaka Nithi in 1965. His National Identity Card Number is 7010981.

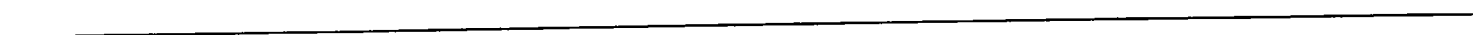

- b. THAT, the nominees presented their academic credentials and professional Certificates and demonstrated their experience in accordance with the provisions



of Section 6(7) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011;

**PUBLIC APPOINTMENTS (PARLIAMENTARY APPROVAL) ACT**

*[Date of assent: 11th November, 2011.]*

*[Date of commencement: 14th November, 2011.]*

**An Act of the Parliament to provide for procedures for parliamentary approval of constitutional and statutory appointments and for connected purposes**

**1. Short title**

This Act may be cited as the Public Appointments (Parliamentary Approval) Act, 2011.

**2. Interpretation**

In this Act, unless the context otherwise requires—

“**appointing authority**” means any person who, under the Constitution or any other law, is required to make an appointment for which the approval of Parliament is required;

“**appointment**” includes any re-appointment to the same body, whether or not in the same capacity;

“**candidate**” means a person who has been proposed or nominated for appointment to a public office;

“**Clerk**” means the Clerk of the relevant House of Parliament; and

“**Committee**” means the relevant committee of Parliament or such other Committee as the Speaker may, for good reasons, direct.

**3. Exercise of powers of appointment**

An appointment under the Constitution or any other law for which the approval of Parliament is required shall not be made unless the appointment is approved or deemed to have been approved by Parliament in accordance with this Act.

**4. Notification of vetting requirements**

Any advertisement inviting applications for nomination for appointment to an office to which this Act applies shall indicate that candidates so nominated shall be required to appear before a committee of Parliament for vetting.

**5. Notification of nomination**

(1) An appointing authority shall, upon nominating a person for an appointment to which this Act applies, notify the relevant House of Parliament accordingly.

(2) A notification under subsection (1) shall be—

- (a) in writing;
- (b) be lodged with the Clerk of the relevant House of Parliament.

(3) A notification of appointment shall be accompanied by information concerning the nominee, having regard to the issues mentioned in section 7.

(4) For purposes of this Act, a notification of nomination shall be deemed to be duly given on the day on which it complies fully with subsections (2) and (3).

## 6. Approval hearing

(1) Upon receipt of a notification of appointment, the Clerk shall invite the Committee to hold an approval hearing.

(2) The Committee shall determine the time and place for the holding of the approval hearing and shall inform the Clerk.

(3) The Clerk shall notify a candidate of the time and place for the holding of an approval hearing.

(4) The Committee shall notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing.

(5) Subject to this Act, all Committee proceedings on public appointments shall be open and transparent.

(6) Despite subsection (5), a Committee may, on its own motion or on the application of a candidate or any other concerned person, determine that the whole or part of its sittings shall be held in camera.

(7) An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

(8) The criteria specified in the Schedule shall be used by a Committee during an approval hearing for the purposes of vetting a candidate.

(9) Any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated.

---

(10) A candidate may, at any time, by notice in writing addressed to the Clerk, withdraw from the approval process and the candidate's nomination shall thereupon lapse.

## 7. Issues for consideration

The issues for consideration by the relevant House of Parliament in relation to any nomination shall be—

- (a) the procedure used to arrive at the nominee;
- (b) any constitutional or statutory requirements relating to the office in question; and
- (c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

**8. Period for consideration and report**

(1) Unless otherwise provided in any law, a Committee shall consider a nomination and table its report in the relevant House for debate and decision within fourteen days from the date on which the notification of nomination was given in accordance with section 5.

(2) At the conclusion of an approval hearing, the Committee shall prepare its report on the suitability of the candidate to be appointed to the office to which the candidate has been nominated, and shall include in the report, such recommendations as the Committee may consider necessary.

**9. Failure of Parliament to act on nomination**

If, after expiry of the period for consideration specified in section 8, Parliament has neither approved nor rejected a nomination of a candidate, the candidate shall be deemed to have been approved.

**10. Rejection of nomination**

Where the nomination of a candidate is rejected by Parliament, the appointing authority may submit to the relevant House the name of another candidate, and the procedure for approval specified in this Act shall apply accordingly.

**11. Notification of decision**

The Clerk shall notify the appointing authority of the decision of the relevant House of Parliament within seven days of the decision.

**12. Powers of the committee**

(1) The committee shall have power to summon any person to appear before it for the purpose of giving evidence or providing information during approval hearing.

(2) For purposes of subsection (1), the committee shall have the same powers as the High Court to—

- (a) enforce the attendance of witnesses and examine them on oath, affirmation or otherwise;
- (b) compel the production of documents; and
- (c) issue a commission or request to examine witnesses abroad.

(3) Any person who—

- (a) disobeys any order made by a committee for attendance or for production of papers, books, documents or records; or
- (b) refuses to be examined before, or to answer any lawful and relevant question put by, a committee,

commits an offence and shall be liable, on conviction, to a fine not exceeding two hundred thousand shillings or to imprisonment for a term not exceeding one year, or to both.
