1.0 Introduction

1.1 Establishment of the Committee

- I. Article 221 (4) of the Constitution and Section 7 of the Public Finance Management Act, 2012 provide for the establishment of a Committee of the National Assembly whose main role is to take the lead in budgetary oversight by the National Assembly. Pursuant to this constitutional provision, Standing Order 207 establishes the Budget and Appropriations Committee with specific mandates as follows:
 - i. Examine the Division of Revenue Bill.
 - ii. Investigate, inquire into, and report on all matters relating to coordination, control, and monitoring of the national budget.
 - iii. Review the budget estimates and make recommendations to the House.
 - iv. Examine the Budget Policy Statement presented to the House.
 - v. Examine bills related to the national budget, including appropriation bills; and
 - vi. Evaluate tax estimates, economic and budgetary policies, and programmes with direct budget outlays.

2.0 Background

6. The County Government Additional Allocation Bill, 2025 (Senate Bill No. 1 of 2025) was published on 6th February 2025. The Bill was read a First time on Tuesday, 4th March 2025. The Senate considered the Bill and passed it with amendments on Tuesday 1st, April 2025. Thereafter, the Bill was referred to the National Assembly for concurrence as per the provisions of Article 110(4) of the Constitution.
7. The Bill provides for the transfer of conditional and unconditional allocations from the National government's share of Revenue and from development partners to the county governments for the financial year 2024/25.
8. The additional allocation to counties is provided for under Article 202(2) of the Constitution, where it is stipulated that County governments may be given additional allocations from the national government's share of the revenue, either conditionally or unconditionally. Further, Article 190 of the Constitution contemplates additional support to county governments to enable them to perform their functions adequately.
9. Overall, the Bill proposes to allocate Ksh.50.5 billion as additional allocations (conditional and unconditional) to County Governments. Out of this, Ksh 8.42 billion will be financed from the National Government's share of revenue, Ksh.116.1 million for Court Fines, and Ksh.42 billion from proceeds of loans and grants from Development Partners.

3.0 Highlights of the County Government Additional Allocation Bill, 2025

10. The National Assembly considered and approved the County Governments Additional Allocations Bill (National Assembly Bill No. 2, of 2025) with a total of Kshs. 50.5 billion as the additional allocations to counties for FY 2024/25. This allocation comprised the following programmes:

a. Supplement Construction to County Headquarters:

11. The Bill allocates a total of Ksh.523.1 million for the construction of county headquarters for five County Governments. However, the funds are distributed among only four counties Isiolo (Ksh. 115.3 million), Lamu (Ksh. 264.7 million), Tana River (Ksh. 95 million), and Tharaka Nithi (Ksh. 47.9 million). It is important to note that Nyandarua County was left out since it had already utilized its full entitlement.

b. County Aggregation and Industrial Parks (CAIPS)

12. The County Aggregation and Industrial Parks (CAIPS) program is a key initiative under the Bottom-up Economic Transformation Agenda (BETA). A total of **Ksh.2.9 billion** has been allocated to 21 counties, with the distribution determined by

outstanding balances from previous funding from the national government and the progress of ongoing projects. One key condition to participating counties is that they must contribute **Ksh.250 million** to complement the national government's funding.

13. The counties to benefit from the project as per the Bill are; Bungoma, Busia, Embu, Garissa, Homa Bay, Kiambu, Kirinyaga, Kisii, Kwale, Machakos, Meru, Migori, Mombasa, Murang'a, Nakuru, Nandi, Nyamira, Siaya, Trans Nzoia, Wajir, and Uasin Gishu. The counties were selected based on the progress made towards project completion, with priority given to those that commenced construction during the first phase in FY 2023/24.

c. Community Health Promoters (CHPs)

14. The program is allocated **Ksh. 3.23 billion**, distributed across all 47 counties according to the number of Community Health Promoters (CHPs) in each County. The funds are intended to provide a monthly stipend of **Ksh.5,000** per CHP, with the National Government contributing **Ksh.2,500** and county governments matching the remaining **Ksh.2,500**. Nationwide, an estimated 107,831 CHPs will receive this compensation.

15. The Community Health Promoters (CHPs) are engaged under the Afya Bora Mashinani program, where they provide direct healthcare services to households. This initiative aims to accelerate progress toward Universal Health Coverage by supporting County Governments. As of the end of the 2023/24 fiscal year, program data indicates that 93,390 CHPs had been provided with an Electronic Community Health Information System (eCHIS) gadget.

d. Salary Arrears for County Government Health Workers

16. The Bill allocates **Ksh.1.759 billion** for the settlement of salary arrears owed to County Government health workers during the 2024/25 Financial Year. This allocation follows a Return-to-Work Agreement signed in March 2024 between the National Government (through the Ministry of Health) and the Kenya Medical Practitioners, Pharmacists, and Dentists Union (KMPDU), which resolved the doctors' industrial action. As part of the agreement, the National Government committed to facilitating the payment of **Ksh.3.5 billion** (the outstanding basic salary arrears accrued by county governments) in two phases.

17. The first phase is being implemented in FY 2024/25, hence the allocation of **Ksh.1.759 billion** under conditional allocation to counties. The amount is shared among the 47 counties as per the number of doctors employed by each county government as

of 30th June 2024. The counties with the highest share are Nairobi, Kakamega, Mombasa, Kiambu, Kisumu, Nakuru, and Homa Bay.

e. Court fines

- 18.** The second schedule contains unconditional additional allocations to counties from court fines amounting to **Ksh.116.1 million**. The allocation covers the total sum of proceeds from court fines collected from violation of county legislation from FY 2019/20 to FY 2022/23. The Ksh.116.1 billion consists of the Ksh.108.6 million contained in the CGAAA, 2024 (not disbursed), and Ksh.7.4 million as proposed in CGAAB, 2024 for FY 2024/25.
- 19.** The amount is shared among ten counties, where fines were collected by the judiciary under the contravention of county laws. The beneficiary counties include; Kiambu County- Ksh.10.7 million, Kisumu County- Ksh.299,912, Kitui County-Ksh. 100,000, Laikipia County –Ksh.1.5 million, Machakos County-Ksh.16 million, Migori County –Ksh. 974,165, Mombasa County –Ksh.13.4 million, Murang’a County-Ksh. 70 million, Nakuru County –Ksh.1.9 million, and Nyeri County –Ksh. 250,000.

f. Conditional allocations financed by proceeds of loans and grants from development partners

- 20.** The third Schedule contains additional allocations from the proceeds of loans and grants from development partners amounting to **Ksh. 42 billion**. The projects are proposed through seventeen (17) programs with inventions being in the **Agriculture and Health sectors, Water and sanitation services and other devolution support programmes**. The World Bank-funded projects account for the highest financings totalling **Ksh.33.1 billion**. The implementation of the projects is towards all 47 counties based on the meeting of the conditions therein. Table I summarizes the donor’s name, Project description, and allocation.

4.0 Submissions by the Council of Governors

21. The Committee invited the Council of Governors to provide submissions on the Bill. The Council of Governors submitted that they do support the County Governments Additional Allocations Bill (Senate Bills No.1 of 2025) in the form currently being considered by the National Assembly. This is because the Bill has incorporated issues raised by Counties and reinstated the additional allocations as budgeted for.
22. Following the downward revision of budgetary allocations for donor-funded projects through Supplementary Appropriation Act No. 2 for FY 2024-25, the Council expressed concern about its adverse impact on budget implementation for the current fiscal year, given that Counties had made commitments based on the initial allocations that informed their budgets and cash flow projections. The effects of such cuts, if not reversed, are dire and threaten the continuity of service delivery in the Counties.
23. The Council also expressed concern over the delays associated with enacting the County Governments Additional Allocations Bills (CGAAB). Since the introduction of CGAAB in the FY 2021/22, it has always been passed late and outside the timelines provided for in the Public Finance Management (PFM) Act CAP 412A. Section 42 of the PFM Act provides that "Parliament shall consider the Division of Revenue Bill, the County Allocation of Revenue Bill, and a County Government's Additional Allocations Bill not later than thirty days after the Bills have been introduced to approve them, *with or without amendments*."

5.0 Committee Observations

24. The Committee considered the matters proposed in the Bill and observed as follows;

- i. That on the 14th March 2025, the National Assembly had considered and passed a similar Bill with a total additional allocation to counties amounting to Kshs. 25.33 billion. The amount was informed by the allocation provisioned in the supplementary estimates II for FY 2024/25. This allocation is Kshs. 25.2 billion less than what is proposed under the Senate Bill.
- ii. The committee raised concerns that delays in passing the bill were already affecting critical activities, notably the timely payment of county health promoters and the completion of the County Aggregate Industrial Parks. This delay not only affects service delivery but also demoralizes essential frontline workers.
- iii. The delay in considering and passing the bill poses a serious risk to donor-funded projects. Since these funds cannot be utilized without a legal framework, valuable support from development partners remains idle, potentially threatening project timelines and outcomes.
- iv. The committee noted that continued delay exposes donor-funded initiatives to exchange rate fluctuations, which could escalate project costs beyond available allocations. This financial uncertainty could undermine the effectiveness and sustainability of such projects, especially in sectors that rely heavily on external funding.

6.0 Recommendation

- 25. Having deliberated on the provisions of the Bill, the Committee recommends that the County Government Additional Allocation Bill, 2025 (*Senate Bill No.1 of 2025*) be **approved without amendments.**

The Parliamentary Budget Office took members through the draft report. The report was proposed by Hon. Hon. Mutuse, Eckomas Mwangi, OGW, M.P. and seconded by Hon. (Dr.) Masara, Peter Francis, M.P. After deliberations, the report was **ADOPTED** with the following observations and recommendations as follows:

OBSERVATIONS

- i. That on the 14th March 2025, the National Assembly had considered and passed a similar Bill with a total additional allocation to counties amounting to Kshs. 25.33 billion. The amount was informed by the allocation provisioned in the supplementary estimates II for FY 2024/25. This allocation is Kshs. 25.2 billion less than what is proposed under the Senate Bill.


