1.0 PREFACE

Mr. Speaker,

The Departmental Committee on Labour and Social Welfare is one of the Departmental Committees established under Standing Order No. 198 whose functions are *inter alia* to:-

- i. investigate, inquire into and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and Departments;
- ii. study the programme and policy objectives of the Ministries and Departments and the effectiveness of the implementation;
- iii. study and review all legislation referred to it;
- iv. study, assess and analyse the relative success of the Ministries and Departments as measured by the results obtained as compared with its stated objectives;
- v. investigate and inquire into all matters relating to the assigned Ministries and Departments as they may deem necessary, and as may be referred to them by the House or a Minister; and
- vi. make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.

Further, Standing Order No. 152 provides that:-

- i) Upon being laid before the National Assembly, the Annual Estimates shall stand committed to the respective Departmental Committees according to their mandates.
- ii) Each Departmental Committee shall consider, discuss and review the Estimates committed to it under this standing order and submit its report thereon to the House within twenty one days after they were first laid before the House.

The Committee is mandated to consider the following issues; Labour and Trade Union Relations; national Manpower Policy and Development; promotion of self employment in micro and small enterprise; National Social Security Fund (NSSF); National

Productivity Centre; Gender, children and Social Development Policies Mainstreaming; Women Enterprise Development Fund; coordination of Volunteer Services and Social Welfare for Vulnerable Groups; Community Development Programmes; Institution for Children's Care and Development; Culture and National Heritage; Disaster Management Policies and Programmes; Coordination of Resettlement and Mitigation for Internally Displaced Person (IDPs); Youth Affairs and Sports among others.

The Terms of Reference

The Ordinary Question Number 919 by the Hon. F.T. Nyammo Member of Parliament for Tetu Constituency Speaker of the National Assembly referred to the Committee on

Wednesday June 15, 2011. He directed that the Committee delves into the matter and reports back to the House.

The Ordinary Question Number 919 read as follows:

The Member for Tetu (Mr. F.T. Nyammo) to ask the Minister of State for Provincial Administration and Internal Security: -

- a) Is the Minister aware that the employees who worked for Nyayo Tea Zone in Tetu Division in 1996-1990, among them Ms. Ruth Muthoni (ID No. 9353450), Mr. David Karimi (ID No. 1425374) and Ms. Sarah W. Nderitu (ID No. 5544960) were not paid their salaries, terminal dues and other benefits?*
- b) Could the Minister confirm that the Ministry of Agriculture recommended to the Ministry of State for Provincial Administration and Internal Security to pay the former employees in 2005?*
- c) What measures has the Government taken to ensure that the persons are paid their dues?*

Meetings

The Committee held meetings with officers of the relevant Government Ministries and other persons who made submissions on Government Policy on Employment and adduced evidence on the nonpayment of salaries, terminal dues and other benefits to the former employees of the Nyayo Tea Zone, Tetu Division, by the Office of the President through the Ministry of State for Provincial Administration and Internal Security.

The Committee received submissions and evidence from the following:-

- i. The Hon F.T. Nyammo, M.P. for Tetu Constituency.
- ii. Representatives of the former employees of the Nyayo Tea Zone, Tetu Division.
- iii. The Chief Executive Officer and Chairman of the Nyayo Tea Zone Development Corporation.
- iv. The Minister for Agriculture.

General Observation

During the Meetings held to discuss the matter of the nonpayment of the workers, the Committee on a broad perspective observed that:-

- i. Most of the former employees of the Nyayo Tea Zone were residents of Tetu Division and some of them were squatters at or near the forest land.
- ii. The Office of the President through the Provincial Administration Officers (District Commissioner, Divisional Officers and Chiefs) contracted the residents to work on casual terms in The Nyayo Tea Zones, Tetu Division.
- iii. The workers were to be paid for piece work which was assigned by the Provincial Administration Officers.
- iv. The records for the casual workers were not handed over to the new Nyayo Tea Zone Corporation.

General Recommendations

The Committee on a broad perspective recommends that:-

All the seven hundred and two former employees of Nyayo Tea Zone, Tetu Division, now the Tetu District be paid their salaries, terminal dues and other benefits by the Office of the President.

The Committee is also grateful to the Member for Tetu for raising the Question in the House.



DEPARTMENTAL COMMITTEE ON LABOUR AND SOCIAL WELFARE

2.0 BACKGROUND

The Kenya National Assembly Standing Order No. 198 (e) mandates the Departmental Committee on Labour and Social Welfare to investigate and inquire into all matters relating to the assigned Ministries and Department as they may deem necessary, and as may be referred to them by the House or a Minister.

The Speaker referred Ordinary Question Number 919 by Hon. F.T. Nyammo, M.P. for Tetu Constituency to the Committee on Wednesday June 15, 2011.

The Committee thereon embarked on hearings, interrogating, and receiving evidence and submissions on Nyayo Tea Zone employment policy.

The Committee held meetings and received evidence and submission at parliament buildings from the following:-

- i. The Hon. F.T. Nyammo, M.P.
- ii. The representative of the former employees of Nyayo Tea Zones Workers in Tetu Division
- iii. The Chief Executive Officer and the Chairman of the Nyayo Tea Zone Development Corporation
- iv. The Minister for Labour
- v. The Minister for Agriculture

The Minister for Provincial Administration and Internal Security did not honour the Committees two invitations to appear before it. He did not give any written submission as requested by the Committee either.

3.0 EVIDENCE ON THE NON-PAYMENT OF SALARIES, TERMINAL DUES AND OTHER BENEFITS TO FORMER EMPLOYEES OF NYAYO TEA ZONE, TETU DIVISION

3.1 Submission by the Hon. F.T Nyammo, M.P. and representatives of the former workers (Mr. Charles Maimba, Muhoya Location; Mr. Samuel N. Kiminda Supervisor

Thiginge Nyayo Tea Zone; and Mr. Joshua Mithui a casual worker, of the Nyayo Tea Zone Tetu Division.

3.1.1 Submission by Mr. Samuel N. Kiminda, Supervisor Thiginge Nyayo tea Zone

Mr. Kiminda informed the Committee that:-

- i. The Chief in Tetu Division informed the local residents that the former President, Daniel Arap Moi had directed that part of Tetu Forest should be cleared for planting of the tea bushes. They were further informed that on clearing the forest part of the cleared land would be allocated to them for permanent settlement as most of them were squatters in the forest.
- ii. The residents adhered to the call and cleared the forest for payment and settlement as directed.
- iii. The portion for clearing by each worker was measured by the Provincial Administration Officers. Each worker was to clear half an acre initially however, on clearing the portion the workers would be assigned another half an acre to clear.
- iv. All the workers were neither paid their dues for the services rendered between the period of 1986 and 1990 nor allocated part of the land as earlier promised.
- v. The initial forest that was cleared was 100 kilometers into the forest. Later, the distance was increased by another 100 kilometers, making it a total of 200 kilometres.
- vi. The work for each portion involved measuring, clearing bushes, digging and uprooting stumps, digging holes, planting tea, shading for the tea bushes, weeding for the tea bushes, pegging the tea bushes and tipping of the tea bushes.
- vii. Officers from the Ministry of Agriculture inspected the work and gave an okay for each stage.
- viii. In total, the people who worked in the then Tetu Division, the now Tetu District were seven hundred and four.
- ix. Some of the officers who supervised the work include; Mr. Malekya as Estate Manager, Mr. Muiruri, Mr. Ndirangu and Mr. Murithi as Agricultural Officers in Charge.
- x. The workers did not get any letters of appointment/commitment largely because they were casual labourers.

- xi. The amount of money owed to the seven hundred and four workers is about Kshs. 20Million. The workers came up with the amount owed of twenty million shillings by considering the piece/s of portion/s that were cleared by every person and the type of work done.

3.1.2 Submission by Mr. Joshua Muthui, a casual worker

Mr. Muthui informed the Committee that:-

- i. People were given notices to leave the forest in 1989.
- ii. Most of the people who worked in the Nyayo Tea Belt were squatters.
- iii. The Nyayo Tea Zone Development Corporation came into operation in 1991 at the time when the tea leaves were ready for plucking.
- iv. Some of the people who worked at the Nyayo Tea Belt between 1986 – 1990 also worked for the Nyayo Tea Zone Corporation from 1991 and they were paid their dues for picking tea, by the Nyayo Tea Zone Development Corporation.
- v. There were three locations in Tetu Division; Tetu Location, Ihithe-hubu-ini Location and Muhoya Location all within Tetu Division.
- vi. The list of the workers claiming their pay was compiled by the Location supervisors.

3.2 Submission by the Minister for Agriculture, The Hon. (Dr.)Sally Kosgei, M.P.

The Hon. Dr. Sally Kosgei, M.P. Minister for Agriculture informed the Committee that:-

- i. The Ministry went through all its files and there was no information whatsoever regarding the workers.
- ii. There was an effort by the Ministry for Agriculture to pay the workers but issues such as identity of the officers who supervised the work, was not known; the terms of services for the workers was also not known; and the issue is over twenty years old.
- iii. The Provincial Administration and Internal Security is best placed to verify the names and documents submitted as the Ministry was the employer at the time when the workers were not paid.
- iv. The Provincial Administration and Internal Security should inform the Committee whether they have a vote to pay the employees.

- v. There is need to find out why the employees were quite from 1990 up to now.
- vi. There is extremely good faith to try to sort out the issue and if the documents and the letters are found to be valid, then the money can be paid to the former employees from a vote in the Nyayo Tea Zones Development Corporation.

3.3 Submission by the Managing Director and Chairman Nyayo Tea Zone Development Corporation

The Managing Director and Chairman Nyayo tea Zone Development Corporation, Dr. Anne Kinyua and Mr. K.M Sang informed the Committee that:-

- i. All the previous records were kept by the office of the president and they were not handed over to the Corporation.
- ii. In 1986-1990, Nyayo Tea Zone was under the office of the President.
- iii. The Nyayo Tea Zone Development Corporation has documents on their employees from 1992 onwards.
- iv. The employer between 1986 and 1990 was the Office of the President and did not handover any claim to the Nyayo Tea Zone Development Corporation.
- v. In 1988, the audited reports did not show any report or debt handed over to the Nyayo Tea Zone Development Corporation nor any liability.
- vi. There are a total of seventeen Tea Zones and only one Tea Zone, Tetu District has raised the issue of having not been paid.

3.4 Submission by the Minister for Labour

The Minister for Labour Hon. John Munyes, M.P. informed the Committee that:-

- i. The Nyayo Tea Zone workers did not report their cases to the Labour Office in Nyeri hence the Ministry was unaware of the case.
- ii. According to Employment Act Clause 17 (1) *'Subject to this Act, an employer shall pay the entire amount of the wages earned by or payable to an employee in respect of work done by the employee in pursuance of a contract of service directly, in the currency of Kenya—*
 - (a) *in cash;*
 - (b) *into an account at a bank, or building society, designated by the employee;*
 - (c) *by cheque, postal order or money order in favour of the employee; or*

(d) in the absence of an employee, to a person other than the employee, if the person is duly authorised by the employee in writing to receive the wages on the employee's behalf.

(2) An employer shall pay wages to an employee on a working day, and during working hours, at or near to the place of employment or at such other place as may be agreed between the employer and the employee.

(3) An employer shall not pay wages to an employee in any place where intoxicating liquor is sold or readily available for supply, except in the case of employees employed to work in that place.

(4) No person shall give or promise to any person any advance of money or any valuable consideration upon a condition expressed or implied that the person or any dependant of that person shall enter upon any employment.

(5) If, in a contract of service or collective agreement, provision is made for the payment of any allowance in kind to an employee with the employees consent the payment may with such consent be made only if, the allowance—

(a) is for the personal use and benefit of the employee ; and

(b) does not consist of or include any intoxicating spirit or noxious drug.

(6) Notwithstanding the provisions of any law for the time being in force, whenever an attachment has been issued against the property of an employer in execution of a decree against him, the proceeds realised in pursuance of that execution shall not be paid by the court to a decree-holder until a decree obtained against the employer in respect of the wages of employees has been satisfied to the extent of a sum not exceeding six months' wages of those employees.

(7) Nothing in subsection (6) shall prevent an employee from recovering any balance due after such satisfaction, by ordinary process of law.

(8) Subsection (6) shall not apply if the attachment is issued against an employer undergoing insolvency as defined under Part-VIII in which case the provisions under that Part shall apply.

(9) If an employer advances to an employee a sum in excess of the amount of one month wages of the employee or, in the case of an employee employed under a written contract of service, a sum in excess of the amount of two month wages of that employee, the excess shall not be recoverable in a court of law.

(10) A person who—

(a) subject to section 19, wilfully fails to make payment of or to tender the wages earned by or payable to an employee in accordance with subsection (1) ;or

(b) contravenes any of the provisions of subsections (2), (3), (4) and (5).

commits an offence and shall on conviction be liable to fine not exceeding one hundred thousand shillings or to imprisonment for a term not exceeding two years or to both.

(11) No employer shall limit or attempt to limit the right of an employee to dispose of his wages in a manner which the employee deems fit, nor by a contract of service or otherwise seek to compel an employee to dispose of his wages or a portion thereof in a particular place or for a particular purpose in which the employer has a direct or indirect beneficial interest.'

- iii. Failing to pay the workers is in contravention of the Employment Act 2007 Clause 17 hence the workers should be paid all their dues.

4.0 COMMITTEE OBSERVATION

The Committee observed that:-

- i. The Nyayo Tea Zone was an initiative from the Office of the President and the Ministry of State for Provincial Administration and Internal Security was charged with executing the initiative.
- ii. Most of the workers were living near the Forest and some were squatters within the forest where the Tea Zones was demarcated.
- iii. The workers records were kept by the supervisors who then forwarded the same to Provincial Administrators.
- iv. By the time the Nyayo Tea Zone became Nyayo Tea Zone Development Corporation many casual workers had not been paid their dues and the supervisors had handed over their original records to Provincial Administration officers
- v. The Nyayo Tea Zone Development Corporation in 1991 took over all the liabilities from the Office of the President, Ministry of State for Provincial Administration and Internal Security.
- vi. The Ministry of State for Provincial Administration and Internal Security was not willing to have a joint deliberation on the subject matter with the Nyayo Tea Zone Development Corporation.

5.0 RECOMMENDATIONS

The Committee recommends that:-

All the seven hundred and two former employees of Nyayo Tea Zone, Tetu Division, now the Tetu District be paid their salaries, terminal dues and other benefits by the office of the President.

The Managing Director of Nyayo Tea Zone Development Corporation, Dr. Anne Kinyua and the Chairman Mr. K.M.Sang informed the Committee that:-

- i. All the previous records on the workers were kept by the office of the president and they were not handed over to the Corporation.
- ii. In 1986-1990, Nyayo Tea Zone was under the office of the President.
- iii. The Nyayo Tea Zone Development Corporation has documents on their employees from 1992 onwards.

- iv. The employer between 1986 and 1990 was the Office of the President and did not handover any claim to the Nyayo Tea Zone Development Corporation.
- v. In 1988, the audited reports did not show any report or debt handed over to the Nyayo Tea Zone Development Corporation nor any liability.
- vi. There are a total of seventeen Tea Zones and only one Tea Zone, Tetu District had raised the issue of having not been paid.



ZONES

Mr. Samuel N. Kiminda a representatives of the former workers of Tetu division Nyayo Tea Zones informed the Committee that:-

- i. The Chief in Tetu Division informed the local residents that the former President. Daniel Arap Moi had directed that part of Tetu Forest should be cleared for planting of the tea bushes. They were further informed that on clearing the forest part of the cleared land would be allocated to them for permanent settlement as most of them were squatters in the forest.
- ii. The residents adhered to the call and cleared the forest for payment and settlement as directed.
- iii. The portion for clearing by each worker was measured by the Provincial Administration Officers. Each worker was to clear half an acre initially however, on clearing the portion the workers would be assigned another half an acre to clear.
- iv. All the workers were neither paid their dues for the services rendered between the period of 1986 and 1990 nor allocated part of the land as earlier promised.
- v. The initial forest that was cleared was 100 kilometers into the forest. Later, the distance was increased by another 100 kilometers, making it a total of 200 kilometres.
- vi. The work for each portion involved measuring, clearing bushes, digging and uprooting stumps, digging holes, planting tea, shading for the tea bushes, weeding for the tea bushes, pegging the tea bushes and tipping of the tea bushes.
- vii. Officers from the Ministry of Agriculture inspected the work and gave an okay for each stage.
- viii. In total, the people who worked in the then Tetu Division, the now Tetu District were seven hundred and four.

- ix. Some of the officers who supervised the work include: Mr. Malekya as Estate Manager, Mr. Muiruri, Mr. Ndirangu and Mr. Murithi as Agricultural Officers in Charge.
- x. The workers did not get any letters of appointment/commitment largely because they were casual labourers.
- xi. The amount of money owed to the seven hundred and four workers is about Kshs. 20Million. The workers came up with the amount owed of twenty million shillings by considering the piece/s of portion/s that were cleared by every person and the type of work done.

Mr. Joshua Muthui, a casual worker and a representative of the former workers of Tetu division Nyayo Tea Zones informed the Committee that:-

- i. People were given notices to leave the forest in 1989.
- ii. Most of the people who worked in the Nyayo Tea Belt were squatters.
- iii. The Nyayo Tea Zone Development Corporation came into operation in 1991 at the time when the tea leaves were ready for plucking.
- iv. Some of the people who worked at the Nyayo Tea Belt between 1986 – 1990 also worked for the Nyayo Tea Zone Corporation from 1991 and they were paid their dues for picking tea, by the Nyayo Tea Zone Development Corporation.
- v. There were three locations in Tetu Division; Tetu Location, Ihithe-hubu-ini Location and Muhoya Location all within Tetu Division.
- vi. The list of the workers claiming their pay was compiled by the Location supervisors.

I have gone through co responses held in this office relating to above and I have the following:-

- 1) Initially, the claimants were 500, and the total debt was 2 million. Reference is a letter to DC Tetu and copied to you among others, dated 7th February, 2005
- 2) In a letter addressed to the DAO Nyeri copied to you the team was claiming that 900 members worked in the tea zones and amount owed to them is 50,000,000 million
- 3) List supporting above has 855 persons and total amount due is 45,052,695.
- 4) On random close checking there are persons who appear twice e.g Alice Wangechi Muchemi and Esther W. Kiliara and hence the number is far below the 900 or 855 quoted.
- 5) The rates used to calculated amount persons owed to my understanding is on the higher side. The rates for half an acre is as follows (Kshs):-

▪ Bush clearing	-	720 per plot
▪ Digging	-	720 per plot
▪ Stump uprooting	-	12000 per stump
▪ Pegs and measuring	-	2000 per plot
▪ Digging holes	-	2000 per plot
▪ Planting	-	2000 per plot
▪ Shading	-	3000 per plot
▪ Weeding	-	3000 per plot
▪ Pegging	-	800 per plot
▪ Tipping	-	200 per plot
TOTAL		38,440 per plot

(assuming each plot had 2 stumps)

- 6) Assuming that the above operations are done once, it means that about 1300 parcels of half an acre each were worked on and tea established. This works out to 144.5 HA currently under tea zone in Tetu, and payments not made.
- 7) Statistic held at the managers office Nyayo tea zone is as follows:-

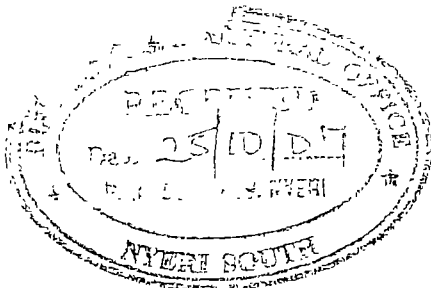
Total area under tea zone (district)	-	186HA
Total area under tea zone (Tetu division)	-	100.6HA
Total area under tea (Muhoyas location)	-	35.6HA
- 8) The statistic above show that the area said to have been established with tea is more than the actual, taking into account that most of the claimants comes from Muhoyas location

- 9) Lists forward to this office have vital information missing eg 52 claimants have no identity and number.
- 10) Assumption is that the claimants are 38 years and above for them to have qualified to work in the tea zone in 1986.
- 11) Documents to support the claims may not be traced at the accountants' office.

CONCLUSION

There may be cases of individuals who worked for the tea zone and were not paid. If the issue is to be addressed I propose the above-cited discrepancies are resolved and authenticity of the forward list established. Investigation can be instituted on the ground to come up with more information.

- (c) We have discussed in your office with the Technical Agricultural Officer who were supervising work by then and they agreed that one (1) plot was worked between 1 worker to twelve workers according to how hard the ground was.
- (d) We have listed only the workers with identity cards and workers within the tea zones.

Finally, in your conclusion, you indicated that there are cases of some people who were not paid and the list attached are those who were not paid. Therefore; we are humbly requesting to be paid our dues in a very near future sir.

- (f) Dues increment profit for those years without payment



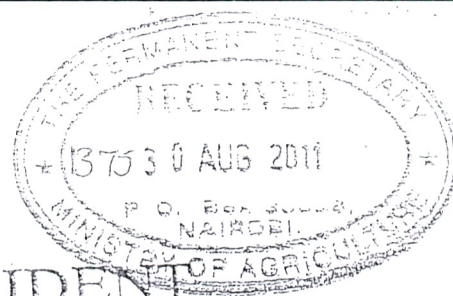

UNPAID DUES OF WORKERS IN NYAYO TEA ZONES 1986-1990

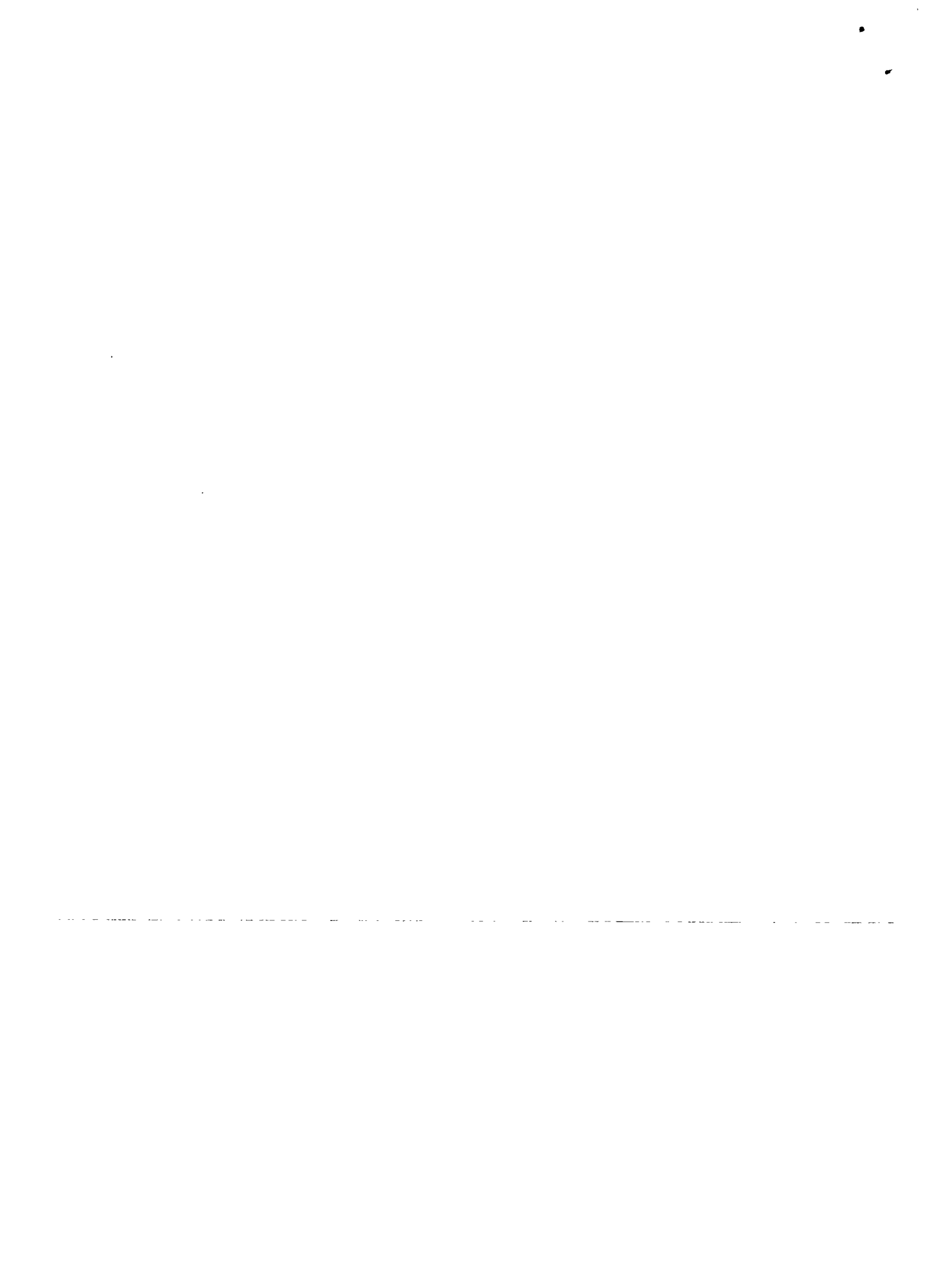
This is to acknowledge receipt of your letter MOA/CORP/11/14/VOL.VI (46) of 16th August, 2011.

This matter was raised in Parliament in May, 2005 by the then MP for Mathira Hon. Nderitu Gachagua to your Ministry. In June, 2011, the speaker directed the Departmental Committee on labour and social welfare to enquire and give a report to the house on question No. 919 that was asked by the Tetu MP, Hon. F.T. Nyammo to this Ministry on the unpaid dues of workers in the Nyayo Tea Zone, (Tetu Division).

Before the Nyayo Tea Zone Development Corporation was established, in 1986, supervision and payment of wages to casuals was done by Provincial Administration and supervised by technical staff from the Ministry of Agriculture. During this period, casuals were paid wages and not salaries as claimed in the parliamentary question, hence do not qualify for any terminal dues.

The casuals claim that they worked in Nyayo Tea Zones, where bush clearing, de-stumping, digging holes, pegging, planting of tea bushes were done. There are no records to support that kind of work they are claiming from any government office, neither do we have any records to support any unpaid casual wages from the officers who were supervising them.

During the transition taking over from the Nyayo Tea Zone Development Corporation confirmed that there were no outstanding liabilities.



There is no record of any correspondence from your Ministry recommending that this Ministry pays the casualties. The complainant's claims cannot be honoured as there is no correspondence from any government office or official to support their claim.
