BUSINESS TRANSACTED BY THE EAST AFRICAN LEGISLATIVE ASSEMBLY:
4TH MEETING - 1ST SESSION - 5TH ASSEMBLY

The 4th Meeting of the 1st Session of the 5th Assembly of the East African Legislative Assembly (EALA) was held from 11th - 23rd June, 2023 in the EALA Chamber, EAC Headquarters in Arusha, Tanzania.

During the meeting, the following business was transacted by the Assembly:

1. The Assembly passed the EAC Budget:-
 - i. The Supplementary Budget of the East African Community for the Financial Year 2022/2023.
 - ii. The Budget of the East African Community for the Financial Year 2023/2024.



Vision:
Deepen and widen East African Integration for Sustainable Development and improved livelihoods of all
Kenyans



2. The following Bills were passed:

- i. The East African Community Supplementary Appropriation Bill, 2023;
- ii. The East African Community Supplementary Appropriation Bill, (No.2) 2023 and
- iii. The East African Community Appropriation Bill, 2023.

3. The following Reports were Tabled/ Debated:-

- i. The Budget Speech of the East African Community for the FY 2023/2024.
- ii. The Report of the Committee on General Purpose on the EAC Supplementary Appropriation (No.1) AND (No.2) Bills.
- iii. Report of the Committee of General Purpose on the East African Community Budget Estimates for Revenue and Expenditure for FY 2023/2024.
- iv. The Report of the Committee on Legal, Rules and Privileges on the oversight activity on implementation of the Protocols and Laws Governing EAC Institutions.
- v. The Report of the Committee on Communication, Trade and Investment on the Oversight activity on Civil Aviation Safety and Security Oversight Agency.
- vi. The Report of the Committee on Legal, Rules and Privileges on consideration of the proposal to amend Rule 80(6) of the Rules of Procedure of the East African Legislative Assembly.
- vii. The Report of the Committee on Accounts on the Oversight activity to assess the programme and performances of the East African Health Research Commission.
- viii. The Report of the Committee on Regional Affairs and Conflict Resolution on the oversight activity to assess the progress made in the development of the EAC Refugee Management Policy.

4. The following Resolutions were adopted: -

- i. A Resolution of the Assembly urging the Council of Ministers and the Partner States to enhance the effective participation of Women and Youth in Business and to equip them to take advantage of the opportunities under the AfCFTA. *(Moved under Articles 49(2) (d), 59(1), 121, and 122 Of The Treaty And Rule 26 Of The Rules of Procedure of Procedure of the Assembly).*

- ii. A Resolution of the Assembly to reinstate the pending Bills of the 4th Assembly into the 5th Assembly. *(Moved under Rule 94B and Rule 26 of the Rules of Procedure of the Assembly).*
- iii. A Resolution of the Assembly recommending to the Council of Ministers and Partner States to use Local Currencies in all transactions in the East African Community region to boost trade. *(Moved under Articles 49(2) (d) and 59 (1) of the Treaty and Rule 26 of the Rules of Procedure of the Assembly).*
- iv. A Resolution of the Assembly to support the East African Pamoja Bid to host the 2027 African Cup of Nations in the East African Community Region. *(Moved under Articles 49(2) (d), 59(1), 119 of the Treaty and Rule 26 of the Rules of Procedure of the Assembly).*
- v. A Resolution of the Assembly urging the Council of Ministers and the Partner States to fast-track the Implementation of the 2014 Malabo Declaration on Accelerated Agriculture Growth and Transformation For Shared Prosperity and Improved Livelihoods. *(Moved under Articles 49(2) (d), 59(1), 105 and 110 of the Treaty and Rule 26 of the Rules of Procedure of the Assembly).*
- vi. A Resolution of the Assembly condemning the attack by the Allied Democratic Forces (ADF) on Lhubirira Secondary School, Kasese District, in the Republic of Uganda and in the Town of Kasindi in North Kivu. *(Moved under Articles 49(2)(d) and 59(1) of the Treaty and Rule 26 of the Rules of Procedure of the Assembly).*

This is therefore to submit copies of the business transacted by the Assembly and Bills passed/introduced, in accordance with the provisions of Article 65 (a) of the Treaty establishing the East African Community.
