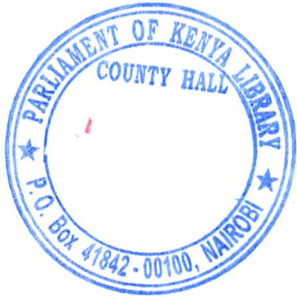

PREFACE

Mr. Speaker Sir,

The Departmental Committee on Health is established pursuant to the provisions of Standing Order No. 216(5) of the National Assembly and in line with Article 124 of the Constitution which provides for the establishment of the Committees by Parliament. The mandate and functions of the Committee is to:

- a) Investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;*
- b) Study the programme and policy objectives of the Ministries and departments and the effectiveness of the implementation;*
- c) Study and review all legislation referred to it;*
- d) Study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with its stated objectives;*
- e) Investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;*
- f) Vet and report on all appointments where the constitution or any law requires the National Assembly to approve, except those under Standing Order 204; and*
- g) Make reports and recommendations to the House as often as possible, including recommendation of proposed legislation.*

The Departmental Committee is mandated to cover the functions of the Ministry of Health alongside seven Semi-autonomous Government Agencies (SAGAs) namely; Kenyatta National Hospital; Moi Teaching and Referral Hospital; Kenya Medical Training College; Kenya Medical Supplies Authority; National Hospital Insurance Fund; Kenya Medical Research institute; National Aids and Control Council.

This report is an outcome of the exercise of Standing Order No. 216 (5) (f), on the vetting of the nominee of the office of Principal Secretary, State Department of Health, Ministry of Health.

EXECUTIVE SUMMARY

Mr. Speaker Sir,

On Tuesday 30th January 2018, pursuant to Standing Order 42(2) of the National Assembly Standing Orders, the Chair notified the House about the receipt of a message from H.E the President and Commander in Chief of the Kenya Defence Forces with respect to appointment of the persons to the various positions of Cabinet Secretary, Principal Secretaries and of High Commissioners/Ambassadors.

Subsequently, the Message from the President containing the names of seven (7) persons nominated to be appointed as Principal Secretaries together with their curriculum vitae was committed to the relevant Departmental Committees to conduct the vetting of the nominees. The respective Departmental Committees were expected to deliberate on the suitability or otherwise of the nominees and table their reports in the House for consideration.

Mr. Speaker Sir,

Following the committal of the nominees to the respective Departmental Committees for vetting and consideration of their suitability for appointment or otherwise by way of a report to the House, the Clerk of the National Assembly invited the interested members of the public through a public advertisement to submit their representations by written statement on oath (affidavit) that they may have on the suitability or otherwise on the said nominees to the respective Departmental Committees.

Subsequent to this, the Clerk of the National Assembly released a schedule of vetting for the various nominees by the respective Departmental committees, notifying the general public that the respective Departmental Committees shall conduct the vetting of the persons for appointment to their respective positions. Pursuant to these provisions of the Constitution and the Standing Orders of the National Assembly the Committees were

required to receive views from members of the public and any other person interested in the matter before the committees.

Mr. Peter Tum, the nominee for the position of the Principal Secretary for the Ministry of Health was committed to the Departmental Committee on Health. He appeared before the Committee on Wednesday, 21st February 2018 at 12.00 noon for vetting as scheduled.

To fulfill its mandate and facilitate the vetting, Mr. Tum submitted relevant documentation and testimonials supporting his case.

The Committee received one (1) written representation from the Third Way Alliance Party of Kenya raising various issues. The Committee noted that the representation did not meet the requirements under section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011. This section requires that a person submitting a memorandum shall make a written statement on oath. Further, the said memorandum was not directed at the suitability or otherwise of the nominee.

Thus, the Committee proceeded to consider the submissions made by Mr. Tum and conducted his vetting. This report of the Committee contains the recommendations based on its analysis.

The Committee recommends approval of nomination of Mr. Peter Kiplagat Tum, as Principal Secretary, Ministry of Health.

PART I

1.0 BACKGROUND

1.1 Constitutional and statutory requirements for the appointment and approval of a Principal Secretary in the Republic of Kenya

1. Articles 155(3), 132(2) of the Constitution and Section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011 assign the explicit role of the appointment of the Principal Secretary to the Public Service Commission, the President and the National Assembly.
2. The Constitution empowers the President to appoint the principal secretary with the approval of National Assembly after the initial recommendation from the public service commission. The process of appointment of the Principal secretary is outlined under Article 155 of the Constitution which provides—
 - (1) *There is established the office of Principal Secretary, which is an office in the public service.*
 - (2) *Each State department shall be under the administration of a Principal Secretary.*
 - (3) *The President shall—*
 - (a) *nominate a person for appointment as Principal Secretary from among persons recommended by the Public Service Commission; and*
 - (b) *With the approval of the National Assembly, appoint Principal Secretaries.*
 - (4) *The President may re-assign a Principal Secretary.*
 - (5) *A Principal Secretary may resign from office by giving notice, in writing, to the President.*
3. The constitution further provides under Article 132(2) (d) that the President shall nominate and, with the approval of the National Assembly, appoint and may dismiss Principal Secretaries in accordance with Article 155, while the Public Appointments

(Parliamentary Approval) Act, 2011 is the relevant statute that provides the general guidelines on the parliamentary approval of nominees for appointment to public offices in the Republic.

4. The Departmental Committee on Health like other Committees of the National Assembly plays an intermediary role for the National Assembly in the approval process. The Committee presents recommendation to the House for consideration. The House by resolution may approve, amend or reject any part of the report of the committee.

1.2 Introduction of the Nominee to the House and Committal to the Departmental Committee on Health

5. On 30th January 2018, the Hon. Speaker notified the House the receipt on 29th January 2018 of a Message from His Excellency the President and Commander in Chief of the Kenya Defence Forces of the Republic of Kenya with respect to appointment of the persons to the various positions of cabinet secretary, principal secretaries and of high commissioners/ambassadors of the Republic of Kenya (*Annex 1 & 3*). Procedurally, once the Speaker made the communication from the chair, the nominees stood committed to the respective departmental Committees for vetting of their suitability or otherwise for the positions they were nominated to be appointed to.

1.3 Call for Public Participation

6. In line with the established procedure, the Clerk of the National Assembly invited the interested members of the public through a public advert (*Annex 4*) to submit their representation by written statement on oath (affidavit) that they may have on the suitability or otherwise on the said nominees to the respective Departmental

Committees. The Clerk of the National Assembly further released a schedule of vetting (*Annex 6*) for the various nominees by the respective Departmental committees. This public advert made reference to the provisions of Article 118 of the Constitution, Section 6(4) of the Public Appointments (Parliamentary Approval) Act (No.33 Of 2011) and Standing Order 45(3), notifying the general public that the respective Departmental Committees shall conduct the vetting of the persons for appointment to their respective positions. Pursuant to these provisions of the Constitution, the statute and the Standing Orders of the National Assembly the Committees were required to receive views from members of the public and any other person interested in the matter before the committees.

1.4 Notification of the Nominee and request for documents

7. On Wednesday, 14th February, 2018, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act, the Clerk in writing (*Annex 5*) invited the nominee for the vetting approval hearing. The notification indicated that the nominee was scheduled to appear before the Departmental committee on Health on Wednesday 2nd February 2018 in Committee Room 7, parliament buildings. The Nominee was expected to fill and submit a vetting questionnaire as required by the Public Appointments (Parliamentary Approval) Act on or before the 19th February, 2018. Mr. Tum was further required to submit to his originals of his Identity Card, academic and professional certificates and other relevant testimonials. In addition, he was expected to bring letters/certificate of clearance/compliance from the following institutions-
 - a) Ethics and Anti-Corruption Commission;
 - b) Kenya Revenue Authority;
 - c) Higher Education Loans Board; and
 - d) Directorate of Criminal Investigations

1.5 Response from the relevant Institutions

8. The institutions that were required to issue letters, certificate of clearance and or compliance certificates responded to the request made to them by Mr. Tum as follows:

- (1) The Higher Education Loans Board on 16th February 2018 issued a compliance certificate (*Annex 7*) to Mr. Tum indicating that he was not a beneficiary of the university loans scheme.
- (2) The Kenya Revenue Authority by way of a letter dated 16th February 2018 (*Annex 8*) indicated that Mr. Tum had complied with his tax obligations.
- (3) The Ethics and Anti- corruption Commission by way of a letter dated 13th February 2018(*Annex 9*) indicated that Mr. Tum had no outstanding issues or ongoing investigations.
- (4) The Registrar of Political Parties by way of a letter dated 15th February 2018 (*Annex 15*) indicated that Mr. Tum according to their records was not an official of a registered political party

1.6 Public participation

9. Prior to the approval hearing, members of the public were invited vide a public advertisement in the local dailies of Wednesday 31st January, 2018 (*Annex 4*) to submit their written representation on oath(affidavit) on the nominee to the Committee.
10. Accordingly, the Committee received no specific written representation concerning the Nominee, Mr. Peter Tum; however the committee considered a memorandum received from the *Third way Alliance* that addressed the whole vetting approval process (*Annex 15*) that addressed itself to the general approval hearing for all the public positions the President was expected to fill. The Committee noted that the

representation did not meet the requirements under section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011.

PART II

2.1 APPROVAL HEARING AND COMMITTEE PROCEEDINGS

11. In exercise of the vetting process, the Committee conducted a chronology of activities which are set out below.

2.1.1 Meetings of the Committee

12. The Committee held its first meeting to consider this subject matter on Wednesday 21st February 2018 at 12.30 pm, where it considered its rules of procedure during the exercise and agreed on a framework for the approval hearing.
13. Thereafter the Committee proceeded to consider the submissions of the public and analyzed documents received from the Nominee, Mr. Peter Tum, the Nominee for the position of Principal Secretary, Ministry of Health.
14. The Committee then invited Mr. Peter Tum to appear before it as scheduled and communicated.
15. The Committee held a subsequent meeting on Thursday, 22nd February 2018 to consider and approve this report. The report of the Committee contains its recommendation based on the information gathered during the course of the vetting and approval hearing of the Nominee, Mr. Peter Tum. The Report is proposed by the Committee for adoption by the National Assembly. The Minutes of the meetings of the Committee are herein attached (*Annex 2*).

2.1.2 Compliance requirements

16. The nominee submitted to the committee all the documents required as per the letter sent by the Clerk of the National Assembly and a duly filled vetting questionnaire (*Annex 13*). The Committee was satisfied that nominee had complied with and

acquired the clearance required from Kenya Revenue authority, Directorate of Criminal Investigation, Higher education Loans Board, Ethics and anti-corruption Commission and the Registrar of political parties. The Nominee further submitted and was also evident from the document he submitted that he had not been charged in a court of law nor convicted, neither was he adversely mentioned in an investigatory report of a Parliamentary Committee or Commission. The Nominee further submitted originals of his national identity card and his passport (*Annex 10*) as proof his Kenyan citizenship. He further indicated that held no other citizenship.

2.1.3 Education, professional training and experience

17. Mr. Tum holds a Master of Science in Energy Management from the University of Nairobi, a Degree in Industrial Technology from Egerton University, a post-graduate Diploma in Medical Electronics & Medical Equipment Management from the University of London, a Higher Diploma with full technological certificates in Electrical Installation from the Kenya Polytechnic (now Technical University of Kenya) and several professional certifications gained locally and abroad. He got his Advanced Certificate of Education, (A' Level) at Chavakali High School and Kenya Certificate of Secondary Education (KCE), Kameloi Secondary School.
18. In addition he presented several professional certifications gained locally and abroad. He stated that he undertook a Strategic Leadership Development Programme (SLDP) at the Kenya School of Government, Performance Appraisal course offered by Directorate of Personnel Management, Leadership and Development programme facilitated by MSH USAID, Implementation of Quality Management Systems (ISO 9001-2000) offered by Kenya Bureau of Standards, T.O.T on Anti-Corruption by the Kenya Anti-Corruption Commission and application of informatics in Health Care Technology at the Medical Research Council in Cape Town South Africa among others. The copies of all the academic and professional certifications Mr. Tum presented to the Committee are herein annexed as (*Annex 14*).

19. He also indicated he was a member of several committees in his professional capacity, among them the College Quality Assurance committee, Disciplinary Committee, examination board, tender and also vice chairman of Tender committee Anti-Corruption committee and; vice chairman of the Association of Medical Engineering of Kenya.
20. In relation to his experience, Mr. Tum presented that he was a long-serving public servant with more than 15 years' of experience in leadership and management within the Public Service. He indicated that he joined the public service in 1990 as Medical Engineering Technologist and meticulously rose through the ranks in the same ministry to his current position as the Chief Executive Officer of the Kenya Medical Training College (KMTTC) in between holding positions such as Principal at the Nakuru KMTTC, Head of Department (medical engineering) and Head of Maintenance Unit at the Mbagathi Hospital. Mr. Tum exuded confidence that this steady experience as an informed insider positions him as the right person with the grasp and understanding of the operations and management of the Ministry of Health and the health sector in general.
21. To further expound on his qualifications as the right candidate for the position Mr. Tum said that he possessed unique experience in resource mobilization institutional development, human resource management and building of strong and sustainable partnerships. He qualified these attributes by the fact that he introduced 21 new programmes into the curriculum of KMTTC, expanded physical presence of the KMTTC to 42 out of the 47 Counties with the latest college opening in Mandera County in March 2018. In addition to meet the local demand this particular college, he said, came as a result of a request from the leadership of Somalia and is expected to meet the training needs of the citizens of Somalia due to the proximity of Mandera county to that country. He further added that the student intake rose from 7,600 in 2014

to 10,700 in 2017 while the student population in the colleges rose from 19,000 to 33,000.

22. Mr. Tum attributed these achievements to his visionary leadership, leverage on ICT and need to train enough human capital for health sector.

2.1.4 Professional affiliations

23. He has chaired and he is also a member of several committees in his professional capacity. He is a registered Engineer with a good grasp of how government works and understands the functions of government which he has worked well within.

2.1.5 Potential conflict of interest

24. Mr. Tum indicated that he had no family members or other persons, parties, categories obligation or financial arrangements that are likely to present potential conflicts-of-interest if he assumed the position of Principal Secretary. He added that he will avoid entering into situations where his actions might create a conflict, whether it's actual, potential or perceived, without disclosing the information. He added that in situations where there may be a reasonably perceived conflict of interest he will appoint an independent third party to oversee the integrity of the process.

2.1.6 Knowledge of the Health Sector

25. Mr. Tum responded to various question under the health sector as follows;

(1) Universal Health Coverage(UHC)

26. He expressed confidence that he will provide the leadership, managerial and technical stewardship to deliver 100% coverage for all households. He stated that for UHC to be successfully implemented, three important components must be decisively and comprehensively addressed: Human resource, accessibility and financing. He will strive to achieve by doing the following-

- (i) Assemble a competent and passionate team that will work closely under him to coordinate, guide and implement all the identified projects and programmes necessary to meet the objective.
- (ii) Deliberately seek to broaden the engagement and collaboration between the Ministry, Parliament and the County Governments to move forward faster and together.
- (iii) Carry out comprehensive skills audit especially of medical doctor so as to identify the existing skills gaps and optimize the existing pool of skills through an elaborate and equitable distribution mechanisms to improve the current 0.9 doctors to 1000 patients ratio
- (iv) Initiate and accelerate the necessary reforms in NHIF so as to provide a strong foundation for the implementation of UHC by delivering a minimum package especially for the vulnerable, poor, the elderly and the young.
- (v) Enhance the efficiency of commodity supplies by reforming and improving the capacity of the Kenya Medical Supplies Agency(KEMSA)
- (vi) Seek to enhance resource allocation to critical institutions like Kenya Medical Research Institute (KEMRI) so that it has both the human and financial capacity to deliver cut-edge research on emerging diseases. He added that there was need for KEMRI to be physically present in all the 47 counties.
- (vii) Work closely with donor organizations to maximize their support
- (viii) Leverage on Information Communication Technology (ICT) to ensure that the services delivery and disease surveillance are synchronized throughout the country. To do this, he stated that he will not reinvent the wheel but will borrow good practices from India, UK and Egypt that already have a working models

(2) Understanding of the Health Act

27. Mr. Tum responded as follows:

- (i) The Health Act 2017 has provided for a governance structure that assigned clear roles and responsibilities
- (ii) Various regulations are under consideration to holistically operationalize the Act
- (iii) The Act makes room for collapsing all the regulatory bodies into one so as to consolidate the numerous pieces of legislations that exist in the sector

(3) Human Resources for Health

28. He responded that having being at the helm of the Kenya Medical Training College, he understood this item. He responded as follows;

- (i) The health function is majorly a devolved function. This invites the National and County governments to develop a mechanism of ensuring that there is structured communication
- (ii) The Human Resources(HRH) should be a national government function, this is necessitated by the fact that training, skills matching, equitable distribution of personnel and emerging health issues will be better handled and managed at a centralized and coordinated point. In addition commodity movement and health financing should be an exclusive function of the national government
- (iii) It has become clear that industrial action in the sector has become a national government problem although county governments exclusively employ doctors and nurses
- (iv) There must be honest conversation with county governments and come up with mitigating mechanisms to assuage their fears about re-assigning some of the health functions to the national government.
- (v) The need to train and employ more community health worker. Experience has shown they fit very well within the communities they come.
- (vi) We need to give more incentive to nurses and motivate them.

(4) National Referral Hospitals

29. On the national referral hospitals, he stated as follows:

- (i) The situation at Kenyatta National Hospital is dire and needs immediate attention. The solution is not only to enhance budgetary allocation to KNH but also involves making the peripheral health facilities equipped and functional to decongest KNH. This also applies to Moi Teaching and Referral Hospital.
- (ii) There is need to re-activate the oxygen and IV fluid plants at KNH for efficiency and as a cost saving measure.
- (iii) The ministry should explore the options for KNH to open satellite clinics.
- (iv) The recent events that happened in KNH were unfortunate and the Ministry shall ensure a proper investigation will be carried and appropriate measures will be put in place.

(5) Medical Tourism

30. The Nominee responded as follows-

- (i) That he had no evidence to back the allegation that some doctors were colluding with health facilities in India to refer Kenyans to that country, but he will investigate to find out the veracity of the allegation. He was however aware that there existed a unit in the Ministry of Health that cleared all patients seeking referral to foreign countries for treatment.
- (ii) With the necessary investment, Kenya can attract patients from the region to be treated in our health facilities. The necessary sets of skills exist.

(6) Health Manufacturing

31. He responded as follows:

- (i) That he will promote the manufacturing of medical equipment and furniture within the country by providing the enabling environment for investors such as offering tax rebates and the necessary infrastructure
- (ii) That in addition to cost effectiveness of the products, the industry will also create jobs and contribute to the achievement of the agenda four items.

(7) Semi-Autonomous Government Agencies(SAGAS) under the Ministry

32. He responded as follows;

- (i) There was need to consolidate overlapping roles of the SAGAs so as to maximize on efficiency and cost-effectiveness
- (ii) There was need for a paradigm shift in the management and operation of SAGAs under the ministry, for instance The National Aids Control Council because of their expertise in control of HIV/AIDs should escalate their services to handle the control and management of related diseases

2.1.7 Vision and Leadership

33. He responded as follows;

- (i) That his main goal and vision is to deliver Universal Health Coverage within the next four years by closely working with the Ministry officials, the Health committee and the County Governments to ensure the delivered UHC packages are accessible at the lowest units of administration in our country
- (ii) He aims to provide managerial and technical leadership at Afya house and get rid of the alleged cartels that exist there

PART III

3.0 OBSERVATIONS AND RECOMMENDATIONS OF THE COMMITTEE

3.1 Observations

34. In making these observations on the suitability of Mr. Peter Tum Kiplagat for appointment to the Position of Principal Secretary of the Ministry of Health , the Committee took into account the following;
- i. The provisions of the Constitution and Public Appointments (Parliamentary Approval) Act with regard to the process of appointment of the Principal Secretary in the Republic of Kenya;
 - ii. The views received from the public;
 - iii. The vetting questionnaire filled and returned by the Nominee;
 - iv. The academic and professional certificates submitted to the committee and;
 - v. The oral submissions the Nominees made before the committee during the approval hearing.
35. The Committee observed as follows;
- (1) That the Nominee had complied with and submitted all the clearance certificate and letters from all the relevant institutions as required.
 - (2) That no affidavit was received from the public against Mr. Peter Tum.
 - (3) That the nominee had methodically progressed to achieve impressive academic and professional qualifications.
 - (4) The Nominee had worked in the Ministry of Health for the last 28 years(1990 to date) rising through the ranks to his current position as the Chief Executive Officer of the Kenya Medical Training College.
 - (5) He has vast knowledge and experience in the operations and management of the affairs of the Ministry of Health acquired during his long service in the ministry.

- (6) The Nominee's knowledge and understanding on subject matter of health was exemplary; his strength was seen to be in the academic and routine managerial processes.
- (7) In accordance with Article 78(1) (2) of the Constitution, the nominee is a Kenyan citizen.
- (8) Cumulatively the nominee's academic qualification, professional training and hands on experience met the threshold required for the position of Principal Secretary
- (9) The nominee satisfies the requirements of Chapter 6 of the Constitution on leadership and integrity. He had been issued with compliance and clearance letters by all relevant institution such as the Directorate of Criminal Investigations (DCI) Higher Education Loans Board (HELB), Kenya Revenue Authority (KRA), Ethics and Anti-corruption Commission (EACC) and the Registrar of Political Parties (RPP).
- (10) The Nominee had neither been charged in a court of law nor convicted, and had also not been adversely mentioned in an investigatory report of a Parliamentary Committee or Commission
- (11) In accordance with the provisions of Article 75(1) of the Constitution, he has no potential conflict of interest and has made pledge to avoid any situation that will compromise his position as a Principal Secretary
- (12) The nominee satisfies the requirements of Article 77(1) of the Constitution in that he does not intend to participate in any other gainful employment; and that he does not hold office in any political party in accordance with the provisions of Article 77(2) of the Constitution; and that he has never been dismissed from office under Article 75 of the Constitution for contravention of the provisions of Articles 75(1) (conflict of interest), 76(financial probity), 77(restriction of State Officers) and 78(2) (dual citizenship)
- (13) The Nominee is generally fit to hold the office of the Principal Secretary and complied with all the necessary legal, constitutional, statutory,

academic, profession and ethical requirements to hold the position of Principal Secretary.

3.2 Recommendation

Having conducted approval hearings and pursuant to Article 155(3) of the Constitution, and Section 8 (1) and (2) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011; the Committee recommends that this House **approves** the nomination and subsequent appointment of Mr. Peter Tum as Principal Secretary, State Department of Health, Ministry of Health.



MIN. NO. 33/2018: PRELIMINARIES / REMARKS BY THE CHAIRPERSON

The Chairperson called the meeting to order at 12.30 pm and requested the Hon. Stephen Mule, MP to say a prayer. All present then introduced themselves.

The letter was dismissed as it was not in the prescribed format, i.e. as an affidavit (oath) and was not specifically addressing the nominee.

MIN. NO. 34/2018: VETTING OF MR. PETER TUM, PRINCIPAL SECRETARY NOMINEE FOR THE OFFICE OF PRINCIPAL SECRETARY MINISTRY OF HEALTH

Mr. Peter Kiplagat Tum, the Principal Secretary nominee, Ministry of Health was orally interviewed pursuant to the provisions of the Constitution of Kenya, the Public Appointments (Parliamentary approvals) Act, 2011 and the Standing Orders of the National Assembly. He informed the Committee as follows;

Academic and professional qualifications

1. He holds a Master of Science degree in Energy Management from the University of Nairobi, a Degree in Industrial Technology from Egerton University, a post-graduate Diploma in Medical Electronics & Medical Equipment Management from the University of London, a Higher Diploma with full technological certificates in Electrical Installation from the Kenya Polytechnic (now Technical University of Kenya) and several professional certifications gained locally and abroad. He got his Advanced Certificate of Education, (A' Level) at Chavakali High School and Kenya Certificate of Secondary Education (KCE), Kameloi Secondary School.
2. He holds several professional certifications gained locally and abroad. He stated that he undertook a Strategic Leadership Development Programme (SLDP) at the Kenya School of Government, Performance Appraisal course offered by Directorate of Personnel Management, Leadership and Development programme facilitated by MSH USAID,

Implementation of Quality Management Systems (ISO 9001-2000) offered by Kenya Bureau of Standards, T.O.T on Anti-Corruption by the Kenya Anti-Corruption Commission and application of informatics in Health Care Technology at the Medical Research Council in Cape Town South Africa among others.

3. He also indicated he was a member of several committees in his professional capacity, among them the College quality Assurance committee, Disciplinary Committee, examination board, tender and also vice chairman of Tender committee Anti-Corruption committee and; vice chairman of the Association of Medical Engineering of Kenya.

Work Experience and achievements

4. In relation to his experience, Mr. Tum presented that he was a long-serving public servant with more than 15 years' of experience in leadership and management within the Public Service. He indicated that he joined the public service in 1990 as Medical Engineering Technologist and meticulously rose through the ranks in the same ministry to his current position as the Chief Executive Officer of the Kenya Medical Training College (KMTC). In between, he held positions such as Principal at the Nakuru KMTC, Head of Department (medical engineering) and Head of Maintenance Unit at the Mbagathi Hospital. Mr. Tum exuded confidence that this steady experience as an informed insider positions him as the right person with the grasp and understanding of the operations and management of the Ministry of Health and the health sector in general.
5. To further expound his unique position as the right candidate for the position Mr. Tum responded that he possessed experience in resource mobilization institutional development, human resource management and building of strong and sustainable partnerships. He qualified these attributes by the fact that he introduced 21 new programmes into the curriculum of KMTC, expanded physical presence of the KMTC to 42 out of the 47 Counties with the latest college opening in Mandera County in March 2018. In addition to meet the local demand this particular college, he said, came as a result of a request from the leadership of Somalia and is expected to meet the training needs of the citizens of Somalia due to the proximity of Mandera County to that country. He further added that the student intake rose from 7,600 in 2014 to 10,700 in 2017 while the student population in the colleges rose from 19,000 to 33, 000.

i) Universal Health Coverage(UHC)

8. He expressed confidence that he will provide the leadership, managerial and technical stewardship to deliver 100% coverage for all households. He stated that for UHC to be successfully implemented, three important components must be decisively and comprehensively addressed: Human resource, accessibility and financing. He will strive to achieve by doing the following:
 - a) Assemble a competent and passionate team that will work closely under him to coordinate, guide and implement all the identified projects and programmes necessary to meet the objective.
 - b) Deliberately seek to broaden the engagement and collaboration between the Ministry, Parliament and the County Governments to move forward faster and together.
 - c) Carry out comprehensive skills audit especially of medical doctor so as to identify the existing skills gaps and optimize the existing pool of skills through an elaborate

and equitable distribution mechanisms to improve the current 0.9 doctors to 1000 patients ratio

- d) Initiate and accelerate the necessary reforms in NHIF so as to provide a strong foundation for the implementation of UHC by delivering a minimum package especially for the vulnerable, poor, the elderly and the young.
- e) Enhance the efficiency of commodity supplies by reforming and improving the capacity of the Kenya Medical Supplies Agency(KEMSA)
- f) Seek to enhance resource allocation to critical institutions like Kenya Medical Research Institute (KEMRI) so that it has both the human and financial capacity to deliver cut-edge research on emerging diseases. He added that there was need for KEMRI to be physically present in all the 47 counties.
- g) Work closely with donor organizations to maximize their support
- h) Leverage on Information Communication Technology (ICT) to ensure that the services delivery and disease surveillance are synchronized throughout the country. To do this, he stated that he will not reinvent the wheel but will borrow good practices from India, UK and Egypt that already have a working models

The Act makes room for collapsing all the regulatory bodies into one so as to consolidate the numerous pieces of legislations that exist in the sector. iii) Human Resources for Health

10. He responded that having being at the helm of the Kenya Medical Training College, he understood this item comprehensively. He responded specifically stated that;
- a) The health function is majorly a devolved function. This invites the National and County governments to develop a mechanism of ensuring that there is structured communication
 - b) The Human Resources(HRH) should be a national government function, this is necessitated by the fact that training, skills matching, equitable distribution of

MEMORANDUM OF THE THIRDWAY ALLIANCE KENYA TO THE VETTING COMMITTEE OF THE NATIONAL ASSEMBLY ON THE APPOINTMENT OF NATIONAL EXECUTIVE (CS, CAS, PS & AMBASSADORS) OUR PERSPECTIVE AND WHAT NATIONAL ASSEMBLY SHOULD CONSIDER BEFORE RECOMMENDING THEM FOR APPOINTMENT.

PREAMBLE

③

First, *Thirdway Alliance Kenya* (hereinafter "*Thirdway*"), a political party duly registered under our laws and which participated in the 2017 General Elections, welcomes the decision of President Uhuru Kenyatta to propose a Cabinet after such a long wait.

Secondly, we appreciate that Parliament is set to begin this long-awaited cabinet. Therefore, and pursuant to **Section 6(9)** of the *Public Appointments (Parliamentary Approval) Act 2011* and further to the provisions of **Article 119** of our 2010 Constitution, *Thirdway* shares below our party's perspective on the proposed nominees for Cabinet Secretaries (CSs), Permanent Secretaries (PSs), Ambassadors, and a newly created post of Chief Administrative Secretary (CAS). Even as we share our views herein, we, however, note that the Cabinet remains incomplete. We hope that Parliament would urge President Uhuru to finalize on his nominees. Any further delay, continues to create anxiety and delayed service delivery to Kenyans.

As Parliament now sits to vet these names, we provide our perspective as follows:

1. Role of the National Assembly

- a. We see the role of the National Assembly, as not just being about vetting the nominees, but also pointing the Executive to the right direction in as far as some national concerns are. We have documented those concerns in this memorandum. To this extent, parliament would be playing its oversight role over the Executive. We urge you not to look at party politics; rather what is in the best interest of Kenyans; it is the responsibility of the National Assembly to guide the president on the best public servants to serve Kenyans.

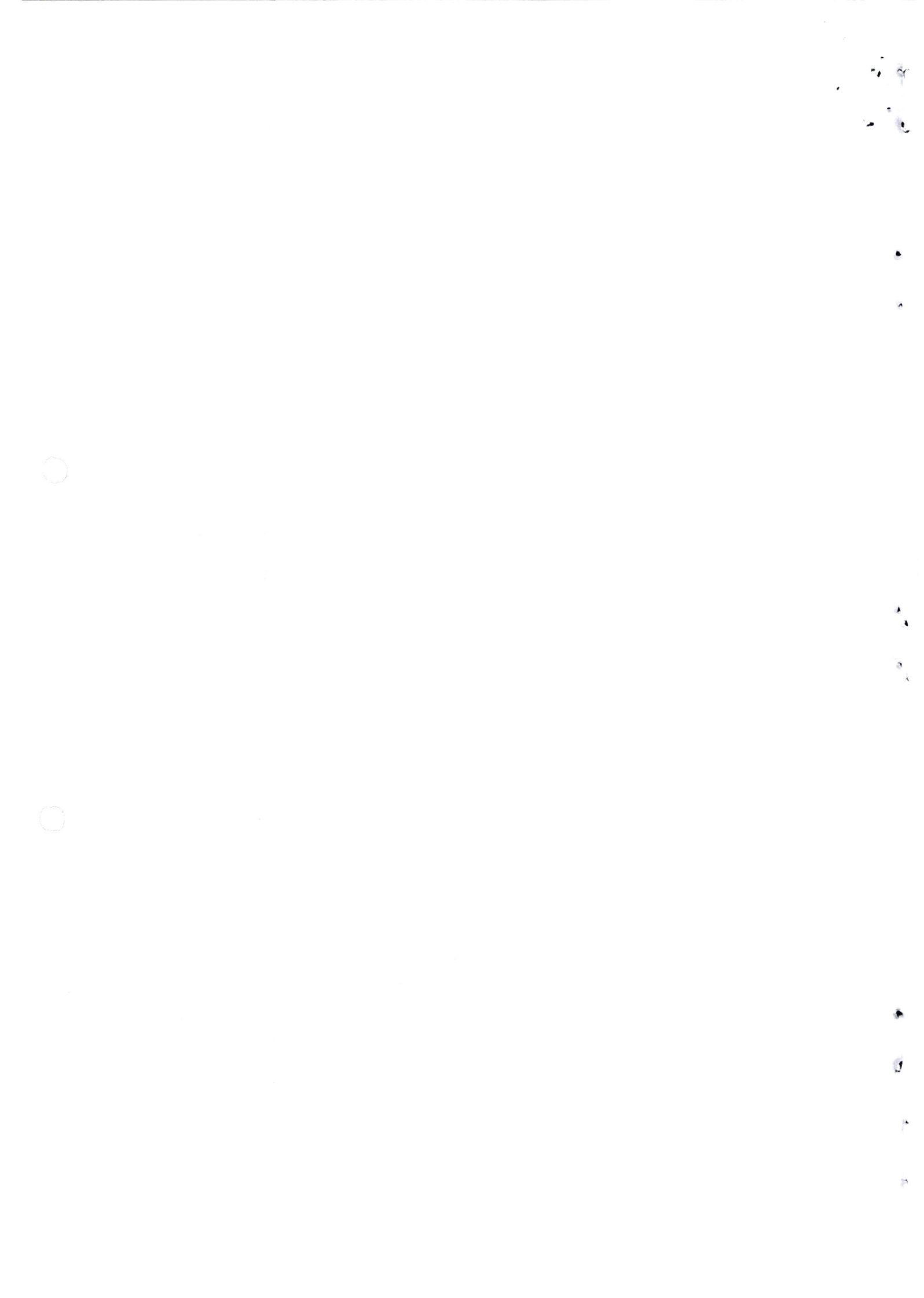
The need to observe chapter 6 of our Constitution & justification for appointments.

- a. Ch.6 of our Constitution speaks to "responsibilities of leadership", and that in selecting such State Officers, regard shall be had to their "competence and suitability", and in the particular instance, to perform a function as a CS, PS, and Ambassadors, amongst others.
- b. **On suitability & competence:** To use two examples in order to illustrate this issue, we do not see a clear justification for the transfer of a CS like Amb. Amina Mohammed to the Education Ministry. Her long, painstaking experience as CS Foreign Affairs will be a great loss to Kenya in terms of experience, skill and

resources. This is because she will have to learn how to manage a new Education docket. Assuming, the transfer was occasioned by her non-performance at the Foreign Affairs docket, why transfer her to the very crucial Education ministry where she has had no experience at all? Similarly, there is no clear justification for the appointment of Dr. Matiang'i as CS for Interior. This is because, he has arguably done an exemplary job as CS Education. At the same time, he has also received wide criticism both locally and internationally for his alleged contribution to the violation of human rights, including recent failure to obey court orders, and shutdown of media houses without compliance with **Article 24** of our Constitution.

- c. **Underperformance:** We urge your Committee to consider the performance, as well as underperformance by some CSs, PSs, who are now either transferred to a new docket or proposed for Ambassadorial appointment. You may want to interrogate the performance track record of each nominee. If on a balance of probability, a CS/PS never performed to expectation, you should reject such a name (*see also issue of integrity & corruption below*). We believe there are many Kenyans with skill, expertise, competence and who are suitable to serve in our public service.
- d. **On qualifications:** It is not clear what justification was used by the President to propose some nominees into Cabinet. Our proposal is that each of the nominees should produce before you, at least, a certified degree certificate from a recognized university. Kenya has so many learned and qualified individuals. We cannot appoint people into our public service, especially at such level as CS, PS and Ambassadors with questionable education credentials.
- e. **Integrity & corruption:** Our reading of the *Auditor General Reports* worryingly indicates that over 20 government departments could not account for public funds; neither could they demonstrate value for money. As you vet some of the returnee CSs and PSs, as well as those nominated for Ambassadorial appointments, it would be prudent to consider the findings of the *Auditor General* in the Ministries/departments they held prior to their now nomination for yet another appointment. For instance, the *Auditor General Reports* for the years 2013/14 and 2014/15 show that various ministries incurred unsupported Expenditure of **KES 66,782,697,987** and **KES 7,321,277,260** respectively. Additionally, various ministries incurred expenditure amounting to **KES 14,435,690,489** whose value for money could not be established. We insist that accounting of public money is paramount, and any nominee whose previous ministry or department could not account for funds must be rejected with recommendation that such individuals be investigated and prosecuted; and money to be recovered.

3. The Gender Rule.

- a. We have observed that President Uhuru Kenyatta overlooked the obligation in our Constitution to ensure the gender rule (1/3 or 2/3) in all key government appointments is met. So far, only 6 women have been appointed to CS positions out of the available 22 slots as well as Ambassadorial positions. This is below the threshold minimum of 30% required in our Constitution. This vetting Committee would agree that continued relegation of women in public appointments fuels inequality and disunity with a majority of Kenyan population who are women and

youth. A progressive government would ensure that it has equal representation of capable women and men for a more harmonious and balanced leadership. Continual denial of the rights of women is no longer tolerable. For the sake of Wanjiku and Atieno, *Thirdway* proposes that there be inclusion of many more capable women into the Cabinet and parliament using all resources under the government's power and control.

4. **The Youth Factor.**

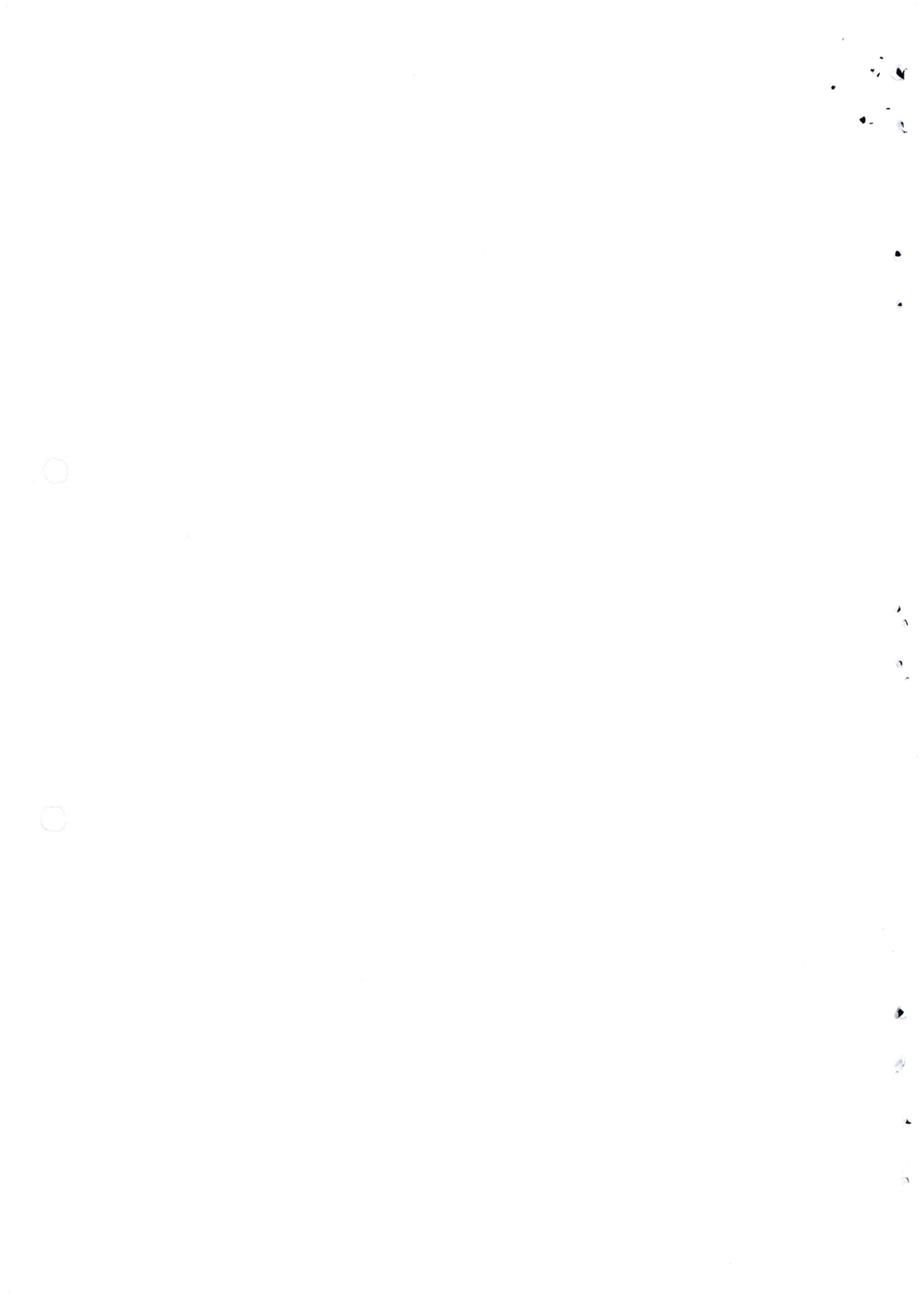
- a. The obvious and rather glaring omission of the youth, 35 years old and below is unfortunate and unacceptable. It must be remembered that our population is more than 70% youth. Young people are excelling in various fields such as IT, communication, Sports, trade and others placing Kenya on the map in many areas including scientific inventions. The Jubilee government must create space for more young and brilliant minds to manage high level government portfolios with introduction of electronic and modern technology to improve public participation.

5. **Special Interest Groups (SIG).**

- a. It is our observation that SIGs (persons living with disabilities, extreme minorities, etc.,) have been left out of the list of nominees. The obvious omission of people living with disability is a key area of concern as this group of people deserve to head one or two cabinet positions. We know that disability is not inability and many people are actually victims, for example, of health and transportation failures. Therefore, it would benefit this country to appoint them into cabinet and other sectors where they can contribute lasting solutions. Their continued under-representation is a culture we can no longer be proud of, as a country.

6. **Observance of Art. 130 of the Constitution.**

- a. The Cabinet, being the National Executive of our Republic, is required to meet the provisions of our Constitution in **Article 130** that "*the composition of the national executive shall reflect the regional and ethnic diversity of the people of Kenya*".
- b. The diversity and inclusivity clause in our Constitution has not been overlooked. At first glance, and without necessarily going into detail, it is clear that the list is ethnically imbalanced and overly generous to members of one or two communities whilst completely omitting and ignoring others. With the current political temperatures and divisive politics that is polarizing communities in our country (principally because of exclusion from government), it only good for our Country to ensure ethnic balancing is achieved in these appointments. We do not expect the government to increase the number of positions to fulfil this requirement; however, an effort must be evident to ensure inclusivity and representativeness of all groups of Kenyans as far as possible.
- c. ***Thirdway formula on ethnic and regional balancing.*** We propose that the President nominates his first 22 nominees for CS positions from 22 different ethnic groups of Kenya; then his second 22 nominees for PS positions from another 22 different ethnic groups of Kenya. That way, the President would have fulfilled both the ethnic and regional diversity of the people of Kenya. His Cabinet would be the true face of Kenya. We believe this would help President Kenyatta build a better legacy and good precedent for future presidents.



7. **“Recycling” of certain names in public service.**
 - a. “Recycling” or “rewinding” of personalities makes for a retrogressive society devoid of new ideas, ways of approaching important issues and problem-solving. We must make space for new faces and personalities who should be carefully selected based on their professional experience and less on their political influence, which is a role best left to MPs to deliver. If someone is today not deemed to have done a better job at Cabinet level, why transfer them to an ambassadorial position?

8. **Incomplete Cabinet list.**
 - a. We observe that the Cabinet remains incomplete. Our view is that this opens up space for unnecessary speculation and negative competition, which following a five-month long wait is clearly unhealthy for the country. All positions should be announced simultaneously and in good time, so as to minimize opportunities for canvassing and irregular appointments due to the need to pay political debts.

9. **Creation of Chief Administrative Secretary ignored need for transparency & a public consultation process.**
 - a. **Funding and void CAS is to fill:** We have asked ourselves these questions: which constitutional bodies gave their approval and advised the president to create the CAS category and for what specific reason? How does government plan to fund this role? Which void does the post of CAS fill in the current public service?

 - b. **Non-compliance with Procedure & consultation under Article 132:** While we appreciate that it is the right of the President in *Article 132* to create a new position in the public service, we also believe that the right and constitutional procedure in creating this new position was overlooked. This makes the position of CAS unconstitutional. The creation of the CAS post ought to have been preceded by a recommendation from the Public Service Commission (PSC). It is only then that the President can create a position in the public service.

 - c. **Public participation:** In addition to the foregoing, it also means that the principle of public participation was overlooked. The Kenyan general public ought to have been given the chance to give views whether this post is necessary under the circumstances; or not.

 - d. **Increased wage bill:** Kenyans are currently unhappy with the huge bill in our public sector including in devolved counties. We believe that the position of CAS is already going to come with another wage bill at a time when we are concerned about cost cutting.

 - e. **Replication of & conflict over duties:** In fact, we believe that the CAS position would replicate the Assistant Minister position that was scrapped in previous regimes. In fact, this post is already introducing an additional bureaucracy through yet another middle level/tier of management. We also see this post as a recipe for conflict between the CS and CAS on the one hand, and CAS and PS on the other. It is worth noting that efficient companies and governments around the world are currently obliterating the “middleman/woman” role due to high costs and

unnecessary bureaucracy, which affects service delivery. Our position is that it is an unnecessary addition to an already bloated government. Kenyans cannot sustainably carry this additional expense with our already highly indebted country. We are an already overburdened citizenry. The CAS positions must, therefore, be rejected with no additional names presented in this category until it is properly justified and resources identified to sustain it. Retaining this post will actually prompt high taxes on an already heavily taxed Kenyan worker.

10. Need for a Lean Government.

- a. Our party holds the view that a lean government in all its levels, is economically desirable for Kenya including, but not limited, to our current over representation in Parliament. A large government is a huge wage bill to the taxpayer. This huge wage bill robs Kenyans of development money (e.g., to ensure adequate water, healthcare, food, security, roads, education, electricity, etc.). Kenyans have expressed support for this view and we will continue to push for consultations and conversations with the Jubilee administration, as well as with Parliament at all levels, on how best to reduce the burden of government on Kenyans. Rather, government must work to create opportunities and support efforts of citizens while conserving funds for essential needs and releasing funds for development and for service provision to the Kenyan people guaranteeing our future prosperity and growth.

Conclusion: Lastly, we thank the Vetting Committee for the opportunity to share our party's views on this important national exercise. We remain optimistic that Parliament will take these views into consideration. We also take this early chance to urge parliament to steer the country towards constructive political conversation. Parliament may want to consider our proposed National Conversation with a 14-point agenda.



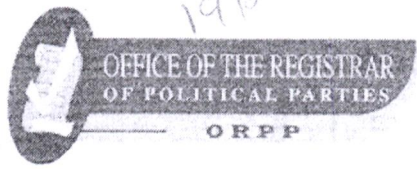
