## INTRODUCTION

The Constituencies Development Fund Act, 2013 Section 29 stipulates that the Board shall, on a monthly basis, submit a report to the National Assembly Select Committee detailing the following;

- a) A summary of the project proposals received from the constituencies in the preceding month and indicating the approval status of such projects;
- (b) A summary of the status of disbursements of funds to the constituencies for that preceding month;
- (c) A summary of the status of disbursements from the Treasury to the National Account;
- (d) Any restriction imposed on a constituency account in accordance with the Act.

Section 30 of the CDF Act 2013 further stipulates that the Board shall ensure that the list of projects forwarded to it by each constituency is, upon approval, funded in accordance with the Act.

The report submitted for the month of September, 2015 covered details of Project Proposals for 2015/16 Financial Year and status of disbursement of funds as at 30<sup>th</sup> September, 2015. This report covers updates on Project Proposals for 2015/16 Financial Year, status of disbursement of funds as at 31<sup>st</sup> October, 2015 and any restriction imposed on a constituency account in accordance with the Act.
